Deputy dragged while attempting arrest

An Owyhee County sheriff's deputy was injured last week after being dragged nearly 300 feet from the window of a vehicle driven by a Homedale woman wanted on a misdemeanor warrant.

A witness to the incident was the only thing that kept Deputy Don Collingwood from being seriously injured or perhaps killed as the woman attempted to flee an arrest with the officer hanging from her vehicle window. Collingwood received bruising to his upper right arm and left leg, but was back on patrol that same afternoon.

The incident began Wednesday afternoon when Collingwood made a traffic stop on Industrial Road and

U.S. 95 in Homedale.

"The driver of the vehicle was a young woman who I knew did not have a driver's license," Collingwood said Thursday. "I asked her for her driver's license and she told me she didn't have one, so I asked her for her registration and proof of insurance. She gave them to me and I cited her for failure to purchase. I had known that her mother, Treasure Kester who was also in the vehicle, had a warrant for her arrest."

As Collingwood waited for the county dispatch to confirm the warrant, Kester's daughter asked if she could walk home.

"Her daughter said she had paperwork at home that would

prove the warrants were taken care of. She asked if she could walk home and get it, so I let her go," Collingwood

continued.

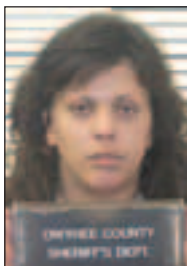
Collingwood said it was when he attempted to arrest Kester, 36, after the warrant

was confirmed, that the trouble began.

"Both doors of the vehicle were locked and the window on the driver's side was rolled down about four or five inches," Collingwood explained. "I reached in and tried to find the door handle as Treasure was trying to move over into the driver's seat. She then started the car up and lunged forward knocking me off my feet."

Kester drove across Highway 95 with Officer Collingwood's arm caught in the window of the driver's door. If it had not been for the quick thinking of a witness to the incident, Collingwood said the crisis could have been much worse.

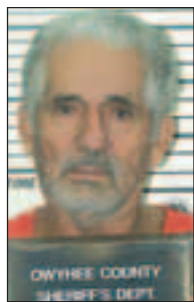
Marsing man's trial rescheduled

A Marsing man arrested on three counts of lewd and lascivious conduct with a minor under 16 will have to wait until January to get his day in court after a mistrial motion was granted to the defense last week.

Abelardo Renteria was arrested in June and charged with the sex crime after being accused of molesting three young girls between the ages of six and nine years of age. He was set for trial Oct. 24, but the judge made a mistake during the instructions to the jury and a motion for a mistrial was made.

"The judge called a recess during the trial and talked to the attorneys," a witness to the trial said Friday. "When they returned, Public Defender Bill

Council drops three percent franchise fee

After hearing arguments from the Homedale School District and from former Mayor Paul Fink, the Homedale City Council moved to amend an amendment to ordinance 312 which added a three percent increase to local Intermountain Gas Company (IGC) rates.

Ordinance 339 amended 312, section six, on July 25th to "provide for a three percent franchise fee of gross annual receipts received by Intermountain Gas Company within the corporate limits of the City of Homedale."

IGC removed a five percent gas adder fee in September, but suggested city of add a three percent franchise fee, which they passed in July.

"I would like to see that you do not put the three percent franchise fee on the natural gas," Fink said. "If it is businesses that you are trying to attract, the fee will keep them away from Homedale."

"During the time that we were trying to bring Intermountain Gas into

New addressing causes confusion

Sheriff asks locals to be patient

Residents living within Homedale, Melba and Murphy zip codes received their new addresses last week as part of the new enhanced 911 system being installed in the county. But with those new addresses, Owyhee County Sheriff Gary Aman says has also caused some confusion.

"There will be some mistakes," Aman said Tuesday. "I want the people of the area to know that they should feel free to contact us with their concerns, but I also ask that they be patient."

People with a Melba zip code can use Opaline, Givens, Wilson or Guffy as their city address, but Aman said it would depend on the location of the address.

"If they live in the Opaline area, they can use Opaline as their city address," Aman explained. "If a person is unsure which town they live in and should use, they should call their local post office for the boundaries. We do not have that information here."

Aman said people should not change — to page 4

my feet she would lunge forward knocking me off my feet again,” Collingwood continued. “I pulled my service weapon and kept trying to point it at her, but she kept slapping it away.”

Betty Eoff happened to be in the right place at the right time when Collingwood needed assistance.

“I was going to Les Schwab to have some work done on my car and I drove by Don and saw that he had a small white car pulled over,” Eoff said Thursday. “He was leaning in the window doing what ever it is he was doing.

“I was in Les Schwab about 20 or 25 minutes and when I came out I noticed that Don was still with the white car. I thought it was peculiar that he would be there so long. Just that quick I could see scuffling going on around the car. I could see that there was some kind of altercation going on.

“Within seconds the car was lurching across highway 95 and I know the person driving didn’t even look to see if there was any oncoming traffic. It just sped across the highway toward me and the car was dragging Don.”

“He was hanging out the window and his legs were hanging. I just could not believe what I was seeing,” Eoff continued. “It was like I was watching something on television from one of those cops shows.”

Eoff said she quickly made a U-turn in an attempt to get in front of Kester’s vehicle so she could force her stop.

“As soon as I saw the car coming at me I started laying on the horn so maybe the people in Les Schwab would call for backup or something,” Eoff explained. “As soon as she shot by me I did a U-turn and knew I had to get in front of her. I pulled in front of her and just knew that she was going to slam into me, but I had to do something.”

Three additional men from Les Schwab came to the officer’s aid just as Kester stopped her vehicle inches from hitting Eoff’s car. Collingwood said it took all four men to subdue Kester.

“All I could see was his legs being drug off,” Eoff said. “It was like she wasn’t in her right mind or something because it happened so fast. She just

floored that vehicle across the road. She wasn’t even trying to slow down. He was in grave danger and I had to do something.”

Eoff said she does not feel like a hero in the situation and said if she had to do it over, she would.

“His life was in danger,” Eoff said. “I just did what I had to do to get that car stopped. As I pulled in front I actually thought that I hoped my insurance would cover me because I was expecting to get hit hard.”

Owyhee County Sheriff Gary Aman said Kester has been charged with aggravated assault on an officer with the intent to commit a serious felony. He said she is currently on felony probation for a burglary conviction.

“She has a very lengthy criminal record,” Aman said. “We are waiting on lab results for possible further charges. I intend to seek very restricted sentencing on this case.

“We greatly appreciate all the people who helped officer Collingwood. It just goes to show the support people in our communities have for each other.”

Kester’s bond has been set at \$200,000.

Homedale man makes death threat in courthouse

A Homedale man was arrested earlier this month after threatening to kill a woman in the Owyhee County Courthouse with a knife.

George Duvall was arrested and charged with disturbing the peace and contempt of court after threatening to retrieve a knife from his vehicle and “cut” a woman’s throat.

“Duvall was apparently in the courtroom on a separate case when he became very agitated,” Owyhee County Sheriff Gary Aman said. “We had several people in the area who said they heard Duvall say he was going to go to his vehicle and get a knife and cut a woman’s throat.

“He had an empty knife sheath on his belt and we found a knife in his vehicle, so he had the ability and obviously the intent to harm someone.” Aman continued. “He was arrested on the spot and sent to jail.”

Aman said the courthouse has had undergone many changes to help protect the people in the building, but he said to be able to install metal detectors could cost the county nearly a million dollars.

“The commissioners and myself have talked in length about different ways to protect the people in the courthouse and we have done many things to make it safe,” Aman said last week. “Installing metal detectors in the building is not something that is going to happen here soon. It is very expensive and I really don’t think at this point that it is a necessity. The building would have to go nearly a million dollars in remodeling to be able to accommodate it.”

Police commissioner resigns position

Homedale City Councilman David Freelove resigned his police commissioner position during a council meeting last week in the wake of a \$1 million lawsuit against the city and the councilman's pending trial for driving under the influence.

Freelove made the announcement after a lengthy executive session during the regular monthly meeting.

"At this time I will resign my position as police commissioner," Freelove told the council. "I apologize for the negative effect it has had on the city and that is my reasoning for resigning and handing my position back to the mayor to decide who to appoint. I have no further comment, nor will I have any further comment."

Homedale Mayor Harold Puri told the council that a decision to reappoint the position would be addressed at a later time.

Freelove was arrested in August for driving under the influence of alcohol. Shortly after his arrest, a local business filed a \$1 million tort claim against the city, the police commissioner, the Homedale Police Department, the City of Wilder and the Wilder Police Department for damages they claim they suffered from an unfounded report of juveniles drinking.

Owners of Owyhee Lanes and Restaurant based the tort claim on damages incurred after the Homedale Police Department closed the establishment when Freelove received a report of juveniles drinking. Children bowling in the business were made to submit to a breathalyzer test in which no juvenile was found to have been drinking.

Freelove is scheduled for a pre-trial hearing on the DUI charge on January 6 at 9 a.m. and a trial is set for January 28.

No county contests in next Tuesday's election

Term limits hottest issue on this year's ballot

Of the five county positions on the ballot in Owyhee County in next Tuesday's election, none of the seats are being contested. This year's hot topic for local voters will be the term limits proposition, Proposition Two.

County candidates up for election this year, but unopposed are County Commissioner Harold Tolmie; County Commissioner, Chris Salove; Clerk of the District Court, Charlotte Sherburn will replace Cyndi Eaton; County Treasurer, Barbara Wright; County Assessor, Brett Endicott will replace retiring Ernie Bahem, and County Coroner, Harvey Grimme. All are running on the Republican ticket.

Voters will have a choice of six candidates for Legislative District No. 23. For State Senator William K. (Bill) Chisholm (D) will run against Republican Tom Gannon. For State Representative position A, Republican incumbent Frances Field will run against Democratic candidate Mike Ihler and in position B, Democratic Candidate Grant R. Atkinson, will run against Douglas R. Jones, Republican.

The propositions that will face voters are the term limits issue, Proposition Two and Proposition One, tribal gaming.

"The ballot that voters will face will seem to be very

confusing," Press Secretary Lindsay Northern from United States Senator Mike Crapo's office said recently. "They want it to be confusing. The bottom line is, if you do not want term limits, vote yes."

A spokesman from Secretary of State Pete Cenarrusa's office said voters will need to read the question on the ballot carefully to understand what it is they are voting for. She said if you oppose term limits, voters will need to vote yes. Those who are in favor of term limits will need to vote no.

The ballot reads, 'shall the legislation repealing term limits for elected state, county, municipal and school district officials be approved?' If voters do not want their state, county, municipal and school district officials to be term limited out of office then they will need to vote yes. If the voter does want their state, county, municipal and school district officials term limited, then they will need to vote no.

Another proposition on the ballot will be "defining tribal video gaming machines and providing for amendment for state-tribal gaming compact providing for their use," also known as Proposition One.

Proposition One reads, "an initiative relating to Indian gaming; providing findings and purposes. Clarifying public policy regarding Indian gaming. Adding Idaho Code § 67-429B defining tribal video gaming machines as gaming

machines used by Indian tribes which are not activated by a handle or lever, do not dispense coins, currency, tokens or chips, and which perform only certain defined functions, and defining such machines as neither slot machine nor imitations or simulations of any form of casino gaming. Adding § 67-429C allowing amendment of state-tribes possession on January 1, 2002, allowing an increase of 5 percent per year not to exceed 25 percent over 10 years. Requiring renegotiations of compacts after 10 years. Providing for automatic approval by State without necessity of executive or legislative action. Making initiative effective upon completion of canvass of votes by Idaho Secretary of State; and containing a severability clause."

Voters are asked to vote yes or no if the above-entitled measure proposed by Proposition One should be approved.

The state election will focus on US Senator race, representative in congress, governor, lieutenant governor, secretary of state, state controller, state treasurer, attorney general and superintendent of public instruction.

Republican candidates include, Larry Craig for United States Senator, Butch Otter for Representative in Congress in the First District, Dirk Kempthorne for Governor, Jim Risch for Lieutenant Governor, Ben Ysursa for Secretary of State, Keith Johnson for State Controller, Ron Crane for State Treasurer, Lawrence Wasden for Attorney General, and Tom Luna for Superintendent of Public Instruction.

Democratic candidates include, Alan Blinken, Senator, Betty Richardson, Congress, Jerry Brady, Governor, Bob Sonnichsen for Controller, Sally Beitia for Treasurer, Keith Roark for Attorney General and Marilyn Howard for Superintendent of Public Instruction.

Libertarian candidates include Donovan Bramwell for Senator, Steve Gothard for Congress, Daniel Adams for Governor, Michael Kempf for Lieutenant Governor, Ronald Perry for Secretary of State, Greg Nalder for State Controller, Sherwin Fellen for Treasurer and Robbi Kier for Superintendent of Public Instruction.

The deadline for voter registration has passed, but voters can still register at the polls on the day of the election. Absentee ballots are available from the county clerk's office in Murphy. Those wanting to

vote absentee can either pick one up or call the clerk's office to receive one by mail, up to Nov. 4. Absentee ballots must be received in the county clerk's office by 8 p.m. Nov. 5.

The polls will be open from 8 a.m. to 8 p.m. at the following precinct locations:

North Homedale, Senior Citizens Center at 224 W. Idaho Avenue; South Homedale, Magistrate Court Building at 31 W. Wyoming Avenue; North Marsing, American Legion Hall at 126 North Bruneau Highway; South Marsing, Extension Office at 238 W. 8th Avenue; Wilson, Wilson Fire Station; Pleasant Valley, Elementary School; Oreana, Community Hall on Oreana Loop Road; Riddle, Riddle Store; Grand View, Eastern Owyhee County Library at 520 Boise Avenue; Three Creek, School Building, Bruneau, American Legion Building and absentee at Murphy Courthouse only.

Whelman moved for a mistrial and the judge granted it.”

Owyhee County Chief Deputy Dick Freund said he received the report of the abuse in 1999 and said the incidents allegedly happened approximately 1993. Renteria was arrested on June 29, 2002. His bond is set at \$25,000 and he remains in the Owyhee County jail.

Rentria’s new trial is set for Jan. 28 and 29, 2003.-CP

the number address that they are given or the street address, but they can change the city.

Aman also said that former roads named north, south, east or west would no longer be listed in addressing as such.

“Roads like ‘South Bruneau,’ or ‘West Market,’ do not exist in addressing anymore,” Aman continued. “A north, south, east or west address is too confusing for emergency personnel to follow, so they will not be listed in addresses.

“People can continue to use their checks and address labels,” Aman continued. “The post office will deliver their mail with their old address for up to a year. We will have the time to sort this out, but I hope the people will be patient and let us do our job on the situation.”

Homedale, we had meetings with the school district and with SSI as we thought they were going to bring a large business into the area.

“The gas prices was a big deal to these business then and with the three percent increase it will do nothing more then keep them out of the area. At that time there was never any intention to put a three percent increase on natural gas after the adder fee was removed. I realize that by law you can add the increase, but as I have said when we brought natural gas into Homedale, we never had any intention of adding an increase. If it had not been for the school, we would never have been able to bring natural gas into Homedale.”

Homedale School District Superintendent Bob Lisonbee was not able to attend the meeting Thursday night due to a family emergency, but School District Board Trustee Moss Watson attended in his place.

Watson told the council that the school district uses over \$60,000 in natural gas per year. He said with the increase, the school district would be paying over \$2,000 per year. He said the money the district had planned to save was going to be used for new books and in classrooms.

“We can be considered one of the biggest users of natural gas in the community,” Watson said. “In 2001 our annual gas bill was \$67,000. In 2002 it was \$61,000. This is a fairly significant use. It amounts to about \$2,000 per year which

would represent two to three classrooms in books.”

Watson told the council that the district did not include the increase in its budget because they were unaware of it. He said he realized the increase was nothing out of the ordinary from most other communities, but he said that if Homedale did not have the franchise fee it might bring in more businesses.

“One thing I looked at before I came into the meeting tonight was the statute that allows cities to have a franchise fee,” Watson explained. “If I am interpreting it right, it says you can not do it without the consent of the utility or a vote. The way it appears to me is it is almost a conflict of interest, because Intermountain Gas could get concessions on whatever they collect on your behalf so why would they not approve a collection.

“I guess the bottom line is it caught us off guard. Our budget is set for this fiscal year and nothing was added in for the fee.”

A motion to amend the amendment number 339 to remove the three percent increase. The motion passed unanimously. -CP

Motion to dismiss denied Cassidy

A judge in an Owyhee County courtroom determined last Tuesday that the Owyhee County Sheriff’s Office had probable cause to make a stop, arrest and search Maureen Cassidy’s vehicle and denied a request to dismiss her charges based on an illegal search.

A spokesman from the State Attorney General’s Office, Bob Cooper, said the court determined there was sufficient probable cause to make the stop, arrest and search.

“There was a motion by the defense to dismiss the charges on the claim of an illegal search and seizure,” Cooper said Monday. “The court ruled there was probable cause to make the stop, make the arrest and make the search. Maureen will be back in court on those charges today, (Oct. 28).”

Cassidy was arrested in April after her former husband, Owyhee County Prosecuting

Attorney Ed Yarbrough reportedly found her attempting to commit suicide by carbon monoxide poisoning. Yarbrough called local law enforcement after finding his wife in the couple’s garage in her vehicle with the vehicle running and a suicide note.


Owyhee County and Canyon County Sheriff’s Deputies pursued Cassidy through portions of Melba, Canyon County and Owyhee County. The chase ended 35 minutes

after it began when Sheriff Gary Aman ordered a road spike strip near the Walter’s Ferry Bridge.

She was arrested and charged with one felony count of eluding a police officer and possession of a controlled substance, methamphetamine. She was also arraigned on one count of misdemeanor possession of a controlled substance and a misdemeanor charge of resisting an officer. Several officers received minor injuries including Aman.

Public hearing on grant applications held Monday

Bruneau and Grand View seek financial assistance for community improvement projects

A public hearing was held on Monday in Murphy, during the weekly Owyhee County Commissioners meeting, to gather input from the community and to discuss two Idaho Community Development Block Grant applications for which the county has applied.

The county has partnered with Sage Community Resources, a non-profit organization that assists cities and counties in Southwest Idaho with community improvement projects.

Sage, acting on the behalf of Owyhee County, must submit the grant applications by Nov. 22.

The Bruneau Water District will ask for \$200,000 that will go towards a proposed \$789,000 upgrade in its water purification system. Grand View Ambulance-Rimrock Search and Rescue, Inc. is soliciting \$280,000 to offset the \$549,000 it needs to build a new facility.

Owyhee County has never before received an Idaho Community Development Block Grant.

The federal Community Development Block Grant Progam (CDBG) allocates the money – \$4.5 million to Idaho this year – by way of the

Community Development Act of 1974. The Department of Housing and Urban Development (H.U.D.) administers the program. The funds are distributed through the Idaho Department of Commerce.

“Idaho gets several million (dollars) a year for certain categories,” said Pat Engel, planning specialist for Sage. This is a public facilities category. (It) provides infrastructure and health and safety improvements for communities.”

The reason why these applications are going forward, according to Engel is a matter of size, scope and income.

Bruneau has a very small water district. The Grand View fire district serves a large area outside the city itself. And both communities fall into a low to moderate income category.

“Funds are only available to cities and counties and must serve people who are 51 percent low to moderate income,” Engel said. “We’ve had to do income surveys to verify that service population meets that criteria.

“And then they need eligible sponsors,” she said. “Bruneau is not incorporated and the Grand View Fire and Ambulance district serves a bigger area than the city of Grand View, so they needed the county to be the sponsor.”

The Grand View Ambulance-Rimrock Search

and Rescue project is proposing the construction of a new emergency services facility in Grand View that will serve eastern Owyhee County.

The facility will have four vehicle bays with interior training rooms and storage capacity for support equipment.

“Currently that’s all separated,” Engel said. “It’s very important from a response time and a health and safety

standpoint to have all your emergency services, training and support equipment in one spot.”

In addition to the H.U.D. grants, both projects can be eligible for matching funds through grants and loans from the United States Department of Agriculture (USDA).

“The fire district has already addressed their taxing levies, so they can repay (the USDA loan) at low interest.” Engel

said. “They have also generated some local cash to match that.

“The Bruneau water district has raised their rates, in preparation for doing this,” she said. “They’re installing a purification system through USDA rural development, both a loan and a grant.

“(The) USDA money in both these instances can be used to match the Community Development Block Grant,” Engel said. – CM

Salove appointed to Resource Advisory Council

"I can only hope to be a voice for the people of Owyhee County."

Interior Secretary Gale Norton announced earlier this month the appointment of 18 members to Idaho's citizen-based Resource Advisory Council (RAC), which advises the Bureau of Land Management (BLM) on federal land issues.

Owyhee County Commissioner Chris Salove was among those appointed by Norton and said last week his goal is to be a voice for Owyhee County and make sure the facts are presented to the RAC board.

"I don't know how much of an impact I can make, I just hope to be a strong voice for Owyhee County," Salove said last week.

Salove said the position came available when former RAC member Rick Branch from Midvale wanted out of the position. He said several local BLM employees that he works with frequently, also approached him.

"Rick and I have crossed paths several times in the past mostly as advocates for Helen Chenoweth," Salove explained. "At first I told him no, I didn't want it. The RAC is another job that takes an enormous amount of time and an enormous amount of energy if you take it seriously and you

have very little to show for it. When he wanted out he wanted to make sure someone would take his place as a voice for cattlemen. So after I thought about it and being approached by several sources from BLM I decided to accept the position."

Salove said he was uncertain if he could make a difference in the ongoing process of grazing rights, property rights and making a living in the agricultural industry, but he said he would make sure the concerns of the people of Owyhee County would be heard.

"I don't know that I will make a difference," Salove continued. "I will help Brenda Richards to make sure that the people on the land are heard. I am not sure what more you can do

on any government committee. I don't care what it is. I don't know what more you can do to make sure that the point of view is heard and to back up the point of view with the facts. And that is what doesn't make it to the RAC a lot of times are the facts. Not only does the point of view not get there, but the facts also do not get there. I hope to be able to do that. Present the points of view and the facts."

Salove said the position can only be filled by an elected official and he said since he is a former farmer, rancher and current business owner, what better person to take the point

of view to the table than a commissioner who knows the business from both sides.

"This is obviously not a position I want for me," Salove said. "I will not gain anything financially from this. I am no longer a farmer or rancher and it will not benefit my retail business, so I have no conflict of interest."

Salove is the last of the Salove lineage to farm and ranch the Owyhee County soil. He said his great grandfather came to the county in the early 1900s and the family has ranched the area since then until a short time ago.

"I am the last one on the Salove side," he said. "Up until about a year and a half ago I grew up around cattle all my life. Now the Salove family is no longer into ranching. I have nothing to do with agriculture anymore."

Salove said people in the area know how to contact him with their concerns, and they do. He said that some days he will have several people per day approaching him about farming and ranching concerns and other times, he won't hear from anyone for weeks.

Council members are not paid and serve a three-year term. New and reappointed members of the councils for the Lower Snake River Resource Advisory Council include Sandra Mitchell from Nampa representing dispersed recreation as a new member, Donna M. Griffin from Meridian reappointed to represent dispersed recreation,

John Robison from Boise appointed as a new member to represent environmental organizations, Robert Amidon from Boise reappointed to represent wild horse and burro, Kenneth Reid, PH.D., from Boise, appointed to represent archaeological/history, Richard Raymondi from Boise

reappointed to represent public-at-large and Don Weilmunster from Garden Valley, reappointed to represent public-at-large.

The next RAC meeting will be held on Nov. 20 for the Lower Snake River District at the Boise District office at 3948 Development Avenue.

Early reports indicate deer harvest down from last year

Still too early to tell according to Fish and Game

There are no hard numbers yet, but the early indicators point to a decline in the deer harvest this year compared to the 2001 season.

“We don’t have report card numbers (for the 2002 general hunt) yet,” said John Rachael, regional wildlife manager for Idaho’s Department of Fish and Game from his Nampa office last Thursday.

Although hunters are required to send report cards to the Fish and Game within 10 days, Rachael said those with general season permits can use them elsewhere in the state during other scheduled general hunts.

“People that have a general season tag could hunt the Owyhees during the two-week, two-point season,” he said. “But they could also use (their permits) up in the panhandle in December during the general season for whitetails.

“As a result, I would not expect to get very many report cards in, with the exception of those that did harvest,” Rachael said. “We don’t even pull the data this early to take a look at it.”

What numbers the agency has at the present time, are those gathered from the two Owyhee County check stations during the first weekend of the two-point deer season which ran from Oct. 5-18.

Rachael said that the Fish and Game checked 439 hunters at stations located in Marsing and Walter’s Ferry. The two-day harvest was 84 deer for the first Saturday and Sunday, a 19 percent success rate.

That compares to a 22 percent success last year, but there are factors to consider.

“This year (deer season) opened on a Saturday,” Rachael said. “Last year, it opened on a Friday. What we saw was a lot of people taking three days off. So we got a lot more hunters through the check stations last year on opening weekend than what we did this year.”

The numbers, Rachael said, from the check stations are but a snapshot and are not indicative of the overall success – or lack thereof – of the season itself.

“Ordinarily, people that hunt deer spend on average between four and five days hunting,” he said. “(It’s) a small sample of the number of hunters (and) only the ones that come out during the daylight hours on the weekend. There’s a bunch that we’re not getting.”

According Rachael, on what day the season opens can be a significant determining factor when the numbers are tallied. If opening day, for instance, falls during the week, the number of hunters through the check stations are lower.

“Really, we won’t be able to tell how many animals were harvested compared to last year until those report cards come in,” he said.

“What we can say is our weekend success was 19 percent, last year was 22 percent,” Rachael said. “This comparison was actually pretty consistent to the other check stations we’ve had in other portions of the region, suggesting that, at this point, the success rates are pretty good, but not quite as good as they were last year.”

Rachael said that a dry summer and unusually warm weather during hunting season might have had an impact on the numbers.

“Usually, the weather during the season or right up before the season has more than anything else to do with success rates,” he said.

In 2001, the Fish and Game received 1,712 report cards from hunters in units, 40, 41 and 42, which encompasses most of Owyhee County. Those hunters reported harvesting 652 deer.

“That gives a success rate of 38 percent for the season. That’s pretty good for that kind of hunt,” Rachael said.”

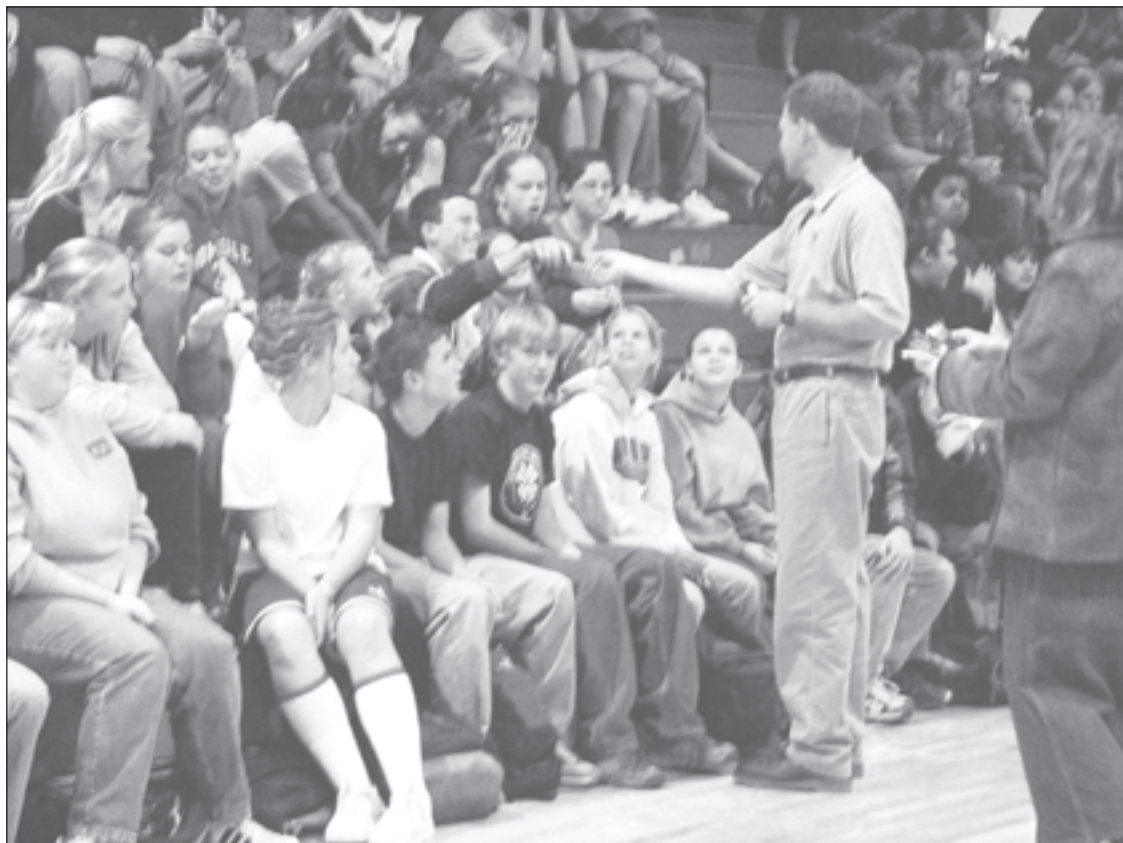

Drought assistance approved

"Drought conditions are having an adverse affect on Idaho agriculture and these counties have already received state disaster declarations.

Pumpkin Pie Right From the Patch

Dear Betty,

My son and I would like to try making a pumpkin pie from a fresh pumpkin. but we don't know where to start!

Berrien Springs, Mich.

You're already off to a great start with your son on this pumpkin-pie adventure! Let me share some tips to make sure it's a success.

Pick the right pumpkin. You can use a small field pumpkin-the kind that's great for jack o'lanterns-although the flesh is a little more stringy and not as sweet. Sugar or pie pumpkins have sweet, fine textured flesh. Look for a pumpkin that's nice and orange, has a tough rind with no soft spots and is heavy for its size.

Get it ready. Give it a good bath. If you're baking it, cut the pumpkin lengthwise in half or quarters and remove the seeds and fibers. If boiling, but the pumpkin into one-inch slices or cubes.

How to cook your pumpkin. You can bake it, boil it or cook it in the microwave.

To bake. Place the pumpkin halves or quarters, cut sides up, in an ungreased baking dish. Pour water into the dish until it's about 1/4 inch deep. Cover the dish and bake at 400 degrees F for 30 to 40 minutes or until tender.

To boil. Put the cubes or slices in a large saucepan. Add enough water to cover the pumpkin. Cover the pan and bring to a boil over high heat. Reduce heat and let the pumpkin cook until it's tender-about 10 to 15 minutes.

To microwave. If you're micro-waving the pumpkin, you don't have to cut it up first. You can use a small, whole pumpkin and then pierce the rind in several places with a knife to let the steam escape. Cook on High for about five minutes or until it feels warm. Cut the pumpkin in half and remove the seeds. Arrange the halves, cut sides down, in a shallow microwaveable dish. Cook five to eight minutes more or until tender. Let it stand for five minutes.

Mash it up. Once the pumpkin is cooked, scrape the flesh from the rind and mash with a fork until it's smooth.

Ready to bake! Now all you need to do is pick a yummy pumpkin recipe to bake. For some great ideas, check out my Web site at Betty Crocker.com.

Marsing High School senior Jeff Roeser has been named to the 2002-03 Wrangler High School All-Star Rodeo Team.

Wrangler, Inc. is the sponsor and the National High School Rodeo Association (NHSRA) is the organization that selects prep rodeo standouts on the basis of "leadership qualities, academic eligibility and athletic achievements," according to a press release issued this month.

Wrangler's high school team is modeled after the western apparel makers pro rodeo team. Roeser, along with other of members, will receive official competition apparel to be worn when they compete in high school and other events.

It's a big honor, but Roeser seems to take in all in stride. He's a modest young man — well grounded — there is no doubt as you sit and talk with him, that he appreciates his life successes.

Jeff is a third generation Roeser to compete in the rodeo arena. His father, Tim, was a high school standout still rides professionally; and Jim, Jeff's grandfather was prominent

professional rider as well.

It's in the blood, one would guess.

While visiting with the Roeser's at their 340-acre horse ranch nestled in the Owyhee Mountains south of Marsing, Jeff's mother, Rita, pulls out some old photos as the question is posed to of Jeff.

"When did you start riding?"

"Oh, gosh," he says. "Probably before I could walk."

Rita lays a photo on the kitchen table. There he is. A half-pint sized Gene Autrey, sitting on a horse, looking as natural as the Singin' Cowboy himself.

He was two.

That picture of him chronicled his first competitive victory in the world of western riding.

Back then, the youngster was entered into contests for looks only. You could win for poise, outfit, horse. Those kind of things. These days, the ride

is a little rougher.

Roeser was born in California. His family moved to the ranch near Marsing in 1997. As a pre- and early adolescent, Roeser rode steers, but as he grew in height, he gravitated away from the riding events and toward the skilled roping events.

Today, he says calf roping is his best event. He also team ropes and recently added steer wrestling to his repertoire.

Upon sight, you just can't imagine this nice guy jumping on a 900 pound animal, twisting its neck, then putting it down in the dirt.

"How was that the first time?" Roeser is asked.

"They say, go 35 miles-an-hour in a pickup, then jump out and grab a mailbox," he says and smiles. "That's steer wrestling."

He added the event this past summer with the idea that a third event will put him in a position to win all-around titles in future rodeos. So far, the results have been positive.

His bulldogging debut was at Homedale in September. He won.

The interesting thing is that he had five days to prepare.

"It was basically a crash course in steer wrestling," Roeser says.

He's only logged one time — a 16.0 — but Roeser says, that at

the high school and amateur level of competition, scoring a time can be good enough.

"If you get one caught, you'll place," he says.

Jeff and his dad describe this past July 4, or as Tim called it, "the Cowboys' Christmas."

They began in Rupert on July 3 and competed in the morning, then moved on to Salmon for an evening go-around. Then it was on to Fallon, Nev. for the Silver State International Rodeo the next

evening.

"We drove over a 1000 miles in those couple of days," Jeff says.

The Silver State competition is an alternate event for those state qualifiers who do not make the national high school finals. In 2002, Roeser's advanced for the first time. He's looking now to making nationals.

Roeser will graduate next year. He's committed to the College of Southern Idaho's rodeo team, but said he chose the school because of its diesel mechanics program.

134 years ago

OCTOBER 24, 1868 Bruneau Valley –Mr. Baker just over from Catherine Creek informs us that several parties from Boise have lately been locating ranchers in Bruneau Valley and will move over with their families this fall. The Statesmen of the 20th, has the following favorable mention of the Bruneau from Mr. A. E. Calloway who has just returned from a tramp out there:

Mr. C. pronounces the Bruneau the best portion of Idaho Territory for stock raising and dairy purposes. It is from thirty to thirty-five miles in length and from three to five miles in with of good land in fact the very best. The grass grows luxuriantly and there is more timber than will furnish the valley with fire wood if it were all settled. The Beavers cut the cottonwood as fast as it grows but the willow grow to a considerable size. Mr. C. says he also saw considerable dedt of cedar logs along the banks of the stream which indicates that there is abundance of timber higher up the river. The soil he pronounces as good if not better than Boise Valley and the climate he feels sure is warmer. The mouth of Bruneau is distant from Silver about fifty miles and as the course of the valley is north and sough the upper end must be less than one hundred mile from the Central Pacific Railroad. There are a few Bruneau Indians over there, but they are entirely friendly and peaceable.

Some good news from city hall

We’re often criticized for not printing “good stuff” about the Homedale City Council. We’ve found some to print this week.

The first item of good news is that the council changed its mind about slapping a three percent tax on natural gas costs. Recently the council had voted to impose the tax when the “adder” fee by Intermountain Gas expired. The adder was an initial fee to help absorb the cost of constructing the main pipeline to Homedale five years ago. The company made a lot of hoopla when the fee ended, but the lower cost of gas was immediately jacked up by our city fathers. It seems they couldn’t stand to see the residents of the city save a few bucks, so they immediately levied the three percent tax on gas bills, just to pad its coffers.



Oh, it was all legal. In fact, one of the loudest protesters of the tax last week was the person who signed the option into law five years ago. Paul Fink was mayor and signed the ordinance into law enabling the city to add the three percent tax. The present council just activated it.

So, kudos to the council for backing off the slap-in-the-face tax it had just imposed.

The other good news coming out of city hall is the announcement of the resignation of David Freelove as police commissioner. Freelove, in his resignation announcement, cited the negative effect he has had on the position – and we might add – the credibility of the council as a whole.

Although the ex-commissioner didn’t elaborate, we can speculate the executive session preceeding the announcement was about the million-dollar lawsuit against two cities, two police departments, and several officers for raiding a local business because of Freelove’s unfounded accusations of juveniles drinking alcohol there; and we can further speculate that Freelove’s charge of driving under the influence of alcohol was also a factor in his decision to resign.

Should the councilman be found guilty on either or both of these charges, we can look forward to announcing his resignation from the council.

Regarding public v. private road

(Owyhee Avalanche Oct. 16, 2002):

Revised Statute 2477 ends at the private property line. R.S.2477 stops the federal government from interfering with travel across federal grounds on R.S.2477 roads. Every livestock trail across federal grounds in Owyhee County is a R.S.2477 road.

The reason there are no R.S.2477 roads across private lands is R.S.2477 is a federal statute, and will be argued in federal court. A right of way across private land is a state court issue that will be argued in state court.

The debate remains the same. Who (what) came first, the public road or the homestead entry date. (Entry date is a number of years ahead of the patent date. The “Homestead Records” need to be researched.) If the public road was first, has there been legal action to close the road. The county action (or lack of action) would have no bearing on a right of way. A road right of way and a ditch right of way are the same. “No use does not close a right of way, it must take legal action on the part of the land owner.”

The right of way may only belong to an individual(s) and not the public. Regarding patent reservation:

If the federal government had reserved a right of way on the patent, it would not be a public road. It would be a federal right of way. The patent only released (or held) property that the federal government had claim on. The states’ (public) interest was not dealt with in the patent.

There is the issue of Territory v. State. The homestead records (I am familiar with) that are before statehood are stomped. “States right do not apply.” This would change upon statehood, but there would still be plenty of issues to sort out. (Involving patents before statehood.)

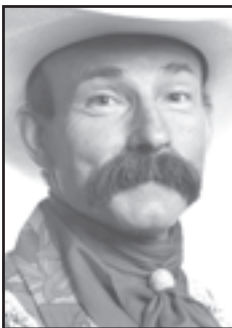

Although the U.S. Supreme Court has ruled that term limits will not be applied to members of Congress, there are many Americans who believe in term limits at some level. There are several states that now limit terms of state legislators, state elected officials and others.

But there is no other state that has of yet been foolish enough to put term limits on every elected from cemetery and school board all the way up to legislators and state office holders. Nevertheless, that

Is precisely what Idaho is preparing to do with Proposition 2.

Idaho Legislators made national news last spring as the first state legislature to repeal a term limits initiative. If they can win in Idaho with a radical proposition that limits every elected official in the state, this campaign of deceit gains momentum.

Term limits supporters argue this proposition will get rid of the fat cats and bring government closer to the people. It’s more likely to accomplish the opposite. Any legislative body that’s as much as half-full of soon to be termed-out officials is a dog that won’t hunt. Creating more lame duck leaders isn’t going to make Idaho government more accountable to the voters.

If you are unhappy with your elected officials, vote for someone else on November 5. But don’t vote to substitute the checks and balances of good government for arbitrary one size fits all regulations. Vote Yes on Proposition 2.

Accuracy in media

ABC news repeats Shaggy Dog story

The Justice Department has renewed it’s campaign to indict Steven Hatfill in the court of public opinion for last fall’s unsolved anthrax killings. ABC’s ace investigative reporter Brian Ross, who had reported unfounded hearsay implicating Hatfill last June, returned to the story on ABC’s World News Tonight on Oct. 22, claiming that three bloodhounds had independently led the FBI directly to Hatfill’s apartment after sniffing scent extracted from anthrax letters posted last year.

Accuracy in Media has been looking into this story since Newsweek first reported it in August. We found that the FBI had the dogs flown here from California, even though there are at least 15 police dog teams in Maryland, including one that is on call with the Bureau’s Hostage Rescue Team. Brian Ross, without mentioning the Maryland dog teams, said the FBI considered the California dogs the best in the country, a view not shared by Maryland law enforcement officers. He ignored the controversy over the “new technology” used by the FBI to collect the scent that supposedly led the dogs to Hatfill.

Had Ross done any investigating, he would have learned, as we did, that the FBI has invested in the Scent Transfer Unit-100, which “vacuums” scent from an article onto a “scent pad.” The STU-100 is popular in California, but the two national police bloodhound associations claim that it is too susceptible to contamination to be admissible as evidence in court and have refused to endorse its use. They fear that the Bureau’s reliance on the STU-100 could discredit the use of bloodhounds in all criminal cases.

They cite a 1996 case in California in which a jury found a defendant guilty on the basis of the prosecution’s claim that the scent pad from an STU-100 had enable a dog to track down the defendant. Police bloodhound handlers from the two national associations were incensed by “irregularities” in the dog’s use. A dog expert flew to California to testify for the defense, and one of the most experienced police dog handlers in the country submitted for the defense a detailed critique of the STU-100 and the dog handler. On the basis of this testimony, the judge threw out the jury’s conviction, and this was upheld on appeal.

Police dog handlers in Maryland are critical of the FBI’s efforts to link Hatfill to the anthrax letters using the STU-100. Hatfill says that the special agents had him sit in an empty apartment in the same building where his apartment was located, and one bloodhound was brought in. He says that he scratched the dog’s ear and the dog returned the affection. That led the handler to cry, “The dog is reacting!” Our police sources say that the FBI should have used a “line-up,” requiring the dog to single out the one matching the scent. They point out that if Hatfill was the only suspect in the room, a good defense lawyer would argue that the handlers were “directing” the dog to Hatfill, as they did in the California case where the jury verdict was overturned.

Ross said that three dogs “were each given the scent from anthrax letters posted last year, and each “independently” led handlers to Hatfill’s apartment. Which apartment? The vacant one in which he was sitting for his own? If the only scent the dogs were given was from the envelope sent through the mail, how cold the dogs distinguish between the person who mailed it, whose who delivered it and those who determined that it contained anthrax?

Dr. Frederic Whitehurst, the special agent with a Ph.D. in chemistry whose exposure of incompetence and corruption in the FBI crime lab resulted in partial reforms and his separation from the Bureau, says what the FBI did is awful. He would like to know if the FBI has run any scientific validation studies on the STU-100. Such studies would be designed to determine the percentage of the cases in which the dogs are able to correctly match or not match humans with STU-100 scent packs.

Many of the dog handlers interviewed by AIM believe that the reason the FBI took the dogs to Hatfill’s apartment was to see if they could scare him into a confession. These handlers say that is a routine police technique, and it is not illegal. It hasn’t worked in Hatfill’s case, but the FBI, with assists from ABC and Newsweek, persists in persecuting him. They can’t prosecute him since he is only “a person of interest.”

CROSS-CONNECTIONS
SECTION 1. CROSS-
CONNECTIONS –
GENERAL POLICY**

1.1 Purpose of Ordinance:

1.1.1. To protect the safe drinking water supply of Murphy Water System from the possibility of contamination or pollution by requiring compliance with state and local plumbing codes, health regulations, OSHA and other applicable industry standards for water system(s) or private water system(s). Compliance with these minimum safety codes will be considered reasonable vigilance for prevention of contaminants or pollutants that could backflow into the public drinking water systems; and,

1.1.2. To promote reasonable elimination or control of cross connections in the plumbing fixtures and industrial piping system(s) of the consumer, as required by state and local plumbing codes, health regulations, OSHA and other applicable industry standards to assure water system safety; and

1.1.3. To provide for the administration of a continuing program of backflow prevention that will systematically and effectively prevent the contamination or pollution of all drinking water systems.

1.2.1 Murphy Water System shall be responsible for the protection of the drinking water distribution system from foreseeable conditions leading to the possible contamination or pollution of the drinking water system due to the backflow of contaminants or pollutants into the drinking water supply.

1.2.2. Drinking water system surveys/inspections of the consumer's water distribution system(s) shall be conducted or caused to be conducted by individuals deemed qualified by and representing Murphy Water System Survey records shall indicate compliance with the aforementioned health and safety standards. All such records will be maintained by Murphy Water System.

1.2.3 Murphy Water System shall notify in writing, all consumers of the need for the periodic system survey to insure compliance with existing applicable minimum health and safety standards.

1.2.4. Selection of an approved backflow prevention assembly for containment control Required at the service entrance shall be determined from the results of the system survey.

1.3 Consumer's Responsibility:

1.3.1. To comply with this ordinance as a term and condition of supply and consumer's acceptance of service is admittance of his/her awareness.

1.3.2. It shall be the responsibility of the consumer to purchase, install, test and maintain any backflow prevention device/assembly required to comply with this ordinance.

1.4 Plumbing Official Responsibility:

1.4.1. The plumbing official's responsibility to enforce the applicable sections of The plumbing code begins at the point of service (downstream or consumer side of the meter) and continues throughout the developed length of the consumer's water system.

1.4.2. The plumbing official will review all plans to ensure that unprotected cross Connections are not an integral part of the consumer's water system. If a cross connection cannot be eliminated, it must be protected by the installation of an air gap or an approved backflow prevention device/ assembly, in accordance with the State Plumbing Code.

1.4.3. Water vacating the drinking water supply must do so via approved air gap or approved mechanical backflow prevention assembly, properly installed and in accordance with the State Plumbing Code.

1.5 Certified Backflow Assembly Technicians, Surveyors or Repair Persons Responsibilities:

1.5.1. Whether employed by the consumer or a utility to survey, test, repair or maintain backflow prevention assemblies the Certified Backflow Technicians, Surveyors or Repair Persons will have the following responsibilities:

1. Insuring acceptable testing equipment and procedures are used for testing, repairing or overhauling backflow prevention assemblies.
2. Make sure of such testing and/or repair to the consumer and water purveyor.
3. The report shall include the list of materials or replacement parts used.
4. Insuring replacement parts are equal in quality to parts originally supplied by the manufacturer of the assembly being repaired
- 5 Not changing the design, material or operational characteristics of the assembly during testing, repair or maintenance.

6. A Certified Technician shall perform all tests of the mechanical devices/assemblies and be responsible for the competence and accuracy of all tests and reports.

7. Insuring their license is current, the testing equipment being used is acceptable to the state, and is in proper operating condition.

8. Be equipped with, and be competent to use, all necessary tools, gauges, and other equipment necessary to properly test, and maintain backflow prevention assemblies.

9. The Certified Technician conducting the test must tag each double check valve, pressure vacuum breaker, reduced pressure backflow assembly and high hazard air gap, showing the serial number, date tested and by whom.

1.5.2. In the case of a consumer requiring a commercially available technician, any certified technician is authorized to make the test and report the results of that test to the consumer and water purveyor.

**SECTION 2
DEFINITIONS**

2.1 Water Purveyor:

The person designated to be in charge of the Water Department of the Murphy Water System, is invested with the authority and responsibility for the implementation of an effective cross connection control program and for the enforcement of the provisions of this ordinance.

2.2 Approved Backflow Assembly: Accepted by the Department of Health, Bureau of Drinking Water/ Sanitation, as meeting an applicable specification or as suitable for the proposed use.

2.3 Auxiliary Water Supply:

Any water supply on or available to the premises other than the purveyor's public water supply will be considered as an auxiliary water supply. These auxiliary waters may

include water from another purveyor's public potable water supply or any natural source(s) such as a well, spring, river, stream, harbor, etc., or "used waters" or "industrial fluids". These waters may be contaminated or polluted or they may be objectionable and constitute an unacceptable water source over which the water purveyor does not have authority for sanitary control.

2.4

Backflow:

The reversal of the normal flow of water caused by either back-pressure or back-siphonage.

2.5 Back-Pressure:

The flow of water or other liquids, mixtures, or substances under pressure into the feeding distribution pipes of a potable water systems from any source(s) other than the intended source.

2.6 Back-Siphonage:

The flow of water or other liquids, mixtures, or substances into the distribution pipes of a potable water supply system from any source(s) other than the intended source, caused by reduction of pressure in the potable water supply system.

2.7 Backflow Prevention Assembly:

An assembly or means designed to prevent backflow. Specifications for backflow prevention assemblies are contained within the Uniform Plumbing Code Chapter 6 and IDAPA 58.01.08.

2.8 Contamination:

Means a degradation of the quality of the potable water supply by sewage, industrial fluids or waste liquids, compounds or other materials.

2.9 Cross Connection

Any physical connection or arrangement of piping or fixtures that may allow non-potable water or industrial fluids or other material of questionable quality to come in contact with potable water inside a distribution system. This would include any temporary connections, such as swing connections, removable sections, four way plug valves, spools, dummy sections of pipe, swivel or change-over devices or sliding multiport tubes or other plumbing arrangements

2.10 Cross Connection – Controlled:

A connection between a potable water system and a non-potable water system with an approved backflow prevention assembly properly installed and maintained so that it will continuously afford the protection commensurate with the degree of hazard.

2.11 Cross Connection – Containment:

The installation of an approved backflow assembly at the water service connection to any customer's premises where it is physically and economically infeasible to find and permanently eliminate or control all actual or potential cross connections within the customer's water system; or, it shall mean the installation of an approved backflow prevention assembly on the service line leading to and supplying a portion of a customer's water system where there are actual or potential cross connections that cannot be effectively eliminated or controlled at the point of the cross connection (isolation).

**SECTION 3
REQUIREMENTS**

3.1 Policy

3.1.1. No water service connection to any premises shall be installed or maintained by the Public Water Purveyor unless the water supply is protected as required by State laws, regulations, codes, and this ordinance. Service of water to a consumer found to be in violation

of this ordinance shall be discontinued by the water purveyor after due process of written notification of violation and an appropriate time suspense for voluntary compliance, if:

1) A backflow prevention assembly required by this ordinance for control of backflow and cross connections is not installed, tested, and maintained, or

2) If it is found that a backflow prevention assembly has been removed or bypassed, or

3) If an unprotected cross connection exists on the premises, or

4) If the periodic system survey has not been conducted. Service will not be restored until such conditions or defects are corrected.

3.1.2. The customer's system(s) shall be open for inspection at all reasonable times to authorized representatives of the water purveyor to determine whether cross connections or other structural or sanitary hazards, including violation of this ordinance exist and to audit the results of the required survey.

3.1.3. Whenever the public water purveyor deems a service connection's water usage contributes a sufficient hazard to the water supply, an approved backflow prevention assembly shall be installed on the service line of the identified consumer's water system, at or near the property line, or immediately inside the building being served; but, in all cases, before the first branch line leading off the service line.

3.1.4. The type of protective assembly required under subsection 3.1.3., shall depend upon the degree of hazard which exists at the point of cross connection (whether direct or indirect), applicable to local and state requirements or resulting from the required survey.

3.1.5. All presently installed backflow prevention assemblies which do not meet the requirements of this section but were approved assemblies for the purposes described herein at the time of installation and maintenance requirements under subsection 3.1.6., shall be excluded from the requirements of these rules so long

as the water purveyor is assured that they will satisfactorily protect the public water system. Whenever the existing assembly is moved from the present location or, requires more than minimum maintenance or, when the water purveyor finds that the operation or maintenance of this assembly constitutes a hazard to health, the unit shall be replaced by an approved backflow prevention assembly meeting the local and state requirements.

3.1.6. It shall be the responsibility of the consumer at any premises where backflow prevention assemblies are installed to have certified survey/inspections, and operational tests made at least once per year at the consumer's expense. In those instances where the Public Water Purveyor deems the hazard to be great, he may require certified surveys/ inspections and test at a more frequent interval. It shall be the duty of the Public Water Purveyor to see that these tests are made according to the standards set forth by the State and local regulations.

3.1.7. No backflow prevention assembly shall be installed so as to create a safety hazard. EXAMPLE: Installed over an electrical panel, steam pipes, boilers, pits, or above ceiling level

3.2 If violations of this ordinance exist or if there has not been any corrective action taken by the consumer within 10 days of the written notification of deficiencies noted within the survey, then the Public Water Purveyors shall deny or immediately discontinue service to the premises by providing a physical break in the service line until the customer has Corrected the condition(s) in conformance with the State and local statutes relating to plumbing, safe drinking water supplies and the regulations adopted pursuant thereto.

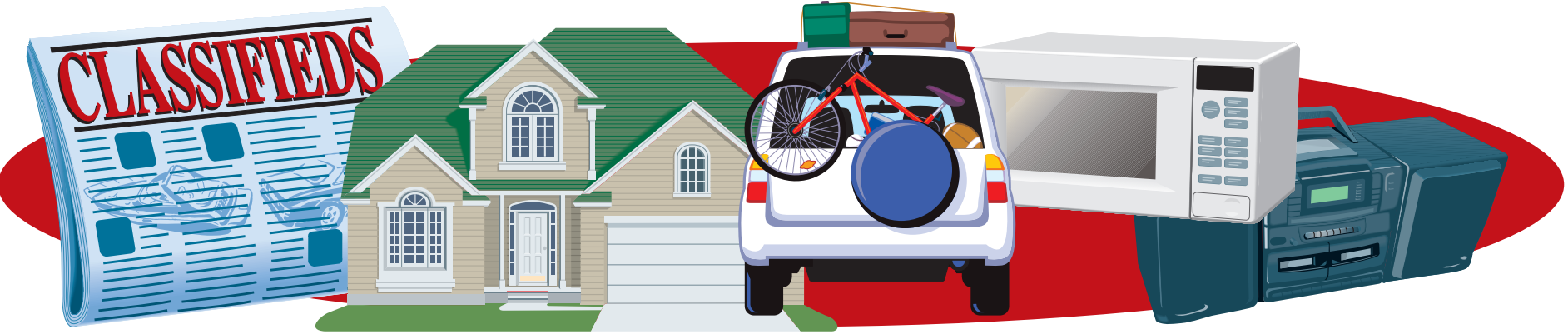

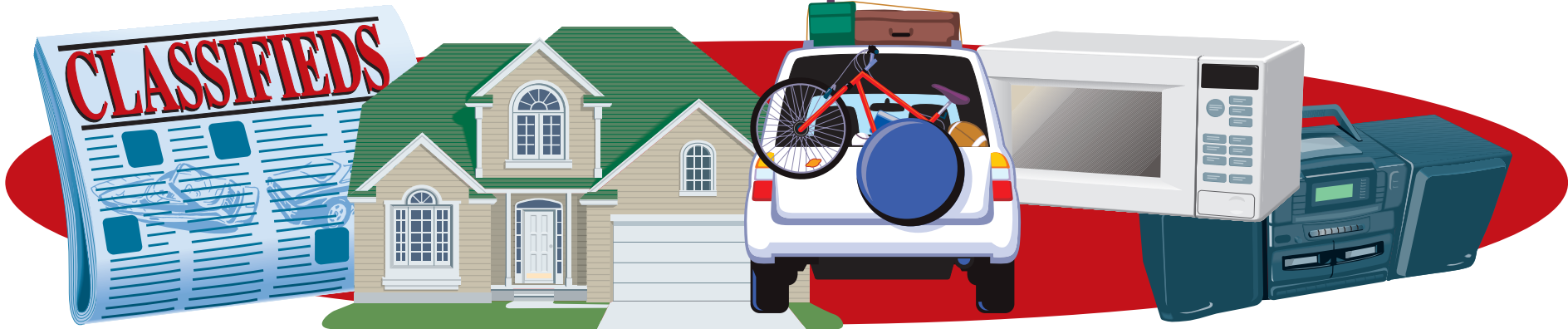


