# Are P&Z commission decisions legal?

City P&Z members' terms in question

After a preliminary search, the city clerk of Homedale cannot find records of the terms of office for several members of the planning and zoning commission, which brings up the question of the legality of decisions the commission has been making.

The Owyhee Avalanche requested a copy of who the current planning and zoning members were, when they were appointed and when their terms expired. But after a nearly two week search through council meeting minutes and documents, the answer still remains a question.

Currently the commission consists of Kenne Metzer, Gypsy Jackson, Herb Fritzley, Poke Henson, Jim Packer, Dave Downum and Reed Batt. Silvia Bahem was appointed the commission as to administrator on December 27,

# **County P&Z** members' terms expired

After requesting copies of the current status of the Owyhee County Planning and Zoning, P and Z coordinator Kay Kelly-Breach discovered that two members of the commission were working on expired terms. Shortly after the discovery, the item was added to the agenda of the commissioners meeting last Monday, but as of press-time a decision as to if the two commissioners would be reappointed was still undecided.

Planning and Zoning Chairman Sid Erwin's term expired in June 2002 and fellow commissioner Ron Geertson has been working on an expired term since June as well. The reappointment of the two commissioners was added to the county commissioners meeting on Thursday to be heard Monday at 10:30 a.m. But Commissioner Chris - to page 4



Barbecue tickets are available at city hall for \$8 each. Gun raffle tickets and t-shirts are also available at city hall.



# Fish and Game plans Walter's Ferry renovation project

Accesses into the Snake River at Walter's Ferry could become much easier in the future as the Idaho Department of Fish and Game is in the beginning stages of plans for a renovation project. The department is in the beginning stages of plans, but Fish and Game Director Steve Huffaker said the project will improve access to the river as well as provide a handicap loading and unloading facility and improved restroom facilities.

"The Walter's Ferry renovation project is still in the planning and permitting stage and no construction contracts have been awarded to date," Huffaker said Wednesday. "Members of the Owyhee County Waterways Board, Larry McDaniels and Bill Jones, have been involved in meetings regarding project planning and development since December with our regional sportsmen's access coordinator Dennis Hardy. They have been exploring the possibility of establishing a joint memorandum of understanding and working together to jointly fund the dock improvements we desire to accomplish at this popular site as well as other Sportsmen's Access sites in the county.

"Our proposed plans are presently being reviewed by the Idaho Department of Environmental Quality to see if they meet requirements regarding the grading and paving of the parking area and its ability to retain all rain water, oil and sediment on the property. We have applied for a permit from the Idaho Department of Transportation and, if approved, will allow us to pave up to and adjoin State Highway 45. We do currently have a temporary 404 permit from the U.S. Army Corps of Engineers for placement of boat docks at the site."

Huffaker said it would be some time before construction would begin at the site. He said the department met with Jens Steffensen, Bryce Roberts, Ron Garrett and Steve Carlin of the Western Whitewater Association last week and coordinated some concerns of available parking. The Association gathers at the site several times a year launching over 30 boats per trip. Huffaker said he felt the department was able to accommodate the association's concerns and revise the plan for parking.

"'Everyone seems to be on board regarding the design and layout of the access site," Huffaker continued. "We will do some further work with some of the organized handicapped groups regarding the placement of a loading-unloading facility for persons with disabilities.

"When we do upgrades on boat ramps we have to comply with American with Disabilities requirements and we have to accommodate the Department of Environmental Quality requirements."

Huffaker said he could not state when construction would begin on the site. -CPB

Meeting minutes state that Fritzley was appointed to the city council as a councilman on Feb. 16, 1976. On Jan. 3, 1977, Fritzley suggested the city start appointing a commission for city planning and zoning. In April 1980, Fritzley presented goals and suggestions for a comprehensive plan for the city setting April 14 for a public hearing on the plan.

On Sept. 9, 1981 the question arose as to whether Fritzley could be a commissioner of the planning and zoning and a councilman at the same time. Fritzley, Howard Bergeson, Mike Parker and Larry Bauer were named as the planning and zoning "committee" at that time.

On March 10, 1982 Fritzley resigned his position on the P and Z.

Several members of the commission resigned shortly after Fritzley, but from minutes of a council meeting on Sept. 8, 1982, then Mayor George T. Murray gave the names of Mick Craven, Wm. McGuire, Charles Kelly and Kenne Metzer to the council. However, no appointments were recorded in the minutes.

Minutes from a council meeting on Jan. 12, 1983 state that "Mayor Murray gave the council a list of names to go on the Planning & Zoning Commission. Cp. Bauer made to approve the following people for appointment to the commission: John Buck, Robert Lowrance, Adrian Kroeger, Charles Maxwell, Fred Aspiazu, Gary Hastriter, Kenne Metzer." The vote carried unanimously.

and Cp. Uda seconded a motion

Minutes dated Nov. 14, 1984 state that councilperson Adren Kroeger reported that John Takasugui had given notice of his resignation as P & Z member, but minutes showing Takasugui as being appointed to the commission were not found. "The mayor and council will have to appoint a new member, Mayor Fink said he would talk to some people and see if they would be interested." No vote to accept the appointment was documented. Fritzley was still a council member.

On May 13, 1987, Metzer was "reappointed" to the commission with Fred Egurrola for six year terms, but documents stating Egurrola's initial appointment were not found.

On Nov. 16, 1988, "Mayor Fink reported that the had three people who would serve on the Planning and Zoning Commission to take the place of the one who have resigned. He appointed Dan Erbe, James Fleming and Clifford Martel. Cp Frtizley made and Cp Mashburn seconded the motion to accept the appointments. Vote carried by vote of the full council."

Jackson was appointed to the commission on April 8, 1992, but no record was found showing a reappointment. Jackson is currently serving on the commission.

On Feb. 12, 1997, Henson was appointed by the council along with Pete Austin and Dirk Tolmie, and on April 12, 2000 minutes show that Reed Batt was appointed to the council as a commissioner from the impact area.

On Dec. 27, 2001, Bahem was recommended to be hired for the administrator position. The council approved the appointment. Bahem was reappointed to her position in Jan. 2003. Downum was appointed to the commission in 2002.

Homedale City ordinance states that a member of the planning and zoning commission will be "appointed by the mayor and confirmed by a majority vote of the city council. The term of office for members shall be not more than three years; provided, however, that at the expiration of the term of office, a member shall be eligible for reappointment."

Idaho Code states "the term of office for members shall be not less than three years, nor more than six years and the length of term shall be prescribed by ordinance. No person shall serve more than two full consecutive terms."

"A memo will be included in the council and mayor's packets for review during the next council meeting Thursday," City Clerk Pam Dugger said Friday. "The documents you requested from 1980 forward do not show when they were appointed, resigned or were reappointed. I did not clearly find any documents that absolutely stated the appointments, resignations, or reappointments. We looked through and identified planning and zoning, but obviously I can not guarantee that there is nothing there."

Dugger confirmed that if the appointments were not made, many planning and zoning decisions would have to be reconsidered. She said she could not say whether the decisions would be legal as she is not an attorney. "I can not speak for the council or on a legal issue, but it will be something the council will have to consider." Homedale code states that the planning and zoning administrator "shall keep a record of all appointments and terms of membership." -CPB

Salove said at 1 p.m. Monday that the reappointment may, or may not, happen until late Monday afternoon.

"We are going to consider it this afternoon," Salove said by telephone from Murphy General Store. "We got crowded out this morning. We are doing some more research on the terms and how long they would be reappointed for, but the reappointments will most likely be made this afternoon. Unless we don't find what we are looking for, we might put it off until next week."

"The Board of County Commissioners appoints the P&Z Commission members and each time a person is appointed, it is treated like an original appointment per Idaho Local Land Use Planning Act,"

Planning and Zoning Coordinator Kay Kelly-Breach stated in a letter Thursday. "Research has not turned up reappointments for Sid Erwin or Ron Geertson, although I had in my mind that it was done and that all appointments were current. The Local Land Use Planning Act states that the Commission members can serve two consecutive terms, then can return after being absent from the Commission for a term. The Board has scheduled 10:30 next Monday to review the Commission appointments."

Idaho Code 67-6504 states: "The term of office for members shall be not less than three years, nor more than six years and the length of term shall be prescribed by ordinance. No person shall serve more than two full consecutive terms."

Documents from 1980 through the current year were searched for the information. The following is the information that could be found.

Gypsy Jackson: originally appointed by the council in 1992. No records found for reappointment.



from deducting purchases of school supplies on their state income taxes, although the deduction is allowed on the federal level. Educators in the state are concerned that with the downfall, bigger class sizes, shorter school weeks, and frozen salaries are not far off.

Homedale board members met Monday night while Bruneau/Grand View members came together on Friday to discuss a resolution to support for the legislature. Both Homedale and Bruneau/ Grand View districts agreed the best option for the rural school districts would be to support the governor's request \$943 million of for kindergarten through 12 public education for fiscal year 2004. Marsing board members plan to meet this week to make their decision, but superintendent Ron Hopkins said the Governor's budget request would be the best way to go.

Homedale School Board Chairman John Demshar said last week that the comments he made during an interview with the Owyhee Avalanche were his own opinion and not



those of the board's.

"Last week some of the legislatures met with the superintendents of the school districts in the state, but since they are not elected officials, they wanted to hear from us directly," Demshar said. "They gave us four scenarios to select from by choosing from a resolution. The board's feeling is to go with scenario two which would support a one cent tax increase, fund all of the statutory increases for the teachers salaries and provide no raises."

Demshar said with any of the scenarios offered, cutbacks in the district were probably going to happen with any of the scenarios the board chose.

In scenario two, the board supports the governor's \$943 million budget figure, and supports a one-cent increase in sales tax. The scenario would still fund education which would fund all statutory requirements for teacher salary, provide no raises, no increases in staff allowance and decrease discretionary monies to districts by \$5 million. But the resolution would not restore the state's building and savings accounts.

"Scenario one is a one and a half increase like the Governor wants," Demshar continued. "He could put money back into the state's building and savings accounts and scenario two is only one penny and does not put money back into those two funds. But the states savings account is not depleted yet."

Demshar said that as for freezing the teachers' salaries, it would not be a choice the local districts would be able to make. He said there is a lot of fear right now that it could happen.

Marsing School District passed a resolution on Friday that states: "The Board of Trustees of the Marsing Joint School District No. 363, as members of the ISBA in good standing, support a \$943 million K-12 public education budget figure including a onecent increase in the state sales tax, excluding groceries." The resolution was passed during a special board meeting.

The Bruneau/Grand View School District also passed a resolution supporting the governor's request for \$943 million and a one cent tax increase.

Many options will be addressed including eliminating 39 of the 114 school districts through consolidation, which would save about \$11 million, freeze the state contribution to teacher salaries at the current level, saving \$15 million, cap property tax relief at \$69 million. Since approved in 1995, the state's 25 percent share of the local school property tax levy has risen from \$40 million to nearly \$75 million next year, reduce transportation cost reimbursement from 85 percent to 80 percent, saving \$3.6 million and increase class sizes, which would save \$25 million.

The budget would have to be cut another 8 percent and more than 1,000 state workers laid off without the extra revenue from Kempthorne's proposal, analysts have said.

Legislative leaders say they may have to order new, bigger cuts to state agencies and force public schools to reduce spending by 2 percent in the current budget year. A move local school districts say they can not afford.

Demshar said the option of putting an emergency levy to vote has also been discussed, but he said he did not feel that, at least the residents of the Homedale School District, could afford it, or pass it.-CPB

He was one of seven children, six boys and one girl. When



he was 8, ranching and farming brought the family to Idaho. They lived in Mtn. Home, Nampa and Kuna. From Kuna they moved to Idaho City. It was there he met and married his wife of 60 years, Adria Lillian Waxbom, on Easter Sunday, April 5, 1942. On June 13, 1996, they were sealed for time and all eternity in the Boise, Idaho LDS Temple. 







# State title decided in battle of the Trojans

## *Homedale's district* comeback ends in bittersweet loss to NC

After four years the Homedale Trojans girl's basketball team finally accomplished its dream of making it to the state tournament. After a battle for a spot in the state tournament during the district playoffs earlier this month, Homedale finally arrived and fought for a chance to be named the best girls basketball team in the Western Idaho Conference 2A state matchup.

Saturday's match found Homedale face to face with long time rival Nampa Christian for the battle of the Trojans, and a battle it was.

In the opening round of district action, Homedale stopped McCall/Donnelly 43-22 to proceed to face No. 2 seeded Nampa Christian who upset No. 1 seed New Plymouth the previous day. Homedale was then thrown into the

loser's circle with a third season loss of 34-48 to the rival Trojans. But the loss didn't slow Homedale as they worked their way through with a 54-40 win over the Melba Mustangs and a double overtime 59-56 victory over the Marsing Huskies.

Homedale was then matched up with the New Plymouth Pilgrims who entered the tournament as the No. 1 seeded team. But Homedale plowed through the Pilgrims with a 48-37 victory and a guaranteed spot in the state tournament.

In round one of last week's contest, Homedale stopped Butte County 59-48 led by Kelsi Haylett who hit 8-of-11 free throws and finished with 21 team high points. Tana Krall had seven rebounds and added nine points.

Homedale lost a starting player for the team with 6:44 left in the game and Jennifer Anzaldua hit the floor with a knee injury. Haylett and Anzaldua missed most of their junior seasons with torn

6:35 left in the first half, but Haylett responded with a three pointer of her own 14 seconds later to pull the Trojans back into the lead.

Butte County again tied Homedale at 20 points with 5:10 left in the first half, but the Trojans followed up with a 20-7 run to take a 40-27 lead in the third quarter.

Homedale matched up with Grangeville (21-2) without

# Girls' state game goes down in record books

The state girls' basketball tournament is not an unfamiliar place for the Rimrock Raiders, but walking away with the State title is something to go down in the school's history books. The four-time district champion Raiders had advanced to the semifinals the three past years and lost. This year, Rimrock (25-1) downed Kootenai in the semis to set up their All-District Three final against Horseshoe Bend.

## February 22, 1868

JACOBS' MILLS. While at Boise City last week we visited Messrs. C. Jacobs and Co's mills situated about half a mile below the city. An excellent quality of floor is manufactured. A large quantity of wheat is on hand and the mills will be started up in about a month. In connection with the establishment is an extensive distillery, which will be put in operation about the same time; so that lovers of "Fenian dew drop" will not be under the necessity of exporting if from Oregon or California. These enterprising gentlemen are also in the hog business, and put up a splendid article of pork and hams. We can vouch for the good quality o specially the latter, as we were presented with a very fine one, nicely cured and smoked, and so big that we could but just get it into a flour sack. Messrs. Jacobs and Co. will be prepared the coming season to furnish those three staple articles, flour, pork and whisky, in unlimited quantities. Who says that Idaho is not self-sustaining?

POLITICAL. Already there is a commotion in the political sky of Idaho. Several Democratic candidate are spoken of as delegates o Congress, on the most prominent of which, at least in Owyhee County is Hill Beachy, who has signified a willingness to become a candidate. Mr. Beachey is a good man and no doubt would ably and faithfully represent the best interests of Idaho, but whether he will be able to run Conventions as successfully as stage lines remains yet to be seen. Among the others mentioned, as candidates are Frank Gerald, Dick Miller, Judge Roseborough and J. A. McQuaid, Mr. Holbrook, our present delegate, publicans are keeping very quiet about the matter and no aspirants are yet mentioned on their side on the house.

# Illegal authority?

A resident who does not comply with local land use planning rulings is subject to fines and jail time. It's the law.

The act was passed over a quarter-century ago, and since that time, local governmental agencies have been usurping private property rights at an alarming rate. And sometimes even beyond the broad authority of the act. Sometimes their demands are the taking of the use of private property. But that's another topic for another time.

Right now there are three commissions in the county designated to "control" land use. They are the Homedale, Marsing, and the Owyhee County planning and zoning commissions. The appointed commissions are established through a law called the Local Land Use Planning Act. Among other things, this act has taken local government's purpose of existence from serving the public to the public serving local government. The government, through its planning act, can dictate where people live, and for



what purpose their land can be used. But, here again, that's another topic for another time.

Right now the Homedale and county p&z commissioners are making decisions on land uses while operating with illegal commissions. The same law that gives these entities the authority to exist and function also sets some rules they must follow.

The county p&z has been operating with two of its members' terms expired. Both Ron Geertson and Sid Erwin are actively participating and voting, even though

their terms have been expired for eight months.

Monday, the county commissioners were to meet at 10 a.m. to discuss reappointments, but the issue was tabled, seeking legal advice, we're told.

The membership status of the Homedale p&z commission is confusing, to say the least. The city's ordinance establishing the commission stipulates the term of its members is three years. A member can serve no more than two full consecutive terms. It's the law.

The city records seem to be incomplete, but what we've gleaned is that Herb Fritzley was on the p&z back at least as far as 1980, then resigned in '82. There's no record he was ever officially reappointed, though he's been a voting member for years and years, just how many no one seems to know. Kenne Metzer was appointed in 1983, and was reappointed in 1987. Sixteen years later, he's still on the commission. Gypsy Jackson was appointed in '92, was not reappointed, but 11 years later she's still on the commission. Poke Henson was appointed in '97 and still serves, though no record is found that he was reappointed. City minutes do not show that Jim Packer was ever officially appointed. Others were named to the commission, and are not presently serving, but no record of resignation or that terms expired can be found.

The conclusion is obvious that these two commissions are functioning outside the law by allowing decisions to be made and votes taken by members serving in violation to the very law they're enforcing.

Whether this negates the decisions they've made is a matter for the courts to determine.



I've been to the Jordan Valley Big Loop where buckaroos carrying more coils than the Wichita lineman tenderly twirled and tossed their twine like fly fisherman front footin' fleet four- legged fillies and fiery fence jumpin' fresh broke, full growed fleabags, frauds, founders, alkali sloggers and snakes in the grass...and made it look pretty.

But 35 feet of medium lay lefthand twist nylon rope always seemed



and in the brandin' pen. I actually thought that if I carried more than that I might tangle in the line and be drug to death like Captain Ahab in Moby Dick. I have a few cows. Not enough to make Rob Brown

or the Mormon Church jealous, but a few. We gathered last fall but had two big calves and a high horned red cow break back, go through the fence in the big trap, and head for two sections of rough country. Francisco, Jack and I lit after 'em on a dead run. Ducking the mesquite and cat claw, leapin' and skirtin' the barrel

cactus, cholla and pear, jumpin' the little arroyos and snow plowin' the big ones.

Jack snagged the 450 lb red heifer on a quick turn back and flattened her. I rode up to him to offer assistance. On the next ridge I saw Francisco in full pursuit silouetted against the sky, runnin' hard, swingin' his rope, the 525 lb black steer, tail in the air, a horse's length in the lead. Francisco's hat blew off. He threw his loop, and missed. The steer swerved to starboard and headed straight for Jack and me. He burst up out of the arroyo and ran right at my horse! He passed within 6 feet of me in the fast lane goin' the opposite direction at the speed of a cheetah. I threw my rope, bingo! The coils peeled out of my hand like he'd fallen off a cliff!

It occurred to me ten minutes later, as I was crawling around on my hands and knees in a mesquite thicket trying to catch the dragging end of my rope, that had I been tied-on or actually caught my dallies, I'd probably been pulled over backwards and smashed flat.

But the longer I had to crawl after that rope, the more I began to appreciate the value of an extra twenty feet.

It takes a long time to learn to be a cowboy.



# Transforming farm belts into energy belts

Rural Idaho is anxiously scanning the horizon for a new economic engine. One clear opportunity is farm-based clean energy production.

Rural areas stand to gain new jobs, businesses and revenue by producing biofuels, windpower and other clean energy sources. A growing and unusual alliance of agricultural organizations, public utilities, rural development organizations and clean energy advocates have united to promote new clean energy production. This emerging alliance will be evidenced in Boise Feb. 10-11 during the Idaho Ag Summit.

The Harvesting Clean Energy Conference/Idaho Ag Summit will focus on practical ways to put profitable, clean energy projects on the ground now.

The goal of these partnerships is to transform farm belts into energy belts. Billions of dollars now leaking to foreign energy producers, threatening energy security and driving trade balances deep into the red, can instead pump up Idaho's rural economy and communities. The conference will highlight opportunities for

developing alternative energy sources.

Targeted investments in clean energy can provide economic paybacks that justify the upfront expenses of new projects. For example, an Iowa study found that using fuel containing a 20 percent blend of biodiesel in all state government diesels would cost \$500,000. The state would recoup that expenditure in new tax revenues if the new market propelled development of a biodiesel plant.

For relatively small expenditures, Idaho might pull substantial resources from the new federal farm bill, the first such bill with a section devoted to energy production. It authorizes \$405 million over five years for clean energy projects, enough to leverage billions in private capital. The state is positioned to draw a significant amount of this money if state action helps pave the way.

Idaho is already a center for oil seed crops, which can feed factories that make biodiesel. The University of Idaho is a major national center of biodiesel research, and many Idaho institutions now use biodiesel and have joined in some of the largest mass biodiesel purchases in the U.S. It is a natural progression to take the next step and grow a biodiesel production industry.




