Caldwell teen arrested in vehicle burglaries

A 16-year-old Caldwell teen is behind bars and several more arrests are expected in the recent rash of vehicle burglaries that have plagued the Homedale High School parking lot.

Homedale Police Chief Jeff Eidemiller said he was in Wilder when the call was dispatched and was unable to locate the men when he came back to Homedale. Owyhee County Sheriff's Deputy Gary Olsen was the first to arrive on the scene.

Eidemiller said the juvenile was picked up in Canyon County on a detention order

School districts prepare for trustee elections

May 20th, school districts in the local area will hold a trustee election with several positions open in various locations.

Homedale's Zone II will hold an election as the term expires this year. John Demshar, current board chairman, filled the position in 1997 on a two year term and is now finishing out a three year term. School District Superintendent Bob Lisonbee said he was unsure if Demshar was planning to run for another term. Due to a family illness, Demshar was unavailable for comment.

In Marsing, 12 year board member Joe Usabel's seat will be open in Zone I. Usabel is currently the board's chairman and a spokesman from the district said Usabel is planning to run for another term.

Zone I will also be up for election in the Bruneau/Grand View School District. Russell Turner is the current incumbent, but details of Turner's term were unavailable.

Those wishing to file for candidacy in the election must declare candidacy by April 18th. The deadline for a write in declaration is May 6th.

Sheriff's office assists in burglary ring capture

With the assistance of the Owyhee County Sheriff's office, a 37-year-old Nampa man is behind bars and dozens of construction site burglaries in Canyon and Ada Counties have been solved.

Three teams of police officers and detectives from Owyhee, Canyon, and Ada Counties and the city county narcotics unit served search warrants on six residences in Nampa and Canyon County last week, discovering stolen property in every one of them.

A suspect in the burglaries was seen leaving the area where one of the houses was being searched, only to arrive at another one a few minutes later, where he was arrested by another search team.

Timothy Lee Driskell was booked into the Canyon County jail on charges of grand theft by possession of stolen property.

Wilder man sought in shooting

A Wilder man remains at large and local authorities are asking for the public's help in locating him. A warrant has been issued for Carlos Torres who is accused of aggravated battery in the shooting of Juventino Castro Jr. 27 of Wilder earlier this month at a residence in Homedale.



Homedale Police Chief Jeff Eidemiller said a group of people gathered at a home on Silver Sage Place Way when an argument broke out. Torres was initially removed from the home, but later returned with several other people and another fight began. Eidemiller said one shot was fired striking Castro in the chest. Castro

Homedale man receives probation on sex charge

Abelardo Renteria, 65 of Homedale was sentenced to seven years probation as part of a Rule 11 plea agreement, after being convicted of sexual abuse of a minor under 16.

Renteria appeared in an Owyhee County courtroom last week with several members of his family. Public defender Bill Wellman told the court that he disagreed with several paragraphs concerning the depth of the presentence investigation report and asked to have several paragraphs omitted. County Prosecuting Attorney Ed Yarbrough told the judge he would leave it to his discretion whether the paragraphs should be omitted or not. Morfitt said he would annotate the paragraphs as items that did not relate to this particular case.

Renteria was arrested in June and charged with three counts of lewd and lascivious conduct with a minor under 16 for allegedly molesting three young girls between the ages of six and nine years old. Per the plea agreement, the charges were amended to sexual abuse with a minor under 16 and two of the charges were dismissed by the state.

Before Morfitt read the sentencing, Wellman pointed out that Renteria had been in custody at the county jail for approximately seven months.

He said his client had been released in January and was now living in Homedale. He said Renteria would like to relocate back to California to be able to reunite with his wife. Wellman asked the court to refrain from ordering a psychological sexual evaluation due to the age, health, and lack of criminal history of the defendant. The judge agreed.

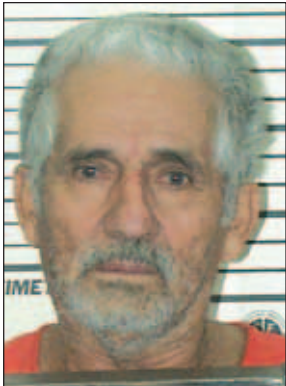
Wellman also stated that the defendant had a no contact order against him to have no contact with any minor children. Wellman told the court that Renteria had many grandchildren who were in homes in the Marsing area. He said the defendant has a good relationship with them and due to the order he could not have a relationship with them. Wellman asked the court to remove the no contact order. He also asked that if the judge ordered probation, if it could be granted in California where his wife lives.

Yarbrough did not ask for any changes and recommended the court sentence Renteria to "a period of probation and local incarceration as reflected in the agreement." He asked the court to accept the rule of agreement, which the court did, but instead of only giving the local man probation, Morfitt added on 365 days of jail time in the

county jail, which he suspended 180 days.

Judge Morfitt sentenced Renteria to three years minimum, in the state board of corrections without the possibility of parole and ten years maximum in which he suspended and ordered probation for seven years. He did not order the defendant to undergo SANE evaluation but he was ordered to have no contact with the victim or any victim named in the charges. He also ordered no "unsupervised" contact with any minor children without a probation supervisor's approval. He is required to register as a sex offender.

Following the ruling, Wellman objected to the addition of jail time stating that "Yarbrough or I either expected additional jail time per the plea agreement." Judge Morfitt told Wellman that he had the authority to impose additional jail time, which he did. After a short break to discuss the situation with the defendant, Renteria was released to the Owyhee County Sheriff's office and is being held in Murphy.

Ron Hopkins, superintendent of the Marsing School District, will end his stay in the local area later this spring after he resigned his position earlier this month. Hopkins said he plans to relocate to northern Idaho to be closer to his children.



County awarded federal funds

Owyhee County has been chosen to receive \$3,401 to supplement emergency food and shelter programs in the county by a national board chaired by FEMA representatives.

The selection was made by the board which is chaired by the Federal emergency Management Agency (FEMA) and consists of representatives from the Salvation Army, American Red Cross, United Jewish Communities, Catholic Charities, USA, National Council of the Churches of Christ in the USA, and United Way of America which will provide the administrative staff and function as fiscal agent.

The board was charged to distribute funds appropriated by Congress to help expand the capacity of food and shelter programs in high need areas around the country.

A local board will determine how the funds awarded will be distributed among the emergency food and shelter programs run by service organizations in the area.

Under the terms of the grant from the board, local organizations chosen to receive funds must be private voluntary nonprofits or units of government. They must have an accounting system and practice nondiscrimination and have demonstrated the capability to deliver emergency food and shelter programs. If the organization is a private voluntary organization, they must have a voluntary board. Qualifying organizations are urged to apply.

Owyhee County has distributed emergency food and shelter funds previously with El-Ada. Public or private voluntary organizations interested in applying for emergency food and shelter program funds must contact Barbara Reynolds at 337-4812 for an application. The deadline for applicants is March 26.

underwent surgery the following day and has since been released from the hospital.

Torres was on probation at the time of the shooting from a conviction of aggravated battery, a felony, on Juventino's brother Jamie Castro in 1998.

In 1998 he allegedly stabbed Jamie, then 22, in the upper arm, chest and face after a confrontation. Jamie was Life Flighted to a local hospital because of his injuries.

Eidemiller said at that time, then police chief Kevin McKinney requested a warrant for attempted murder, but court documents show that Torres was arrested, after he turned himself in, for the aggravated battery charge.

Torres has prior charges of failure to appear from Canyon County, resisting an officer and probation violation.

Eidemiller said anyone who knows the whereabouts of Torres are advised to contact their local law enforcement agency.

✓ Tools

Detectives say they recovered power tools, electrical fittings and fixtures, generators, compressors, nail guns, airless paint sprayers, interior and exterior doors, air hoses, heavy duty extension cords, halogen work lights, ladders, cases of nails, hand tools, computers, monitors, keyboards, printers, cabinets and appliances including microwave oven, range, refrigerator and a fiberglass bathtub and shower unit.

Owyhee County Sheriff Gary Aman said the property came from construction sites in Canyon and Ada Counties. He said including the arrest, several children were also taken into custody for child endangerment. Aman said that currently none of the items found are connected to any burglaries in Owyhee County.

"They didn't have enough manpower to do it all, so we sent some of our guys to help," Aman said.

He also said that construction businesses in the Owyhee County area should contact the Canyon County Sheriff's Office if they have had items stolen recently. He said at this time, he did not think any of the discovered items were from the area.

for probation violation. He said two other men who were reportedly in the vehicle in Homedale, were no longer in the car when Canyon County officers stopped him in a maroon Pontiac Grand Prix in Caldwell. Eidemiller said a local businessman, whose name was not released, was able to identify several items about the vehicle that helped the departments identify it.

"If it had not been for a concerned citizen we never would have gotten them," Eidemiller said. "He is totally responsible for catching these guys. I would really like to thank him for his help."

The police chief said he would request warrants for five counts of vehicular burglary, five counts of petit theft and five counts of malicious destruction of private property. He said Canyon County has sent their case to the prosecutor for one count of burglary, one count of malicious injury to property and one count of petit theft.

After a search of the vehicle, two stereos were located in the trunk of the car. One is in direct connection with the burglary that happened last week. A stereo and speakers were recovered from the vehicle, several compact discs that were taken from a vehicle were recovered and a set of speakers from another Homedale student's vehicle were recovered. Eidemiller said the teen has confessed to six separate burglaries, five in Homedale and one in Canyon County.

"He said he came out to Homedale to find a job and when he could not find a job he said he needed to make some money somehow," Eidemiller said.

✓ COSSA

for a fixed amount of \$65,000, but Homedale School District Superintendent Bob Lisonbee said due to rising costs the district's cost for COSSA programs has steadily increased over the past ten years.

Currently, \$32,000 is sent to the COSSA program from the general fund and Lisonbee said that only covered the professional technical program. He said more is taken out to cover the special education program and the gifted and talented program.

"This levy will allow us to reclaim at least \$32,000 at a minimum and possibly \$60,000 to be put back into our regular education classrooms," Lisonbee explained. "With the threat of pending legislature cutbacks, the levy would help offset any pending state losses."

Lisonbee said the new levy is being run a little before the expiration date of the last levy because the present levy amount is not meeting current expenditures for the programs in COSSA. The levy will make it possible to meet Homedale School District's share of the costs of all vocational programs offered. It may also meet some of the special education and gifted and talented costs that Homedale School District students require.

The district is asking voters to approve a levy of one tenth of one percent (.1%) of market value of assessed property in the school district. This would raise approximately \$130,000 annually if the school board chose to levy the whole amount. The school board has the discretion of levying a lesser amount if they so choose. The levy would never exceed one tenth of one percent of market value for the ten years of the life of the levy.

The increase from the levy on an average \$75,000 home with a lot and a homeowner's exemption would be about \$22.75 per year.

The purpose of COSSA is to provide educational programs that the individual school districts would not be able to offer students. COSSA includes the five school districts of Wilder, Notus, Parma, Marsing and Homedale and services include professional-technical education, special education and gifted and talented education. Professional-technical classes include auto and diesel repair, auto body, health occupations, building trades, welding and Cisco Systems training.

Lisonbee said the programs are the finest in the state of Idaho producing many state winners and national competitors. Students can go directly to work after graduation or on to further training in post-secondary work.

Homedale School District has about 65 students enrolled in the professional-technical programs, by far the most students from any of the five districts in COSSA. There are 106 students served in the special education programs and about 72 served in the gifted and talented program. The district could not afford to provide all these classes and services without going in with the other school districts in COSSA. The students are getting excellent services and classes at a minimal cost to the district. The other districts have all approved this same levy in their latest votes. Homedale School District is the last district to ask for approval of this levy.

Lisonbee said if the public has any questions about the levy, they should call the district office or speak to their board member.

Oregon Livestock Producers praise Hage ruling

"Good news for ranchers with grazing allotments" was the message at February 27 and March 1st seminars sponsored by the Oregon Livestock Producer Association (OLPA) in Jordan Valley, OR and John Day, OR. The newly formed producer association has a two prong mission statement – to ensure open competitive livestock markets and to secure property rights for their members. In keeping with this mission, "Securing Your Property" seminars were presented by rancher and property rights advocate, Wayne Hage and former U.S. Congressman Helen Chenoweth-Hage.

With over 200 attendees, Hage announced that the United States Court of Federal Claims, Washington, DC ruled that Hage did not need a grazing permit to access his water rights and forage on his grazing allotments. His rights to his grazing allotment are private property and are not a revocable privilege. Because he owns his right to the water and forage, the land is no longer public land, but federal land. As a result, the federal government cannot interfere with his grazing allotment without "just compensation".

According to Hage, "Virtually all national forest lands and grazing districts have rights attached in the form of vested water rights." The key to whether the grazing allotment is private property or a conditional privilege to graze is determined through a detailed title search.

After proving chain of title and vested water rights, any interference with a rancher's grazing allotment by the Federal government will be considered a "taking" – a Constitutional right for the Federal government to take private property with just compensation. Ranchers must file their claim in the Federal Claims Court as a taking.

The primary message to ranchers from Hage is to act.

Ranchers must determine whether their grazing allotment is private property by proving their title and demanding compensation from the Federal government for any interference with this private property right. Hage believes that when the Federal agencies realize that they will have to pay for restrictions and interference, dramatic changes in their rules and regulations will occur. This realization will extend beyond BLM/Forest Service to the Endangered Species Act and other Federal agency actions affecting rancher's grazing rights. Once title is proven, no one can interfere with a rancher's grazing allotment unless they pay the rancher for it.

It must be said that there is much confusion within the livestock industry and legal profession with regard to the meaning and implications of the Final Decision. Yet

Hage v. U.S. is the only case that has prevailed in recognizing a rancher's vested water rights, allotment forage rights and access rights on his grazing allotments in the last 90 years. Anyone paying a hefty retainer to an attorney in a case involving federal land grazing allotments needs to insist that their attorney attend this seminar to clarify any discrepancies between their reading of the case and what is presented in the seminar. Too much is at stake for most allotment owners to risk following just ANY approach, including that in

Hage v. U.S., blindly. Get your questions answered and get your attorney's questions answered!

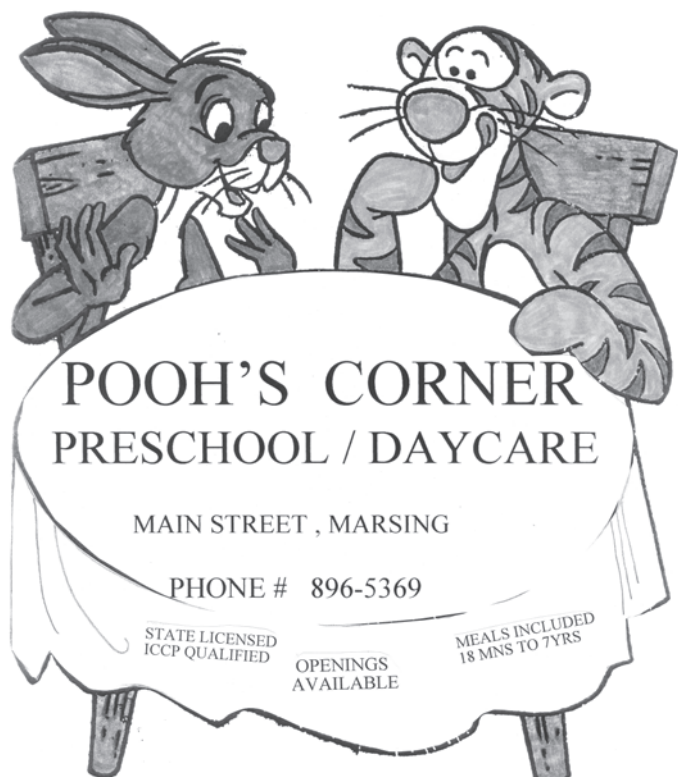

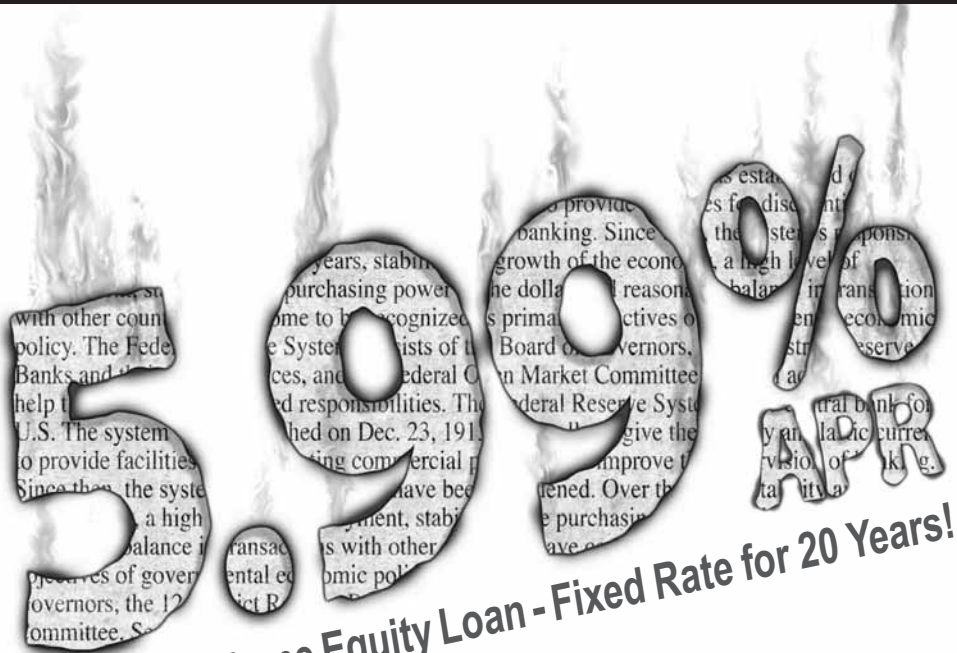

School board meets over variety of issues

A variety of issues were discussed during last week's monthly Homedale School Board meeting at the district office. Teachers, administration and concerned citizens spoke of issues including student writing growth, a formation of a sixth grade band and the adoption of a annual trustee election.

Board member Moss Watson presided over the meeting due to the absence of John Demshar. The meeting began with an executive session concerning a student.

The minutes of the Feb. 10, meeting and a special meeting held on Feb. 17th were approved as well as the month's bills.

Homedale Middle School fifth and sixth grade teacher Pam Silveria gave a report to the board depicting the continued increase in scores for the reading assessment program. Silveria read essays written by several of her students at the beginning of the school year and followed up with essays written by the same students many months later.

"One of the things I am probably most excited in my life right now is what is going on in my classroom," Silveria told the board. "I have a combined classroom of fifth and sixth graders. I have included a copy of the students' Star Vocabulary scores on Sept. 19th and again on Jan. 21st at the beginning of the second semester. As you can see, the kids are making gains."

Kris Hopkins, Site Coordinator/Curriculum Director, reported that Scott Freeby, Keith Field, Bob Lisonbee and herself attended a two day session in Assessment Leadership in February.

She said "Rick Stiggins, the presenter, is also the author of the Assessment Literacy course and resources used two years ago in training all teachers in quality assessment practices. He clarified Assessment FOR Learning, which is what happens when teachers use assessment to help students learn more and Assessment OF Learning, which is finding out how much students have learned as a particular point in time."

Hopkins told the board that Freeby, Field, Ron Huckins and Hopkins attended the Idaho Falls District to learn about their standards reporting process/implementation and technology issues as well as their continuing curriculum development. She reported that enough money has been set aside to employ Huckins for another year within the CHPS budget.

Homedale High School Athletic Director Randy Potter reported that the girls varsity basketball team took second place in the state tournament in Nampa last month. He said the freshman boys basketball team held its season ending tournament at the high school. He reported the tournament was a fun event and the boys played their best games of the season.

The junior varsity boys team played a tournament in Melba and lost their first game, but won their second. The boys varsity team finished its regular season in third place with an 8-4 record and went into the district tournament playing Nampa Christian. Homedale defeated the opposing Trojans.

Potter gave a report on the wrestlers who attended the state tournament in Pocatello placing fourth overall.

Over 150 students have signed up for spring sports, which began this week. Their will not be a junior varsity baseball team this year as Potter reported not enough students signed up to participate.

Homedale High School Principal Mike Williams told the board that the school inducted 27 new members into the honor society March 4.

Field told the board that many students and parents have shown interest in a sixth grade band class at the middle school. He said a poll of students and parents has been given and the overall interest has been good. The board moved and approved a sixth grade band program for the next school year.

Other action approved by the board Monday night included giving \$100 to the senior all night drug free party held in May and allowing the senior class to use the gymnasium for its party. They amended policy 6.60, classified staff-sick and personal leave, adopted a resolution to change Idaho Code 33-502B concerning the deadline to announce unopposed winners of board elections, adopted a resolution calling for an annual trustee election and set a date for the amended budget hearing.

Policy 7.50, instructional program, curriculum development received its first reading and a policy, 8.08, regarding students, extracurricular programs addition/reduction was discussed but tabled until the April meeting.

The board approved funding \$300 per person eligible for the BPA national convention in Dallas, Texas later this year and approved the middle school spring sports schedules for track and tennis.

Board member Benita Miller opened a discussion for the district to develop a policy to designate a district spokesman. After a short discussion, the majority of the board decided not to pursue the subject.

In closing the meeting Monday night, the board hired all tenure staff.

Next month's board meeting will be held on April 14 at the district office. -CPB

For the game, Weiser finished with seven errors. Homedale did not commit any.

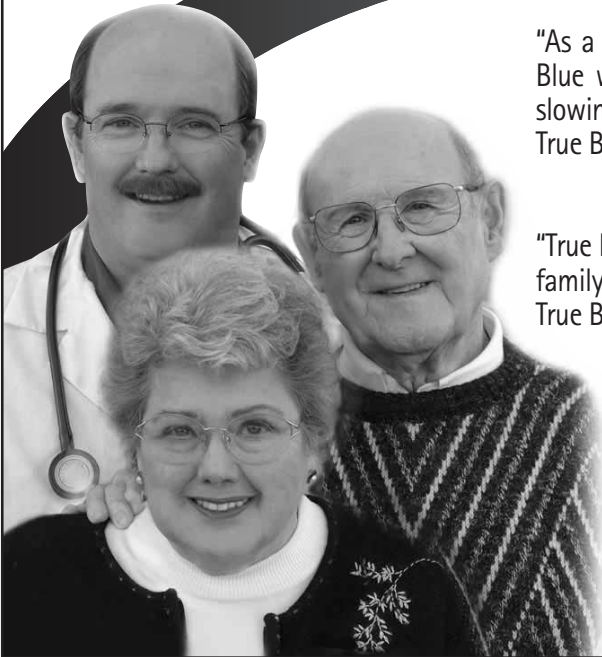

ABCs of diabetes cooking

Dear Betty,
My husband was just diagnosed with Type II diabetes. Where do I start to plan and cook meals for him?
Westfield, Mass.

Learning how to live, planning, shopping, cooking, eating and exercising with diabetes can be overwhelming at first. So start by learning as much about it as possible. Be sure to meet with his diabetes care team to develop a food plan that’s right for him. That’s a good time to ask questions too. With knowledge and a food-plan outline in hand:

1. Plan ahead. Spelling out what, when and how much to eat will help your husband as he learns to make food choices to control his diabetes. 2. Embrace variety. Eating a variety of foods and snacks will keep boredom at bay and provide needed nutrients. 3. Read the labels. Where you once may have checked for fat grams or calories, now look for carbohydrate amounts. 4. Watch the fat. Choose low-fat dairy products and lean meats. Go lightly on butter, margarine and cream sauces. 5. Get moving. Exercise helps maintain lower blood-sugar levels. Make it a family affair by joining a health club or just walking the dog together.

Another big help is the new Betty Crocker Diabetes Cookbook, coming out April 1. We developed it in conjunction with the International Diabetes Center, which provided medical and nutritional information. We also talked with people living with diabetes and included their real-life advice.

Of course, the cookbook’s full of wonderful recipes from my test kitchens. They’re super for your husband, as well as anyone in the family who wants to eat healthier or lose weight. As you get started, you’ll appreciate the seven days of healthy meals and snacks we’ve planned.

Dear Betty,
My 10-year-old son’s best friend has Type I diabetes, and sometimes he comes over to our house right after school. What after-school snacks will both boys enjoy?
Vicksburg, Miss.

I’m sure the mother of your son’s friend thanks you for being so conscientious. Step one is to check with his mother to find out what his usual snack includes. Most meal plans call for snack choices with a one- or two-carbohydrate value assigned by the American Diabetes Assn. These one-carbohydrate snack choices are easy to keep on hand, and they’re healthy and tasty for both boys. If more than one carbohydrate choice is called for, simply double the portion or add another choice.

Seasoned mini rice or popcorn cakes (10); Sugar-free pudding (1/2 cup); Tortilla chips (10–15) and salsa (1/4 cup); Apple, orange or pear (1 medium); Animal crackers (6); Raw veggies (3 cups) and low-fat dip; Granola bar (1); Sugar-free hot cocoa (1 cup); Ready-to-eat cereal mixed with small handful of peanuts (1 ounce); Cheese, meat or peanut butter sandwich (1/2); String cheese (1 ounce) and lowfat crackers (6–10)

They were married in the Methodist Church at Emmett, March 24, 1928, and have lived in the Marsing and Sunny Slope areas all their married life.</p> <p>The reception will be held in the Fellowship Hall of the Deer Flat Free Methodist Church, Saturday, March 18 from 2-5 p.m.</p> <p>Trailer court, subdivision discussed</p> <p>Marsing City Council met Monday, March 13, for its regular session at City Hall. Councilmen Bob Malmberg, Mike Percifield, R.K. Caldwell and councilwoman Francis Needs met with Mayor Gene Showalter for a full evening of city business.</p> <p>City engineer Bob Fenton introduced two proposed plans for council approval. Pace.</p> <p>The board set its regular meeting nights as the 1st and 3rd Wednesday of every month.</p> <p>Celebrates 111th Anniversary</p> <p>The Relief Society held a party Tuesday afternoon celebrating their 111th birthday anniversary. The afternoon was spent playing games with a program and refreshments being served. There were about 38 presents.</p>	<p>INDIAN MASSACRE. Again we are compelled to chronicle another of those terrible outrages that during the last four years have been so common in our midst. Again an industrious citizen has been brutally murdered and added to the bloody list of savage atrocities. On Wednesday, the 18th inst., as a Mr. Jarvis, from Boise Valley, was bringing a wagon-load of vegetables to this place, he was killed by Indians in the Canon between Carson's Ranch, on Reynold's Creek, and Fruit's Ferry, on Snake River, the same locality where the stage was attacked and three men killed about a year ago. There are but few facts known in relation to this last bloody deed, as there are no living witnesses except the murderers themselves. From a gentleman named McDowell, who was the first to come along afterwards, we learn the following particulars: Mr. Jarvis crossed Snake River in the morning, on the same boat with the stage, which was also coming this way. He had a span of horses and light wagon loaded with potatoes, cabbages, eggs, and c., intended for this market. He followed after the stage from this market. He followed after the stage, which was probably an hour ahead of him at the time of the attack, supposed to be about noon. Mr. McDowell came along the next morning, and when above two miles below the scene of the murder he discovered moccasin tacks apparently by two Indians in crossing the road. Proceeding up the canoe, he found the remains of the wagon, which had been burned; the vegetables were scattered round and the eggs broken. A short distance above the wagon our informant noticed some blood in the road, and apparently where a scuffle had ensued. Supposing that some one had been killed, and probably not being quite sure of the safety of his own scalp he passed on over the summit. Meeting the return stage, Mr. McDowell accompanied it back to the spot where the wagon was burned, near which the body of Jarvis was found, stripped naked but not mutilated, not even scalped. He was shot in the lower of part of the abdomen and in the breast. Of course the horses and everything the Indians could appropriate were taken away. The body was put on the stage and taken down to the Ferry. We have been unable to learn ought of the history of the unfortunate man. It is supposed that a Chinaman was killed or taken prisoner the same day, as he left Reynold's Creek en route for Boise City that morning, and had not since been heard of. There was probably not more than four Indians in the murderous band. One evening bout the beginning of the week they took away a cow from Carson's Ranch, and nearly succeeded in effecting an entrance to a stable containing a number of horses. It is thought that the feuds intended to attack the stage on the morning in question, but there being a large number of passengers they feared to make the attempt.</p> <p>WHY? Last November General Elliot issued several military order of the protections of travel: among others was one providing a mounted escort for the stage to and fro throughout the Reynold's Creek Canon, which was accordingly done for a time; but they were taken away again and the road was left without protection, and why was it? Why is it that soldiers are kept in the barricades at Fort Boise where they are no earthly benefit and our lines of travel left unprotected? Had the soldiers not been, taken away from the canon it is more than likely that the late horrible tragedy would not have occurred, which make eight men that have been killed by Indians on that portion of the road. Was it fancied because no Indians were seen while the escort was there that the danger was over: Of course the bloodthirsty feuds would not show themselves while there was ample protection the object of which was to keep them away.</p>

Farm Bureau

Common sense legislation stalled in senate

Legislation requiring the Idaho Department of Environmental Quality to use sound science when passing rules that are more restrictive than federal EPA requirements appears to be stuck in the Idaho Senate's Health and Welfare Committee.

Idaho DEQ employees are lobbying against the bill. The House passed the measure on a 50-18 vote. It was forwarded for Senate consideration on February 18.

Resistance to this legislation highlights longstanding apprehension Idaho Farm Bureau members have with DEQ. Why would a state agency whose implied mission is the application of sound science resist this legislation? We think it's because DEQ wants to be able to continue to run roughshod over the private property owners of this state.

Last year in a botched attempt to regulate dairy odor, DEQ attempted to pass hydrogen sulfide standards that would have eliminated most of Idaho's dairy and beef industries. The proposed standards would have also shut down gas stations, at least one hospital failed the test, farmers would have been prohibited from making corn silage, and most municipal waste systems would have failed as well.

To further illustrate this unfortunate situation consider that last spring in Idaho Falls, DEQ attempted to fine a landowner \$1,500 per day because of "fugitive dust" blowing from a potato field. And the overzealous regulations don't stop there. In an even more common-sense defying sham, DEQ is attempting to fine one Rexburg landowner for a soil contamination problem that clearly came from several different sources over several years.

There are dozens of other examples of DEQ either not doing its job, or overstepping its authority. Legislation requiring this agency to use sound science that stands up to peer review is past due. HB 150 doesn't ask too much from an agency that inherently depends on good science to do its job right. Contact your state senator and let them know that House Bill 150 will help protect Idaho citizens from speculation and faulty science.
