Week of moisture may boost irrigation outlook

The Joint Board met Tuesday night to reevaluate the outlook of irrigation release allotments. Although the results of that meeting were not available at press time, South Board of Control Manager Rex Barrie said with nearly a week of moisture in the area, the outlook is looking better.

"The Joint Board will reevaluate the water situation tomorrow night," Barrie said Monday. "I anticipate they will increase the allotment. Anything is better than the previous 1.3 acre feet planned."

Barrie said as of Monday morning, pumps from the Gem Irrigation System were started on the Snake River. He said that by the end of the week, they should be able to deliver water to the area. Water is expected to be turned into the South Canal System on April 14th.

"Typically we would have water in the canal now, but every week we delay is an added week on the end of the season," Barrie explained.

On March 31st, Owyhee Reservoir recorded 198,202-acre feet with 365 cfs running through the river near Rome. On Monday, the reservoir held 204,745-acre feet and the river recorded 302 cfs near Rome.

BLM to hold public meeting for proposed landfill

The Bureau of Land Management, Lower Snake River District, is inviting the public to attend a scoping meeting to discuss Owyhee County's intention to purchase 1,360 acres of public land from the BLM-LSRD, for the purpose of constructing and operating a landfill for disposal of trash.

An Environmental Analysis is being prepared to outline the alternatives and associated resource issues and impacts. The purpose of the meeting will be to provide the public an opportunity to express their thoughts with BLM about the landfill site and any information that will assist BLM in its development of the EA.

The meeting will be held on April 15th from 6-9 p.m. at the Marsing Community Center on Bruneau Highway.

The parcel of land proposed is located southwest of Marsing approximately one mile east of Highway 95 on Sommercamp Road. A map showing the location of the proposed landfill will be available at the meeting. A copy can also be obtained by calling BLM Realty Specialist, Kelley Moore at 384-3452.

Local families send love and prayers to soldiers overseas

As war rages on in Iraq with American military forces continuing to maintain an upper-hand on Iraqi regime, local families stay focused on television screens, news paper articles and news radio stations as they pray for the safe return of every military person overseas, including their own children from Owyhee County.

Lisa Walker and Kim Haynes are two such moms who watch and pray for their children who are military personnel. Walker's son Steve (Doug) Simmons is a private first class with the Marines and is currently somewhere in Kuwait or in Iraq which she is unsure of. She last spoke to her son on March 29th when he called from Germany on his way to Kuwait, just to tell her he loved her.

Sherry Sheets watches the news daily as well because her husband, Eldon, is also overseas in the

Middle East. Eldon is in the Air Force as a security police. Sherry said Eldon has been in the military since 1984, a year after the couple was married. She said about 10 years ago he went active guard. He left in December, but she says she has frequent contact with him by e-mail. The couple has two girls, Mandy and Wendy and a son Shane.

"With lots of prayer and the help of wonderful family and friends we keep our spirits up," Sherry explained. "I was able to talk to him nearly every day, but since the war started I have not spoken to him for a couple of weeks now. He was supposed to come home this month, but now we don't know."

Sherry said if she could talk to her husband right now she would tell him, "I am proud of you for all that you are doing for our freedom. I love you and I miss you and I can't wait until you come home."

Sherry said her children are doing as well as can be expected. She said her son seems to have the hardest time, "since he feels his dad is the greatest thing in the world," Sherry laughed.

Haynes knows exactly where her two sons, Kevin and Kenny Overton are for now because neither of her sons have been deployed yet, but both could go soon. A thought she does not like to consider.

For Walker, talking about her son is very difficult with out crying. She said the last she knows Doug is in Kuwait, but currently she does not know exactly where he is. Doug is a logistics officer.

"I am stressed," Walker said Wednesday. "They bring in supplies, heavy equipment, they can bring in ammo, they can take it into the infantry. From

what he told me there are nine different jobs that they can be doing.”

Walker said if she could tell her son anything right now she would just love to tell him, “to make sure he is right with god and I am very, very proud of him.”

Haynes’ sons joined the military at different times in the past year. Kenny, 20, and is currently at Camp Pendelton. She said he leaves for boot camp next week.

Kevin, 19, enlisted in the Marines on February 14th, 2003. She said in January she and her son went to San Diego for Kenny’s graduation, that is when Kevin decided to enlist as well.

“Kenny’s thing was the September 11 attack,” Kim recalled. “He went to college right after high school, but when Sept. 11th happened, he became very passionate about

the situation. The one-year anniversary came around and he asked me what I thought about him joining. I asked him if he really wanted to know.

“I am very proud of him, of both of them, but yes as a mother I hate it. Hopefully they will find a resolution and they won’t have to go, but it doesn’t look like that is going to happen.”

Haynes said she received a call from her son last month

and he told her that rumors were he may be deployed soon. She said she did not hear from her son for a week, then finally Sunday night he called her.


“I cried, I cried a lot,” Haynes explained. “Kevin had to take the phone because I couldn’t talk. Kenny kept telling me to calm down. I just couldn’t talk. I told him that he doesn’t see what I see.”

Haynes said she tries not to watch too much of the war coverage on television, but she does watch just enough to keep up.

“I have seen things like the interview on a television station,” Haynes recalled. “The soldier was on a gurney and they were interviewing him and his mom. The reporter asked him what was the one thing he wanted to hear his mom say and he said he wanted to hear his mom say that she loved him. It just tore my heart out. You are so proud of them because they are so patriotic and they want to do what is right for our country and our freedom, but you are selfish at the same time and you want

them home with you.”

Haynes said her son Kevin is anxious to get into boot camp. She said he thinks it is unfair that since the two brothers are enlisted and are Haynes’ only sons, only one of the two boys will go to war.

“It just drives me nuts,” Haynes continued. “Kevin thinks it should be him who gets to go instead of his brother. He wants to be the one out there. I don’t want either one of them to be out there, but if that is what they need to do, I support them.”

Local women coordinate military banner

To show support to local service men and women, two local women have been gathering names of military personnel who are now stationed or involved in the on going war with Iraq.

Lori Davies and Lori Maupin said Thursday they wanted to do something to show the local service people how proud the people of Homedale are of their efforts to fight terrorism. They chose to gather names of as many service men and women and have them sewn on a banner, which they hope to display at the entrance to the city off of Highway 95.

“We wanted to do something to show our support,” both women agreed.

“Something we can have so the world driving by can see who from our community are

involved in the war on terrorism.”

Both women work for Ken’s

Tent and Canvas and said Ken Bahem, owner, donated the use of his machines and the women’s time to put the banner together. Mark Jolley from Allied Signs is also donating materials for the sign.

“Now comes the hard part,” Davies said. “Getting the names of all the people in the

area who are involved. We don’t want to miss anyone, but the government is not quick about sharing the names of the people overseas.”

Councilman’s absence stalls city mayor nomination

The Homedale City Council was stalled in its efforts to appoint an interim mayor to replace recently resigned Mayor Harold Puri during a special meeting called last Wednesday night due to the absence of one councilman and the refusal of another to attend the assembly.

Puri submitted a surprise resignation late last month a few hours before a regular meeting was scheduled, stating several personal reasons for walking away from the position. The council tabled accepting or denying Puri’s resignation at the March 27th meeting stating the council wanted a chance to speak with Puri and “find out what is going on.”

Council President David Freelove and Councilman Hap Duryee requested that a special meeting convene on Wednesday late Monday afternoon to accept or deny Puri’s resignation and to

appoint an interim mayor who would fill the position until a general election is held in November. But the meeting didn’t completely happen last week when councilman Charles Garrison didn’t show up and Councilman Kevin Barlow refused to attend as long as Garrison was absent.

Freelove who presided over the gathering recessed the meeting, which was scheduled to begin at 7 p.m., until 7:30 p.m. saying Garrison had called earlier in the day and said due to a working conflict he could not attend until late. Freelove, Duryee, Barlow and City Clerk Pam Dugger were then in attendance.

At 7:30 p.m., Freelove requested the council to chambers and said he would convene the meeting. Barlow said he would not attend the meeting if Garrison were not present.

“This is a very important meeting and I think all four

council members should be present for it,” Barlow told the council. “Electing a mayor is not a small thing and I will not attend if all four of us are not here. He already had his work planned when this meeting was scheduled. How can he get out of a job? I understand this is important but it was not on the schedule.”

“How long do you think we should wait then, Kevin?” Freelove asked. “Do you want us to wait until nine o’clock?”

“He said he would be here by eight o’clock at the latest,” Dugger stated.

“Ok, we will wait until eight o’clock,” Barlow said. “If he said he would be here at eight, we will wait until eight. I don’t think we should start without him.”

The council convened the meeting at 8:04 p.m. and moved to accept the resignation of Puri, but when the issue of nominating an interim mayor was suggested, Barlow again

stated he would not be a part of the council if Garrison was not in attendance for nominations.

“We had to recess and he will not come back in until

Charlie gets here,” Duryee said during the recess.

When the meeting reconvened, Duryee moved on — to page 12

Cities schedule irrigation startups

Spring is in the air and local cities will soon be filling area irrigation systems for the spring and summer watering season.

The City of Marsing is scheduled to begin its season on April 22, but city officials say the water could be turned on sooner or later than the scheduled date depending on spring rains. Questions may be directed to city hall personnel at 896-4122 ext. 2.

In Homedale, irrigation water is scheduled to be released on April 15th, again depending on spring rains. Questions can be answered by calling 337-4641 ext. 2.

In the Bruneau/Grand View area, canals began filling on March 21st for this year's season. Spokesman from the Grand View Irrigation District said that currently canals in the area are full and up-and-running.

Hatchery salmon seasons slated

Break out the heavy tackle. Another salmon season is nearly here.

Meeting via conference call this week, the Idaho Fish and Game Commission approved hatchery salmon fishing seasons on the Clearwater, Lower Salmon and Little Salmon Rivers.

The Clearwater River is slated to open on April 19, with both the Lower Salmon and Little Salmon seasons opening on April 26. The Lower Salmon River season will close on June 15, the Clearwater on July 6, and the Little Salmon River on August 3 unless closed earlier by Commission action.


Fishing boundaries are similar to last year. The Lower Salmon fishery will be open from Hammer Creek upstream to the mouth of the Little Salmon River (no change from last season), while the Little Salmon River will be open from its mouth upstream to the Highway 95 bridge, just north of the highway rest area. All boundaries will be clearly marked.

Anglers will see reduced numbers of returning adult salmon in relation to the last two seasons. Poor water years and low juvenile salmon survival in their journey to the ocean are largely responsible for the lower returns. For example, about 1,200 hatchery chinook are available for sport harvest in the Little Salmon River. This represents about one-third the number of adult hatchery fish that anglers took home last year. The run of returning adults will be monitored closely, and seasons may be closed early to allow enough adult fish to return to Rapid River Hatchery for broodstock purposes.

This reduction in numbers is reflected in the bag and possession limits for hatchery salmon this season. Limits are two hatchery salmon per day, six in possession and ten for the season.

Rodeo board battles fair board in concession agreement

The ongoing battle of who will be allowed to serve concessions between the rodeo board and the American Legion, at the Owyhee County Fair and Rodeo this year, remains a mystery as all groups remained at a stalemate Thursday night during a fair board meeting.

The issue continues to be over a five-year contract that the fair board signed last year giving the American Legion the sole right to sell beer, although the fair board agreed on a rule several years ago that states no one will have “exclusive” rights to concessions during the annual event.

Since giving the American Legion exclusive rights to the beer sales, several other service clubs have approached the fair board in hopes of obtaining exclusive rights including the Homedale Chamber of Commerce and the Basque Club. Both were denied.

Fair board members David Rutan and Ray Bicandi have been acting as “liaisons” between the rodeo board and the Legion attempting to find a solution to the problem. But Thursday night’s meeting still held no answers for the rodeo board after Legion members voted to retain the exclusive right.

During previous meetings, fair board president Gwen Miller stated several times that the fair board does not want any responsibility in the rodeo board’s problem of selling beer. She again said Thursday that the problem would have to be solved between the legion and the rodeo board that the fair board did not want to take any responsibility since they had signed a contract with the Legion.

Rodeo board members were given a “Conditional Use Agreement” from fair board members Thursday compiled from information given by liaisons Bicandi and Rutan. The agreement included a usage fee of \$1,000 and stated

a signing deadline of April 3rd. But after a lengthy discussion, it was finally agreed that the two boards would again meet on April 11th “just to sign the agreement.”

Miller told the rodeo members that she had hoped a resolution could be reached Thursday night. Parrill explained that the four members attending the meeting could not make that kind of decision and since it was the first time they had seen the agreement. A vote would have to be taken. Miller then demanded the agreement be signed, but additional fair board members moved to postpone a meeting until next week.

“We are ready to sign something,” Miller continued. “We don’t want to spend all summer working on this, we want to get something signed tonight.”

Bicandi asked the rodeo members if they had any other concerns with the agreement. Kent Curtis said the rodeo board had not yet been informed of the decision made by the American Legion during a meeting they had held the previous night. American Legion Post Commander Jake Pierce told the group that the legion members had voted to retain the exclusive right to sell beer and due to past hard feelings, they would not commit to an agreement with the rodeo board.

“As it stands right now, they do not want to have any dealings with the rodeo board because of ill feelings,” Pierce said. “I am not a voting member of the legion. I think what would be best is if the rodeo board approached the legion board and talked to them. I don’t have a problem with it and I think it is a good deal, but you guys are trying to sell the wrong person. It is the board that will have to decide.”

Pierce said he would attempt to hold another meeting of its members so the rodeo board

could approach them. The meeting was planned for tonight (Wednesday).

The proposal the rodeo board offered the Legion was to guarantee the Legion would receive the difference between this year’s beer sales and last year’s sales from the rodeo board. Bicandi said the Legion could sell beer before and during the rodeo and the rodeo board would keep its sale to during rodeo times and in their own beer garden near the rodeo grounds. Bicandi said the rodeo board would sign an agreement with the Legion guaranteeing them the offer.

“This is a win win situation,” Bicandi said. “They will each have their own licenses and they will be guaranteed the same income as they had last year. I am surprised they rejected it. I can’t see why they rejected it.”


“There are some hard feelings there,” Pierce said. “I don’t have any, but the board does.”

“The problem is Jake, you can’t let the past get in the way of having a productive affair,” Bicandi said. “We need to work together. A house divided will not stand. We can’t change the past. Being resistant and not trying to cooperate is not going to change that.

“The fair board gave, back in November, the exclusive rights to the Legion. Now the fair board has come to the Legion asking them to please help us with an answer to this problem and to be a part of the solution. The rodeo board I think has come down and said ok we are willing to work with the legion. They want to make sure the legion is whole and I hate to see the legion cut their nose off despite their face.”

The agreement offered to the rodeo board from the fair board states in paragraph two that “user shall have the right and responsibility to decide which vendors will be authorized to sell concessions in the grandstands during the evening hours of each performance and entitled to any fees from doing so.” But paragraph three states that the “American Legion Post #32 holds exclusive rights to

BLM considers “Working Landscape” policy changes

State director to host “listening” meetings

Bureau of Land Management State Director K Lynn Bennett announced last week that several “listening” meetings will be held in Idaho later this month to “learn people’s views about potential policies that could promote innovative partnerships and increase flexibility in managing livestock grazing on public (federal) lands.”

The meetings are in conjunction with many changes the BLM is considering to grazing policies and regulations as announced by BLM Director Kathleen

Clarke last month. This month’s meetings are being held to discuss policy concepts the BLM is considering as part of its “sustaining working landscapes.” Initiative.

The listening meetings will be held in Salmon, Burley and in Boise.

“By ‘working landscapes,’ the BLM means landscapes on the public lands that are both economically productive and environmentally healthy,” Barry Rose stated in a statement released last week. “The policy concepts are intended to promote citizen-based stewardship by providing more options for

resource managers, ranchers, conservationists, and others to work together to achieve healthier Western rangelands.”

“The Bureau of Land Management is considering some important policy concepts, but we consider this a first draft,” Bennett said. “We want to encourage people’s thoughts and ideas to help us prepare the best policies for improving the management and health of public lands.”

The listening meetings will be held from 4:00 p.m. until 8:00 p.m. at the following locations:

April 22 in Salmon at the

Public Lands Center (BLM/ Forest Service Office), located at 50 Highway 93 South, April 23 in Burley at the Best Western Burley Inn, located at 800 N. Overland Avenue and on April 24 in Boise at the Idaho BLM State Office, located at 1387 S. Vinnell Way.

The meetings will be conducted as open houses, which allow people to participate at their convenience. The public can arrive at anytime during the open house to learn about and discuss the policy concepts with BLM staff.

“These potential policy

changes would complement various grazing regulatory changes that the BLM is already considering,” said Bennett. “The Sustaining Working Landscapes Initiative encompasses a variety of ideas to improve the BLM’s grazing management program. Some ideas would require changes in grazing regulations while other ideas may be authorized through changes in policy. The potential changes in regulations and policies are related, and all are intended to enhance the BLM’s management of grazing as part of sustainable working landscapes in the 21st century”

The policy concepts being considered are:

Reserve Common Allotments — Reserve Common Allotments would represent a new type of grazing unit. These allotments would be created with ranchers cooperatively and voluntarily to promote healthier grazing lands and to help ranchers who temporarily cannot use their permits for various reasons. Grazing permittees could use these reserve allotments for livestock forage while their regular allotments undergo range improvement. Existing regulations, however, would limit implementation of this concept for use by the BLM, individuals, livestock grazing associations, and non-profit third parties. As a result, the BLM is considering rules changes that would overcome current limits on action, thus enhancing the ability of the Bureau and its partners to promote sustainable rangelands and sustainable ranching.

Conservation Partnerships — A Conservation Partnership would enable a grazing permit holder, on a strictly voluntary basis, to enter into a performance-based contract with the BLM aimed at promoting environmental health. Performance-based actions would include those that help restore stream banks and wetlands, enhance the quality and quantity of water flow, improve wildlife or fisheries habitat, and support the recovery of species listed

as threatened or endangered. In return, the grazing permittee would be eligible for such things as stewardship grants, management flexibility within certain prescribed limits, and the potential for increased livestock grazing made possible by successes in conservation efforts.

Voluntary Allotment Restructuring — Voluntary Allotment Restructuring would merge the grazing allotments of two permittees. One of the permittees temporarily would not graze, while the other would graze his or her herd over the newly combined area. The net result would be lighter grazing use over the entire area, thus improving range conditions while sustaining a working landscape.

Conservation Easements — Conservation easements involve obtaining voluntary land-use restrictions. Under this exchange system, the BLM would offer grazing permittees the opportunity to acquire lands already identified for “disposal” through the BLM’s land-use planning process; in return, permittees would place conservation easements on their adjacent private land. The aim would be to preserve open space and better manage landscapes and watersheds. The BLM is also examining the concept of acquiring conservation easements with funds that could potentially be

made available from land-disposal revenues.

Endangered Species Act Mitigation — Conservation Partnerships, RCAs, restructured allotments and conservation easements all provide options to mitigate affects to listed species

resulting from livestock grazing. For example, Conservation Partnerships could be used to restore rangelands, which benefit listed species. Also, RCAs are intended to be grazed intermittently, and then only to the extent consistent with

sustaining their long-term conservation objective.



Moving? tips for taking your kitchen along

Dear Betty,
We're moving to another city when school's out, and I was wondering if you have any tips for packing the food in my kitchen?
McAllen, Texas

Whether you're moving cross-country or across town, your kitchen can be one of the biggest packing jobs. These tips can make your food move easier:

Find out which food items your mover will or won't move.
Take a look at what's in your pantry about one month before your move. Plan your meals accordingly to use up as much as possible.

Give away or toss anything that will spill or spoil.
Be sure all bottles, jars and packages are tightly sealed. Pack these and canned items in small, sturdy boxes, keeping the weight of each box to less than 50 pounds.

Now about the fridge and freezer, most movers won't handle perishable items. So take stock of what you have on-hand and start thinking about how to whittle it down. Here are some ideas to get you started:

Have a going-away party. All that hamburger in the freezer would make super Sloppy Joes or burgers on the grill. Lots of frozen chicken breasts? Grill them and serve chicken Caesar salads.

Give it away. Those thick, juicy steaks you've been saving would make a nice parting gift for your next-door neighbors. Check with local food shelves or feeding programs to see if they can take frozen foods or fresh staples such as potatoes and onions.

Have a clean-out-the-fridge night or two. Let your family create a buffet with a wide array of leftover perishable items from the fridge or freezer. See who can come up with the most clever and tasty concoction.

Dear Betty,
I'm trying to watch our budget more closely. When buying fruits and vegetables, can you tell me what is the best buy fresh, frozen or canned?
Shepherd, Mich.

Your question is a little more complicated than it seems. Determining the value of fruits and vegetables is a blend of price, quality and how you're going to use them. In general, when fresh fruits and vegetables are

in season, they're a good buy but be sure to use them before they spoil. The price of both canned and frozen fruits and vegetables tend to be more consistent than fresh.

My research staff says frozen vegetables are comparable in quality if not better than fresh because freezing locks in their nutrients instantly. Using canned or frozen vegetables in a recipe may not only be more economical, but also a timesaver.

Puri's resignation saying, "I move we accept the mayor's resignation. I spoke to Harold. That is his decision and I will honor his decision." The resignation was approved by a unanimous vote.

"I feel this is a very important meeting and we need the full council to make this decision," Barlow said after the meeting. "He had a scheduled ball game and he wasn't notified until yesterday and the schedule was already written out. I was notified Monday night and again yesterday (Tuesday). Why Charlie was not called I don't know. That is why I did that. We are a council and we need to vote as a council, not as a three member council, but as a four member council."

Barlow said he has someone in mind for the position, but he declined to name the person of interest saying, "there [are] just some things going through my head right now and we need to be as a full council. We need to be a full council and as a full council I think we can make the right decisions."

Freelove said everyone was notified within the required 24-hours. He said he too has a person in mind for the nomination but said he would not say who that person was.

"It was Kevin Barlow's wish that Charlie had to be here for the interim mayor nomination so we will try to take care of the matter during next week's regular meeting," Freelove explained after the meeting.

"As of right now we do not have a mayor," Dugger said Thursday. "The statute says the president of the council can fill in during the course of a temporary absence, but this is a permanent absence. We did not actually convene until four minutes after eight. Between seven o'clock and four minutes after eight, each time the president of the council who is chairing the meeting, said we were in fact going to convene, councilman Barlow would remove himself from council chambers."

Dugger said several issues are pending in the city that need the attention of a mayor, including a meeting scheduled with the county commissioners on Monday to attempt and resolve a monetary issue of removing hazardous waste materials from the Homedale Airport. She said Mike Murray from HDR would be attending that meeting and as of Wednesday night's meeting only one, maybe two, of the council would also be attending the meeting. Freelove committed attending and Duryee expressed that he

would attempt to attend as well.

The city was notified last month that they have 30 days to submit a plan and schedule to remove and dispose a contaminated soil, which could cost the city nearly \$60,000. The city currently has approximately \$6,000 left in an account DEQ made available to the city.

The appointment of an interim mayor will be addressed during today's council meeting, which begins at 7 p.m.

3,000 acres in Snake River Valley under Opaline project

The 1953 Opaline field day next Wednesday, April 15, will mark the beginning of a new era of irrigated agriculture for a 3,000 acre area in that section of Owyhee country, Arlie L. Parkins of Marsing, general chairman, said this week. The spectacle of the 1953 day will be nearly a quarter million dollars worth of farm equipment that will turn 80 acres of sagebrush range into a modern irrigated farm. The 80 acre tract is seven miles southeast of Marsing on the highway to Murphy. Snake River and Boise Valley residents are invited to the field day. The daylong program will begin at 8:30 a.m. The 80 acres that will be cleared of brush, leveled, plowed, worked up, seeded, ditched and irrigated belong to 28 year old World War II veteran, Nolan Prescott. Water flowered in the canals of the Opaline irrigation district this week for the first time, climaxing more than 30 years of planning and a year of construction. The pump, 8 miles southeast of Marsing, was turned on Monday, April 6, and irrigation district officials began checking the 10 mile canal system.

School reorganization proposal is approved

The proposal to reorganize the Homedale school district into a Class A district at Homedale has been approved by both the Canyon and Owyhee county school reorganization boards and is now before the state committee where approval is expected this week. If approval is given by the state committee, elections will be held in the two districts to determine whether or not the reorganization will be effected. The Central Cove school boards held meeting with both the Wilder and Homedale boards at separate times last week and decided to consolidate with the Homedale district. The more was approved by the Canyon county board last Monday evening and by the Owyhee county board Tuesday evening. Central Cove has an assessed valuation of approximately \$190,000 which would increase the valuation of the new district by that amount. Central cove has no bonded indebtedness but would assume its share of the indebtedness of the present Homedale district. At present several high school students from the Central Cove community are attending school at Homedale as tuition students. Under the reorganization plan, the Central Cove school would be abandoned and all pupils would attend school in Homedale.

Owyhee lands may be revalued

A public meeting will be held at the courthouse in Murphy on May 12 to discuss plans for re-evaluating and reclassifying property in Owyhee County, Manford Logan, county commissioner, said this week. The meeting has been called by Owyhee County Planning Board and all persons interested are welcome to attend the meeting. The plan would entail the spending of approximately \$16,000 over the course of some three years to completely reclassify all the property within the county.

135 years ago

April 11, 1868

THE MILITARY. We were misinformed last week in relation to the number of soldiers who came over from Fort Boise. Instead of fifty, as we stated, the total number was ninety-five, seventy-five from Co. “B”, 23rd Infantry, and 20 from Co. “D”, 8th Cavalry, under command of Brevet-Colonel James B. Sinclair and 1st Lieutenant Chas. Bird, 23rd Infantry. Colonel Sinclair has our thanks for this information. The command arrived in town last Saturday morning, and took up their quarters in Brigham and Weeks large Hall. The Company divided into messes and cooked their food by campfires outdoors, the Colonel and his officers partaking of the same fare as the private soldiers. The lively notes of the bugle and the beating of the drum gave our bustling mining town quite a martial air, while the saucy little brass 12-pounder, termed by the Colonel his pocket-piece, and the bright muskets and bayonets in the bands of sturdy men, conveyed the impressions in a very forcible manner that Uncle Sam is able to assert and maintain his authority. Col. Sinclair is proud of his men, and well he may be; they are all young, none of them probably more than thirty years of age, and are a quiet orderly and noble looking set of fellows. They dress in full uniform, including the hat and feather. We can truly say of these men what cannot often be said of a company of soldiers, that during their sojourn here not one of them was known to be intoxicated, a fact worthy of note and a great credit to them selves as well as their commander. A majority of them are Danes and Swedes, large, powerful men, inured to hardships, many of them having been all through the late war. Col. Sinclair is a gentlemen in every sense of the term, and his men show a great attachment for him. Affable and courteous, he is respected and esteemed by all who are favored with his acquaintance. Lieut. Bird is also a gentlemen of estimable qualities and a true soldier. As all our recent troubles had quieted down and no signs of disturbance were manifest, the military took their departure for Fort Boise again on Wednesday morning, leaving behind them a very favorable impression. While we regret the circumstances that brought them here and hope that the like may never occur again, it is gratifying to know that such assistance can be obtained when necessity demands. MOVING. Our readers will excuse us for lack of interesting local matters this week when they understand that we have been moving our material into a new office, corner of Clinton and Second Streets. Moving is no small job and leaves things topsy-turvy for a while. We will soon get things arranged, then we will be all right again. THE WEATHER. It rained at intervals yesterday and the day before. The snow is fast disappearing and but little now remains in our streets. The roads are muddy, but in a few days will be in a good condition. Mails arrive and depart regularly every day. FROM CAMP LYON. A mail carrier from Camp Lyon informs us that Mr. Bebee, scout, with six soldiers, three packers and seven Indians have started out on a tour of observation. We understand they will proceed to the mouth of the Owyhee and search the county along the river up as far as Lockwood and Cable’s Ferry. If there be any hostile Indians in that vicinity “Old Bebee” and the scout will take care of them. PARTNERSHIP. Messrs A.H. Webb and A.V. Bradly have formed a partnership in the Book and Stationery trade. They are doing business in the Post office building, next door below Webb and Wyrick’s Bank.

The wonders of politics

It was amazing to me to attend two, what I considered to be, very important meetings that could have a predominately huge impact on the future of the City of Homedale and the county last week and to find how so many people were more interested in who will be allowed to sell beer at the annual fair and rodeo, than who would be the governing father of the City of Homedale.

During a council meeting last week the future of the next mayor was unexpectedly put into the hands of four council members after the resignation of Mayor Harold Puri. One of which could not get out of umpiring a baseball game to attend the specially called meeting, one refused to give his presence in council chambers until the other arrived and two who seemed to just want to get on with it.

Those sitting in the audience, including myself, were a former mayor, former councilwoman, a spectator, the assistant city clerk who operates the tape machine and the chief of police. Now one must wonder, why would a former mayor and city councilperson be the only ones interested in the next mayor?

But during the next night's fair board meeting, members of several of the city and county's service clubs attended to a standing room only get-together to see who would have exclusive rights to sell beer during our annual fair and rodeo. Baffling.

Obviously both meetings were of great interest to me, due to no matter who gets to run the city or who gets to sell beer, both would give me news articles. But to see that it is more important to find out who can sell beer, than who would operate a city that spends hundreds of thousands of tax payers money was a mystery to me.

During the fair board meeting two additional service clubs attending asking for exclusive rights to sell their product during the fair and rodeo, which is held in August. The point of both being, since the fair board has chosen that no one, excluding the American Legion, can have exclusive rights, the groups' largest fundraising events have now nearly become their smallest. But the answer to the question as to why one group can have exclusive rights and the other can not, from the president of the fair board, was; "because beer is not considered a concession. It falls into a completely different category. It requires licenses and other things that make it different."

The basic response of the fair board was at this point to assist the two service clubs in finding a product that no one else may be selling during this year's fair and rodeo. But the final answer boils down to "no" they will not be allowed to have exclusive rights to sell a particular product during the event.

Under the Idaho State Code Section 22-204, which the fair board most frequently quotes, it states: "It (County Fair Board) shall take charge of and manage all such property as the county may have acquired or set aside for fair purposes pursuant to the provisions of section 31-822, Idaho Code.

"It may recommend to the board of county commissioners that such board purchase such real and personal property as may be needed for fair purposes. It shall have power to employ labor, award prizes, make exhibition contracts, fix and charge admission and entrance fees,

let contracts for concessions or services to be conducted at the fair or under the direction of the county fair board, but if any concession or service is to extend for a period of less than twelve (12) days in a calendar year, the concession or service may be awarded without bid, and do all other things necessary for holding county fairs. It shall fix the salaries of the secretary and treasurer and prescribe the time and manner of payment."

In the Merriam-Webster Dictionary the word "concession" is defined as: "1. the act or an instance of conceding, admitting of a point claimed in argument. 2. Something conceded, acknowledgement, admission grant. A grant of land or property especially by a government in return for services or for a particular use, a right to undertake and profit by a specified activity, a lease of a portion of premises for a particular purpose; also: the portion leased or the activities carried on."

If someone else is able to find a list of what a "concession" is, I have not been able to find it. So it again comes down to the decision being at the discretion of the members of the fair board, which I must add, seems to be coming down to a four to three vote, but a vote was not taken by the current board to accept a five year lease agreement to allow the American Legion the exclusive right to sell a "concession" during the fair and rodeo.

If I am reading the Merriam-Webster Dictionary correctly, a concession is not particularly a product, but a place to sell a product.

That is my view.
