## Grand View cowboy injured at Roundup

A Grand View cowboy was taken to a local hospital by air ambulance Sunday after he was injured when he was bucked off of a bronc at the Bruneau Roundup.

Kevin Bacon was riding "Bin Laden" when he was bucked off seconds into his ride.

Witnesses said they feared the worst when Bacon hit the ground, but Monday a rodeo spokesman said Bacon received several broken bones, but was released from the hospital Monday.

Results of the rodeo were not available at press time.

## County budgets to bring voting system into compliance

The county commissioners raised its election budget by nearly \$10,000 to accommodate a nation wide "Help America Vote Act" passed by congress in 2002. The act requires states to be in compliance with voting reforms to the nation's elections process in order to address problems with voting systems and voter access that were discovered following the 2000 presidential campaign.

County Clerk Charlotte Sherburn said last week that the elections budget, "an under-funded budget anyway," was raised because the

county does not know what it will cost to bring its voting systems into compliance.

HAVA requires state and local governments to create and maintain a single, uniform, centralized voter registration system, provide information to voters on how to correct their ballots and request replacement ballots, improve access, privacy and independence for voters with disabilities and provide a formal procedure for complaints about state

and county compliance with the act.

Idaho Secretary of State Ben Ysursa announced in April that a draft Idaho plan had been released after receiving comments from state and county elections officials, legislators and representatives of advocacy and interest groups. To comply with HAVA, Idaho proposed to provide electronic voting devices to increase independence, privacy and access for people with disabilities. The devices will be available in all of the

more than 900 election precincts.

Ysursa said Idaho plans to create a centralized voter registration system maintained by the state. He said in April that it would speed updating information for voters who change registration close to an election. The public was invited to submit input to the Secretary of State's office by May 30.

"We don't know what it will cost us to comply," Sherburn said. "There is a lot of federal monies in the program, but the state does not have

# Givens replaces roof on historic hot springs facility

The roof at Givens Hot Springs, recently damaged by a wind micro-burst, has been removed in preparation for installing a new one. For the first time in 50 years, and for a brief time before the new roof blocks the view, a visitor can enjoy an unobstructed overhead observation of fluffy clouds and trumpet-vine covered trees by day, and a star-studded sky by night, while basking in the warmth of the hot spring pool.

Owner Nadine Givens said "People tell me, 'I remember coming here as a child,' often from people in their eighties and nineties. This event is an opportunity for today's young parents to tell their (great) grandchildren, 'I remember going out to Givens when the roof was off.'"

Givens said the pool will be open throughout the remodel. She said almost everyone who has come in since we took off the roof has loved having it open; most encouraging us to leave it that way.

"We do plan to have a translucent sky-light to let in more light, however, probably along the top edge," Givens said. "We expect many will want to come watch the progress, as they did when we first took it over and remodeled 12 years ago."

Built in 1952, the current pool-house replaced a smaller version built by Oregon Trail pioneers Milford and Mattie Givens and sons in 1906. Homesteaded in 1881 by the Givens family, Givens Hot Springs and it's amenities have provided entertainment and therapy for six or more generations of area residents, as well as travelers from all 50 states and numerous foreign countries.

Givens Hot Springs is an Idaho State Historical site. Long a campsite for nomadic Indian tribes, the springs became an inviting stopover point for Oregon-bound pioneers. During it's development in the late 1800's and early 1900's, Silver City miners were frequent visitors, spending a week at a time soaking their arthritic bodies in it's therapeutic waters. Over the years Givens, with its extensive park areas, has hosted everything from

political rallies and family reunions to company picnics and school field trips.

Givens will continue to operate regular days and hours, noon to 10 p.m. Monday through Sunday, while the roof is being replaced. Enclosed dressing rooms make changing more comfortable on nippy days until the new roof is completed. # Big Loop rodeo action begins Friday

Farm and ranch supporters from surrounding states will gather in Jordan Valley this weekend to support the fifth annual Jordan Valley Big Loop Ride and Rodeo. Funds gathered by the event are used to support Owyhee and Malheur County Cattlemen's Associations legal defense funds. After five years, the group has raised over \$100,000 to assist in the ongoing battle between farmers, ranchers, and environmentalist groups.

The event is a stock dog field trial, muley cattle, horse roping, and buckaroo bronc riding competition. Contestants who enter this event donate a percentage of their entry fees to the Stewards of the Range legal defense fund. The rest of the entries are paid out as prizes.

The Event starts Friday the 26<sup>th</sup> at 9 am in the Jordan Valley rodeo arena with the cow dog trials. Rodeo coordinator Doug Burgess said last week that prize money, buckles and donated items will be given to the winners of the event. Burgess said sign-ups for the event will continue until the morning of the event. To enter contact Craig Christianson at 208-845-2055.

The cow dog trials, not to be confused with the sheep dog trials, will feature some of the top cow dogs in the area. Burgess said some of the dogs will be sold at the Red Bluff, California a premiere dog sale later this year.

"There will be a dog at this trial owned by Roger Urelcqui who took a dog back to a national trial and won \$10,000 first prize," Burgess said. "You

aren't going to see just mutts, you will see some very well trained quality dogs." The finals for the top ten dogs is Saturday at 9 a.m.

The ranch style bronc riding will follow the finals at Noon with the muley roping event following. The stock saddle bronc-riding event will begin at noon on Saturday with a \$500 added purse.

Muley roping will follow at 2:30 p.m. Contestants may enter four times in Latigo or Mule hide horn wrap only event. No PRCA cardholders will be allowed to rope together.

There will be a tri-tip beef BBQ all day Saturday and Sunday. Burgess said the fee for the "best tri-tip sandwich you will eat" will be minimal and additional concession stands will be available.

On Sunday, the last chance horse and muley roping contest will be held. Contestants will sign up at 9 a.m. for two horses, two steers. The roping will begin at 10 a.m. The stock is donated by Agri Beef in Boise and the range horses are provided by Wally Blossom of Nevada.

Tickets for the annual four-wheeler drawing will be held on Sunday and ticket will continue to be sold during the event. Tickets will be sold for \$5 each or five for \$20. The Jordan Valley Big Loop Rodeo Board puts on the event.

Big View Builders has applied to subdivide a 2.76 acre section of property on Main Street east of the senior citizen apartment complex, Homedale Garden Apartments, into five parcels.

The notice also states that the planning and zoning commission will also rehear

an application for special use permit to build four-four-plexes on the same property.

P and Z Administrator Silvia Bahem said the company needs to be reheard on the application for special use because the city council would not address the application until the subdivision application was addressed.

## Carlson challenges in mayoral race

A Marsing man says he may not have any experience in politics, but said he feels he could be a strong voice for Marsing residents and is asking voters to elect him on November 4.

Dan Carlson is a Vietnam vet and was a photographer for the navy. He said he has owned a business so he does have budgeting background. Currently he works extensively with the Marsing Resource Center.

Carlson has lived in Marsing since 1987, but has spent much of his life in Idaho. He said he was instrumental in the beginning stages of the Migrant Resource Center in Nampa. He said he helped start the photo lab section of the center. Currently he is has spent much of his life involved in community service and enjoys helping children.

Carlson has entered the political ring several time in past years running for city council but has not been elected.

"I stopped running for a few years because I was doing some mining in the mountains," Carlson said. "I figured if I couldn't devote my time to it I

would not run. Once you take an office, you have the responsibility to be there when the people need you. I believe the mayor is to service the community. I don't believe that a mayor should go in telling everyone what they are going to do. I believe we are not here for our own benefit, we are here for the people of the city."

Carlson said he advised former mayor Jenny Haken concerning the city's water issues.

"Jenny and I talked about getting away from chlorine," Carlson said. "We used the same system in Vietnam. So I do know some about it already."

"I told Jenny that anything we can do to get away from chlorine we needed to do. Chlorine is a deadly poison and we drink it everyday. We don't want to use things that are bad for us."

Carlson said he is asking voters to elect him because he knows as mayor he can only recommend issues. He said the council is the ruling party. But he said as mayor, strong recommendations as a voice for the citizens is what he has to offer.

## Elementary librarian seeks council seat

Marsing Elementary School librarian Paula Enrico has joined three others in announcing her intentions to seek one of two open council seats with the City of Marsing in the November election.

Enrico has worked with the school district for 14 years and she has been a commissioner for the city planning and zoning for nearly a year.

"I think I can make a difference," Enrico said. "I want to go in there and do what is right for the people. I think I can make a difference. I want to go in there and do what is right for the people not just because I think it needs to be done, but because it is what the people want me to do. I know you can't make everyone happy all of the time, but I feel I can go in with an open mind."

Enrico said she is active in the community and hears the concerns of the people of Marsing. She said she has raised three children in Marsing.

"I know we have a dog problem in this area and we have problems with how the city looks," Enrico said. "We have sewer problems and actually we have a lot of problems."

Enrico said she doesn't really have any goals because she does not want to go into office making promises.

"You are just one person and you work with a group of people," Enrico said. "You can't go in saying you are going to do all of these things, because you just don't know. But I can be a voice. I will have to learn as I go and I just feel I can help make a difference."

## Former city employee runs for mayor

Former city employee Bud Peck says the City of Marsing has water and sewer issues, which he feels he has the knowledge to address, if he is elected as the city's next mayor.

Peck has lived in Marsing for 10 years and worked for the city for five years on its maintenance crew. He retired in 2000.

"I am certified in water and waste water," Peck said in a statement released last week. "Having worked for the city, I am familiar with the infrastructure of the water and waste water."

Peck said since he retired he has attended seminars put on by SWIAS. "Many of these

have been on the present and future laws passed by the legislation on water and the newest one on waste water," Peck continued. "I would like to be involved when laws come into affect. I look forward to working with the city council on the situations that come before the city. I feel there will be a need for more water storage and possibly more water. I feel it is very important to work with the state and federal agencies."

Peck will join current mayor Faye Pfrimmer, Dan Carlson and Carol Edwards on the ballot on Nov. 4.

## County to receive alien assistance funds

State and local law enforcement agencies will be reimbursed for the costs of holding, transporting and deporting criminal illegal aliens.

About \$600,000 will be given under State Criminal Alien Assistance Program administered by the Department of Justice.

Criminal illegal aliens are defined by Federal officials as, "illegal aliens convicted of one felony or two misdemeanor offenses."

Funding is based on the number of illegal aliens held for 72 consecutive hours or more. The money doesn't have to be used for correctional purposes and can go to state or county general funds.

About \$336,841 will be awarded to statewide agencies while a number of counties will receive their own funds.

Those counties include: Ada, Adams, Bannock, Bingham, Blaine, Bonneville, Canyon, Cassia, Elmore, Gooding, Jefferson, Latah, Madison, Owyhee, Power, Teton, Twin Falls and Washington.

much and there may be county matches to state funds. That is why we put the extra money in the budget.”

Sherburn said she expects the county will continue to place funds into the budget next year so the county can be in compliance by a 2006 deadline.

“We have to have a machine in each precinct in which a person that is legally blind can come in and vote,” Sherburn said. “We don’t have that anywhere yet. We have to have a ramp with hand rails at every voting precinct in the county so anyone in a wheel chair can vote.”

Sherburn said there are 11 voting precincts in the county. She said some of the precincts might be discontinued if current legislation is approved.

“They are trying to get legislation through that there has to be at least 110 people in a precinct or the precinct would be an absentee precinct,” Sherburn explained. “I am not sure that will be done in time.

“That budget has been under-funded for many years that is also why it has been increased. I increased election supplies from \$3,500 last year to \$6,000 this fiscal year. Other expenses in the election budget were raised from \$10,100 to \$26,500. This year’s total election budget approved last month is \$28,200.”

Two precincts will need to be upgraded. Riddle and Three Creek precincts will need wheelchair ramps and hand rails if they are not discontinued by legislation which Sherburn said may not happen before the HAVA deadline. She said in the primary last year 16 people cast ballots in Three Creek and 14 voted in Riddle.

Big news in Helena during rodeo week. The animal rights group PETA was prevented from putting anti-rodeo billboards up in the city. It turns out the owner of the billboard company thought the poster was too risqué. Actually, I thought part of the poster was funny. It had a seductive model laying on a bed of straw with the caption: “Nobody likes an eight second ride.”

But PETA had also added a crude play on words that justifies its rejection. PETA is known for its vulgarity and insensitive ads, activities and pronouncements such as comparing slaughtered chickens to the holocaust, butchering hogs to Jeffrey Dahmer the child killer cannibal, and stating it would be a good thing if American animals contracted foot and mouth disease.

Some of their ad campaigns also bordered on a sort of a loopy cleverness with promotions such as “Drink beer, not milk”, and “Jesus was a vegetarian.” But they don’t quite know when to stop.

## Editor’s notebook



### Destroying public trust

Every so often this newspaper receives a call from a disgruntled citizen telling us about something of which some local governmental board is doing illegally. Sometimes there is no basis for the complaint; often times there is.

The majority of the calls are in reference to violations of the state’s Open Meeting Law. We would like to believe that, when there is a violation, it is the result of ignorance of the law. Sometimes that’s the case, oftentimes not.

The common expression “ignorance of the law is no excuse” especially holds true when referring to public officials. They are offered training in the law through workshops; they have access to state attorneys and state associations for advice. Most – but not all – local governments retain attorneys to offer advice on legal matters.

As a reminder to local officials and as information to the public, here’s a brief outline of the law:

Any instance where two or more members of a governing body discuss any matter regarding that public agency, it is considered a meeting of that body, and falls within the purview of the Open Meeting Law.

**Notice of meetings:** A public agency which holds meetings at regular intervals at least once a month must give public notice of its meeting dates at least once a year. Other regular meetings require a five-day notice. Agendas of all meetings must be posted at least 48 hours prior to each meeting. Additional items may be added to the agenda up to the meeting time, with certain restrictions.

**Special meetings:** These meetings require at least a 24-hour meeting and agenda notice, with exceptions for certain emergencies. (News media are to be notified of all meetings, if requested.)

**Executive sessions only:** Here again, these meetings require at least a 24-hour meeting and agenda notice.

**Executive sessions within a regular or special meeting:** Idaho’s open meeting law allows executive sessions to be held under certain conditions. First, the board must vote to go into executive session, and the individual vote to do so must be recorded in the minutes of the meeting. Executive sessions can be

held during (not before or after) any legally-held meeting. The presiding officer must identify the authorization for the holding of the executive session.

Such authorizations are inclusively:

(a) To consider hiring a public officer, employee, staff member or individual agent. This paragraph does not apply to filling a vacancy in an elective office;

(b) To consider the evaluation, dismissal or disciplining of, or to hear complaints or charges brought against, a public officer, employee, staff member or individual agent, or public school student;

(c) To conduct deliberations concerning labor negotiations or to acquire an interest in real property which is not owned by a public agency;

(d) To consider records that are exempt from disclosure as provided in chapter 3, title 9, Idaho Code;

(e) To consider preliminary negotiations involving matters of trade or commerce in which the governing body is in competition with governing bodies in other states or nations;

(f) To consider and advise its legal representatives in pending litigation or where there is a general public awareness of probable litigation;

(g) By the commission of pardons and parole, as provided by law;

(h) By the sexual offender classification board, as provided by chapter 83, title 18, Idaho Code;

(i) By the custody review board of the Idaho department of juvenile corrections, as provided by law.

(2) Labor negotiations may be conducted in executive session if either side requests closed meetings. Notwithstanding the provisions of section 67-2343, Idaho Code, subsequent sessions of the negotiations may continue without further public notice.

(3) No executive session may be held for the purpose of taking any final action or making any final decision.

When government operates in secrecy, the law is broken. And when public officials violate the law that governs them, public trust is destroyed.

## Not important ... *but possibly of interest* Stuff happens



Two weeks ago, the nation paused again to remember that September 11, 2001 when the rules changed.

It is right to remember the folks who died that day, although I do believe the best way to honor them go on with our lives as normally as possibly—not giving the terrorists the satisfaction of seeing our country stumble.

This year, however there was a news item that, in my opinion, tarnished the 9-11 anniversary.

A few days before September 11, a judge had ruled the relatives of some of the victims of the terror attack could sue for damages. That wasn't the surprise. What stunned me was WHO they were suing—two of the prime defendants being the airlines who operated the aircraft that flew into the buildings, and Boeing, the company that built the planes.

The lawsuit contends Boeing and the airlines are partially responsible for the deaths—that they should have taken precautions to make sure it couldn't happen. Such a claim, in my opinion is absurd. How could the airlines or Boeing prepare for such a situation? If such a claim has merit, it would make sense for the airlines to sue the families of the passengers who died, contending that if they hadn't purchased tickets the flights would have never left the airports and the attacks would never have occurred.

The lawsuit classically demonstrates one of the major problems with modern American society. Attorneys and sociologists want us to believe we are a nation of victims. If something bad happens to us, it is someone else's fault, preferably a large company with deep pockets. If the trend continues, it will eventually destroy us.

There is a saying used by the military and police to explain things that happen that shouldn't happen. They shrug and say. "Stuff Happens" (actually I cleaned it up a little). A more sophisticated way of putting it is "life is what happens to us while we are making other plans."

A spokesperson for the families that are suing says "it's not about the money,"—it's to make sure it can't happen again. I don't buy that. If that is the case, they should be suing the terrorist organizations and the rogue countries that finance and harbor such groups. They, not the airlines or Boeing, are responsible for the deaths of more than 3,000 people. And they are the ones who should be held accountable.

Right after 9-11, an oft-heard phrase was that the attack "changed America forever." The lawsuit is proof that we haven't changed—we're still trying to blame "stuff" that happens on somebody who can pay. The lawsuit is an insult to those who died on the September day two years ago.

### Lawsuit could shut down Idaho agriculture

Take a little extra time to appreciate a fresh Idaho potato, onion, or ear of sweet corn this fall. If a group of radical environmentalists have their way, the farmer's market down on the corner won't be open for business next year. And neither will hundreds of other Idaho businesses.

If these extremists follow through on a threat to sue the federal government to halt delivery of irrigation water in 2004 and win in court, it will make the 2001 raid on Klamath Basin irrigation water seem as dull as white rice.

Four environmental groups, the Idaho Conservation League, Idaho Rivers United, American Rivers and the National Wildlife Federation, filed a 60-day notice of intent to sue the Bureau of Reclamation and the National Marine Fisheries Service on August 22. Their claim is the government isn't providing enough water to sustain downstream salmon and steelhead and they believe language in the Endangered Species Act supports their position.

We don't make a habit of forecasting gloom and doom, but it's beyond paramount that Idaho residents understand this threat. First, accept that the Endangered Species Act is a sledgehammer custom made to beat rural America into submission. ESA reform has been past due since the spotted owl took thousands of Northwest jobs. Congress has failed to fix the ESA while honest, hard working families suffer.

Second, and in spite of the fact that the federal government gave incentives for people to move west, homestead land and develop water, recent court rulings have favored endangered species over irrigators. In 2001 the government took irrigation water from hundreds of Klamath Basin farms and dried up 200,000 acres of farmland.

Third, in May of this year U.S. District Court Judge James Redden ruled that the government's plan for managing salmon on the lower Snake and Columbia rivers was too narrowly defined. That ruling invalidates federal dam management plans on the lower Snake and Columbia rivers and this coalition of radial environmental groups has made it the centerpiece of their deceitful plans. Because of the Oregon ruling, they say the government has to re-evaluate upper Snake River management plans.

In June the 10th Circuit Court of Appeals in Denver sent another strong message to rural America, ruling in a New Mexico case that the Bureau of Reclamation has the power to take water earmarked for cities and farms to help the silvery minnow.

Although spokesmen for these groups that would cripple Idaho's economy are now saying they are just trying to start a dialogue about salmon, don't think for a minute they care about your job or your family. If the courts rule in their favor, Idaho residents who currently work on farms, for irrigation supply and canal companies, seed, fertilizer and equipment dealerships, banks, fuel distributors, food processing plants, and dozens of other industries will be out of work. Directly or indirectly, it has the potential to affect every Idaho family and it could send this state's economy into a tailspin not felt since the 1930s.

## Summary judgement Fiddling while Montana burns

Rains fell last week in parts of Montana giving firefighters a respite and Montana residents hope that the terrible fires that have dominated the news and the forest lands in Montana may have seen their worst and now may be brought under control. But the danger will not be over until snows begin later this month. Then Montana residents concerned about forest health will be able to turn their attention to Washington, D.C. and attempt to figure out why a lawsuit they filed three years ago has yet to receive a federal court's attention.

In October 1999, shortly after President Clinton decided to close 60 million acres of national forests, ostensibly to protect pristine roadless areas, which are neither pristine nor roadless, the people of northwestern Montana learned how that decision would impact them. For decades, Lincoln County residents worked as loggers and miners. But years of litigation by environmental groups and adverse rulings by Clinton officials killed most of those jobs. So, the community began working to develop a ski hill near Libby. Because nearly eighty percent of the land in Lincoln County is federally owned, permission of the U.S. Forest Service was required. Hundreds of man hours and tens of thousands of dollars were spent on the effort. However, within days of Clinton's announcement, a local Forest Service official gave the bad news to the community: "The ski hill is dead!"

A local grass roots organization, Communities for a Great Northwest (CGNW), joined with other Lincoln County entities in filing a lawsuit, in June 2000, to challenge Clinton's actions. Because, years earlier, CGNW had prevailed in timber litigation in Washington, D.C., the lawsuit was filed in the nation's Capitol. However, just as the case got underway, the terrible forest fires of the summer of 2002 began; as a result every federal and state park and forest was closed to the public. Because all available persons and equipment were devoted to fighting the fires, those challenging Clinton's decree were unable to work on the litigation.

In the aftermath of those terrible fires, Montana's

timber producing counties realized that their ability to protect forest health and to fight future forest fires would be compromised by Clinton's decree. In February 2001, they asked and were given permission to join Lincoln County's lawsuit. The Montana counties were not alone. Similar lawsuits were filed in Idaho, Wyoming, and Utah.

At first those filing the lawsuits had hoped that the Bush Administration would reverse Clinton's illegal order. But early on, officials in the White House said that no such order would be issued. Clinton's designation of 60 million acres of de facto wilderness would be allowed to stand. Worst yet, the U.S. Department of Justice would defend Clinton's actions. And defend them it did. When a federal district court in Idaho ruled that Clinton's fiat was illegal and enjoined its implementation, the Justice Department quickly appealed to the U.S. Court of Appeals for the Ninth Circuit. Not surprisingly, the Ninth Circuit reversed the district court.

Meanwhile, the Montana Counties sought to move their case forward in federal district court in Washington, D.C. However, on October 1, 2001, the federal district court hearing the case stopped all proceedings. Notwithstanding the speedy proceedings in the Idaho case and a recent ruling by the federal district court in Wyoming, which concluded that Clinton's decree was a "thinly veiled attempt to designate wilderness areas in violation of the clear and unambiguous process established by the Wilderness Act," the Washington, D.C. court has taken no action.

With the fires abating somewhat, the Montana Counties will ask the district court to do its job, to rule on whether Clinton violated federal law, and to advise the people of Montana if they must continue to live under the threat of forest fires. With devastating and destructive fire seasons two of the last three years, Montana cannot afford more fiddling in Washington.

The county school levy, (levied by the state), dropped from .793 to .262.</p> <p>The mill levy for cities on Owyhee County, dropped in Homedale, but rose slightly in Marsing. Homedale residents will be assessed at a rate of 5.091 mills compared with last year's figure of 5.394 mills per \$100 of assessed valuation. In Marsing the figure climbed from 3.814 to 3.844 mills.</p> <p>On levies for school districts, Marsing and Homedale levies dropped: Homedale by .010 mill and Marsing by .410 mill. Grand View-Bruneau, Three Creek, Castleford, Melba and Pleasant Valley all rose slightly. At Grand View-Bruneau, they levy climbed from the current levy of 4.535 to 4.698 mills.</p> <p>Levies for fire districts dropped slightly at Marsing and Grand View, doubled at Bruneau (.223 to .465), and rose slightly at Homedale.</p> <p>On levies for the cemetery districts, the Homedale-Marsing district dropped along with Bruneau. The Riverside levy rose slightly and Owyhee Pioneer rose from zero to .038 mill.</p> <p>The county highway district levy increased somewhat, (1.120 to 1.135). All other highway districts remained at last year's level or dropped somewhat.</p>	<p><b>Special school bond election set</b></p> <p>A special election will be held within that portion of Homedale Joint Class A school district which was formerly the Central Cove district in Canyon county to determine whether or not that area will assume its prorata share of the bonded indebtedness of the Homedale school district.</p> <p>The election is the result of protests that the district was illegally reorganized in that people of the Central Cove area did not vote by a two thirds majority for reorganization and that percentage is necessary to pass a bond election. We'd like to commend them for their excellent sportsmanship," he said.</p>	<p>WATER WORKS. We have frequently urged upon this community the necessity of organizing some plan for the protection of our property from fire, and now, without arrogating to ourselves more credit than is really due, we are pleased to say that our suggestions have been accepted and acted upon almost to the letter. A joint stock company has been organized with a capital stock of \$50,000, and officers elected, the trustees for the first three months being Messrs. J. F. Dye, W. F. Sommercamp, F. 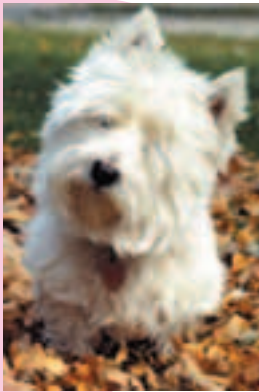

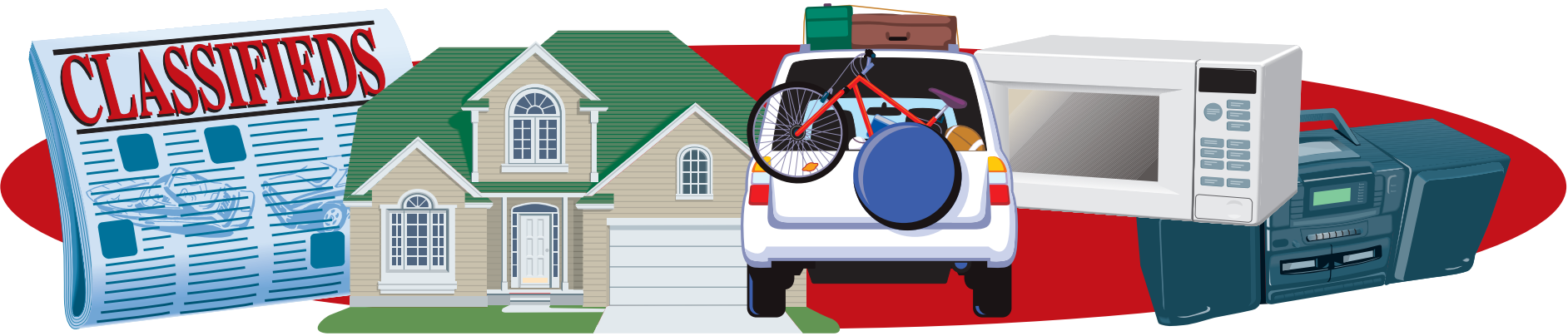
