Five seek mayor's seat in **Marsing**

Homedale mayor and former mayor to battle in November

Mayor and council elections will be held on November 4 throughout the State of Idaho and this year in Marsing and Homedale, voters will have a variety of candidates to choose from.

In Marsing, five residents will vie for the city's top position including the incumbent mayor Faye Pfrimmer, a long time councilperson, Carol Edwards and a newly elected councilperson, Don Osterhoudt will face off against each other for the title of Mayor.

As of the deadline Friday, Dan Carlson, president of the Marsing Resource Center and LeRoy "Bud" Peck, a former city employee will also be on the ballot.

Commissioners to repeal ordinance, hold hearing on solid waste fees

The Owyhee County Commissioners have stated they plan to repeal an ordinance which they adopted last month, increasing solid waste fees. The annual fees, which doubled the previous charge, were to be set at \$40 per household and \$80 per commercial unit.

Any time a fee increase proposal is made by a government entity which would exceed 105% of the amount of the fee last collected, it first must hold a hearing upon such proposed fee increase after it gives public notice of the hearing.

A notice of hearing is published in this issue of the Avalanche, which states "This proposed increase is deemed necessary by the increasing costs for operating the system. 1987, Since the increasing costs have been met mainly by property tax revenues.

While that main reliance on the property tax will still exist, the increase will distribute more of the cost to the users."

The community of Murphy will come to life Saturday night with Hawaiian dancers, authentic cuisine and historic speakers in a fundraiser for the Owyhee County Historical Museum.

"Aloha in the Owyhees" will be held in Murphy Saturday evening to celebrate and raise funds for a 6,000 foot addition to the Owyhee County Historical Museum.

Coordinator Debra Lindner said last week that special speakers will be attending the event including Sara Edlin-Marlowe from the Idaho Humanities Council Speakers Bureau. She will perform the "Six Women of the Hawaiian Monarchy."

"What we are doing is making a connection between Owyhee and Hawaii," Lindner said. "That is what roasted in the ground with lettuce we have decided to celebrate. We hope that it will be an annual function."

As a graduate student at the University of Hawaii, Edlin-Marlowe worked to document the strong women of the Hawaiian Monarchy. She will perform at 5 p.m. Saturday evening.

The name Owyhee comes from early fur trappers. In 1819, three natives from Hawaii, part of Donald McKenzie's fur-trapping expedition, were sent to trap a large stream that emptied into the Snake River. When they did not return, McKenzie investigated and found one man murdered in camp and no sign of the others. The stream was named in their honor. "Owyhee" is an early spelling for the word Hawaii.

A dispatcher at the Owyhee County Sheriff's Office said the cause of the accident was still under investigation. County Coroner Joe Bongiovi said Wednesday that he has determined that McDonnell died from injuries she sustained in the accident.

Local grocer to open Boise store

Homedale-based Paul's Markets has announced the grocery chain will open yet another store early next year.

Paul Zatica, president of the firm, Z, Inc., said last week that he has arranged to open a new store at Lake Hazel and Five Mile, in the Old Lake Hazel Shopping Center, south of Boise. The store will be a 41,000 square foot facility.

The family operation, has eight stores, located in Homedale, Caldwell, Nampa, Kuna, McCall, Mountain Home, ID, and Ontario, OR. Sons Stan and Steve Zatica are officers in the corporation.

"We're very proud to make this announcement, and we are excited about this new facility. It will be supplied with gasoline, pharmacy, dollar store, bakery, and deli, and we'll provide quality meats and produce at that market", Zatica said.

In 1955 Zatica opened Paul's Groceteria on East Idaho Avenue in Homedale. Offices are located at Main and East Owyhee, in the building that was previously the Homedale store.

Tax notices mailed

Thefirst installment of property taxes for Owyhee County property owners is due Dec. 20 and notices will be mailed the first week in November.

Owyhee County Treasurer Barbara Wright said last week that county tax payers who have had an address change in the last year, will need to make certain that their address has been changed with the county assessor. Wright said according to local post offices, if the address is not correct, some tax notices may not be delivered.

Property taxes in Idaho are collected in two semi-annual installments. First half is due into the treasurer's office by 5 p.m. on Dec. 20 to keep from having any late charges. The second half will be due in June.

Subdivision hearing goes on as scheduled

The Homedale Planning and Zoning will gather for a public hearing Monday night at 7 p.m. to review an application for a subdivision filed by Big View Builders, Inc. to subdivide 2.76 acres on Main Street just east of the Homedale Garden Apartments.

After a city council meeting last week, questions were raised as to if the hearing would proceed as scheduled after the council was informed that the appropriate steps have not been followed for a subdivision.

Mayor Hap Duryee said Monday that the appropriate steps have not been taken in applying for permits for the subdivision. He said he feels the "cart has been put before the horse."

"I asked Kevin (Barlow, councilman) to take that back before planning and zoning to get the steps corrected before the special meeting," Duryee said. "At this point I asked Pam (Dugger, City Clerk) if she had sent out the letters of notification and she stated that she had not. I feel that the hearing is a little like putting the cart before the horse."

Duryee said the planning and zoning ordinance on subdivisions says the developer must come to the city clerk first and file an application. He said that step has not been done.

"Then it goes to the city engineer for his review, then to the administrator," Duryee said. "At that point the planning and zoning can address it. The first two items have not been done. We need to get the cart back behind the horse instead of in front of the horse and get the paperwork done, the review and then send it to planning and zoning. I don't think we need to have a special use permit. I think we just need to have a hearing on the subdivision.

"The first step is to come to the clerk and file the paper work and that has not been done," Duryee said. "You have to file the paperwork, the engineer has to look at it and he may have some suggestions, then it goes to the planning and zoning."

Planning and zoning administrator Silvia Bahem said Monday that to the best of her knowledge, the meeting is still scheduled as planned. She said property owner Tony Valdez and Big View Builders have been working with City Engineer Bob Walker and the only thing missing had been the plat. She said the preliminary plat was to be submitted to the clerk on Monday.

"The only thing missing was the plat and that needs to be turned into me," Bahem said. "They have been working directly with Bob Walker after they were finally able to get a hold of him. They didn't have a preliminary plat done until late last week. I understand that they have been able to go over it with Bob Walker. The way I read the ordinance they will get it to city hall and they will forward it to me."

Deputy Al Showalter would not release the name of the suspect who shot Hailee, but said an investigation into the incident continues. Showalter said three 17 year-old boys and an 18 year-old boy have admitted to participating in the incident. But he said he would not release the name of the adult young man because no one has been arrested.

Showalter said the Canyon County Sheriff's Office received a report from Mercy Medical Center in Nampa when Hailee was taken in. He said the officer's report stated that Hailee and some friends were standing on Ustick Road preparing to "toilet paper" a friend's house in conjunction with homecoming. He said as the group was gathered on the road, a pickup with four male teens drove by and opened fire on the group. Showalter said the suspects are all from Homedale.

"The investigating officers from Canyon County have contacted four teenage suspects," Showalter said. "They are very remorseful and fearful. Right now no charges have been filed nor have any arrests been made. There were three different shooters and a driver. All of them have acknowledged their participation in this event. They have all been released to their parents and the case will go to the prosecutor for disposition."

Showalter said a paint ball gun is considered a weapon and the boys could be charged with aggravated battery. He said it would be up to the prosecuting attorney's office what, if anything, the suspects would be charged with.

Homedale School Board Superintendent Bob Lisonbee said the incident did not happen on school property and was not a part of school scheduled homecoming events. He said the district is aware of the boys accused of the incident, but the district does not have any jurisdiction over the event.

A source from Homedale High School said the Garretts have sent e-mail letters to staff members and say the Hailee is under observation by doctors, and that she is in good spirits.

"As of Thursday, we have not received many calls concerning vandalism," Lisonbee said. "I have heard of some acts of aggression, but the incidents have not happened during our activities."

High school principal Mike Williams said he has been made aware of several incidents involving students throughout the homecoming week, but said only one has happened on school property. The rest have happened elsewhere in the city, and not during scheduled

school events.

Williams said an incident in Homedale of a teen threatening kids with a belt had been reported, and several reports of fighting.

As the popularity of paintball has increased over the past several years, so have eyerelated injuries.† The game is played with gelatin balls measuring about 0.68 of an inch in diameter that are filled with water-soluble paint. When fired through a gun at 300 feet per second, they have been said to turn into small missiles.† Doctors have stated that injuries with this sport are often serious because the paintball fits perfectly in an eye socket, increasing the risk of perforating the globe.††

According to American Sports Data Inc, the number of paintball players has increased to over 6.4 million in the past ten years.†

Showalter said kids need to avoid taking these kinds of risks. "If they use poor judgment and someone is hurt, they will have to suffer the consequences."

√ Elections

Marsing has two four year city council positions up for grabs as well. Both positions will have some competition.

Incumbent Paul Holzhey, Ed Pfeifer, a teacher, Paula Enrico, a librarian and Jim Natale, a driver for the Meals on Wheels program in Marsing will seek the two seats.

In Homedale three council seats will be contested. Two four year terms will see incumbent Charles Garrison, Steve Schultz, and appointed councilman Dave Downum campaigning for the seats. Businesswoman Cindy Sims and local attorney Lois Hart, who declared in the final hours before the deadline Friday, will

compete for the two year seat.

For the mayor position, incumbent mayor Hap Duryee is running against former mayor Paul Fink for the top office.

In Grand View, the mayor and one council position will run unopposed unless a late candidate files as a write-in candidate.

Paul Spang will run for the mayor's office and incumbent Franklin Hart filed for one of two four year council terms. A spokesman from the City of Grand View said Monday that write in candidates can file for office until Oct. 21. If no one files for the second council seat, the mayor will appoint someone to the position and the seat will be up in the next general election.



SOUTH MT. MINING DISTRICT LOOKS **PROMISING**

Talk of the New Rail Road Awakens Interest in Famous Old Owyhee

Copper and Lead Camp.

Chas. Harvison came in Sunday from South Mountian where he has spent the past four months doing some development work on the Standard group of mining claims. Mr. Harvison is very enthusiastic over the out-look in that district and believes that it will some lay in the near future develop into one of the biggest and best mining districts in the west.

Mr. Harvison states that while running the cross-cut tunnell on which he had a contract he encountered a good ledge of ore which showed a rich streak of from 18 to 24 inches wide carrying very rich ore. He did not prospect the ledge but sent some samples to the company in Denver and although they did not inform him of the assay value of the samples they seem to be well pleased with the showing. The tunnel on which he is working will cross-cut another ledge which has a good surface showing in about 200 feet further in.

Mr. Harvison has finished his contract but since coming to town he has received word from the company to secure another man and resume work on the property. The property is owned by the Standard Mining and Milling Company of Denver, of which company L. F. Clemmons is general manager, Mr. Clemmons informs Mr. Harvison that he will pay a visit to the property in about a month and will be accompanied by some capitalists and mining men. It is believed that the company will do considerable development work on the property this summer.

There is no question but that the South Mountain country is a rich copper and lead district and that the only thing that has held it back has been the lack of transportation facilities. With the building of the proposed Boise-Winnemucca line this district will be given good transportation facilities and its future will be assured.

Mr. Harvison states that it is reported that another large company ich owns property in that preparing to take up development work on a large scale this summer. Considerable snow is still on the ground in that section and it will be at least 30 days before surface prospect work can be taken up to good advantage.







That is not to say that literary and artistic skills such as being a cartoonist, a ballet dancer or a newspaper reporter can't add seasoning to our world, but compared to skills such as laying brick, roping or navigation, they lack gravitis.

It is one of the injustices of civilization that the farmer is paid less than the chef. That the movie star is emulated more than the hero she plays on the screen, or the baseball player makes more than the policeman.

The more civilized people become, the more our communal perspective is skewed. In the highly industrialized countries, power, money and prestige is bestowed upon people whose skills involve splitting hairs, finding loopholes and hypnotizing the gullible. But the true evaluation of essential skills should be made against a more primitive background, like present-day Afghanistan, the Amazon Jungle, or being adrift in a lifeboat. Being able to track, shoot and row carries a lot more weight in preservation of the species, than do card players, TV anchorpersons or senators. Who would you rather have covering your back at a mugging, Albert Einstein or Jesse Ventura?

This fall the Democrat party is trying to select a presidential nominee. Philosophically they aren't much different, but under the ground fog of speeches, I expect we'll find some carpenters, cowboys, soldiers, sailors, gardeners, hunters, electricians, plumbers and fix-it folks. Unfortunately, these useful abilities will have less influence on their success than clever sound bites, a celebrity endorsement or a full head of hair.

I don't live in a disposable world

Nowadays, we throw almost everything away. When a computer drops behind the technology curve, it is sent to the crusher. Family snapshots are made with cameras that are thrown away when the film is processed or digital cameras that are obsolete the day they hit store shelves. Most modern furniture won't last more than a few years.

It's a disposable world.

In the spring of 1945, my mother was president of the Kuna, Idaho PTA. She also was expecting her third child. To show their appreciation for mom's service, the parents and teachers chipped in and got a high chair for the expected blessed event. The high chair was of all wood construction because metal was needed for the war effort. There wasn't any fancy scrollwork or decoration. The finish was plain, clear varnish. Less than a month before Germany surrendered, mom gave birth to a relatively bouncing baby boy—me.

My very first memory is of sitting in that wooden high chair. It served me well and was still in good shape when my niece used it a few years later. Eventually, the chair was decommissioned and placed in the attic.

In 1972, our first child arrived. I hauled my old high chair out of storage. The years hadn't been kind. The varnish had literally lifted off the chair. I scraped off the finish and covered the entire chair with avocado green enamel paint (it looked very

"in" at the time but so were leisure suits). The chair didn't have safety straps. We lashed Daughter Number One, and Daughters Two and Three into it with dish towels. It may not have been a Consumer Safety Commission-approved restraining device, but no one ever fell out of the chair.

When our young ones passed the high chair stage, it went off to the storage shed. There it remained for about 25 years, to reappear recently when Granddaughter Number One arrived.

The chair appeared to be a lost cause. It was nicked and scratched and dirty and covered with that awful green paint. The only hope was to take it back to its original state. I re-glued all the joints. After stripping the paint and doing considerable sanding, I applied multiple coats of varnish. The project is almost finished now and the chair looks like it did when I was a kid. There are a few flecks of green paint still showing but that's OK. They are reminders of the second generation that used it.

Now, when grandchildren come to visit, they will have a chair to sit in while they eat. And hopefully, when Generation Three gets done using it, someone will store it away to await babies of the future. And maybe someday a mother or father will tell their child about how the Kuna PTA got the chair for their great grandfather.

H2A reform will benefit consumers, producers and workers

Legislation aimed at reforming the agricultural guest worker program (H2A) is a needed step in the right direction for consumers, agriculture interests and the workers themselves.

Sponsored by Idaho Senator Larry Craig, Senator Ted Kennedy, and others, the Agricultural Job, Opportunity, Benefits Security Act of 2003 (AgJOBS) provides a two-step reform that shores up the H2A legal guest worker program. First, it provides stability for experienced migrant workers by allowing them to stay in the U.S. legally while they earn adjustment to legal status. And in the long-term, the legislation overhauls and streamlines the cumbersome regulations in H2A.

Over half of the 1.6 million agriculture workers in the U.S. are currently here illegally according to the Department of Labor. Some private estimates run to 85 percent or higher. The fact that so many farmworkers and food processing plant employees are illegal is a dirty little secret no one in agriculture likes to talk much about. It's neither right nor fair that while Idaho and many other farm state economies depend on these workers, they must hide, falsify documents and lie in order to live here. Workers who come to the U.S. looking for

opportunities that aren't available in Mexico and other countries deserve the chance to earn citizenship, as long as they are willing to abide by the law.

Producers get peace of mind in knowing that the INS isn't going to show up and haul off their crew on any given day. Lost days brought on by INS raids can cost farms, packing sheds and processing plants thousands of dollars. Those losses can cause a ripple effect in local economies that can be difficult to recover from. The costs associated with rounding up illegal workers and deporting them is also a drain of tax dollars that could be better used elsewhere.

For consumers this legislation helps insure a steady supply of fruit, vegetables, grains, meat and dairy products. Most Americans can't remember a time when food was hard to come by and we don't associate a safe, affordable, abundant food supply with our national security. But the fact of the matter is that without that ready supply of healthy food produced by American farmers and ranchers we wouldn't be able to enjoy this level of independence and economic freedom. When you stop to consider that Americans spend an average of 10.9 percent of annual income on food (the lowest in the world) compared to 48 percent in India, it's not difficult to see a connection between domestic agriculture and self-sufficiency.

An affordable, healthy food supply allows Americans to live a better lifestyle than many other people around the world. This legislation is a common sense tool that will help maintain that lifestyle.

Patrons nix consolidation question

In Homedale, it wasn't even close. One hundred fifty seven patrons opposed the proposal with a total of 16 favored it.

Homedale. Members of the Homedale City Council Tuesday night approved exercising an option on a city well site. The action was taken at a special meeting of the Council.

The well site adjoins old U.S. 95, on the east side of the Snake River.

135 years ago

October 10, 1868

WE DIRECT ATTENTION today to the advertisement of the Owyhee Road and Bridge Co. They now have their road completed in good shape from here to Camp McDermitt. The distance, as measured is 87 miles, with excellent water and grass all the way. There is a first rate gravelly ford at the crossing of the Owyhee and before high water in the spring a substantial bridge will be built. No toll is charged.

ESCAPED. John McMorrow, who was in jail for shooting McCormack escaped one night last week. He managed to break or twist off the head of a bolt holding an iron bar, with which the jail door was secured. He then used the bar in prying open the door. Sheriff Springer has been on the search for the culprit, who as yet has not been heard of.

STILL THEY COME. Happening in at W. F. and Co's office on Tuesday last, we noticed a brick worth a little over \$22,000. It was taken from the Ida Elmore mine, and has since been sent to San Francisco by Thos. Cole, Jr. Quite a monetary transaction for a small mining town.

NOW IS THE TIME to agitate the question of a change of name as suggested by our correspondent. If this opportunity be allowed to pass without effecting a change our citizens will be subjected to a further inconvenience of two years. Every week brings to light additional reasons why a new name should be substituted. It frequently happens that letters of importance, intended for this place, go to Silver City, Nevada, often causing a serious loss of time and money. We would prefer plain "Owyhee," without the "City" appendage. As there is some contention in regard to names between the people of Oro and Owyhee in Flint, we hope they will look with favor upon the suggestion of our correspondent and drop both, substituting "Lenton" or some other appropriate name for the great city that will soon be built there.

SCHOOLS. The School Marshal has just made his report, from which we find that there are 101 children in this district between the ages of 5 and 21. These children should all be going to school; in fact, it is almost criminal on the part of the people any longer to neglect the necessary arrangements for the establishment of a good school. The fact is the capacity of the school house or jail, one or the other, have to be increased very soon, for it is impossible for that number of the American youth to be idle. In this connection, we may add that the School Trustees

have about made arrangements for the erection of a house, and if they can get sufficient assistance they will build a comfortable and substantial structure and one that will be an ornament to the place. About \$1,500 currency have been subscribed for this purpose and the amounts not already paid will probably be called for within the next week or two. If that amount could be doubled it would be sufficient for the present purpose. They will either commence the building immediately or refund the money already collected.

STRUCK IT RICH. Last Wednesday, Messrs. Peck and Porter struck it rich in their mine, the Second South Extension of the Oro Fino. One hundred feet from the surface and twenty-five feet north of the main shaft a two-feet vein of exceedingly rich gold and silver bearing quartz was found. The ore resembles that of the Golden Chariot and Ida Elmore in character and richness. This will not be wondered at when it is known to be nearly on the same range with those mines. Some large pieces which we examined were completely covered over and diffused throughout with gold. P and P have certainly got a good thing.

On Tuesday, October 14, 2003, at 10:00 am, in the Magistrate Courtroom in the County Courthouse in Murphy, the Board of Owyhee County Commissioners will consider increasing the solid waste user fees from the current \$20 fee which was set in 1987 to an amount of at least \$40 in order to decrease the impact on property taxes of operations costs for the solid waste disposal system.

This proposed increase is deemed necessary by the increasing costs for operating the system. Since 1987, the increasing costs have been met mainly by property tax revenues. While that main reliance on the property tax will still exist, the increase will distribute more of the cost to the users.

The Board previously enacted Ordinance 03-04 which established this increase pursuant to Idaho Code, 31-4404, but did not subject the increase to a public meeting pursuant to Idaho Code, 67-1311A. The use increase established by 03-04 will be repealed at the Board's October 6, 2003 meeting, and the increase will be reconsidered after public input to be given on Tuesday, October 14, 2003.
