Mayor takes reservoir site back to the drawing board

“At the request of Mayor Hap Duryee and Homedale City Councilman Dave Downum, Engineering went back to the drawing board to try and find a way to use the current site for the new reservoir,” Homedale City Engineer Bob Walker told the council at a meeting Wednesday night. And without council approval, that is exactly what Mayor Duryee said is going to happen. But the decision has at least one councilman fuming.

(The “reservoir” referred to is more commonly called a “water tank”.)

Walker announced during the meeting that due to council, mayor and resident pressure he has been looking at the option of putting the reservoir in the same location as the current reservoir. He said that the

Extension agent calls it quits

The University of Idaho Owyhee County Extension Agent has called it quits and said he plans to leave his position he has held for four years in the spring.

Eric Morrison said last week that he was leaving the position due to conflict with “University campus” personnel.

Homedale man sought by police

A Homedale man is being sought in connection with an aggravated assault involving a firearm Friday afternoon.

Police Chief Jeff Eidemiller said Monday that 19 year-old Curtis Benavidez is a suspect in the crime and is also wanted on a failure to appear warrant from Canyon County on an unrelated charge. Eidemiller said Friday Benavidez was accused of pointing a shotgun in the face of a Homedale woman. He would not release the identity of the victim.

“Benavidez is accused of pulling a shotgun, cocking it and pointing it at the victim's face,” Eidemiller said. “He was reported to have fled the area in a pickup, but when the vehicle was stopped he was not in it. The vehicle was stopped in Canyon County.”

Johnstone Road right-of-way questioned

For many years people in the Homedale-Marsing area have used the south end of Johnstone Road for access to the county tipping station on Fridays, Saturdays, Sundays and Mondays, except holidays. The rest of the time the road had been shut with a locked gate. But recently the county unlocked the gate, actually removed the gate. The action has one county resident furious as he believes the access is across his property.

Tom Wilke, a farmer in the area, recently sent a letter to the county commissioners stating: “A requirement for entering our property is that the gate at the entrance to our property, at the end of Johnstone Road, be locked when the Tipping Station is not open. This has been the custom and practice for years, if not decades. As of yet the county has not provided us with documentation that it has a legal easement through our property. Please provide proof of such

an easement.”

Commissioner Chris Salove said the dispute began when the county opened the road after many years and put a gate at the entrance to the tipping station, instead of at the South Canal entrance where it had been. He said when the county decided to have electricity put in at the station, Wilke filed a complaint claiming the county did not have an easement along the road and he did not want power taken to the station.

“Now we have a gate to the tipping station,” Salove said last week. “Basically this started because of the two road hearings we held on Poison Creek and Reynolds Creek. We felt the county should not be in the middle of an access issue when we were deciding access issues, so we decided we should not be closing a road. We felt if we needed a gate at the tipping station we should have a gate at the tipping station.”

Salove said from his understanding,

Wilke claimed in his letter that the road is not a public road and can only be used for access to the tipping station.

Owyhee County Assessor Brett Endicott said he checked the plat of the

Former city police officer Rob Cook returned to the force Thursday and will be replacing former officer Mike Spagnola. Eidemiller said six applications were submitted for the position.

HomedaleChamber to host candidate forum

Two candidates are running for the position of Homedale's mayor and five residents are running for three open positions on the city's council. On Oct. 27, the voters of the City of Homedale will have the opportunity to meet the candidates and listen to their ideas concerning current and future issues.

The Homedale Chamber of Commerce will gather all of the candidates together for a public forum to help voters in the community know who the candidates are and what they represent.

Incumbent mayor Hap Duryee and former mayor Paul Fink will battle for the position of mayor in November's election.

Council incumbent Charles Garrison, Steve Schultz, and appointed councilman Dave Downum will compete for one of two four year term seats and former councilperson Lois Hart and Homedale businesswoman Cindy Sims will vie for the two year seat vacated.

The forum will be held at the Homedale Middle School cafeteria at 6:30 p.m. Coordinators said all of the candidates have been invited to participate in the event which will be moderated by chamber president Robin Tolmie.

Each candidate will be given time to offer a personal introduction and to state their reason for running for office. The moderator will then ask a series of questions to which each candidate will be asked to respond.

The public is invited to attend and to familiarize themselves with those who seek to be their leaders in Homedale government.

Tolmie said citizens are in-

vited to submit questions concerning what they would like to hear from the candidates. She said questions may be sent to P.O. Box 455, Homedale or by calling any chamber member. Questions will need to be submitted by Oct. 22.

Poachers slaughter deer in season opener

Poachers went wild in Owyhee County during the first week of deer season, slaughtering at least seven deer from small does to large three and four point bucks. Idaho Department of Fish and Game Conservation Officer John Nagle said last week, the killers don't seem to care what they are killing as they are leaving the bodies.

Deer season opened in the area on Oct. 5 and will close on Oct. 18. The area is only open for two point deer.

Nagle said three important descriptions of vehicles have been reported to officers. He said at least four large bucks and three does have been killed since opening day.

Nagle said a maroon or burgundy late model ford pickup extended cab with Owyhee County plates was seen in the Flint Creek area and is responsible for a three point, a four point buck and a doe poaching. He said seven does were killed in the Cow Creek, Delemar area and a white Chevy pickup with a spot light in the middle of the roof above the windshield was seen in the area. He said the vehicle is a late 1980s pickup.

Nagle is also seeking information on a dark red Ford step-side mid 1980s pickup with Oregon plates. He said the vehicle was also seen in the area of one of the poachings.

Three deer were killed in the Jordan Creek area and four were shot in the Cow Creek area.

"They have just been shooting them and leaving them lay," Nagle said. "In one place they shot a huge three point and a doe at the same time. Left both of them lay on the ground. If people come to us and tell us they made a mistake we can be lenient with them but these people are just killing them to kill them."

Nagle said ranchers in the area are also dealing with trespassers. He said most ranchers he deals with are accommodating to hunters by telling them that they are on private land. But some of the trespassers are not as understanding.

"I have a rancher on the head of Cow Creek who got a hold of me who found three poached does during archery season," Nagle said. "He has his property clearly marked for no trespassing in areas he does not want people in. He spent a great deal of money on signs in his cabin area. Now the sign he had built for the area has been torn out of its frame. I would not blame him if he closed the entire area and not let anyone in. These people don't know that it is a privilege for them to be on private land and they misuse that privilege. Before long, no one will allow anyone on their land."

Nagle said to report a poaching or suspicious activity call local law enforcement. He said people reporting cases that are convicted can receive up to a \$250 reward.

Parents give update on daughter's eye injury

Homedale parents Gregg and Randee Garrett have spent the past several weeks traveling to Portland to meet with specialists concerning an injury to their daughter's eye. Hailee Garrett was shot in the eye by a local teen with a paintball during homecoming week. She has since had to endure hours of doctors' visits and waits to see if surgery will help her regain some of the sight in her right eye.

Last week, her parents released a statement on Hailee's condition.

"Hailee sustained a severe traumatic injury to her right eye. She has not regained any vision in that eye other than only slight detection of light and movement.

"The extent of the injury is as follows; there is a divot out of her cornea with frontal lacerations, a torn iris, a traumatic cataract, damage to the optic nerve, and a rupture of the chor-

oid (the layer of the eye behind the retina)." The Garretts said the retina appears to be OK.

"We have visited specialists at the Casey Eye Institute in Portland twice since her injury, as well as 3 doctors in the treasure valley," Gregg and Randee explained. "The current prognosis is to allow the eye to heal and stabilize for three to four weeks before surgery. Her next step will be to receive cataract surgery in an attempt to replace the cloudy lens, which hopefully will allow doctors to see parts of the eye that are in question. There is hope that this may restore some vision, at least peripherally. Additional surgeries may be needed later, possibly involving the cornea.

"Hailee has always been a very happy and positive young lady and her spirits are high. She looks great, but unfortunately right now, 'it looks a lot better looking in than looking

out.'

"The overwhelming support and prayers from her close friends, relatives, community members, and people and students from other towns, have been an essential part of her attitude and healing process. Our family cannot begin to express in words our grateful thank you to each and every one for their continued concern, support, and kind words. Please keep Hailee in your prayers as we proceed with her recovery."

New restrictions made on motorized vehicle use for hunting

The Idaho Department of Fish and Game has adopted a rule regulating the use of motorized vehicles by hunters in selected areas in southern Idaho, including Game Management Units 32 and 32A. This rule was adopted in response to concerns expressed by many sportsmen about the increased amount of off-road travel during hunting seasons. These concerns include hunts being disrupted by off-road travel, maintaining the fair chase aspects of hunting, and the increased vulnerability of game to hunters that has resulted in low buck/doe and bull/cow ratios. The intent of the rule is to address sportsmen’s concerns regarding the quality of their hunting experience by reducing the amount of off-road motorized vehicle travel during the hunting season.

The new regulation reads: “Motorized vehicle use as an aid to hunting for wildlife is restricted to established roadways open to motorized vehicle traffic capable of travel by full-sized automobiles. A full-sized automobile is defined as any motorized vehicle with a gross vehicle weight in excess of 1,500 pounds.”

This rule applies only to hunting. You will be considered hunting if you have a valid hunting license and tag and are chasing, driving, flushing, attracting, pursuing, seeking, following, trailing, shooting at, stalking, or lying in wait for any wildlife while in possession of a hunting weapon. This includes traveling to and from hunting spots and transporting hunters while in the field. That means you cannot use your ATV or motorcycle to drive a couple up a trail then park the vehicle and start hunting from there. The rule does not affect you if you are staying on established roads used by full-sized vehicles or if you are doing other outdoor recreational activities such as sight-seeing or camping.

Retrieving game and packing in camps is still allowed. To minimize conflicts and confusion, IDFG suggests retrieving game during the middle of the day without your hunting weapon, and packing in your camp with your weapon fully cased and ammunitions packed away. Keep in mind that regardless of what outdoor activity you are participating in, you must adhere to existing Forest Service, Bureau of Land Management, or private land owner travel regulations.

Here in the Southwest Region, we selected Units 32 and 32A to try out this new rule because these are the units from which we have most frequently heard complaints about off-road vehicle use by hunters. In addition, because of hunter densities, road densities, and ease of access in these units, deer and elk are particularly vulnerable to hunters. Although deer and elk herds are doing fairly well, hunters routinely complain about seeing very few bucks, and particularly few bucks larger than forked-horns. In fact, our buck/doe ratios have continued to decline in these units. Our objective for these units is to maintain 15 bucks for 100 does in the population after the hunting season. In recent years, we have routinely counted fewer than 10 bucks : 100 does, and have counted as few as 6 bucks for every 100 does. With so few bucks surviving the hunting season, it’s no surprise that hunters see few bucks than yearlings that are typically forked-horns.


Our hope is that the new rules on motorized vehicle use will improve the likelihood of more bucks surviving the hunting season so that in years to come we’ll have both a higher number of bucks and more bucks in the older age classes with larger antlers.

site will require some excavation and a retaining wall, but so would the site the council approved to purchase several months ago.

"We came to the conclusion yesterday that we can put it in the existing reservoir site," Walker told the council. "It will take a little additional work, but it is feasible."

Walker handed out a press release to the council which said: "For several months now the placement of the new water storage reservoir in the City of Homedale has been a controversial subject. Initially Project Engineer, Robert Walker, sought another location site for the reservoir due to limited land availability at the existing site. The potential new site selected was a concern to residents of Royal Vista Subdivision, located outside the City limits and outside the City Impact Area."

The announcement came as a complete surprise to most of the council members who seemed to be split on the decision.

"I don't understand this," Councilman Charles Garrison stated. "How do we go from putting this reservoir from where we had planned for months and months to now placing it at the original location. I don't understand."

Walker said he did it because he was requested by the mayor to look at it.

"Why did we not request this when Rick (Kushlan, developer of Royal Vista Subdivision) had all of these problems," Garrison questioned. "That is what I don't understand. This is exactly what I want to see happen, but I am not too happy about it. The point of waiting months and months to come to a conclusion like this."

"I was directed by the mayor to look at this," Walker explained. "And obviously you don't want to give those people false hope. And if it would not have worked it would have gone where it was originally."

Garrison said he agreed, but felt that the council should not have decided on the original location from the beginning.

Garrison, Councilman Kevin Barlow and Mayor Duryee agreed following the meeting that the council several months ago approved a motion to purchase a section of property near the original site, but a site that would block a valley view from many homes in the Royal Vista Estates. Duryee said the council did not need to approve the current location because it already is the site of the reservoir. He said the previous approval was

made with contingencies and those contingencies could not be met.

"We approved the site months ago," Garrison said. "We should have looked at the original site then instead of up heaving people's lives, causing undue stress and then going back to the original site anyway. It was a total waste."

"We had contingencies," Duryee said following the meeting. "We had problems with the drain. We could not use the existing drain. We had enough public input. We had people come to the meeting so I asked Bob to look at the other location. At this point the council has not approved the current location. We are already on that site and I don't think it needs council approval. The drain is part of the reason we changed the location. We have the existing site. It is not deeded to us, but we have that site."

Walker stated that the reservoir will be announced for bid in the near future and, pending approval by DEQ, construction is expected to commence in late fall. "The new reservoir should be completed and operational in early 2004."

philosophy. As of now he hasn't turned in a resignation, but he said he is serious that he will be leaving, and plans to leave the position sometime in May.

area and is confident that the section line runs down the middle of the road leaving one half on Wilke's property and one half another land owner. He said he did not know if an easement had been recorded.

"What we found is the section marker and some surveyors markers ran up the hill," Endicott said. "Basically what that indicated is where the section line is. On the east side of the section line Mr. Wilke owns. Mr. Burgess owns part of it on the other side, the county owns part of it and I think the rest is BLM on the west side. A lot of times easements were not recorded, but I have not been asked to check into that so I don't know if this particular easement was recorded or not. I am fairly confident where the section line is. It looks to run right down the middle of the road."

"The disputed portion is within the highway district," Salove continued. "From what we have been told, it is our belief that it is a public road. We don't have jurisdiction over the road or what happens to the road."

Salove said the commissioners are only involved because they want to put in power lines for power to the tipping station. He said Wilke is disputing power line access to the tipping station.

"Right now the people out there have no heat, lights, phone service," Salove con-

tinued. "We have been trying to get power out there for a long time."

"We have no authority over the highway district. From my understanding, the same code we used to decide the Poison Creek and Reynolds Creek road that same code applies to the highway district for hearings. They can conduct a hearing the same way we conducted those. It is one of those no win situations. The county looks heavy handed when we try to push something on one of our

citizens, but we have to look at what is best for everyone."

Homedale Highway District Board Chairman Mark Stimmell said last week that the district is waiting for legal advice before moving on.

"We don't have any immediate plans to solve this problem," Stimmell said. "We will probably have a hearing in the future. Right now we are waiting for legal advice."

Wilke did not return several phone calls or messages for comment.

Sheriff's log of road dispute

The county sheriff's office has also been contacted with reports of theft, trespass and locked gates in a road dispute that seems to be heating up. The dispute does not seem to be over shutting down a road, it seems to be because the road has been opened.

Sept. 25, 1:28 p.m. a report from the sheriff's office states that an employee from the South Board of Control had been threatened by a man owning the ditch bank by the dump. Officers were dispatched to the South Board office.


Oct. 5, 7:45 p.m. a report stated: "Gate at the landfill couldn't get out, cut the chain. Wilke advised they are trespassing. Kent Curtis, employee for the highway district, was on scene. He advised that the county key would not work so he cut the chain with bolt cutters. Wilke now blocking road with his Jeep." A report was entered.

Oct. 7, 1:10 p.m. officers conducted a civil standby as requested from the highway district. Reports show that the district removed the gate and contacted Wilke to inform him that the district had his lock and it could be picked up the following day.

Oct. 8, 1:04 p.m. a report of malicious destruction of property was entered, but officers determined that the case would be petit theft. "Someone has cut chain and padlock off of the tipping station gate."

Oct. 8, 6:42 p.m. another call was made to the sheriff stating that a new gate had been installed at the entrance of the road. Officers responded. "Reporting party advised that a farmer was back trying to put the gate and fence back up on the road going to the dump after county took it down." Officers reportedly spoke with Wilke and were advised that he did put the fence up on "their property as advised by lawyer." The report shows that the chain is a wrap around to look like it is locked.

The first girl in a family of 12 children, born in a log cabin, premature, weighing only two pounds, and kept alive in the oven of a wood stove, she was immediately nicknamed “Bobbi” by her older brother trying to call her “my baby.” Bobbi graduated from Estherville Iowa High School, received her Teacher’s Certificate, and taught school in the state. She acquired further higher education through the Iowa State Teachers’ College; the Normal School in Dillon, Montana; and the Albion, Idaho Normal School from which she received her Intermediate School Life Diploma. Bobbi taught in Enid, Montana, then came further “out West” and arrived in Jordan Valley on the mail stage. She lived with the Morgans and first taught at Morgan’s School at South Mountain south of Jordan Valley, then, at the Cliff’s Idaho School; and, after her children were raised, she taught at the Jordan Valley Elementary School.



On the edge of common sense

Helpin' out the neighbor

Dave is one of those good men that neighbors feel comfortable asking for a little help now and then.

Homer is a trader of livestock, canned goods, used lumber, small appliance parts and railroad salvage. He's known for bein' tight with a dollar and for his primitive thinking.

Homer caught Dave at the coffee shop and asked if he'd be able to help him castrate some bull calves he'd recently bought from a rancher south of St. Francis, Kansas.

"Anything I need to bring?" asked Dave.

"Yup," said Homer, "a good horse."

Dave had recently watched a cattle handling safety video put out by Oklahoma State University. So, what are they proposing?



In this week's Public Notice section there's a notice announcing a hearing for "Consideration of increase in fees to be assessed for Planning and Zoning and Development Services".

The county commissioners are holding the hearing in compliance with I.C. 63-1311A. This code requires that a taxing district which plans to increase any fee exceeding 105% of the current fee must first hold a hearing.

But, prior to that, the county must give public notice "for the purpose of hearing public comments regarding any proposed fee increase beyond the limits prescribed... or imposition of a new fee and to explain the reasons for such action."

This they have done. Except they intention-

ally fail to make public the proposed fee increases. They do, however, make it known that if you really want to know, the proposed fee increase list is available in Murphy.

The purpose of the law requiring the hearing is to give the public a heads-up notice of the intentions of increasing fees. A notice that the county commissioners plan to increase fees and will hear comments on the proposed increases, without listing what those increases amount to, defies logic and the intent of the law itself.

As soon as the list of proposed increases is available in Murphy, we plan to obtain a copy and reveal to the public what they are - something the commissioners should have done in the notice.

Imaginary enemies on imaginary battlefields



Recently, I ran across a news item about a proposed federal law that would ban toy guns. Backers of the legislation claim allowing kids to play with toy guns makes them more likely to shoot someone when they get older.

I was probably six or seven when I got my first toy cap pistol-complete with fiberboard holsters my dad made in his workshop. They weren't as neat as the red plastic holsters my playmate Richard Reynolds had (plastic was new in those days), but they served their purpose.

In those days it was OK to bring your cap guns to school as long as you left the caps home and only used your artillery during recess. At noon hour, our gang of first grade desperados saddled up and galloped around the playground, brandishing our weapons as we robbed the train (actually the merry-go-round) concealing our identities by tying red bandanas over our faces.

Playing train robber at school was fun. But not as much fun as the wars fought in our neighborhood after school and on weekends. America was less than ten years past World War II and our men were fighting in Korea. Even the comic books were full of stories about heroic U.S. soldiers battling the ruthless Germans and the sneaky Japanese. Our gang devoted a lot of our free time to re-creating those conflicts.

By the time I was ten or eleven I had given up "store-bought" toy guns and was making my own. My favorite "war" weapon was a machine gun I sawed and carved from a length of two-by-six lumber. The end of the barrel was a white ceramic insulator off an electric fence. The ammo belt that dangled from the side of the gun had been the

rubber tread on a toy bulldozer in a former life.

My home brew machine gun was a devastating weapon. It stopped innumerable banzai attacks, stacking up imaginary sons of Nippon like cordwood. Given the massive casualties my weapon inflicted on the Wehrmacht, it's amazing there were any males left in Germany. Italian fascists also felt its sting, although every American boy knew the primary danger posed by Italians was getting trampled by them when they retreated the minute the firing started.

So, like many other members of my generation, I shot my way through childhood. In my teens, I quit blasting imaginary enemies and turned my attention to hunting real game. And nobody got excited if a youthful hunter stored his shotgun in his locker so he could get into the fields quickly after class.

Despite my constant exposure to toy guns, it never once occurred to me, or any of my friends, to shoot anybody with a real gun. Even when Kenny Tucker and Larry Joseph relieved me of my pants on a bus ride home from a basketball game in McCall, I didn't contemplate settling the score by bringing my shotgun to school for reasons other than duck hunting.

When I was a kid, we killed imaginary enemies on imaginary battlefields with our pretend guns. Some of today's kids spend hundreds of hours splattering the blood of life-like foes generated on a computer screen. There isn't any imagination involved. We knew where our imaginary world stopped and the real world began. That line of reality is a lot fuzzier today. But I don't believe that change has anything to do with toy guns.

Accuracy in media

Anthrax killers still on the loose

Just a few months into the search for Iraqi weapons of mass destruction, the media are demanding answers. But it has been two years since the anthrax letter attacks killed five people and the FBI still doesn’t know who did it. The installation of electronic eavesdropping equipment in Dr. Steven Hatfill’s apartment has failed to produce any evidence against this “person of interest.” A search of a Maryland pond for biowarfare equipment was another foolish waste of time and money. Hatfill, who has repeatedly proclaimed his innocence, was working in the Washington, D.C. area when the anthrax letters were mailed from New Jersey.

While the FBI pursues Hatfill, even running over his foot with a car on a Washington street, a report from the Partnership for Public Service warns that the U.S. doesn’t have enough scientists to respond to bioterrorism. If he’s done with his tour on behalf of the Patriot Act, Attorney General John Ashcroft should settle Hatfill’s lawsuit against the department, apologize, and let him take a job on the front lines helping to protect the U.S. from another biological attack.

No progress in the “Amerithrax” case has been made in two years primarily because the FBI made an early mistake, under political pressure, in assuming that because the anthrax was a “military strain” used in U.S. defense labs, the perpetrator had to be a current or former U.S. government scientist.

In his study, “The Anthrax Evidence Points to Iraq,” published in the International Journal of Intelligence and CounterIntelligence, Dr. Dany Shoham, (who is affiliated with the Begin-Sadat Center for Strategic Studies at Bar-Ilan University in Israel), debunks the notion that Iraq never got access to the Ames strain and writes that Saddam’s use of Ames as a weapon would have been preferred “because its origin would seem to be from within the U.S.” He explains, “In conducting an act of bio-terrorism against the U.S., Iraq would reasonably make an effort to mask, rather than manifest, its involvement.”

In a taunting “open letter” to the West on October 29, 2001, Saddam said, “We have heard in the news, recently, that American officials think that the source of anthrax is probably the U.S. itself. Is thisÖjust a tactic to divert the attention of those who were terrorized to hear that bin Laden is the source of

anthraxÖOr have they done this to divert attention from the incompetence of American official bodies in the events of September 11Ö” The anthrax letters included praise for Allah.

The Bureau dismisses evidence implicating Iraq and/or al Qaeda, such as that one of the 9/11 hijackers was diagnosed with an anthrax sore and others were shopping for crop dusters for possible use in a biological attack. What’s more, there is a possibility that the FBI interviewed and released the killers or their accomplices in the roundup of Muslim militants after 9/11. Many of these “detainees” had come from New Jersey. Two of them had passports, cash, hair dye, box-cutting knives, and magazines with articles about chemical and biological weapons.

Similarly, the Bureau interviewed and released an Iraqi in New Jersey who was involved in the 1993 World Trade Center attack. The New York Times reports that Abdul Rahman Yasin, who fled to Baghdad and now has a \$25 million price tag on his head, is suspected of having ties to al Qaeda.

The FBI may have ignored a foreign connection for other reasons. The White House, which is now unfairly accused of hyping an Iraq-al Qaeda connection, did not want to focus on Iraq at the time because of the Afghanistan war. Second, a key staff member in the office of liberal Senator Patrick Leahy, the target of one of the anthrax letters, believed the culprit was a “right-wing zealot deliberately targeting liberals,” according to Marilyn Thompson’s book, *The Killer Strain*. Third, left-wing groups conducted a campaign to blame the U.S. military or the CIA. Their advocate, Barbara Hatch Rosenberg, met with the FBI and Leahy’s staff.

So while the Democrats yell about missing weapons of mass destruction in Iraq, they bear some of the blame for the missing anthrax killers.

A similar fiasco happened before when Richard Jewell was falsely suspected by the FBI of being the Olympic Park bomber. The FBI suspected for years that CIA officer Brian Kelley was the Russian mole in the U.S. Government who turned out to be FBI Supervisory Special Agent Robert Hanssen.

Speaking at an Accuracy in Media conference, Hatfill said, “I didn’t know it could be like this in the United States. We’ve gone nuts. We eat our own here.” The FBI’s misconduct is exceeded by the reporters who ignore or excuse it.






