## Chemical identified as hydrochloric acid

*One suspect arrested in rash of Marsing burglaries*

State lab officials identified a hazardous chemical left by burglars in an elderly Marsing couple's home last week as a high concentrate of hydrochloric acid, and Owyhee County Sheriff Gary Aman said he has suspects.

An 18 year-old Marsing man was arrested for the burglary of a real estate office in Marsing last week, and Aman said the man is also being questioned in connection with several other burglaries in the local town including the burglary where the chemical was left.

Jaye and Arthur Bish came home to green spray paint and a toxic chemical on the floor of their home on June 6. The couple had to leave their home

## Commissioners appoint hearing examiner for deserted P and Z

The Owyhee County Commissioners appointed a planning and zoning hearing examiner after the p&z commission dissolved with the resignation of three of the four remaining members. In May only one commissioner remained after chairman Sid Erwin, Dave Shenk and Dave Holton resigned because the county commissioners stopped paying them a compensation above a per diem they already received. Remaining commissioner Gene Tindall's term expired this month and county commissioner Chris Salove said Tindall expressed that he would not be willing to return to the job.

Since the commissioners quit last month, county commissioners have not appointed anyone else to the jobs. But last week, Salove said a hearing examiner had been appointed and planning and zoning issues are being taken care of.

"Fred Grant has been appointed to hear the applicants that are already on the docket so those people are not just put off

indefinitely," Salove explained. "Beyond that, no, we have not done anything else about it except discuss it extensively."

Salove said he could not speak for the rest of the commissioners, but he felt that for the best interest of the people, it might be best to stay with a hearing examiner.

"Let them all be heard by a hearing examiner," Salove said. "We would still need a planning and zoning, but they would fall back into the roll of an advisory council. They would advise on

## Father and son visit World War II Memorial

Steve Heidt of Marsing was given the opportunity to take his thirteen-year-old son Andre on the trip of a lifetime to Washington D.C. over Memorial Day weekend. Heidt received the opportunity to visit the dedication of the World War II Memorial. Andre said he could not think of anything else he would have rather done.

The Heidts are members of the Marsing American Legion Post 128 and of Squadron 18 of the Sons of the American Legion and have been since Andre was young. The trip was made possible by the legions Marsing and Nampa Posts and the Sons of the American Legion after Steve was chosen to represent the groups during the dedication.

Andre said the trip was something he would not soon forget.

"It was great," Andre stated. "When I found out we were going, I though cool."

Andre is a student at Marsing Middle School and Steve is a computer consultant. But Steve said he was motivated to go on the trip to honor his uncle, Roy F. Heidt who was killed in action in October 1944 at the Battle of Monte Casino in Italy.

Andre said he and his father are starting a Squadron in the Marsing area for local people interested in the legion and he said it would be sponsored by the local Post 128.

"The only requirement is to be an ancestor or have a living relative who was in active military," Andre said. "I know a few kids at school who might be interested. It is a very good learning experience for kids to be involved in."

for several days until authorities could identify the chemical left by burglars. Now most of the carpet, kitchen flooring and other items have been removed due to the chemical.

On Wednesday night Aman said someone broke into the Coldwell Banker Real Estate Office and vandalized the business. He said Charles Lindsey, 18 of Marsing was arrested for burglary and malicious injury to property. He said Lindsey is also being questioned in connection with several other burglaries in the area.

“They entered with the intent to steal money, but they couldn’t find any, so they did some minor vandalism,” Aman said. “We have a group of kids who are involved. They are suspects in numerous other burglaries and vandalisms in town.”

He said several additional people are involved and will be charged later.

Those arrested could be charged with aggravated battery or even attempted murder. Aman said he suspects that injuring the couple is what the suspects intended to do. Aman said about 10 people ranging in ages from 15-21 are being questioned.

If convicted of leaving the hazardous waste in the couple’s home, those involved could be made to pay for the damage to the Bish home.

Exposure to hydrochloric acid can cause circulatory collapse, which may lead to death. It can also cause asphyxial death due to glottic edema. It can also cause conjunctivitis and corneal burns, inflammation and ulceration of the respiratory tract, dermatitis, skin burns, rhinitis, laryngitis, tracheitis, bronchitis, pulmonary edema, dental erosion, hoarseness, a feeling of suffocation, nausea, vomiting, abdominal pain, diarrhea, dehydration, convulsions, oliguria, hypotension, chills, shock, lethargy, stupor, permanent visual damage, cough, and choking. Ingestion or skin

contact with hydrochloric acid can cause corrosion of mucous membranes of the mouth, throat, and esophagus, with immediate

pain and dysphagia; it can also cause gastric hemorrhage and intense thirst.

ordinances and that type of thing.”

When asked if he thought the board had strayed from an advisory council to a decision making council, Salove said he does not feel the board had strayed, unless a decision the commission made was not appealed. He said the law does not allow the board to be anything but an advisory council.

“With it being appeal-able with us, they can not be anything but an advisory council,” Salove said. “The only way they were not an advisory council is if their decision was not appealed.

“We need to recreate the p and z. There is no question of that. They need to be there because there is any number of ordinances that need to be redrafted and we need the input from a planning commission in order to come up with a new ordinance. I would love to have people volunteer for the job, but as far as going on with the applications, even if we had five people call and say they wanted to be on

the p and z, it still would not be practical to have them start out hearing applications right off because they would need to get up to speed. The whole idea is to get someone who hears the applications based just on knowledge of planning and zoning law and county ordinances. I would imagine there would be a number of them that would be appealed to us. There are not near the hearings that there used to be because of the new planning and zoning ordinance.”

A hearing before an examiner is much different than a hearing before the commission. Testimony is taken and only taken on very specific issues.

“I think people going into a hearing before an examiner will have much faster results and a decision would be made much faster,” Salove said. “When you get to bouncing back and forth among people, that is when you get the conflict.”

Commissioners Hal Tolmie and Dick Reynolds were not available for comment.

# A Tribute

## Ronald Reagan

1911 - 2004

“When the Lord calls me home, whenever that may be, I will leave with the greatest love for this country of ours and eternal optimism for its future. I now begin the journey that will lead me into the sunset of my life. I know that for America there will always be a bright dawn ahead.”

The Lord has called home His good and faithful servant and America and the world mourn his passing. Ronald Reagan was an unabashed conservative who believed in limited government, justice and liberty for all. His tax cuts revived a limping economy,



leading to an unprecedented economic surge and his shrewd foreign policy led to the end of the “evil empire.” “Mr. Gorbachev, Tear down this wall.”

His firm belief in private property rights led him to formulate a remarkable document, Executive Order 12630, which laid out rules for government agencies and departments to follow when contemplating regulations that could negatively impact private property. EO 12630 ordered that agencies and departments must carefully evaluate the results of federal licensing, permitting, or other condition requirement limitations on private property use to avoid unnecessary takings. EO 12630 has never been rescinded, although government agencies today seem blissfully unaware of its existence.

A bit of Reagan optimism is in order though. “We kept faith with a promise as old as this land we love and as big as the sky, a brilliant vision of America as a shining city on a hill. Thanks to all of you, and with God’s help, America’s greatest chapter is still to be written, for the best is yet to come”.

# Recovered rifle connected to Canyon County case

A Caldwell woman was injured in a one-vehicle rollover near Highway 95 and Jump Creek during the Memorial Day weekend last month, but its what officers found in her vehicle that was connected to a statewide burglary spree and to the identity of a Caldwell man who has been using the name of his dead brother for nearly 10 years.

County investigators said last week that Jennifer Meredith, 30 of Caldwell was still under investigation for driving under the influence, but it was a 22 caliber rifle found in the vehicle she was driving that was connected to a home in Caldwell which had much more than just stolen property. Drugs, paraphernalia and identity theft were also discovered.

The rifle with a scope was confiscated from the vehicle and has been confirmed stolen from Kootenia County. But county sheriff Gary Aman said Meredith will not be charged with possession of a stolen gun, but she will probably be charged with driving under the influence because the vehicle she was driving belonged to Michael James, also known as Daniel James, Meredith's boyfriend. Last week it was confirmed that Michael had been using his dead brother's identity for many years. Now he will face approximately 16 criminal charges from identity fraud to domestic violence.

Canyon County Detective Tracy Kimberling said last week that Michael James had turned himself into officials on a warrant for false information to a police officer.

Kimberling said Maryland confirmed that Michael's brother, Daniel died about 10 years ago and that Michael had been using his identity for nearly as long. She said he probably began using his brother's identity because Michael had a warrant from Maryland.

Michael is facing charges from Valley County, Ada County, the City of Caldwell, the City of Meridian and the City of Nampa as well as from Kootenia County. She said the county would file charges for fraud since Michael used Daniel's name as his own. She said that Federal investigators would be notified about the identity fraud since Michael has been using the name for so long.

# Former councilman re-appointed

A former councilman was appointed for a second time to the city council by a two to one vote.

Dave Downum was appointed to the city council last year to replace then newly appointed mayor Hap Duryee. Wednesday he was appointed to replace leaving councilman Charles Garrison. Garrison resigned his position last month after being called to duty to serve in Iraq.

Downum had been a member of the city planning and zoning before being appointed last May. In November he ran for the council seat during the city's general election, but was beat by Steve Schultz and Garrison.

"I have talked to Dave and invited him here tonight because I would like to appoint him to replace Charlie who has gone to serve in Iraq," Fink told the council. "I think he would do the people a great job as a councilman."

Downum received two of three council member votes. Councilwoman Cindy Sims and Councilman Kevin Barlow voted in favor of Downum, but Schultz voted against appointing Downum.

"I felt that in November I ran against Dave and he represented the former administration," Schultz said. "I think the voters spoke then and I owed it to my constituents to vote against him. I have nothing against him personally, but I felt I owed it to my voters."

Downum, who was appointed to the council earlier but was defeated in the last election, began his position on Wednesday.

# Jordan Valley man honored as outstanding citizen

Owyhee County Commissioners announce the selection of Tom Skinner as their first honoree to the Commissioners' roster of outstanding citizens. Skinner was honored during a presentation on June 14 at the commissioners meeting.

The commissioners announce the establishment of the "Commissioners' Roster of Outstanding Citizens" as a recognition program for persons who have made significant contributions to the custom, culture and citizens of Owyhee County.

Commissioner Dick Reynolds commented on the award program by pointing out that, "We don't have very many people in this large county and yet there's plenty of work to get done. We know that we have some great things being done in the interests of the county by people who don't get much recognition for their work. We wanted a way to give them some recognition."

"This county has many great people who not only work on

their own interests but also take on a tremendous amount of work that benefits their local community and the county in general," Commissioner Chris Salove agreed. "We wanted a way to say thanks to folks that make the extra efforts."

"The Owyhee County Commissioners' Roster of Outstanding Citizens. The persons named here are honored for their selflessness, dedication, and Commitment to the Custom, Culture and Citizens of our great County."

Below the inscription will be placed the name of each recipient and the date of receipt. Each recipient will receive their own plaque, which, in addition to the image of the County seal, bears the inscription, "The Owyhee County Commissioners Honor (recipient name) for lifelong service and dedication to the custom, culture, and citizens of Owyhee County. Given this (date), Hal Tolmie, Chairman, Chris Salove, Commissioner, Dick Reynolds, Commissioner.

Commission Chairman Hal Tolmie stated that the commissioners designed the program to allow for flexibility.

Skinner, who currently resides in Caldwell, has a long history of involvement with Owyhee County. While he is now a Canyon County resident and was born in Boise in 1917, He was reared on a ranch in Jordan Valley, Oregon one mile west of the Owyhee County line. He said he remembers how his family struggled through the depression of the late 1920's and 30's.

"We were always looking for our stray cattle that wandered into Owyhee County looking for feed," Skinner recalled.

He graduated from Jordan Valley High in 1935 and from Oregon State in 1940 with a degree in Range Management. With that degree, he took a job in Lakeview, Oregon with the Division of Grazing, which is now the BLM. After serving in the Army during WW II, He returned to run the ranch. He eventually became a real estate appraiser doing both residential and ranch properties and in 1996 retired from that profession.

Skinner's love for Owyhee County has never wavered and he is still active in county issues as a member of the Owyhee County Historical Society, Natural Resources Committee, Sage Grouse Local Working Group, and People for the Owyhees. But those simple statements don't convey the degree to which he remains committed to the custom, culture, and citizens of Owyhee County.

Despite medical concerns that would sideline most, he is not only present at the meetings of the groups mentioned above, but is extremely active in them. He recently served as a field trip leader for the Historical Society and last year participated in a grueling two-day tour of remote grazing allotments as a member of the Natural Resources Committee. During water adjudication trials held under the Snake River Basin Adjudication, His knowledge of the Pleasant Valley ranching area and his confident testimony was crucial to the case.

Skinner has never lost his love for the people and places of Owyhee County. His continuing participation in so many matters of importance to the county prompted the Board of County Commissioners to select him as the first person to be honored on their Roster of Outstanding Citizens.

# Commissioners appoint two to NRC board

Owyhee County Commissioners appointed two new members to the Natural Resources Committee last week after approving a recommendation for the members from the current committee. Paul Waldon of Boise and Wyatt Foss from Nampa will join the board next month.

Foss applied as an alternate for Bill Walsh, president of SIDRA, South Western Idaho Desert Racing Association president and stated that his involvement, interest in and expertise in the multiple uses of the federally and state managed lands within Owyhee County include SIDRA land use fund from 1994 to the present, involvement with the RMP from 1994 to 2000 and he has dealt with ranchers and BLM by helping organize motorcycle races since 1990. Foss said he has also worked with the BLM on mapping trails on the Owyhee Front from 1990 to present.

Foss also stated that he is a supporter of the Owyhee Cattlemen's legal fund and supporter of the People for the Owyhee's rallies.

Waldon has lived in Boise since 1980 and said he has worked in the forest products industry for many years. He is employed by J&H Forest Products and stated that his responsibilities include selling sawmills, production and brokering wood products from other producers to customers all across the United States.

"My spare time is primarily spent outdoors, hunting birds and big game, and fishing and camping with friends and family," Waldon stated in his application. ""My outdoor afflictions have led me to explore much of Owyhee County over the years. There are few places I have not been in the county."

Waldon said he has participated in habitat improvement projects on the Joyce Ranch and plans for more. He said he has traversed the county on foot, four-wheel drive pickup, on horseback and on ATV. He is past president of the Gem State Chapter of the National Wild Turkey Federation, member of Ducks Unlimited for 25 years and served on the task forces for Idaho Department of Fish and Game.

"I feel my diverse interests in what Owyhee County offers the sportsman and my resource based career gives me a unique perspective into the county's issues," Waldon concluded.

## Watershed council opens small grant program

The Owyhee Watershed Council announced the opening of its 2004-2005 small grant program last week.

The program is available to address resource concerns in the Oregon portion of the Owyhee River Basin and portions of the Mid-Snake Succor Subbasin in Oregon only.

The Oregon Watershed Enhancement Board allocated \$80,000 of State Lottery funds for small watershed restoration projects within the Owyhee Watershed Council and the Malheur Co. SWCD, is charged with administering the funds.

The small grant team will review and approve project applications. Priority consideration will be given to projects addressing water quality concerns. Projects that address water quantity, rangeland health, soil condition, AFO/CAFO waste management and wildlife concerns are also eligible for funding. Funding decisions will be based on an objective scoring criteria based on the identified local priorities.

Applications will be taken on a continuous basis until June 1, 2005 or until funds are exhausted. Individual grant awards must not exceed \$10,000 and must demonstrate a minimum 35 percent match.

## Airman could face manslaughter charges

A single vehicle rollover last month at milepost 44 on Highway 51 near Riddle claimed the life of a female member of the Air Force assigned to Mountain Home AFB. Now the man driving the vehicle may be charged with her death.

Airman Tanna Teresa Preston, originally from Sacramento, Calif. was pronounced dead at the scene near a treacherous stretch of sharp curves known locally as the "flying 44." Owyhee County Sheriff Gary Aman said the stretch of road has received its name because of the number of vehicle over the years that have left the road there after failing to negotiate the curves.

But Aman said after an investigation, which included a re-enactment of the accident, Airman First Class Zachary Chotia 18,

could be charged with vehicular manslaughter.

"Our investigation shows that Chotia was traveling at speeds in excess of 70 miles per hour," Aman said last week. "She was thrown from the vehicle and killed instantly. After the final report is finished, the case will be given to the prosecutor for criminal charges."

Preliminary reports indicated that the vehicle began to go off the road and the driver overcorrected, and the car then rolled down a small embankment.

Preston was thrown from the vehicle. Chotia was found by Grand View ambulance crews to be walking around the scene, but suffered from "serious" head injuries.

Temperatures in the Owyhee County area are expected to increase this week as a high-pressure system builds in the area reports from the National Weather Service stated.

“A surface thermal through will begin to develop across the Nevada/Idaho border by Wednesday bringing above normal temperatures and afternoon humidity’s near 10-15 percent to the BLM lands Wednesday and Thursday,” the report states.

Wednesday is expected to be clear with lows in the upper 30s to lower 50s and highs in the 70s to 80s. Winds are expected to be light at about 10 miles per hour.

Above average temperatures are expected to remain in the area through next week. Below normal precipitation is expected.

Reports from Owyhee Reservoir Monday reported 298 cubic feet per second entering the reservoir at Rome. The reservoir is at 51 percent of full with 362,234 acre-feet of water. Two hundred thirteen cubic feet per second is being released from the dam.

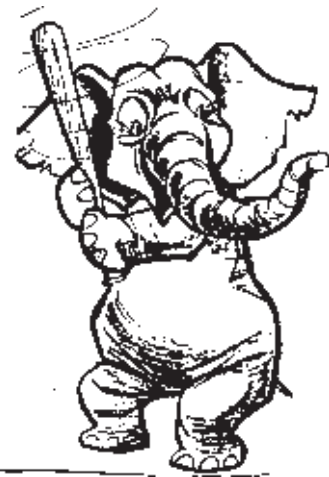

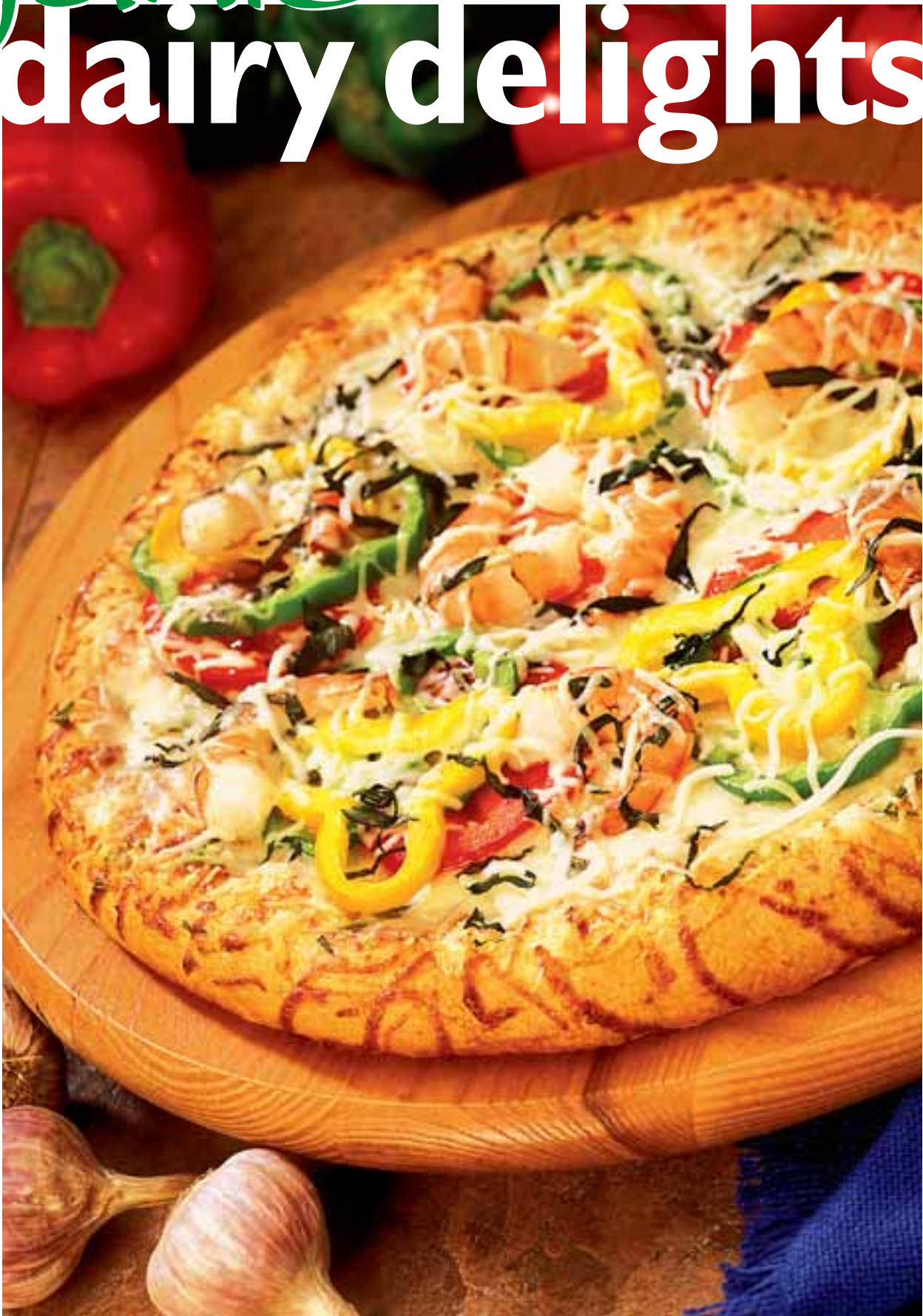

### Sunburst Cheesecake

Must prepare day ahead

**Crust:**

- 1 1/2 cups graham cracker crumbs, cinnamon or plain
- 1/2 teaspoon ground cinnamon
- 3 tablespoons sugar
- 6 tablespoons Horizon Organic unsalted butter, melted

## Not important ... *but possibly of interest*



When I was a kid, it was the custom for members of each fourth grade class at Kuna Elementary School to take a special trip. On a designated day, all the fourth graders were loaded on a passenger train for a ride to Boise. They had a picnic in Julia Davis Park before returning home on busses.

When we reached the fourth grade we were devastated to learn the train ride was discontinued. We felt we had been robbed of a birthright. But our teachers came up with a new plan. When we were sixth graders we were informed we would be the first class to start a new tradition. We would all get a ride in a real airplane!

On a spring day in 1957, a school bus took us to the Boise Airport. Parked on the tarmac was our ride - A Douglas DC-3 operated by Empire Airlines, a small company that served Pacific Northwest communities.

The DC-3 wasn’t a new airplane. It was first used commercially in the early 1940s. During the war, thousands of the two-engine transports were built in a military version called the C-47. When the war ended, many of the C-47s were converted into civilian airliners. It’s quite possible that the plane sitting on the runway at the Boise airport had dropped paratroopers behind the Normandy beaches twelve years earlier.

As we boarded the plane the butterflies fluttered in my stomach. The stewardess showed us how to fasten our seatbelts. The engines started and we taxied out to the end of the runway. We sat there for what seemed like an eternity while the pilot revved up one engine, then the

other-sort of like a horse pawing the ground before the start of a race.. The entire plane shook and rattled and the wings appeared to be flapping. Finally, the brakes were released and the aircraft started to move. With engines howling we gained speed. Suddenly, I got a weird sensation in my stomach. I looked out the window and realized we were airborne.

The landing gear retracted with a thump and the pilot throttled back the engines somewhat. Still, the noise made it difficult to talk. That wasn’t a big problem because we all were staring out the windows. In those days, air travel was still pretty new and I’m guessing it was the first time anyone in our class had been airborne.

I marveled at how small everything on the ground looked from the dizzying altitude of 5,000 feet. The DC-3 did considerable bumping and jumping around as we cruised above the Boise River-all the way to Lucky Peak Dam, at a breathtaking 140 miles an hour . Then we turned around and flew back down the river. As we approached the airport, I tried to take photos of the city below with my Ansco Pioneer 620 camera. The pictures, which I still have, were terribly blurred because of the vibration generated by the plane’s snarling engines.

I think our 15-minute flight was the first and last taken by a Kuna Elementary sixth grade class. Possibly the airline decided the trip wasn’t worth the trouble from a financial standpoint. More likely, some parent or teacher realized that if one of the war surplus engines on that DC-3 had quit, the Kuna Hugh School class of 1963 would have been pretty darn small.

## Accuracy in media

### The media hated Reagan

*Cliff Kincaid, Editor of the AIM Report.*

Washington Post media reporter Howard Kurtz wonders why much of the coverage of Ronald Reagan at the time he was president is so different from the way he is being revered today. It's a good question. Kurtz doesn't have the right answer.

I was in Washington, D.C. at the time, documenting the anti-Reagan media bias for Accuracy in Media and other groups. Ben Bradlee of the Washington Post said that covering the Iran-Contra affair was as much fun as Watergate. He thought they'd nail another Republican president. The sharks smelled blood in the water. I met Reagan at a White House Christmas party and presented him with a button that AIM had made up showing a shark with a big "X" on it. I gave it to Reagan, he laughed, and he told wife Nancy: "That means 'no.'"

In the end, of course, they didn't nail Reagan on Iran-Contra. The sharks had to feed on lesser prey. Reagan didn't have the details about the arms deals with Iran and the Nicaraguan freedom fighters, the Contras, and

National Security Council staff member Oliver North and others took the fall. The Iran part of it was designed to free American hostages in the Middle East. It worked for a while. The Contra part was designed to keep the resistance alive while the liberal Congress, led by Senator John Kerry, tried to destroy it. Reagan, North and the freedom fighters ultimately prevailed. We still have many problems in the Middle East but Central America is free of communism.

So why is the coverage of Reagan's death favorable? Kurtz says there is a tendency in the media to say nice things after someone has died. "More important," he adds, "a man's legacy looks very different 15 years after he leaves the White House, and following a long illness that took him out of the political wars. No one knew when Reagan stepped down that his military buildup would ultimately play a role in the demise of the evil empire he railed against."

It is possible, of course, that the media recognize that Reagan's anti-communism produced dividends for the U.S. and the world. I think it's doubtful. Remember that reporters at the time, such as Karen DeYoung of the Washington Post, said journalists regarded left-wing groups in Central America as the "good guys." This included the Nicaraguan Communist Sandinistas, who seized power in 1979 with the help of then-

President Jimmy Carter, and the communist guerrillas in neighboring El Salvador. Reagan opposed these groups. His policy of supporting the Nicaraguan freedom fighters, or Contras, resulted in the demise of these and other anti-American terrorists movements in the region.

Reporters are trying to appear pro-Reagan because they don't want to be perceived as completely out-of-touch with the sentiments of the American people. I don't really think that journalists ever liked his policies, then or now. The recent Pew Research Center survey indicates the press is even more liberal than it used to be. This is why, I believe, that traditional liberal news organizations are losing readers and viewers and why conservative outlets, such as talk radio and Fox News, have grown in popularity.

Reporters are aware of these results, even though the findings have not been widely publicized. But a more recent Pew Research poll is even more significant. It confirmed that Fox News Channel is making dramatic gains in attracting conservative and Republican viewers. A perceived conservative news organization is enjoying incredible success.

Fox, of course, is not necessarily conservative. Bill O'Reilly rejects the label, and several hosts, including Greta Van Susteren, are regarded as being to the left. The new host of Fox News Sunday, Chris Wallace, is the son of liberal media icon Mike Wallace. But Fox does provide conservatives and Republicans with access, and for that they are clearly grateful. Plus, Fox covers a lot of news of interest to conservatives.

At the Brookings Institution forum where the latest Pew results were released, panelists decried the "polarization" of the media. They didn't like the fact that conservatives were drifting toward Fox News while liberals and Democrats were sticking with news organization such as National Public Radio and CNN. I submit they don't like this development because it spells more trouble for liberals, a far smaller percentage of the general population, and their preferred media. I told the panel that "polarization" was a healthy development and that it would continue. I don't think a burst of pro-Reagan coverage by the liberal media will affect the trend toward more conservative-oriented media. But the liberal media seem to be showing some awareness of the trend that is threatening their existence.

### Accused petitioner responds

I read with interest the article "Patrons Petition for Removal of Administrator and Principal" that appeared in the June 2 issue of the Owyhee Avalanche. I was surprised to read that Superintendent Taylor accused me of starting the petition. While naturally flattered, I cannot take credit for the good work of others. I had no part in starting or writing the petition, but was honored that they asked me to sign it. As I understand it, a large group of Bruneau / Grand View patrons met and put it together. I was not part of the process; I was busy attending my son's little league games.

This is just one more example of the false accusations that have become the standard of behavior for the Bruneau / Grand View School District Administration. This is twice this year the administration has attacked my family with such tactics. Those with evil intent often credit their enemies with their own motives. The administration apparently thinks I am intent on revenge. The truth is that I have a business to run, a sick wife to care for and burgers to flip at my son's baseball games. My life is too full to be bothered with revenge and I refuse to return evil for evil. But I will stand up and expose evil when it starts hurting the children, teachers and parents of my community. If the administration wants to continue attacking me, fine, my shoulders are broad enough, but I think the community has had just about enough of this abusive behavior.

Elsewhere in the article Russ Turner stated that not one patron has approached him with concerns about the administration. I have been to numerous board meetings where patrons have repeatedly expressed such concerns. This can be verified in board minutes. If board members wonder why they are not being contacted by patrons outside of meetings, there are good reasons. Board members refuse to talk to patrons about the most serious issues because they involve personnel, and that can only be discussed in executive session, from which the public is excluded. Bruneau / Grand View patrons have also learned that any complaint about the administration is met with retribution! Two days after I confronted the administration about their unsafe snowball throwing policies, my wife, a teacher at Grand View, was falsely accused, tried in executive session without her knowledge, and handed over to her accusers for punishment. There was no prior notice that anything was wrong and no chance given to correct any behavior. To this day the school board has never asked my wife to present her side or followed up on any of the accusations. Without any kind of supervision by the board, Principal Delle was free to harass my wife

until her health broke.

Meanwhile, the unsafe snowball throwing policy has never been addressed. Grand View is the only school in Idaho that allows the unsafe practice snowball throwing! Principle Delle told me that any child that chose to throw a snowball had to face the consequences of their action. Small comfort if my son had lost his eye instead of his glasses! We send out children to school on the assumption that they will be placed in a safe environment. When I confronted the principal and superintendent about their unsafe policy, I received only insult for my son's injury. Two days later, without any notice, the administration chose to pay me back for the confrontation and hide the safety issue by attacking my wife in executive session.

At the May 20 board meeting I presented documentation of the administration's unethical behavior concerning the dismissal of the school's VISTA volunteer, a subject that can be freely discussed outside executive session. In the newspaper article the administration stated that no proof has ever been given of the charges against the administration. I can only say everyone heard me at the meeting and that the evidence is rock solid. Now in retaliation, Dr. Taylor has chosen to use the local newspaper in an attempt to defame and discredit me. But as I stated above, she missed the mark and another of her false accusations is exposed.

There are two sides to this story. The administration would have you believe all is sweetness and light at the school. They do not tell you of the constant parade of teachers and staff to the health center for stress-related illnesses. They do not tell you about the plummeting science and social studies scores in the school. They do not tell you of the constant fear by the teachers and staff that they will be the next targets. People working under the administration know all too well that if they speak up, they may find themselves reassigned to an unfamiliar grade, reprimanded, or put on probation on trumped up charges.

I ask that the Owyhee Avalanche investigate both sides of the story. Call up to Kamiah and find out why Dr. Taylor was asked to leave that community. Investigate the dismissal of the VISTA Volunteer. You don't need to take my word for it, investigate. Find out why the incumbent Chairman of the School Board was easily defeated by a write-in candidate. If no one will talk to you, dig harder and get past the fear of retribution that has silenced other victims. The facts you will find will speak clearly enough for themselves.

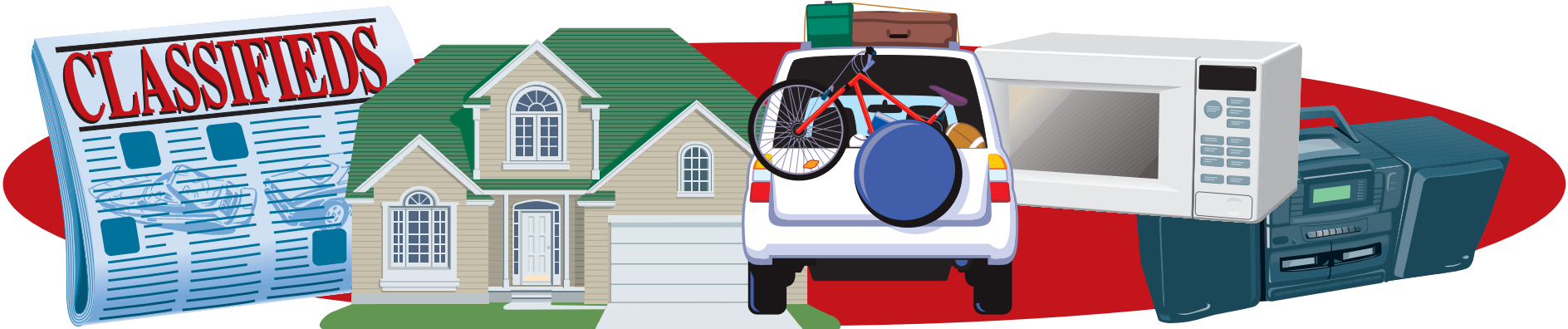

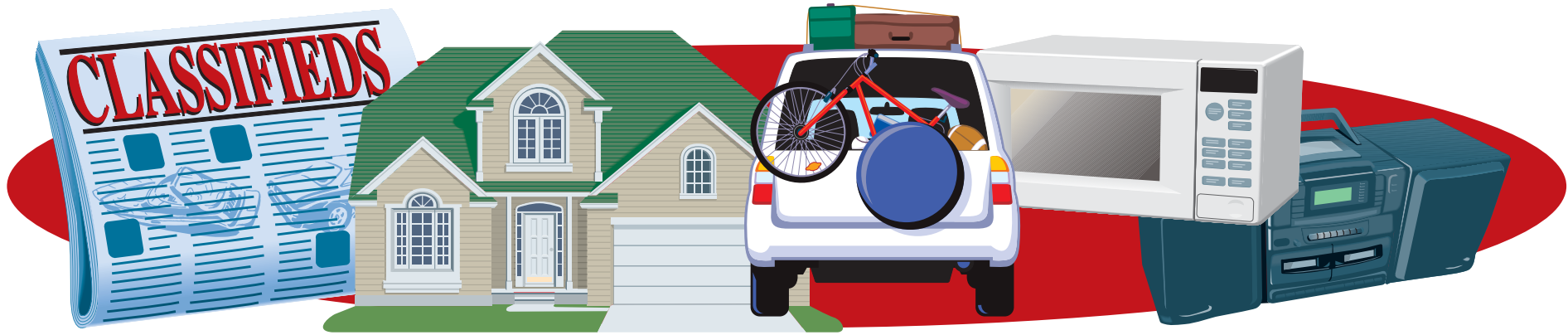
