Junior Livestock Sale grosses second highest sales ever recorded

Overall

sales were at

\$117,219.36

this year.

The Junior Livestock Sale during the Owyhee County Fair and Rodeo grossed the second highest amount of sales recorded by the county extension office, a spokesman said last week. Overall sales were at \$117,219.36 this year, just under the record of \$123,742 set in 1994.

County extension secretary Debbie Titus said the of-

fice has kept records of the sales since 1991 and although the amount of animals sold was down, the total income was up. Buyers included \$20,185.76 in add-ons.

Twenty-six beef were sold this year of a gross total of \$48,148.16. Eighty-two hogs were sold for \$54,627.80 and 31 sheep were sold for a total of \$14,443.40.

Last year, 30 beef were sold for \$39,568.37. Eighty-five hogs were sold for \$53,918.60 and 30 sheep sold for \$16,467.45. Last year's total sales were at \$109,954.42.

In 1994, 45 beef sold for \$60,312, 110 hogs at \$47,571

and 60 sheep at \$15,859. From 1991 to 2004, minus 2001, which the extension office did not have a record of, 408 beef have sold for a grand total of \$547,913.47, 1,115 hogs for \$542,417.18 and 512 sheep for \$181,703.33.

The average bid for a beef was \$1.49 per pound with an average sale price of \$1,851.85. The total weight of beef sold was


32,094 pounds. In sheep, the average bid was \$3.735 for an

19.36 average seller price of \$465.92. Three thousand eight hundred fifty seven pounds of sheep were sold.

Eighty-two hogs were sold for an average bid of \$2.434 per pound. The average seller price was \$666.19 and a total weight of 22,452 pounds.

Overall summary shows 139 animals sold for an average bid of \$2.547 and an average seller price of \$843.30. Over 580 thousand pounds of animals were sold.

Titus said an additional \$20,185.76 had been added on in donations to the sale.

County prosecutor's residency questioned

According to documents at the Canyon County Recorder's Office, Owyhee County Prosecuting Attorney Ed Yarbrough recently purchased a home in Canyon County and it is unclear if the prosecutor still lives in Owyhee County.

It was reported that Yarbrough was staying with his grandfather,

the prosecutor has left in office, doing anything about it would be a waste of time.

"He would have us tied up in court until his term of office was up anyway," Salove said last month. "We would still end up paying him for the rest of his term regardless."

City spending comes to a stand-still

Council approves proposed budget in special meeting

Homedale Mayor Paul Fink told council members during a budget workshop Wednesday night that any unnecessary spending of city funds would have to stop until the city has a better idea of how much money it has. On Tuesday evening, a special meeting was called to approve the 2004-2005 proposed budget, which included some changes.

Fink said the budget is only the operating costs the city will use for the next year. He said the budget would be reopened later this year to include contingency money and amend the budget.

"Right now we believe, with the help of everybody, that we have put together a budget we can squeeze by with for next year," Fink told the council. "With that I would recommend this proposed budget for 2004-2005 be approved."

The proposed budget is set at \$1.15 million, which is nearly \$900 thousand dollars less than the current budget of \$2.042 million. Fink said the proposed budget at this point is mostly estimates, as the city does not have any idea what the carryover will be, if any.

"This budget is the bare bones until we get that audit done and see what we have," Fink said Tuesday. "We only plan to reopen the budget if we get in trouble. We have no idea where we are at right now. We have no idea what our carryover is going to be until the audit is done, and it won't be done until about Sept. 10. It is tough shape." Homedale City Clerk Susan Mansisidor said Thursday that several line items had been drastically reduced because of a variety of issues including "two" sets - to page 5

He said he would address the matter with legal consultant Fred Grant during Monday's commissioners meeting, but right now he did not know if an elected official had to live in the county or not.

Tolmie said the county is paying an additional attorney for civil matters when they should be using the current prosecutor. He said if the prosecutor was removed from office because he does not live in the county, the county would be paying for three attorneys.

Phone calls to the prosecutor were not returned by press time.

Grand View man killed in vehicle accident

A Grand View man was killed instantly in a vehicle accident on Highway 78 early Thursday morning. Reports show that Phillip Patrick Rahn, 28 was driving a silver Dodge Ram pickup at about 2:30 a.m. Thursday on Highway 78 about five miles west of Grand View when he swerved in front of a semi cattle truck.

Tye Smalley of Redmond, Oregon was westbound in the semi when he approached an attempted to pass Rahn. The accident report states that as the semi was in the process of passing, Rahn without warning attempted to make a left turn on a nearby road, crossing in front of the semi. The semi hit the driver's side of Rahn's vehicle killing him in the crash. Smalley was uninjured.

The crash remains under investigation and troopers report alcohol may have been a factor.

Sheriff's office assists in \$40,000 theft recovery

In April, Jennifer Meredith of Caldwell was injured in a one-vehicle accident near Highway 95 and Jump Creek and when officers arrived they discovered that Meredith was in possession of a stolen rifle. The investigation into the rifle started a domino effect and now has led to the arrest of a Caldwell man for stealing \$40,000 in items and in a search for a boat worth just about as much.

Owyhee County Sheriff Gary Aman said that Meredith was in possession of a 22-caliber rifle at the time of the accident. After an investigation by county officers it was discovered that the rifle was stolen and it was traced back to Kootenia County. The firearm was connected with an investigation being conducted by Canyon County officers in connection with drugs, paraphernalia and identity theft.

Meredith was driving a vehicle belonging to James, also known as Daniel James. James had been using the name of his dead brother, Daniel, for approximately 10 years. Last week Canyon County Sheriff's Deputies recovered about \$40,000 of the stolen property from James' rural Caldwell home, but they are still looking for a fishing boat. James is suspected of stealing the items and was arrested and released on bond last week. Now James will not tell detectives were the boat is.

Deputies recovered the stolen items from a residence belonging to James, located on the corner of Deer Flat and Map Rock roads east of Marsing.

The stolen property included several firearms, a four-wheeler, two trailers and other miscellaneous items taken from houses and construction sites during burglaries dating back to 1995. Investigators said they also found illegal drugs at the residence.

In addition to the stolen goods, sheriff's officials said deputies found an identification plate and trolling motor from a missing Ranger bass boat valued at about \$35,000. Witnesses said they had seen James with the boat, but authorities said he has refused to tell detectives where it is.

Canyon County sheriff's officials said Tuesday that James has been arrested and charged with 16 felony counts of possession of stolen property and is out on bond awaiting court proceedings.

James could be facing charges from Valley County, Ada County, the cities of Caldwell, Meridian and Nampa as well as from Kootenia County. Officials said the county would file charges for fraud since James used Daniel's name as his own. Officials said that Federal investigators were notified about the identity fraud since James has been using the name for so long.

Suspect in local stabbing arrested in Nevada

A Homedale man suspected of stabbing a 20 year-old woman a week ago is behind bars in Humboldt County, Nevada after being picked up during a traffic stop.

Homedale Police Chief Jeff Eidemiller said Mauro Ortiz Guzman, 24, was arrested Saturday morning on a highway in Nevada. Guzman is accused of stabbing Teresa Solano Cruz.

Kuskie said Guzman reported to his department that he would not fight extradition, but that he is not the man officials should be looking for.

"We picked him up after an informant told us he would be traveling the road," Kuskie said. "We initiated a traffic stop on a white Chevy cavalier between Kings River and Oravada. When we booked him in he tried to sign in with a different name and when we checked another jail, he was listed with another name there. He told us it wasn't him."

Kuskie said when Guzman was picked up he had scratches and scraps on his body. He said Guzman reported that he received the injuries when a woman tried to hit him in a truck.

"He seems to know what happened, but he says it was another guy," Kuskie said. "He knows why he is here."

Heat wave breaks, fall temps expected through week

Near 100-degree temperatures for the past several weeks broke Sunday morning as fall-like temperatures set in and are expected throughout the rest of this week. A strong cold system moved through the Owyhee Valley Saturday night dropping rain and temperatures dipped into the lower 50s for the night.

The National Weather Service stated that a distinct change in air mass during the cold front dropped temperatures to an "almost autumn like feel."

"The upcoming week looks to be active as well with a series of short waves," the statement said. "This promises to keep the area cool and moist through at least midweek and possibly beyond. Despite this weak amount of drying on Monday, air mass remains cool and conditionally unstable. An even stronger short wave moves into the forecast area Wednesday afternoon." Highs on Sunday only reached the upper 60s and light rain fell most of the day. Today, Wednesday, is expected to be mostly cloudy with a 40 percent chance of scattered showers and thunderstorms. Highs should be in the upper 60s to low 70s. The chance of rain increases throughout the night to 50 percent and lows 41-50. Thursday calls for partly cloudy with a slight chance of showers and chance of thunderstorms. Chance of showers is 20 percent. Highs are expected to be between 64 and 71 degrees with lows 43 to 51 degrees.



Marsing council amends current city budget

Work is under way to provide the Bureau of Land Management with a new field office in the City of Marsing, but to do so the council had to first amend its current budget by over \$260,000. The city approved the amendment during a special meeting Wednesday night although a legal notice published stated the meeting was to be held on Aug. 10.

Marsing Mayor Don Osterhoudt said originally the budget was going to be amended for \$223,000 but the price went up with extra additions at the request of BLM. He said the amendment would be paid by BLM over a term of seven years and after the BLM was done using the site, the City would have a new city hall.

"We have pretty much a firm commitment on what we are looking at," Osterhoudt said. "We will raise the amount as to what we will take in and what we will expend. We have had public hearings on the subject and I think pretty much everyone is in favor of pursuing the building."

Osterhoudt said the building is prefabricated and the city will purchase it. He said a sidewalk and landscaping would also be done. He said BLM is currently putting together a lease, which has not been presented to the council. Plans are to have the site up and operational by Oct. 1.

"We will have to let the fencing contract and the paving contract, but other than that all we have to do is place the building and it is ready," Osterhoudt said Wednesday. "I don't know yet if the people we are buying the building from are going to provide the foundation or what. Those are the nuts and bolts I don't have the answers to yet."

Osterhoudt said nothing would be done until he has a signed commitment from BLM on the lease agreement.

"They are telling us that they are adjusting staff right now for between 12 and 15 people," Osterhoudt said. "The whole thing about it is they are hoping they can hire some of the local people. With a seven year commitment there may come a point and time when someone feels that Marsing is a great place to raise a family. It is not inconceivable to have people move into the area and live in Marsing. That is our goal."



Sheriff says county received two grants from Homeland Security

Owyhee County Sheriff Gary Aman said an article published in The Owyhee Avalanche on Aug. 11 should have been clarified to state that the county has received two grants from Homeland Security equaling out to nearly \$500,000. One grant is for the county and the other is designated for the civil defense fund.

The Homeland Security grant is for about \$128,000. He said it would be divided up among the fire and ambulance departments throughout the county. Homedale will get approximately \$20,000 and Grand View will get about \$40,000.

"It will also go to purchase a community wide system," Aman said. "It is a big speaker on a pole that is programmable to notify residents of emergency circumstances like a dam break, chemical spills or even severe storm warnings. It will take up to 14 different messages and tones."

Aman said he plans to purchase three night search goggles for the county's portion of the grant. On the second grant, the sheriff's office will receive about \$77,000 and it will be used for training and equipment.


"The second grant is for the county to establish emergency response for bio-chemical disasters or hazardous materials disasters," Aman said. "It is about a \$308,000 grant."

He said one grant will be used for the purchase of the Office of Domestic Preparedness and Idaho State Bureau of Homeland Security approved equipment, training, exercises, planning, LEPT and citizens corps and the other will be used for community wide civil defense. Aman said Civil Defense Director Larry Howard has been meeting with county fire and ambulance officials and putting together community emergency response teams. He said Grand View would be the first community response team put together.

"It is made up of community people, volunteers," Aman continued. "The \$40,000 will help for packs for all of the officers and fire people. The packs will support that person with enough equipment to survive for 72 hours. It has food, water, clothing, respirators and more in it."

The announcement of the grant was made last month and is broken down into several programs. Equipment is allocated to receive \$168,440.74, exercises will receive \$22,847.27, training will receive \$21,321.61, planning, \$18,715.64, and LEPT will receive \$77,212.45.

"If it was not for Larry, this county would not have some of the grants it has gotten," Aman said. "He has written five grants in the last year for us. He should be commended for his work."

of budgets. She said the operating budget in the city's computer, "which is what the city operates under" does not match the budget that was published by the city for 2003-2004.

Mansisidor said the city's operating budget shows cost for the water project at \$350,000, but the actual to date expenses have been \$354,000, which puts the budget at a negative \$4,000. She said the bridge project was budgeted for \$18,000 but \$108,000 was actually spent. She said the account received grants, which they will not receive this next year.

"In sewer on revenue the city has year-to-date received \$79,000 and there is no way we will receive another \$20,000 by September 30," Mansisidor said. "We do conceivably feel that we will collect more this coming year as enforcing past due payments has not been done in the past."

The public hearing on the proposed budget is set for Aug. 26 at City Hall at 6 p.m.

Simco Road project completed

The long-awaited paving of Simco Road, connecting Interstate 84 and State Highway 67 near Grand View is now complete.

J.R. Simplot Company and U.S. Ecology funded the project jointly in conjunction with the Mountain Home Highway District. It includes the full 20mile length of Simco Road south of Interstate 84.

Tom Basabe, president of Simplot Livestock, said the project would enable Simplot cattle and supply trucks to use the road, reducing travel by 15 miles per trip or about 325,000 per year. Simplot operates a 150,000 head cattle feedlot and has farming properties I the Grand View Valley.

"U.S. Ecology Idaho was pleased to contribute to the paving of Simco Road," Simon Bell, manager of the company's Grand View operation said. "This paving project will substantially reduce truck traffic to our waste disposal facility through or near Mountain Home."

The Mountain Home Highway District will maintain the road. Various proposals to pave Simco Road have been considered by the district over the past 40 years, but adequate funding was not available.

Tim Corder, chairman of the Mountain Home Highway District, said the project represents a cooperative effort between industry and local government.

"This is of significant benefit not only to the residents of Elmore County, but Owyhee County as well," he said.




The reservoir is holding 24 percent of full at 168,167 acre-feet.






Homedale High School was honored as the top 2A school and Rimrock High School in Bruneau was honored as the top 1A school.



Goodbye Dr. Charlie

This is a personal story. In my travels around the country I make it a habit to stop and visit with folks. I'll see a farmer on a tractor, a cowboy on a horse or a kid with six tattoos, spiked hair the color of a highway flare, and a face that looks like he fell in Grandpa's tackle box, and I'll pull off the road and introduce myself.

One Saturday morning four years ago, I pulled into a small veterinary clinic in south Louisiana. I met Dr. Charlie. He offered coffee and I made another friend. A few short weeks ago we talked on the phone. He had full-blown cancer and, according to his doctor, had "two days, two weeks or two months to live."

I sat slack-jawed and flat-footed on the telephone and listened to his story and was humbled by his positive attitude in the face of such tragedy. Then he told me jokes and stories. I was actually laughing when I hung up and wiped the tears from my eyes. He died a week later.

Here is one of his stories, which he swore was true, and I know a Cajun wouldn't exaggerate!

Early in Dr. Charlie's veterinary career he assumed the veterinary care of a dairy run by a cloistered order of nuns. It became his charity work. Because of their rules, only two of the Sisters were allowed to talk to him. They wore army fatigue combat boots and a pink habit head dressing.

Sister Mary, a bright, but serious grandmotherly woman was his liaison. One afternoon he was called to the dairy to examine a dead cow. She appeared to have bloated but "Dr. Charles," as Sister Mary called him, thought a necropsy was appropriate.

He asked Sister Mary to stand back as he punctured the rumen. She did not gag, but paid close attention as he pushed his arm inside for a feel and retracted a long piece of cloth that was still partially occluding the esophagus.

Sister Mary delicately collected the offending cloth and rinsed it under a faucet. It was one of the pink Joe Aman

Editor's notebook

I don't mind paying taxes, but ...



Owyhee County's cash situation is as low as it has been in a few decades or so, and the consequences of this situation will be reflected on each property owner's tax bill

Based on the proposed budget an overall increase in the tax bill will be 9.7%. That is, unless you own commercial property in Homedale.

According to the assessor's office, commercial land in the Homedale area is suddenly worth a lot more money. So much – according to the assessor – it has doubled. So, naturally, the taxes will double. Oh, yeh, and then add the 9.7% county increase.

In the real world, if last year your property assessment on commercial land in Homedale was \$10,000, the county tab was \$35.82. This year that same land is said to be worth \$20,000, raising the tax to \$71.64; add the 9.7% and you have a tax bill of \$78.59. And that's just the county portion.

Should city, school, cemetery, fire, and highway district levies remain as last year (any bets?), that last year's \$10,000 city commercial land taxes will increase to \$388.39 compared to the previous bill of \$177.02.

Yes, it's true that the Homedale Highway District taxes the property in Homedale city, in spite of the city taxing for streets. The city maintains the streets, the highway district doesn't. Never has. That's called double taxation. This double-whammy needs rectified. Either turn the streets over to the highway district and drop the city taxation, or take the city out of the highway district and drop the

district tax. Preference is to turn the streets over to the district, which is responsible for all public roads within the district anyway. And then the city could cut its budget, and the district could pick up the \$94,000 in gas taxes the city now gets. ***

Speaking of cutting, the county is cutting a deal to lease the court facilities in Homedale from the city. The amount offered is \$6,000 annually. (That's not a lot of money in the scheme of things, but it's about a third of what the county cut from the expected pay increases for employees for next year – due, of course, to lack of money.)

The point is that the county has no legal obligation to pay the city a dime for the court facilities. State law requires the city to pay for not only the court facilities, but staff, supplies, and other expenses. Maybe - since the city is in worse financial straits than the county - the commission felt it should make this contribution of tax money to the city. Only thing I can figure. ***

Over the decades I've been in this business, local governments are usually crowding the deadline for publishing budgets, and often, many miss the deadline required by law. This experience caused me to have egg on my face when I didn't see Marsing's budget in last week's issue. So, I immediately called Janice at Marsing City Hall to enquire, only to be reminded it had run the first week of this month - three weeks before the deadline. Now, that's efficiency!

When Father and Mother moved to the farm in 1941, they didn't have the money to buy a lot of the basic equipment they needed for that occupation. Then the war came along and made farm machinery impossible to get even if you had the money.

Dad went into inventor mode. Using scrap metal and miscellaneous auto parts, he scratch built several pieces of machinery to perform specific tasks. They weren't pretty. But they did the job.

The Airplane Tractor didn't look like any other tractor in existence at that time. It was taller than most tractors.

Driving a tractor racing along at one-half-mile-a-hour isn't the best way to entertain a 10-year-old. The only thing Pat had to do was stop the machine at the end of the field and wait for Dad to turn it around. She entertained herself the rest of the time reading a Jack & Jill magazine. Most girls wore dresses in those days, even when they drove tractors. Pat was dressed in a homemade cotton model with a flat lace collar around the top.

The day wore on. The tractor chugged along while the crew picked up rocks and threw them on a sled pulled by the machine. The driver was so absorbed in her magazine she didn't notice when the drive shaft, turning slowly beneath her, caught a thread hanging off her dress hem. With every turn, the drive shaft unraveled more thread. The process was so slow and the day was so hot that the tractor operator didn't notice the change of temperature around her.

Dr. Charlie swore Sister Mary never reacted, but he was forced to whip off several swift genuflects to cover his giggling and guffawing!

It could straddle the rows of seed onions. It was called the Airplane Tractor because it allegedly contained some parts salvaged from a crashed aircraft.

The Airplane Tractor was powered by an ancient twelvehorsepower, two-cylinder engine. It didn't need a big power plant. The secret was a series of five transmissions -- all from different makes and models of cars -- hooked end-to-end in the drivetrain. By moving the gear shifts of the transmissions to various positions, the operator had an almost infinite number of speeds and power ratios. The gearing allowed the machine to chug along all day at speeds measured in feet per hour.

The tractor driver sat near the back on a crude seat, straddling the collection of exposed gears and pulleys. The design would give a modern day OSHA inspector a heart attack.

One day Dad decided to clear a field of the latest crop of lava rock that had worked its way to the surface. He hired some teenagers, most of them classmates of Lila Claire, my oldest sister, to help. My other sister, Pat, who was about 10 years old at the time, was recruited to drive the Airplane Tractor.

Eventually, Father looked up from his rock picking. "Why Patty," he asked.

"What happened to your clothes?"

His question brought the driver back to reality. She was sitting in the operator's seat, wearing only her underwear and the lace collar.

Pat let out a bellow that was probably heard by the crews of the B-24 bombers passing overhead on training missions. She leaped from the Airplane Tractor, hit the ground running and didn't stop screaming until she reached the house a half mile away.

I wasn't a witness to the incident. I heard the story from my mother.

Whenever the conversation turned to memorable family moments, she retold the tale. Everyone always laughed. Well, just about everyone.

Owyhee budget tight

The budget for the Owyhee County Sheriff's office was the main item of discussion when the county commissioners held their annual budget hearing Tuesday in Murphy.

The hearing was held to seek public comment on the county budget for the 1979-80 fiscal year which begins October 1. Next year's proposed budget totals \$1,619,368 down from this year's budget of \$1,776,225.

The major comments on the budget came from Owyhee county deputy sheriff John Prescott and Marsing area businessman Julio Churruca. Both men questioned he commissioners on the possibility of increasing the sheriff's budget for the coming year.

Earlier this year, Owyhee County Sheriff Tim Nettleton said he would be forced to curtail services next year if forced to stay within the same budget in force this year.

Local school numbers up

Enrollment in the Homedale School District this fall is up about three percent, according statistics released this week.

Total enrollment in Homedale schools stands at 912 students 25 more than the 887 enrolled at this time last year.

The largest class is the incoming kindergarten group. Kindergarten enrollment now stands at 94 students, a record. School Superintendent Deward. Bell says his office will be watching the kindergarten to see if the high enrollment is a sign of a long term trend or simply a one year increase.

Seventy one students are enrolled in the three first grade classes. There are 72 second grade students; 78 third grade; 72 fourth grade; 69 fifth grade and 55 sixth grade.

One hundred thirty nine students are enrolled stands at 262. The freshman class is the smallest with 57 students. This year's senior class is next with 62; followed by the sophomores with 70 and the juniors with 73.

138 years ago

September 1, 1866

WHISKEY GULCH. Visited this ledge on Monday. Main shaft down seventy five feet, at the bottom of which a tunnel is run north thirty five feet. The ledge in this tunnel will average four feet. Next to the east casing there is fifteen inches of as rich quartz as ever found in that sized body. On the west side there is another equally rich but smaller strata which is growing larger. At the end of the tunnel there is fully five feet of vein matter including these two bodies of very rich ore. At a depth of probably forty feet, another tunnel extends northward with not quite so rich showing as below. Near the surface is another tunnel in the same direction. The ledge at this point is wide, and contains the largest body of very rich ore we have ever seen in any ledge. It is a sight good for doubting and querulous individuals. This ledge is easily traced for a thousand feet on the surface, and is clearly defined to a depth of seventy five feet, and every indication of improvement at a great depth. It varies in size but averages about three and one half feet between casings. Messrs. Story and Hanna own 700 feet of the 800 in the claim, and have four miners in addition to themselves working it. If the Whisky Gulch does not prove a permanent and first-class ledge, then no reliance can be placed upon the usual marks indicating such a vein. The dump pile presents a rich sight that anybody can freely examine.

FAILURE OF MORE & FOGUS. On Thursday last it become publicly known that this mining firm had disposed of its property and was insolvent. The extent of their liabilities we do not know, but must be very large, probably between two and three hundred thousand dollars. On the 14th day of August, the property was transferred to the Minear Mining and Milling Co. for the sum of \$156,000. We are informed that C.E. Tilton, of New York, held a mortgage on the mill, adjacent buildings and grounds upon which they are situated for \$36,000. If any other creditors are secured, we are unable to learn the fact. We know of scores who have their obligations for sums ranging from \$100 to \$30,000. We are informed that More & Fogus have stock and obligations of the Minear Mining Milling Co. to a large amount which they are willing to exchange for their own paper. The community at the writing (Friday) is in a state of uncertain temper, and now we will neither attempt to aggravate nor pollute this feeling. Another week may and doubtless will be a more proper time.

NEW SILVER DISTRICT DISCOVERED. Mr. Lobenean, Mining Engineer and Assayer, who came be the last Chico stage to Silver City, in the employ of Mr. Blake, assayer, reports that the miners now working at the Pueblo copper mines have just discovered a silver ledge five feet wide, which he pronounces a sulfate of silver, containing 85 per cent of pure silver. This is quite equal to the Poorman. The Pueblo mines are located on the Chico stage route, and about 150 miles from Silver City. It is on the stage range of the Black rock, Pine Forrest district and where the ores have been successfully worked by the mills at Virginia City and Washoe Wood and water are in close proximity to this ledge, and in ample quantities for mining purposes. This discovery will be interesting to miners who intend returning from Idaho to California. We are indebted to Capt. Mullan for the

present Trojan coach. Last year Ken emerged as the victor. This year is was Daryl's turn.


