## Travel delays

## Bridge work delays travel on Highway 55 at Marsing

Work on the Snake River Bridge in Marsing will continue to delay traffic at least until November as Idaho Transportation Department crews work on several repair projects.

A spokesman from

ITD said traffic has been reduced from two lanes to one and are being guided by temporary traffic signals as crews are working on bridge deck, expansion joint, and handrail and guardrail repairs. He said

the project is expected to be completed by mid November.

He said the project will cost about \$183,000 and the work is being done by Mcalain Construction of Boise.

## Pursuit ends with one arrest

A pursuit that interrupted a Homedale football game Friday night ended with one arrest and a citation to a 15 year-old male from Wilder. Homedale Police Chief Jeff Eidemiller said the pursuit ended on the hill just above the Deward Bell stadium as the Homedale Trojans were playing the Nampa Christian Trojans. He said the Nampa Christian team assisted in the location of the driver who was hiding under a pickup bed.

The pursuit began on 6<sup>th</sup> Street and Nevada Avenue when officers received a complaint of a reckless driver. But when the Homedale officer attempted a traffic stop, Alberto Angeles, 19 of Wilder, tried to flee the scene. Eidemiller said the pursuit traveled through the town on residential streets and speeds exceeded 70 miles per hour.

"The suspect traveled down a alley for an es-

## City ordinance to fine "water stealers"

An ordinance passed by the Homedale City Council during a meeting late last month, will fine "irrigation stealers" triple the amount past due on their irrigation bill, but not over \$300. The ordinance establishes that "no person shall take, divert, appropriate, turn on, or use in any way irrigation water provided to properties located within the city of Homedale if their irrigation bill is not current on payments."

The ordinance, which goes into effect after publication, was approved by council members after being notified that the city is carrying over \$32,000 in past due irrigation bills. Mayor Paul Fink said the city had to "write off" thousands of dollars in late irrigation bills because of discrepancies in the city's book keeping. He said many

## Sheriff's office to crack down on drunk drivers

As of August 28, the Owyhee County Sheriff's Office has been investigating or been involved in the investigation of 29 injury or fatal accidents on county roadways. Nine of those accidents have been determined to be alcohol related. Six of those accidents involved a death of which five have been determined to be alcohol or drug related. The sixth accident is still under investigation and toxicology reports are not back on it yet.

County sheriff Gary Aman said last week that he has had enough. As of last week his office had

begun DUI and drug saturation patrols with the assistance of the Idaho State Police. Deputies and state patrolmen began their effort on the roadways of the Bruneau-Grand View area.

"Something has to be done," Aman said. "People do not seem to realize the impact alcohol and drugs have on our society. I am not sure if people just think they can get away with it or that a serious accident cannot happen to them. I know there is a sense of belief that it is okay to get drunk and drive or to allow kids to go out and drink. Just a couple of weeks ago we had a fatal acci-

dent involving alcohol and people who went to the funeral went home after drinking too much. It is just not sinking in."

But Aman is not only going to stop at alcohol or drug violations, he is also going after speeders and people not wearing seat belts. He said traffic violations are a huge problem in the county and he wants to send a warning to anyone breaking them.

"If you look at the statistics it bears it all out," Aman explained. "If we had some bio-terrorism chemical that killed this many people in the county there would be a demand that it be stopped.

However it seems it is acceptable for people to get high or drunk and cause accidents that kill and people just turn their heads. Hopefully, we can make a difference and slow down the rate our citizens and other innocent people are being killed or hurt."

Most states in the nation saw a drop in drunk driving fatalities, but in Idaho, the increases have been dramatic. About 10,000 DUI offenders are caught in Idaho every year.

June, July and August are the months when Idaho State Police say they see the most alcohol re-

lated crashes.

“This is the time of year we typically see this,” says Rick Ohnsman of the Idaho State Police. “Be on the look-out for these people. If you can tip us off, and tell us that you have spotted what you think is a drunk

driver, that’s a great help to us,” Ohnsman said. “If you’re in your car and see someone driving as if they’re impaired, dial star ISP.”

That’s what the Idaho State Police REDDI line is for – to “Report Every Drunk Driver Immediately.”

# Driving under the influence

## Those killed or injured this year

The list of people injured or killed in drug or alcohol related car accidents in the county this year is much higher than it has been in years past, county sheriff Gary Aman said. The following is those who were injured or killed on Owyhee County roads.

Jan. 11, Dennis Murdoch, 57 from Oreana, killed in a single vehicle accident at mile marker 52 on Highway 78. Murdoch’s blood alcohol level was .23

March 10, Elton Eugene Gifford, 71 of Nampa, killed in a single vehicle accident at mile marker 25 on Highway 95. Gifford was not intoxicated, but the driver of the vehicle is suspected to have been under the influence of prescription drugs. Two additional people were in the vehicle and were transported to local hospitals.

March 31, Christina Kober, 25 of Grand View was injured in a single vehicle accident on Riverside Ave. in Grand View after she hit a power pole. Kober’s blood alcohol level was .15. She was cited for driving under the

influence.

May 10, Mountain Home Air Force Airman Tana Preston, 19, originally from Sacramento, Calif. died in a single vehicle accident while riding in a vehicle with Airman First Class Zachary Chotia, 18. The accident is being investigated for drugs and Chotia could be charged with vehicular manslaughter.

May 15, Matthew James Abrams, 21 of Baker City, Oregon, and an unidentified female passenger were injured on Trout Creek Road near Jordan Valley. Alcohol was involved. Reports state that medical records have been subpoenaed, but they have not been returned as of print.

May 30, Jennifer Ann Meredith, 30 from Nampa was injured in a single vehicle accident on Highway 95 and Jump Creek. Meredith’s blood alcohol level was a .21

June 4, Ryan Paul Marshall, 18 from Nampa and an underage passenger were transported to a Boise hospital by air ambulance with injuries from a single vehicle accident on ConShea Basin road. Marshall’s records have been subpoenaed, but have not been received by the sheriff’s

office yet. The passenger had a blood alcohol content of .10 was cited and released to parents.

Aug. 1, five people were injured in a chain reaction accident on Highway 55 one mile west of Marsing. Seventy five year old Lawrence Walker of Marsing admitted to drinking “two to three small” glasses of red beer.

Aug. 6, Merci Marcel Garity, 32 of Reno, Nevada was killed on Highway 51 at mile marker 22 in a single car roll over. Drugs were found on the scene.

Aug. 19, Phillip Pat Rahn, 28 of Grand View was killed on Highway 78 at mile marker 55 when he turned in front of a semi truck attempting to pass him. Rahn’s blood alcohol results have not been returned yet, but records from the Idaho State Police state that alcohol was found at the scene. He left behind a wife, a four-year old son and a two-year-old daughter.

Aug. 28, Antonio Reyes, 38 of Caldwell was killed in a one-vehicle accident on Highway 78 at mile marker 43.. His passenger was injured and transported to a local hospital. Reports show that drugs were found on Reyes’ body.

Burst water line leaves city dry

A burst water main pipe burst last week and left the City of Homedale dry for several hours. The pipe broke near the Friends Church on Montana Avenue and 5<sup>th</sup> Street W. It went thousands of gallons of water down the street and into yards across from the break.

Homedale Mayor Paul Fink said last week that since replacing the water tower in the city and a new well, some of the pipes are not handling the increased pressure due to age of the lines. He said replacing the pipes is something the city will need to look at over the coming year.

"We have fought this pipe line several times," Maintenance Supervisor Larry Bauer said from the scene. "We won't know what we have until we get all of the water out."

Crews turned off the supply of water to the city and kept the water from damaging homes near the scene. Fink said if the break had happened during the night, the city may not have been so lucky.

"We are pursuing grants to help with replacing this line," Fink said. "If we can't get grant

money, we may have to look into taking a loan. We have to do something."

Fink said the subject would be discussed during a city council meeting Wednesday night.

County issues 52 residential building permits so far this year

So far this year, 52 residential building permits have been issued in Owyhee County, 31 for stick built homes and 21 for manufactured homes. Twelve commercial permits for new non-residential construction, commercial or commercial alterations have been issued compared to two for all of last year. Last year 47 permits for stick built homes were issued and 32 for manufactured homes.

In Homedale, City Clerk Susan Mansidor said although she does not have a breakdown of the building permits, 29 total permits were purchased last year and 23 of those were for new businesses or residences. So far this year, 23 permits have been purchased and 19 of those are for new residences or businesses.

Marsing has not issued any new commercial building permits, but has issued one commercial alterations permit. Only two residential permits were issued, one for a stick built home and one for a manufactured home.

Last year, the city issued three permits for stick built homes, one for a manufactured home and one for a commercial alteration. No new commercial permits were issued last year.

cape route, and fortunately the driver's lack of experience and lack of knowledge of the city, he entered an alley that did not have an exit," Eidemiller said. "One of the suspects was caught after about a 100 yard foot pursuit and Angeles was found under a pickup bed above the football field."

Eidemiller said Nampa Christian football players could see where Angeles was hiding and announced to officers his location. Eidemiller said he wanted to thank those who helped in the arrest.

"We received assistance from the announcer at the game," Eidemiller said. "The act was very dangerous. It was absolute stupidity on the part of the driver. The troubles he had were nothing compared to what he is facing now."

Angeles was arrested for driving under the influence, driving without privileges and felony eluding.

He never sold a single melon or cantaloupe but hundreds were given away every summer. Governor Cecil Andrus presented Bob with the American Legion's Outstanding Legionnaire for Idaho after he served as department Vice-Commander for 1973-74.

Bob is survived by his best friend, Florence Paxton of Homedale; brothers, George (Helene) of El Paso, TX and Ben Maxine of Abilene, TX; his daughter, Colleen Lowder of Homedale; sons, Bob (Cathi) of Boise, Matt (Brenda) of Homedale and Jim (Kym) of Caldwell. # Historical Society plans September trips

# Trojans win season opener battle

Following a Nampa Christian fumble, Obregon took runs of four and 14 yards to put Homedale at first and goal on the nine yard line. Trojan Kyle Carson followed by gaining four yards and put it in the end zone on a fourth down for Homedale's first TD and a 7-0 lead.

Obregon made an 18-yard gain before junior quarterback Brett Hopkins and senior wide receiver Nick Williams took over.

Hopkins hit Williams with a pass for an 11-yard gain. Then

Homedale opened the second half by holding Nampa Christian at the 20. Williams went to work again with a 30-yard halfback touchdown pass to Ricco Gonzalez and a 20-0 score.

Homedale's final touchdown was made in the fourth quarter after Hopkins hit Ryan Rupp for 16 yards then found Marcus Eby for a 26-yard gain. Carson found the goal and took Homedale to its win.

Hopkins finished 13 for 16 for 192 yards and Williams had seven catches for 106 yards.

Homedale will travel to Parma to meet the Panthers Friday night.

Makes 16 servings

- CRUST
  - 1 1/2 cups gingersnap cookie crumbs (about 36 cookies)
  - 1/4 cup granulated sugar
  - 3 tablespoons butter or margarine, melted
- CHEESECAKE
  - 3 packages (8 ounces each) cream cheese, softened

  - 1/4 cup packed light brown sugar

FOR CHEESECAKE: BEAT cream cheese, granulated sugar and brown sugar in large mixer bowl until fluffy. Beat in eggs, pumpkin and evaporated milk. Add cornstarch, ginger and cloves; beat well. Pour into crust. Place pan in large roasting pan; fill roasting pan with hot water to 1-inch depth. BAKE 65 to 75 minutes or until edge is set but center still moves slightly. FOR TOPPING: COMBINE sour cream, granulated sugar and vanilla extract in small bowl; mix well. Remove cheesecake from water bath, leaving water bath in oven. Spread sour cream mixture over surface of warm cheesecake. Return cake to water bath; bake 5 minutes longer. Remove cheesecake from water bath to wire rack. Run knife around edge of cheesecake. Cool completely. Refrigerate several hours or overnight. Top with crumbled gingersnaps. Remove side of pan.

**Low storage reserve makes shutoff of water necessary**

The Owyhee reservoir will have the smallest carryover of water this winter of any time in its history.

According to W.H. Robinson, manager of the South Board of Control, Owyhee Project, Homedale, the water will be turned out of the canals of the Owyhee Project on October 1, 1954, and if necessary from lack of rain, will again be turned into the canals October 10<sup>th</sup> , for a seven day run.

This is necessary on account of the small holdover in the reservoir and the uncertainty of the amount of run off during the winter months for next year’s supply. The total amount of storage in the reservoir at the present time is a little less than 20,000 acre feet, which will probably leave a little over 100,000 acre feet at the end of the season, the capacity of the reservoir being 715,000 acre feet.

**Football suits are issued to Trojans; team heavier now**

Twenty three suits have been issued to prospective football players at Homedale high school this fall, James Bostwick, coach, announced this morning. He said he expected several more fellows to come out for the team when the school term begins next Tuesday.

Of the twenty three men practicing presently, twelve are returning lettermen. At least two more letterman are expected to try out for the Trojan team.

Bostwick said that the team this fall will be considerably heavier on an average than t hat of last year. The boys have looked fairly good in early practice sessions, he said, adding that he hopes to produce a winning team this year.

### Owyhee valuation is down

An increase in the assessed valuation of real and personal property and utilities within the state of Idaho of \$2,260,406 was announced this week by the State Tax Commission. This sum is over the 1953 assessed valuation within the state.

The total value for taxing purposes has been set by commission at \$582,976,791.

The Owyhee County valuation was decreased by \$676,609 from the 1953 evaluation to make a tax base of \$8,798,640.

An indication of what this decrease means was made apparent when the information was received that the tax revenue of the Homedale school district would be about \$1500 less than it was a year ago.

## 138 years ago

September 15, 1866

BATCHELDER, christened Nathaniel, is the subject of this place. He arrived in Owyhee last Spring. Reported himself from Virginia, Nevada. Put on considered style; drank much whisky; succeeded in getting a position as Superintendent of amine and convincing his employers that he was a scoundrel; offered to hire himself out to kill a well know citizen for a price; tired to defraud everybody who would credit him, and did succeed with many amount the latter we include ourselves. It is useless to detail the acts and attempted deeds of this villain. Where his has gone to, we can’t say, don’t even know that his has left here; but our exchanges can do their readers no greater service than to copy this article. We have abundant proof of what we assert. Batchelder is about six feet tall, heavy set, ruddy face, black whiskers and hair, and is very pompous in his manner.

We have a few more subjects under consideration.

FOR SEVERAL trips in succession, previous to the change from pony to stage, the Humboldt mail brought Virginia papers with Eastern telegraphic one and two days later than received from Salt Lake. When the stages get fairly started, Owyheceans will be no more than two days from the telegraph at Star City, four from Virginia and five from San Francisco.

MESSRS. KING, WEBB & CO. have completed the most substantial fire proof cellar in Owyhee. We understand it is now ready to receive storage, and the walls being three feet thick, no more safe place could be desired. Located in rear of K., W. & Co’s. Bank, Jordan street.

ONE MORE. We are informed that there is considerable indebtedness hanging over the Church in Ruby; that it is now born almost wholly by one man; that many who promised liberal aid in its construction have failed to make good their promises. To saddle all this burden on one is wrong, and once more we urge all interested in church service to right this matter. It is due to the credit of all concerned to right this thing, and we hope and believe it will be done. “Only this and nothing more.”

JAMES H. O’CONNOR, an old Owyhee placer miner, left during the present week for Rome, Oncida county, New York. He succeeded in getting considerable dust of which we are pleased for he is an industrious and honest man. Several other miners left him, all very successful in “gatherin gear”.

PROPERTY ASSESSED. The assessed value of real estate property in Owyhee County, as returned by the Assessor up to Aug. 27, amounts to \$531,424; personal property to same date, \$600,654; total \$1,151,988. There has been paid into the Treasury \$8,938.79 – all from collections on personal property. There is remaining due the county and territory, on personal property, something over \$5,000, and on real property over \$12,666. The county’s proportion of the above taxes is about \$11,600.

James H. hays, Deputy Recorder, has kindly furnished us with the above figures.

GONE GLOMMING. During a trip to Flint District, in the early part of the week, Capt. Miller of the Lincoln mill, let his horse get away with the saddle turned under his body. The last seen of the beast he was going at lightning speed into the very heart of the Piute nation; and, although followed by very swift chargers, an experienced rider could balance of the day, he outstripped all pursuit, and is probably at this moment at Winnemucca’s headquarters.

WEATHER has been mostly clear and cool during the past two weeks. Had a few sprinkles of rain, and a little fire evenings and recordings has been conducive of comfort.

HORSE KILLED BY A RATTLESNAKE. A fine mare, belonging to Col. A. H. Webb, of the Book Store, died on his ranch of O. R. Johnson at Oro Flint District, on Tuesday night from the effects of a rattlesnake bite.

## On the edge of common sense Ay Chihuahua!

Ay Chihuahua!

We crossed the border at Antelope Wells, NM, 40 miles south of Hachita on Hwy 81 which is paved right up till your front tire hits Mexico. It must be the loneliest immigration outpost in the country. We drove the 72 miles from Animas, NM to Mexico Hwy 2, in the middle of the day and only passed one car that wasn't up on blocks. The U.S. agent held us for ten minutes just to visit. We agreed to write him occasionally and he finally let us through. We didn't wake the Mexican border guard.

It's big country in northern Chihuahua; big and brown. They are in a years-long drought. Cow numbers have steadily declined as ranchers sold off. No grass, no feed. What's left are down to eating prickly pear and bird nests.

We arrived at our destination, a big ranch, northwest of Janos. 50,000 acres, a 40 km driveway, its own chapel, its own mountain range, its own pen of goats. The big rancho where we spent the next two days looked like a Hollywood movie set. A beautiful rock hacienda with a courtyard was surrounded by freshly painted cottages for the help, a large cookhouse and a quaint white stucco Catholic chapel complete with cross and bell.

The indoor decor of the hacienda was elaborate and rich, befitting the now incarcerated drug lord who had been the previous owner. The silent presence of Malathion was appreciated in the obvious absence of roaches, scorpions and centipedes. I was accompanying Dr. Harold, a USDA veterinarian who monitors the spaying of Mexican heifers for import to the U.S. Sexually complete fertile cattle must undergo lengthy testing for Brucellosis and TB at the border. Spaying the females shortens the delay considerably.

The facilities were good. Two Mexican veterinarians did the surgery. Two squeeze chutes ran simultaneously and two ovaries were laid on each heifer's back as proof. 505 heifers in 5 1/2 hours, one every 46 seconds, cost to rancher \$8 - \$12 U.S./heifer. The spayed heifers were given an official USDA ear tag and they were branded with an MX on the right hip. I felt a renewed respect for our government veterinary corp.

We ate all meals in the cookhouse with the cowboys. Beans and tortillas every meal, with a different spicy side meat each time. I didn't keep track of the chickens and goats in the yard, but the large parrot in the courtyard that greeted our arrival was missing when we left.

The trip home included a pass through a Mennonite community where you could buy a soda pop for 50¢, 2 1/2 lbs of homemade cheese for \$3.50, and gas for \$2.00/gallon.

Chihuahua was another world, and yet punchin' cows through a chute, visitin' with cow people, and bein' able to see the stars at night was no different than if I was in Oregon, Kansas or Georgia.

I felt right at home.

## Not important ... *but possibly of interest*



Exploding matches weren't the only burning objects that gave Father trouble. There also was the infamous Chicken House Incident..

The chicken house stood on the south edge of the farmyard. The last chicken disappeared before I started school, but the smell lingered. Once a building has been used as a chicken house, it isn't good for much except housing chickens.

Several decades worth of chicken manure made the area around the chicken house an ideal growing environment. The weeds literally jumped out of the ground each spring. By mid summer they were as tall as a man. Father waited each year until the weeds matured and dried out. Then he got the box of wooden stick matches out of the kitchen cupboard and announced his intention to burn the weeds around the chicken house. Then he always paused for a moment and waited for Mother to speak.

"Clyde," Mom would say. "You better get the fire department to come out and stand by. One of these days you are going to burn down that chicken house."

After mother finished her warning, Father did what he always did. He ignored her advice and burned the weeds.

It was a hot, August day. Willard, my best friend, had dropped by to go for a swim in the canal just up the road. We were on our way out the door when Father entered the kitchen, walked over to a cupboard and took down the box of stick matches.

"Today is a good day to burn the weeds around the chicken house," he announced. He looked toward Moth-

er, who was kneading bread dough. "Clyde, you had better get the fire department to come out and stand by," mother said. "One of these days you are going to burn down the chicken house."

With the formalities out of the way, Father went off to burn the weeds. Willard and I had soaked in the canal for about a half an hour when we heard the fire alarm in town, about a mile away, start to wail. A few minutes later we identified the siren of the fire truck as it left the station. From the sound we could tell the fire truck was headed our direction. We climbed out of the canal. From the ditch bank we could see the truck as it rolled along Highway 69 about a quarter of a mile south of us. The truck rounded a curve and headed north. Its route of travel would take it past our farm. I told Willard the fire must be somewhere in the neighborhood. We had been facing away from the family homestead as we watched and listened to the fire truck. As we turned to keep it in sight, it became obvious where the fire was located.

The tarpaper-covered chicken house was burning splendidly, sending flames a good 50 feet into the sky, scorching the leaves on nearby trees. Father was standing off to one side, leaning on his shovel handle, watching the ammonia enhanced inferno. Mother was next to him. Her mouth was moving rapidly and she was waving her arms excitedly and pointing at the blaze. Willard and I were too far away to hear the conversation, but I have a pretty good idea what was being said.

Mom was almost always right - eventually.

### Kentucky Man Faces Charges For Killing Bear

Terry Brock stepped outside his home the morning of June 2, to discover a black bear looking for breakfast. He immediately dashed back inside and told his wife to call the Kentucky Department of Fish and Wildlife (KDFW) while he tried to scare the animal away. The bear wouldn't scare and became aggressive, so Brock grabbed his antique 30-30 and killed it. The KDFW then filed charges against him because it is unlawful to kill a black bear in Kentucky. If Brock agreed to plead guilty he would avoid a possible jail sentence, but would have to pay a \$250 fine, lose his hunting privileges, and forfeit his heirloom 30-30. Brock refused the deal, preferring to take his chances with a jury of his peers, even though he could get a year in jail and a \$1,000 fine if convicted. "I don't feel like I've done anything wrong," Brock said. It may be the KDFW wants to make an example of Mr. Brock because they won't drop the charges. "This is our first case," said Frank Campbell, a conservation officer. "I feel it's a very important case for us." Defense attorney Jamie Hatton remarked, "It seems like he had a right to protect his family, his dogs, his horse, from this bear. It's not like he was poaching."

### Tyrannosaurus Tex

It began with a campaign promise and has now morphed into a colossal behemoth that threatens to swallow rural Texas. In 2002, Governor Rick Perry promised to build a super highway to facilitate expected increased traffic from the National Free Trade Agreement (NAFTA) and only now are the staggering dimensions of the project coming to light. Tyrannosaurus Tex will have ten vehicle lanes, six rail tracks, utilities, pipelines, state concessions (gas stations, restaurants, motels, stores, warehouses, etc.) all on 4,000 miles of toll roads that will consume more than one-half million acres of Texas. What was supposed to

occur over fifty years has been steered into the fast lane by the Texas legislature's enabling law HB 3588, which, said Transportation Commissioner Robert L. Nichols, "gives us all of the authority and all of the power we need on a state level to move forward on the Trans-Texas Corridor, plus some." Other states, such as Indiana, that were receptive to the idea of I-69, the original NAFTA highway, are now having second thoughts, fearing they too could be trampled by their own super corridor. Critics warn the mammoth undertaking will wreak havoc with property rights as the State will use the power of eminent domain to seize property from unwilling sellers.

### Update on a National Shame

For 16 years, John Rapanos from Michigan has been fighting the federal government over their claim that he filled a wetland on his property. Only problem is, there never was a wetland on his 200 acre field because the county government dug drainage ditches around the plot in 1904. At Rapanos' second sentencing, Federal District Court Judge Lawrence P. Zatkoff balked at carrying out the government's vendetta and sentenced him to 200 hours community service, three years probation and a \$185,000 fine. But the Justice Department is still not satisfied demanding Judge Zatkoff sentence him to at least 10 months in prison. To make matters worse, the government wants civil damages to the tune of \$10 million in fines, forfeiture of 81 acres of land and \$3 million in mitigation fees to restore wetlands that never existed. Rapanos' scheduled August 18 sentencing trial has been postponed, according to Greg Broderick, attorney with the Pacific Legal Foundation because Judge Zatkoff wants to wait on a ruling in a federal sentencing guidelines case (Booker) to be heard by the U. S. Supreme Court in October. Hopefully, the Supreme Court ruling will favorably impact Mr. Rapanos's situation. If not, this will remain a national disgrace.

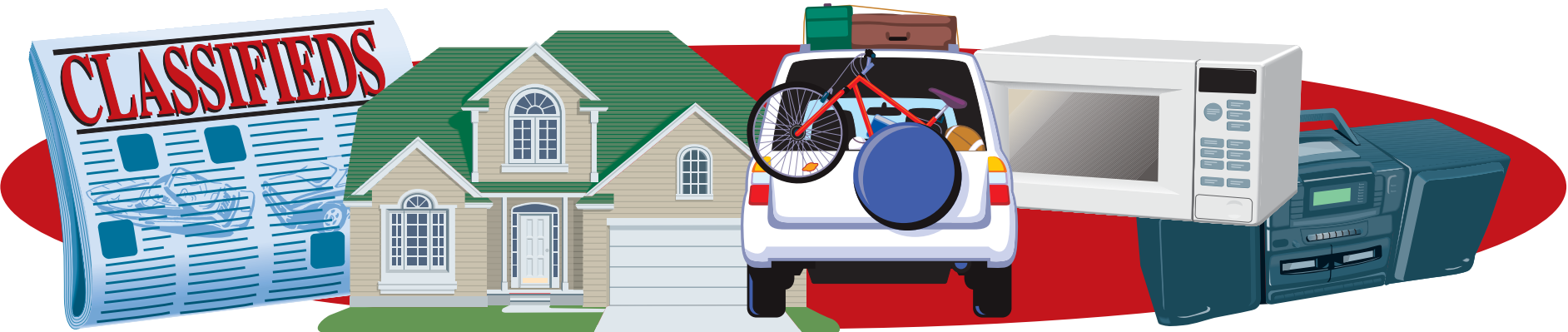
