"Aloha" celebration in Murphy Saturday

The second annual Aloha from the Owyhees celebration will be held in Murphy Saturday evening complete with Hawaiian dancers, authentic cuisine and historic speakers. The fundraiser event is held for the Owyhee County Historical Museum and will get underway at 6 p.m.

Coordinator Debra Lindner said last week that Aumau Alualu-Fouret will begin the festivities with "Polynesia, We are Always One, a sharing culture, keeping it alive through music, dance and language."

At 6:30 p.m. there will be a progress report on the Capital Fund Raising Campaign for the new building addition. Construction is scheduled to start within the next 30 days and proceeds from the event will benefit the building fund.

At 7 p.m. the dinner show will begin with Aumau and her group E Mau I Lokahi O Polynesia, along with Marilyn Hunt and some members of the Hawaiian at Heart group. The native dance will take center stage as those attending are treated to a Hawaiian

Marsing marijuana growers arrested

2,000+ marijuana plants destroyed in major bust

With the assistance of the Owyhee County Sheriff's office, state investigators confiscated 2,000 nearly mature marijuana plants near Banks. Now five Marsing residents are behind bars accused of growing the crop and county sheriff Gary Aman said more arrests are planned.

Law enforcement officers converged on the crop near Banks

Tuesday afternoon last week after receiving a tip. Investigators said they found millions of dollars worth of pot in an area nearly two-football fields long. The plants were uprooted and flown from the remote area and were later destroyed. Officers were flown into the area where investigators said they believe

City anticipates final 2003 audit

The City of Homedale may get some answers during a council meeting next month as the mayor says the audit is nearly complete.

The audit report has been scheduled on the council's agenda for the last two meetings, but Mayor Paul Fink said every time the auditor is nearly finished, a new question popped up and the audit had to be reopened. During last week's council meeting, Fink said the auditor was "99 percent" completed so he told the auditor to wait and present it next month. The audit is again scheduled to be presented on Oct. 13 at 7 p.m.

The city has questioned many issues, which Fink said some would be addressed in the audit, from irrigation discrepancies to missing receipts for purchases. He said any other issues that are under investigation by the state Attorney General's office may not be released, yet.

Only two weeks after being into office as the city's leader, Fink requested law enforcement officials investigate the city's bookkeeping records because of missing computer entries and missing receipts. Since then, Fink said many more discrepancies have been found.

"Sometimes it is almost a daily thing," Fink said. "We don't know where we are and that makes running a city very difficult. Sometimes it feels like it is nearly impossible."

The city received another setback when the city audit was nearly complete in May.

Then auditor Jared Zwygart from Bailey and Company CPAs

Historic cemetery dedicated 50 years ago

It was 50 years ago this week that the cemetery of Graveyard Point received a plaque and monument during a dedication to honor five early-day settlers who are buried there.

Graveyard Point pioneer cemetery is located southwest of Homedale. The marker is near the south canal, at the west end of Graveyard Point Road. The burial site, plaque, and access are on private property.

From the pages of the Owyhee Chronicle in 1954, Professor Harold Tucker of the College of Idaho, said "we cannot develop those beautiful traits of character without going through the trials of human

stress. Many of you can remember standing on this hill and as far as you could see was just sagebrush. A lot of our history is getting away from us. As much as we can, we should keep that heritage for those who come after us."

Tucker told the group then of the ancient lakes in the area, and of the lakes drying up. He said "the white men fell in two categories, those who dared to come and those who dared to stay."

Tucker paid tribute to the gem societies, which financed the monument. C.W. Hankins of Homedale provided the ground, Earl Van Deventer, chairman of the affair and Herb Enoch who assisted with construction were present.

struction were present.

Tucker said of early history that their had been some confusion over the name of Sucker Creek. He said that a French party named it Succor Creek as there it escaped massacre at the hands of the Indians. Then he said a survey party came out from Washington, D.C. and it changed the name to Sucker Creek on the grounds that "these westerners don't know how to spell."

The monument still stands today, but the gravesites are nearly impossible to locate. The hills of Graveyard Point are privately owned, but groups still travel to the area in search of agates and jasper.

Mark Black was given the honor of all around cowboy for his participation in the annual Bruneau Roundup Rodeo which was held earlier this month. Juanita O’Malley from Slash T Rodeo Company announced the results of the roundup last week. The annual event drew hundreds of rodeo fans to Bruneau for a two-day event.

In the bareback riding event, Toby Miller won first place with 76 points followed by Matt McGuire with 70 points for second place and Sky Grant and Ty Jones tied for third and fourth 69 points.

Mark Gage won first place in the saddle bronc riding with 75 points followed by John Denis in second with 74 points and Sammy Mackenzie in third with 72 points. Derrick Huffaker rounded out the top four with a 70-point ride.

On the bulls, two cowboys scored 75 points for a tie with Buster Prescott taking first and Michael Sparks in second. Zac Vankomen scored 69 points for third place and tied with Alex Retter who took fourth. Dustin Larsen scored 64 points.

Ty Thomas scored 13.07 for first place in the calf-roping event. Bland Ballard scored 19.31 for second place followed by Paul Cope in third with 19.72 and Chris Hoaglund took fourth with 20.56 time.

In barrel racing, Katie Davis

timed at 17.18 for first place with Danna Stovner in a close second place with 17.19. Bobby Jean Jones pushed the pack with 17.3 for third place and Pam Hoskovec closely followed in fourth with 17.37. Karen Ewy placed fifth with 17.5 and Jamie Beutler took the sixth spot with 17.66.

Terry Russell and Jeff Palmer took first place in the wild cow riding with 52.0. Russell and Palmer placed second last year in the event.

Chris Black and Pat Tindall placed second in the event with 53.2 followed by Mark Black and Cory Ainsle with 58.5 in third place and Kit Bachman and Joe Aquiso took fourth with one minute flat.

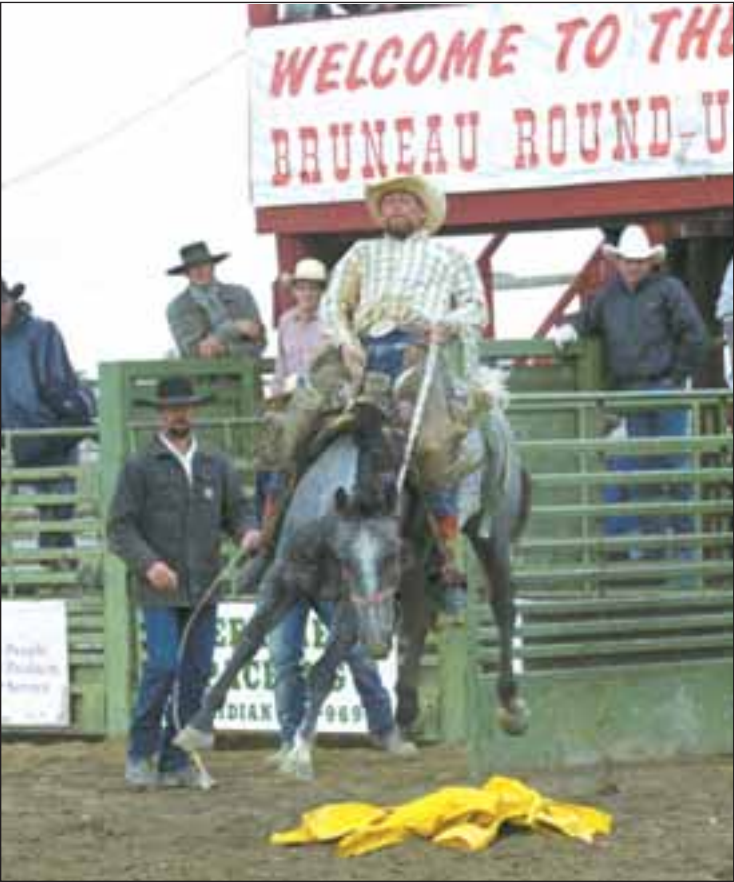

Pioneer cemeteries receive helping hand

The Owyhee County Historical Society toured ranches in the Wagentown area on Sept. 11, with a clean up of the pioneer DeLamar cemetery on Sept. 12.

On Saturday, the group had an overview of Camp Lyon, a US Cavalry camp established in June 1865, and abandoned in 1869. There is still a fenced cemetery at the site, and there may be two graves, although they are unmarked.

Next stop on the tour was the Stanford ranch, where members of the Stanford family hosted the group. Stops were made at two sites on the Elordi ranch, and at the homestead of historian Mildretta and Walt Adams. The hosts were Marilyn Adams Burke and her son, John. A printed field trip guide included memories of the couple's other daughters, Alene Downing, and Pat Davis, as well. The trip ended at the pioneer Wagentown

cemetery.

On Sunday, a small, but dedicated group met in DeLamar, and, led by Nick Ihli, spent several hours sawing, digging, and hauling brush to clear the DeLamar cemetery.

The cemetery was founded in 1890, and it was surveyed, the graves marked, and the cemetery fenced, by Charlie Nettleton and helpers, in the early 1960's. The site has only received sporadic maintenance since.

Some headstones were found that probably hadn't seen sunlight in decades. The latest date found on a headstone was 1919. All agreed that the group had accomplished much needed work, and much more similar work was needed if pioneer cemeteries were to survive.

The next OCHS field trip will be to the Sumpter, OR mining district on September 25. Call the Museum, 495-2319 for details.

two suspects were staying in a camper nearby, but fled when officers flew overhead.

Idaho State Police Officer Don Van Cleave said the plants would have been worth several million dollars when it reached the streets in about three weeks. He said the pot had been grown in a rough terrain and the plants were camouflaged by other vegetation. It was watered with natural springs through an intricate pipe system.

“This has probably been going on for at least the last year or two and they were successful in their operations,” said Van Cleave. “They’ve made a lot of money off of this.”

Van Cleave said growers feel safe planting pot in remote areas like Boise County, but what they didn’t realize is the close working relationship and cooperation they have with all law enforcement agencies in the area. Aman said the coordinated effort paid off and is a very important part of law enforcement work.

“If it’s growing up here, we’re going to work real hard to find it,” said Van Cleave.

On Wednesday, four men and one woman from Marsing were arrested on felony charges stemming from the operation. County deputies served a search warrant on two homes in Marsing and arrested Constantino Cervantes, Jose Lopez-Cervantes, Abel Santoyo, Antioco Santoyo and Emma Santoyo

Authorities returned to a rugged area about four miles north of Banks Wednesday to search for additional marijuana plants.

The suspects arrested and booked are:

- Constantino L. Cervantes, 21, of Marsing, for aiding and abetting in the manufacturing of a controlled substance,
- Jose Lopez-Cervantes, 19, of Marsing, for manufacturing of a controlled substance,
- Abel Santoyo, 19, of Marsing, for manufacturing of a controlled substance,
- Antioco Santoyo, 22, of Marsing, for aiding and abetting in the manufacturing of a controlled substance,
- Emma Santoyo, 25, of Marsing, for aiding and abetting in the manufacturing of a controlled substance.

“The society is very excited about this presentation and invites everyone to enjoy the great food and wonderful entertainment,” Lindner said.

Lindner said the addition will give 14 additional rooms to the

complex with a multipurpose room with kitchen facilities for banquets and family gatherings. It will have a library, shop, artifact storage area, two vaults, gift shop and an office for the director.

“It will be a fantastic addition to this community,” Lindner said. “People will be able to rent the room for functions. There is no place around this area were people can have large functions, family reunions or meetings that a large amount of people can attend.”

The name, Owyhee, comes from early fur trappers. In 1819, three natives from Hawaii, part of Donald McKenzie’s fur-trapping expedition, were sent to trap a large stream that emptied into the Snake River. When they did not return, McKenzie investigated and found one man murdered in camp and no sign of the others. The stream was named in their honor. “Owyhee” is an early spelling for the word Hawaii.

The museum is located in Murphy, which is perhaps the nation’s smallest county seat. The town grew up around the railhead of the Boise, Nampa and Owyhee Railroad, the county’s first railroad. Its central location won it both the county seat and the Owyhee County Museum.

in Nampa suddenly quit because of comments Fink made in an article published in The Owyhee Avalanche.

“We may never know where a lot of money went,” Fink said in April. “I can say at this time the city is holding its own. We have found many, many mistakes and squandered spending, but we have pulled together as a team and are tightening our belts. Some of the projects we wanted to get done will not get done this year. But we are bringing the city back to where it needs to be.”

After Zwygart’s resignation, the city hired Bowen and Parker to perform the audit, which they began in May.

“We are going to get hit pretty hard in this audit,” Fink said in May. “Mike Parker’s office is going to help us as best as he can. It is very late in the year to find an auditor and this is not a normal audit. We don’t have receipts to give him, but this administration cannot do anything about it because we cannot fabricate missing receipts. We will just have to take the lumps and go on.”

The city has reported that it has already saved thousands of dollars in what Fink called “wasted spending.” Many contracts have been re-negotiated and canceled because the council considered

them to be unnecessary. Late irrigation and water payments have been brought back up to date, but the city will still be faced with repaying dedicated funds for an emergency bridge project. Fink said water and sewer rates probably would be raised in the future to repay an estimated \$60,000 taken to replace a main waterline on the Snake River Bridge. -CB

As of Monday, Owyhee Reservoir contained 102,190 acre-feet of water, which is 14 percent of full. One hundred fifteen cubic feet per second is entering the reservoir at Rome and 186 CFS is being released at the dam.

October 11, 1979

Water solution near

Only time can cure Homedale’s current water problems. That is the consensus of representatives of the State Department of Health and Homedale City engineers.

On September 17 the City of Homedale was informed by the State Health Department of the presence of coliform bacteria in the city water supply. The bacteria was discovered when the Southwest Idaho health District tested the water in local foster homes on September 15. The SWIHD notified the home operators by letter but did not notify the state health people until late September. The state office immediately recommended that local residents boil their drinking water. Now, city and state personnel are attempting to find a way to treat the problem.

Although the well producing the coliform has now been shut down, the bacteria may still remain in the water system. The coliform can be killed by clorinating the water. The city’s main problem seems to be finding a way to get the clorinated water through all parts of the water system.

Candidates vie for city seats

Residents of valley communities will go to the polls November 6 to choose mayors and city council members.

In Homedale, Mayor George Murray is running unopposed for re-election. Earlier, Murray announced he would not seek another term. Later, however, he changed his mind and announced he would run.

The other incumbent seeking re-election in Homedale is councilman Larry Bauer. Bauer was appointed in 1978 to complete the term of Mike Kelly. Gordon Cahill, the other council member whose term expires, announced he would not run for re-election. Candidates for the two four year council seats include Bauer, Charles Maxwell, George Ash, R.L. Michaelson, and Roger Nash. The two candidates receiving the most votes will fill the contested seats.

At Marsing, three candidates are opposing incumbent councilmen Jack Bish and R.K. Caldwell. The three challengers include Roy Herman, Gary Seney and Martin Davies.

Marsing man enjoys military

Sergeant William C. Jones, Jr., son of Mr. and Mrs. William C. Jones, Sr., Marsing, took part in “Constant Enforcer,” a maneuver that saw American, German, Canadian and Belgian troops move through almost 4,500 square miles in Central West Germany.

Jones, 24, is a squad leader in B Company, 1st Battalion, 6th Infantry of the 1st Armored Division and he likes his job. “I enjoy meeting people from different countries and also I enjoy working with people who like what they do and who are good at what they do,” he said.

Jones joined the Army in December, 1972, after dropping out of Marsing high school. “I came into the Army after I quit school because I was interested in the Army and wanted to take advantage of the things the Army offered,” he explained.

The Western Idaho Football conference title may well be decided October 19 when Homedale and Rimrock clash.

Both Owyhee County clubs passed crucial tests last week as the Raiders dumped defending champion Parma 12-0 and Homedale mauled Fruitland 33-13. Fruitland, which stepped down to the WIC from the SRV conference this year, was an early season favorite.

The Homedale Rimrock contest might decide the conference crown and the playoff berth. Parma is nearly out of the race at this point with losses to Rimrock and Fruitland. The Grizzlies, with one loss, must defeat Rimrock this week if they hope to remain in contention.

City crews have been busy the past few days painting new parking lines and crosswalks on the streets of the city. Under the supervision of Warren Stimmel, the streets have taken on a clean and fresh look with the new painting job. Recently the street crews removed all the trash, weeds and dirt that had accumulated in the gutters of the streets.

Special meeting scheduled Friday at grade school

Homedale residents are reminded of the special meeting scheduled for tomorrow, Friday, evening at the new grade school building at which time a discussion will be held on the feasibility of the local school district purchasing and operating the school busses for the district.

The meeting has been called by the school board and a group of school patrons in order that interested persons may become acquainted with school transportation problems and aid in finding a solution for problems.

A group of local school district patrons is proposing that the district purchase the present school busses and buy four more in order for the district to have sufficient transportation to make early morning and late afternoon bus runs unnecessary.

Merry Milkman to appear in Homedale

Homedale Kiwanis Kids Day will be held this Saturday, Sept. 25, and will begin with an Aunt Jemima pancake breakfast from 8am until 1pm in the city park. For a very small charge Aunt Jemima will serve all you can eat, and the proceeds go for a most worthy cause, the Kiwanis Underprivileged Children’s Fund.

The annual Kids Day parade will leave the Armory at 2pm and there will be three sections. The first section to be judged will be the costume section; the second, decorated vehicle section, and the third, pet section. There will be first, second and third prizes in each section. Prizes will be limited to grade school children only.

After the parade there will be entertainment in the city park. Milt Hale, the Merry Milkman, of television fame, will be present to entertain the kiddies, and Aunt Jemima will also be present. There will be a dog show with prizes given for different qualifications such as best behaved, largest and smallest, longest and shortest tail, among others.

Owyhee County registers a drop in assessed valuation

Assessed valuation of Owyhee County property will be down about \$600,000 this year, mainly because of a drop in evaluation of livestock and grazing land, County Assessor J. W. Dunning said.

The cut is expected to affect especially the school districts of Owyhee County, some of which will lose 17 per cent of their valuation. Homedale schools will lose about \$4200 in revenue, Marsing school district \$3300 and Grandview district \$3500, Dunning said.

In 1952 the assessed value of livestock in the county was \$2,100,000. Since that time the sale value of livestock has fallen about 60 per cent, and the assessed value of livestock has been lowered about 40 per cent. The number of livestock in the county has been nearly the same for several years, Dunning explained.

Assessed valuation of livestock will be lowered again in 1955, Dunning said, as they are still assessed at a higher percentage than any other class of property in Owyhee County.

Homedale Trojans tie with Notus 6-6

The Homedale Trojans opened fast against Notus Friday and pushed across the fast touchdown with Jim Hinton scoring from the 15 yard line. The blocking on this drive was very good and the running of sophomore Bill Carson, and Jim Hinton, a two year letterman, looked good.

The defense of the Trojans was the biggest spot of the game. The line, sparked by beg Denny Wyman, 185 lb. Tackle, and Kenne Metzger, guard, held Notus to 3 first downs and 22 yards from scrimmage during the whole game.

The half ended with the ball on the Notus yard line but time ran out before the Trojans could score.

138 years ago

October 6, 1866

CURRENCY. What more can we say on this subject? The public know that the creek dust in circulation now is not worth an average of \$3 per ounce, and Bannock not over \$10. It is equally well known that it is passing for \$12 and \$16. There are respectable men who know who are engaged in the manufacture and adulteration of this dust, but through fear or policy decline to name them. This community has been outraged with specious dust. It falls most heavily upon the laboring man, and many good ones are leaving for places where money is paid for labor. Men who apparently have a respectable standing in business are charged with being either principals or agents in the nefarious practice of making or passing the spurious stuff. It is no more our business to make specific charges than it is of any other members of the community. The continuance of a dust currency will, as it ought, drive every prudent inboret out of the country. We advise them to quit work in a body of demand and have money for their labor. From and after this date (Oct. 6th) our bills will be made upon a greenback basis. A liberal discount will be given for coin and dust if taken at all, some as greenbacks.

CHIMNENYS, PIPES, &c. It is the duty of all citizens to exercise every possible precaution to prevent fires; but as many fail to do so, either from carelessness or neglect, it is right that the citizens should call a meeting and appoint a committee to make an inspection of all flues, stove-pipes and chimneys. This action is taken in many places, and so good citizen can reasonably object to it in Owyhee. There are so many Chinese dens, dance houses and other she bangs in town that it will be a wonder if a fire does not break out in some of them. An inspection of them by a committee duly appointed by the citizens would be of two fold value: that of impressing everyone with the importance of watching to prevent fire, and of immediately mending any defects about chimneys that might be discovered.

We present these remains for the consideration of our readers, and respectfully urge that a public meeting be held for the appointment of such committee; and, in the mean time, that everybody will look well to their pipes and chimneys.

THE LECTURE by Rev. Wm. Roberts in the Church, last Saturday evening, was well patronized. The lecturer handled his subject with fair though not masterly ability. However, he gave every attentive listener and thinker a full dollar’s worth, and the music can be counted upon as clear profit. There are few ministers that can give an entertaining lecture, even though they are eminent divines. Pulpit oratory is in place in the pulpit but out of place in the lecture room. The “gospel sound” is sweet on the Sabbath as it falls front the lips on the sincere divine, but it is erroneous to embellish a lecture with it. “Music’s voluptuous swell” in the ball room; in the church choir, its awe inspiring, heavenly tones. The owners believe the property worth more money, but at the same time wisely act upon the true doctrine that it is better to sell for a price that will be safe to the purchaser and profitable to themselves. The sale will increase a thorough development of the ledges in 1867, which the owners were unable to make.

What were they thinking?



The audit of the Homedale city's books isn't completed yet, but we've been told it will be by the next council meeting. Some of what will be included may be surprising, and some of the information may be expected.

The reason the audit is taking so long – which will only cover fiscal year 2003 – is that the books are in such a disarray that the city is unable to determine on its own just how much money it has – or doesn't have.

At the same time this is going on, the state Attorney General's office is conducting an in-depth investigation into possible criminal activities pertaining to the operation of the city. No timeline has been given as to when this will be completed.

Due to the nature of the investigation, no information is being released as to what is being found, the parties to the action, or how much money is involved. It may be a while before it's completed.

Due to the closed-mouth policy of the AG's office (and rightly so), it's not clear just how far back the investigation goes. It is hoped the inspection of the books includes years other than just 2003.

This newspaper is looking into some activities of city officials and employees, too. We're focusing on years prior to the one the audit covers. Though we're far from

through, we can say that there were several apparent violations of the Ethics in Government law and other laws. We can also say that there were many instances of waste. Lots and lots of waste.

To give a taste of this waste, it was disgusting to see the city spent nearly \$1,000 on a float for the Homedale Christmas parade, including \$300 for custom-made gingerbread outfits (which, by the way, have disappeared). That's \$1,000 of your tax money for a 15-minute parade. This is just one of many instances of waste the city council approved.

What on earth were the councilmen thinking when they okayed such foolishness? They are charged with being frugal with the tax dollars we pay to operate the city, not to squander it on such unnecessary fluff.

We have found instances of councilmen and employees directly benefitting from city bidding and contracting, and being paid over and above their salaries for other city work.

We will continue to dig through the mountains of paperwork and expose the corruption and waste as we find it. In the meantime, we sympathize with the auditor, mayor, and council as they work to attempt to reconstruct the finances of our fair city.

Not important ... *but possibly of interest*



Mother’s mother died when I was a baby. Mother’s father lived in an old house that was dark, dreary and smelled of pipe tobacco. The atmosphere matched his personality.

Mom’s dad always had a new story about some argument with his neighbors. He gave us his version in a high, staccato voice. The fact that the last of his teeth had disappeared at least a decade earlier didn’t make it any easier to understand the story. He may have been the source of the phrase, “flapping his gums.”

Everyone avoided talking politics when grandpa was around. His assessment of every elected official, including the president, was, “Somebody ought to shoot the SOB!” Fortunately, the only weapon he had in the house was an air rifle used to take pot shots at the robins that raided his cherry trees. He hated robins more than politicians.

Grandpa usually was too wrapped up in his personal trials to pay much attention to visiting grandchildren. Somebody once talked him into getting out his old guitar and harmonica to entertain us kids. He played both instruments at the same time and he played both badly.

My father’s parents lived in a cinder block house on the edge of a small town about 25 miles from our home.

Family was important to the Cornells. Some branch of the clan held a reunion almost every year. Grandma’s kin were the reunion specialists. Many of her brothers and sisters also had migrated to Idaho. Most of the get togethers had to be held in the city park.

The family reunions must have strained the local chicken population. Nearly every family contributed fried chicken to the picnic menu. Every cook had her own chicken recipe. Being a connoisseur of fried chicken, I could take roll by sampling the various poultry dishes.

I always urged my parents to arrive at Grandma and Grandpa’s early for the annual Thanksgiving dinner. That gave me first shot at the box of toys stored in the spare bedroom before my numerous cousins showed up. There was an assortment of stuff in the toy box - most of it dating back to the early 1900s when my father was a child.

The combination living-dining room in my grandparent’s home seemed huge. Grandpa and his sons settled at the south end of the room and talked about current events, politics and the price of seed.

Grandpa always wore suspenders - wide green ones. He knew just how to lean back in his rocker with one hand wrapped around a suspender strap. It made him look very wise. I suspect grandfather wore suspenders all his life. But by the time I arrived on the scene, they were a necessity. As is the case with a lot of elderly men, grandpa’s backside had melted away to nothing. He sort of rattled around in his trousers which were held at the proper height by his suspenders.

At the north end of the room, the women of the family bustled about preparing the meal and setting the table. Grandma, who seemed to have the metabolism of a humming bird, darted here and there, stirring this, spooning that, issuing last-minute instructions and fussing over the details. When it was time to eat, all the adults sat at the big table. The grandchildren were scattered around the room at folding card tables that had been brought along by the various families.

Family dinners were for adults and younger kids. The teenage members of the clan considered such gatherings embarrassing. They were too old to play games with the kids and too young to participate in the adult discussions. So they stayed home. Their parents seemed to understand and seldom forced the issue unless it was a very special occasion.

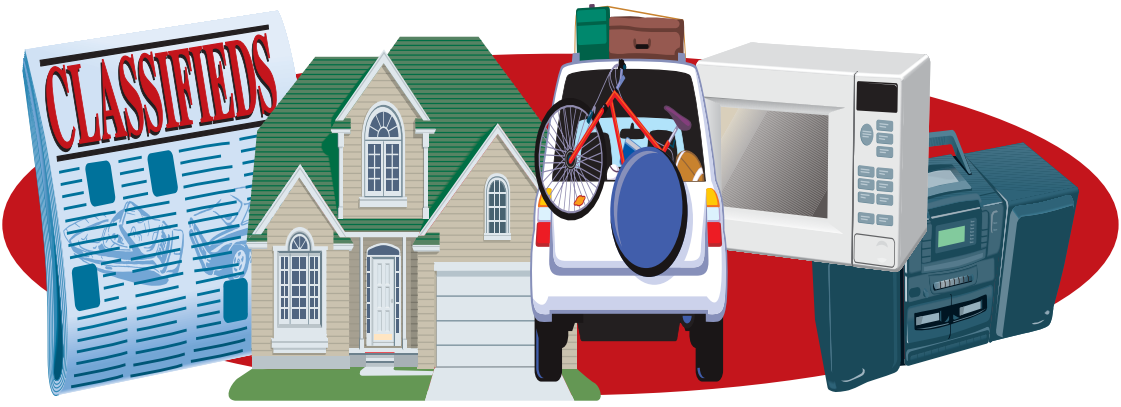

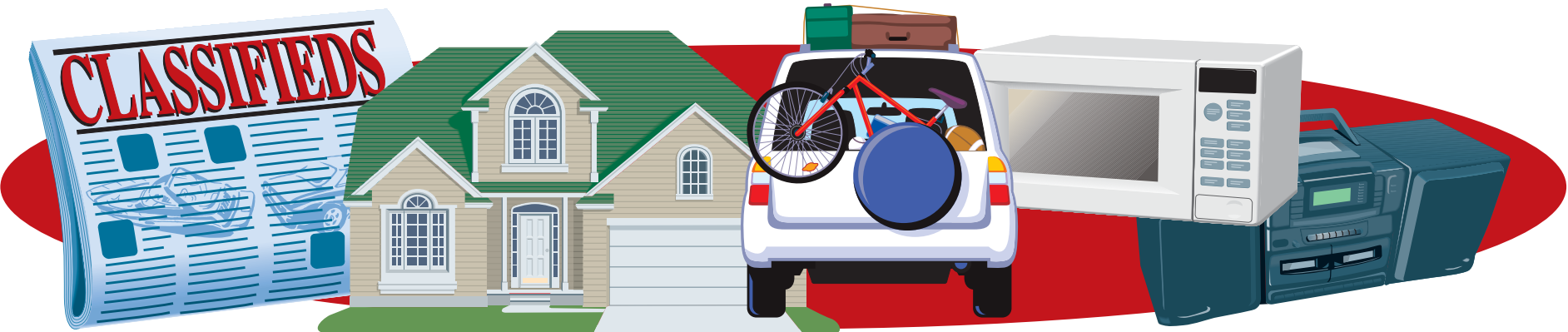
