Initiative signing delayed — again

The date for the next meeting of the Owyhee Initiative Work Group has been changed. Previously scheduled for October 5, then re-scheduled for October 12, the meeting will be rescheduled again, because of conflicting prior commitments for some members. A new date will soon be set and will be announced in time for the next issue of the Owyhee Avalanche.

The next meeting will be held in Murphy, where the Initiative was announced just over three years ago.

Road dispute to be decided Wednesday

The dispute over who has the rights to a road outside of Homedale could be over next week as the decision is scheduled to be made during a Homedale Highway District meeting Oct. 13 at 8 p.m. Hearing officer Fred Grant said last week that after a review of the statutes by counsel, no provision for a special meeting is made so the decision would have to be made during a regular meeting.

The dispute began after the county removed a gate crossing Johnstone Road at South Canal. The county had a gate installed for many years at the access to the county tipping station.

Districts to hold elections

Incumbents to be challenged in M-H cemetery election

For the first time in 18 years, one taxing district will be holding an election in November. This year there will be an election for district maintenance commissioner for the Marsing-Homedale Cemetery District and as of this printing, four people have filed for candidacy. In the past, an election has not been held in the district due to candidates running un-opposed.

Other districts in the county also have seats up for election including the Grand View Irrigation District, the Opaline Irrigation District and the Gem Irrigation District.

The election may not go as well for the cemetery district as the election for president or the county because boundary information is apparently not on record. Many residents have called this office to question if

they can vote in the upcoming commissioner election. The only information that can be found is if a resident pays Marsing-Homedale taxes, they can vote.

Cemetery District Secretary/Treasurer Rick Sherrow said last week that he has no idea — and has not found anyone else who knows — what the boundaries of the cemetery district are. He said the cemetery commissioners also have not yet determined where voting polls will be but plan to during an upcoming meeting on Oct. 4, the deadline to determine voting locations.

After being denied access to candidate information last week by Sherrow, and after a lengthy debate, Sherrow admitted that the district has four candidates for Cemetery Maintenance Commissioner including the two long

Voter registration closes Friday

Owyhee County Clerk Charlotte Sherburn said last week that Oct. 8 is the last day for electors to pre-register for the general election, which will be held on Nov. 2.

“An individual who is eligible to vote may register at the polls on election day by completing a registration card and providing proof of residency,” Sherburn said. “They must show a drivers license or identification card and proof of residency, such as a bill being sent to their home.”

Individuals residing in the mail ballot designated precincts that have not registered to vote by October 8 will have to go to the courthouse in Murphy to register on Election Day.

Quandering your taxes

City spending includes disc jockey and hockey tickets

The receipts for excessive spending by former city fathers and administration continue to emerge from the files of the City of Homedale. Last week it was discovered that not only had the city paid upwards of \$800 for a Christmas party, but that it paid at least that much two years in a row.

Homedale City Mayor Paul Fink said he was astounded at what has been emerging from the city's invoice files. He said some of the spending is not considered to be illegal, but it is very excessive and unnecessary.

One receipt that the mayor says he really does not understand is a check written to the Idaho Steelheads for hockey game tickets in the amount of \$1,141.50 in 2002. Homedale City Clerk Susan Mansidor said that minutes show that the city was offered a special to attend a hockey game on “Homedale Night.” The mayor, then Harold Puri, was invited to get on the ice and hit the opening hockey puck. But Mansidor said the city was supposed to get the tickets at a reduced amount of \$8 each.

If the city was charged \$8 for each ticket they would have purchased 142 tickets. Elected, full time maintenance, office clerks and full time police department personnel total 16 people..

Vale man arrested after stealing two vehicles, attempting two others

A Vale man was arrested Saturday in a vehicle theft spree that left two cars stolen and two others unsuccessfully stolen. One of the vehicles he attempted to steal had the owner of the pickup sleeping in a camper attached to the vehicle.

Guillermo Rodriguez, 40 was taken into custody at about 7:30 a.m. Saturday morning near the Snake River bridge at Marsing after he had left a trail of stolen and damaged vehicles from Homedale to Marsing.

Reports show that Rodriguez's spree began with a stolen 1998 Chrysler Concorde outside of Homedale on Highway 19. The vehicle was found on Highway 95 and Percifield where a dispatcher said Rodriguez tried to steal another vehicle from the Roy Herman residence near that location, but without success.

He then apparently tried to steal a pickup with the owner sleeping in a fifth wheel camper attached to the vehicle, and fin-

ished with the theft of an F-250 Ford extra cab pickup of Kendall Electric. Both vehicles were parked at the ION Truck Plaza.

The dispatcher said the owner of the vehicle with the fifth wheel attached, awoke and yelled at Rodriguez when he heard glass breaking on his pickup. He told dispatchers that the would-be thief ran from the scene, but he could be identified. As he was reporting the incident at the ION Truck Center, another vehicle was being reported missing from a truck center customer, Kendall Electric.

The dispatcher said Rodriguez was arrested on two counts of grand theft, two counts of attempted grand theft and one count of malicious injury to property. He is currently being held in the Owyhee County jail.

Another man, Manuel Nicolas Diaz, 21 from Ontario, the owner of the Concorde, was taken into custody on a burglary warrant from Canyon County when he

arrived at the scene to retrieve his stolen car.

District, cities to shut off irrigation water

Homedale City Maintenance Supervisor Larry Bauer said the city will shut the gates to the water on Oct. 8 and residents should not have any more water by the weekend.

The South Board of Control plans to shut the gates from the Owyhee Reservoir on Oct. 15 as well.

Public asked to voice opinions on fair boundary issues

The public will get the chance to tell the Owyhee County Fair Board what they think should be done with the boundaries for 4-H members to participate in the annual county fair. On Oct. 7, the fair board will hold its regular meeting, but this time members of the public are being asked to attend and offer solutions to solve the on going dispute.

The board agreed to revise livestock sale rules to exclude out of county 4-Hers that sell their animals at the annual Junior Livestock Sale held every year. The ruling would only allow 4-H kids who live or attend a school located in Owyhee County instead of including kids who attend a school district located in Owyhee County.

Fair board members addressed the issue during a meeting in March where member Dave Rutan told the board that he had been approached over the issue because of a 4-H club located in Canyon County. Rutan said the 4-H kids live in Canyon County, but the kids attend school in Owyhee County, which allows them to participate in the sale.

After a lengthy discussion, it was later decided to change the wording of the rule to state, "to

exhibit or market livestock in the fair, one must be a 4-H club member living in Owyhee County or attending a school located in Owyhee County."

Fair board member Kenny Tindall adamantly disagreed with the ruling and has asked the board several times to reconsider.

The group agreed that the rule would not take effect for this year's fair, but it would be in effect for the 2005 fair.

County Extension Agent Scott Jensen said the boundary issue would be the main topic of discussion at the meeting.

"The fair board will dedicate their meeting to listening to interested persons about the issue," Jensen said. "The format will be similar to a public hearing. Each individual who wishes to speak will sign in. They will have up to three minutes before the fair board to state their thoughts on the issue. The fair board members will then have the opportunity to ask questions. Written comments can also be submitted from individuals not wishing to speak publicly. The fair board has expressed to me that what they want to hear are solutions, not sob stories. Please consider

that as you prepare your comments."

The fair board will issue a final decision at its November meeting.

Library to hold discussion on "Mountain City" book

The Homedale Library will hold a book discussion of "Mountain City" by Gregory Martin. The experiences of Martin, a memoir of his days spent in the isolated town, will be discussed on Oct. 11 at 7 p.m.

"Imagine you are the descendant of Basques who settled in northern Nevada," Liberian Margaret Fujishin said. "As a child, you spend most of your free time with them in a small store in a small town miles away, watching the comings and goings of the town's 33 residents, the area miners and ranchers, and the Indians from the nearby Duck Valley reservation.

"Imagine learning the secret stories of the area's residents, most of them old and all of them just getting by as best they can. You sometimes learn things you wish you didn't know, about your relatives and about the colorful characters that populate the mountains and valleys. These were the experiences of Gregory Martin."

The author will also be visiting the Treasure Valley the same week. He will read from his book and talk about writing it on Oct. 14 at 7 p.m. at the Jewett auditorium at Albertson College of Idaho. Attendance is free of charge and is open to the public.

✓ Initiative

The Work Group appointed at that time by the Owyhee County Commissioners has worked diligently and with great patience to develop a proposal by which the goal of the Initiative can be achieved. Their work has been strongly supported by Senator Mike Crapo and his staff.

A draft proposal was issued for public review and comment in April 2004. After public meetings, workshops, and public hearings, in June, the Work Group voted unanimously to continue consideration of all components of the draft proposal. Drafting and Wilderness/Wild and Scenic subcommittees have spent countless hours revising the draft proposal in light of the comments received from the public. At the next meeting, the Work Group

members will vote on the revised proposal. A “yes” vote will favor sending the proposal on for legislative action; a “no” vote will oppose such action. The members will vote on each component of the proposal, and then on the proposal as a whole.

Meanwhile, the Shoshone Paiute Tribes and the Owyhee County Commissioners have worked on developing an historic Memorandum of Agreement to establish a process for implementing coordination between the governments of the Tribes and County. The MOA is based upon the principle of government-to-government interactions between the Tribes and the county. While the MOA has not yet been signed, it has been agreed to in detail and has been ratified by Resolution of the Tribal Council. The MOA will be signed by the

Chairman of the Tribes and the Chairman of the County Commissioners on the day that the Initiative Work Group meets to vote on the revised proposal. It will be an historic event. For years the Tribes and the County have exercised, individually, their coordinate status with the BLM. But, the signing of the MOA will commence the first formal governmental coordination between the Tribes and the County.

The Owyhee Initiative was conceived with the intent that the Shoshone Paiute Tribes and Owyhee County could, through government-to-government coordination, mutually launch a process for resolving land use conflicts, protecting the landscape resource, protecting cultural resources and achieving economic stability. With the

impetus provided by the Memorandum of Agreement, the Tribes and the County stand ready to mutually submit an Owyhee Initiative proposal to Senator Crapo for initiation of legislative action to implement the Initiative.

Poison Creek Posse to host Halloween horse party

Poison Creek Posse 4-H Horse Club members and parents attended an end of the year party at Boondocks Fun Center last month and the group will host a horse Halloween party on Oct. 10 at 1 p.m. at the Owyhee County Rodeo arena in Homedale.

Coordinators of the event said a group of 17 battled out boys against girls, kids against parents and one against the other in laser tag throughout the day at Boondocks.

Posse members will begin the new 4-H year with a costume horse and rider Halloween party on Sunday. Games, treats and prizes will be given. Members who attend do not have to bring a horse or dress up.

Leader Terry Reuck said that anyone interested in joining the club and attending the party can call her at 337-5914. She said to join the program a child must be at least in the third grade and eight years old by Jan. 1. Children eight to 19 are eligible to join. Younger members must be at least five to seven years old by January 1 and can join in the Cloverbud 4-H horse program.

✓ Voter

and Three Creek,” Sherburn explained. “Residents may register at city hall, the county courthouse or download a registration form from the Internet by going to owyheecounty.net and click on Clerk-Auditor Recorder and register by mail.”

To request an absentee ballot for the general election, a registered voter may make a written application to the Clerk’s office for an official ballot.

“You must request an absentee ballot by filling out an application signing it and returning it to the clerk’s office either by mail, or fax,” Sherburn said.

The last day for an application for mail-in absentee ballot is October 27. Registered voters may also vote absentee at the courthouse anytime between now and Election Day.

Applications can be faxed to 495-1173. For more information contact Sherburn at 495-2421 or Jamie Wylie 495-2806.

✓ Spending

“It is astounding what we have found,” Fink said. “It is something else every day. Things have changed, I can tell you that. We are not allowing any extra spending now. We can’t. We still don’t know where we are in the budget.”

But hockey tickets was not the only “excessive” payment made that has caused the mayor concern, the cost of Christmas parties also has him hot under the collar.

In 1999, the city spent \$375 to the “Rock ‘N Rooster”, a disc jockey for a Christmas party, \$33.17 for decorations for the party, \$50 for the rental of the American Legion hall, and \$723.96 for Caba’s Catering Service for a grand total of \$1,182.13. If every employee attended the party and brought along a spouse or one additional friend, the party would cost \$37

per person. Records for 2001 to the present had not yet been searched.

✓ Cemetery

time incumbents Don Osterhoudt for the Marsing sub-district and Bruce Sibert for the Homedale sub-district. Val Dines from Homedale has filed to run against Sibert and Garland Smith from Marsing will seek Osterhoudt’s position.

Owyhee County Assessor Brett Endicott said Thursday that he could determine from tax assessments the boundary for the district, but he said he was not sure if he could determine the boundaries for the sub-districts. County Clerk Charlotte Sherburn said it was the responsibility of the cemetery district to have on file a map of the boundaries. She said she does not have one.

A spokesman from the Secretary of State’s Election office said Thursday that the district is required to publish the location of the polling places but they do not have to publish the boundaries. She said residents living within the Marsing-Homedale Cemetery District are able to vote for both commissioners. She said

Commission Chairman Don Osterhoudt said Thursday afternoon that he was unsure why Sherrow would not release the names of the candidates, but he said he felt since the district has not held an election in so many years, Sherrow may not understand how the election works.

“He did not know if he could legally disclose those names or not,” Osterhoudt said. “He needed to talk to the county clerk before he did that.

“We have made so many changes to the way the cemetery district is operated. I think we have done some very good things out there and I hope to be able to continue to do good things at the cemetery.”

The Grand View Irrigation District will elect one director

from division three for a three-year term. Nominations for the position are available from Dixie McDaniel, secretary and are due by Oct. 13 at 3:30 p.m.

Joe Denardi’s seat is up for election in the Opaline Irrigation District also for a three-year term. Petitions are due to Cynthia Eaton, secretary-treasurer by Oct. 13 at 5 p.m.

In the Gem Irrigation District, Dan Felty’s position is up for election and petitions are due by Oct. 13 at 5 p.m.

The deadline has passed to declare candidacy by petition for the cemetery district, but several candidates got their petitions in on time. Write in candidates can still file for candidacy, but it must be done by Oct. 8.

✓ Road

But when other road issues in the county began to be decided, the county felt they also did not have the right to close a road. But one farmer in the area did not agree.

Tom Wilke alleges that he owns the right of way of the road and installed a gate. He kept the gate unlocked during the tipping station hours, but kept it locked the rest of the time.

The county Sheriff’s Office had been called to the scene several times since the dispute began, including a fight where shots were fired.

In July a public hearing was held before a hearing officer to decide if the road was public or private.

Youth hunt being held in Owyhee County

Young hunters in Owyhee County are finally able to hunt big game under the provisions of a youth hunt that has been offered in most of the rest of the state for several years. The season opened Oct. 5 in local units 40 and 41 and allows hunters 12-17 years old to hunt either sex deer in a general season. Units 40 and 41 traditionally have been two point deer only units unless hunters drew a controlled hunt permit.

The season runs from Oct. 5 through Nov. 24 for youth and is only in a small portion of units 40 and 41.

The boundary, as written in the Idaho Department of Fish and Game regulations, states that "only that portion of Units 40 and 41 within the following boundary are open to youth antlerless hunting: starting at the Oregon border on the Snake River then upstream to the C.J. Strike Dam Road then south on C.J. Strike Dam Road to Highway 78 at Rim Rock High School, then east on Highway 78 to Highway 51, then south on

Highway 51 to the Shoofly Cut-off Road, then west on the Shoofly Cut-off Road to the Mudflat Road, then north on the Mudflat Road to Highway 78, continue west on Highway 78 to the powerline that crosses Noble Island, then west along the powerline to the Oregon border, then north along the Oregon border to the Snake River, the point of beginning."

Youth are also give additional opportunities to hunt game in Idaho.

Any resident of the State of Idaho 10-17 years old who has just graduated from an Idaho hunter education course and has never had a hunting license may receive a Hunter Education Graduate Hunting License.

The license allows youth to hunt upland game birds, migratory birds, cottontail rabbits, and unprotected and predatory birds and animals, but not turkeys or sandhill cranes. Also, the holder of an adult Idaho hunting license must accompany the young hunter in the field. The cost for this license

is included in the hunter education class fees and it is valid for the current year.

Youth who are 10 or 11 years old and wish to hunt turkeys or sandhill cranes (not permitted by the Hunter Education Graduate License) during the current year, and must purchase a Youth Small Game Hunting license at any license vendor, such as a sporting goods store, for \$6.50.

Youth will need to provide the vendor with their hunter education certification and social security number. The Youth Small Game Hunting License allows youth to hunt all of the species mentioned in the above Hunter Education Graduate Hunting License plus turkeys and sandhill cranes. The holder of an adult Idaho hunting license also must accompany them in the field.

Jail lockdown causes problem

The Owyhee County Jail was not designed to hold a suspect, not matter what the crime, for more than a year. That is the evaluation of Owyhee County Sheriff Tim Nettleton. Nettleton made the observation in response to charges that he has been too lax with the security for a youth accused of murder.

The controversy boiled up last week after a Canyon County newspaper published a story concerning the security at the jail. According to the Caldwell News-Tribune, Nettleton recently received a call from district Judge Jim Doolittle. The judge told he sheriff he had received complaints from courthouse personnel at Murphy because a murder suspect has been allowed outside his cell to do chores. Nettleton immediately issued a memo, stating that the youth will no longer be allowed outside the jail.

Health Department lifts water boiling restriction

It's OK to drink Homedale water again.

The word was passed around the community Monday morning after tests during the weekend by personnel from the Idaho Department of health.

The State Health Department issued a "boil before drinking" order September 27 after learning of the existence of coliform bacteria in the Homedale water supply. Coliform is normally found in the intestines of animals and is an indication that material containing human or animal wastes has entered the water system.

Grazing fight planned

Members of the Owyhee Cattlemen's Association are organizing to fight the Bureau of Land Management's plans for the Owyhee Resource Area.

The Owyhee Resource area covers the western portion of Owyhee County and parts of Eastern Oregon.

In a final draft proposal last month the BLM recommended drastic cuts in the number of cattle that can be grazed on BLM land. Ranchers who use the range say the cuts, as high as 70 percent in some areas, would put many of them out of business. The cattlemen also contend the survey done by the BLM may not have been accurate indicator of the area's ability to support grazing.

Water alternative eyed

Homedale City officials were busy this week discussing ways to make extra water available in case of a major fire in the city.

The situation was made critical when one of the city's three wells was taken off line because it was contaminated with coliform bacteria. At the October 12 meeting of the Homedale City Council, water supervisor Paul Simon said the two remaining wells should provide enough water for normal use. Simon warned, however, that the city might face problems if forced to fight a major fire.

Homedale's present water storage tank is too small to hold enough water to fight a major blaze. And, with only two wells on line, the pumping capacity would not keep p with fire equipment for an extended period of time. The lack of capacity will be solved when the new city water system goes on line next year. The City is taking steps to provide emergency water should the need arise.

Tros, Raiders face shootout

It won't be a battle of the unbeatens Friday night when Homedale and Rimrock clash in their annual cross-country battle.

The highly touted Raiders dropped out of the ranks of the unbeaten last Friday when they ran into a buzz saw by the name of Fruitland. When the dust settled the Raiders were on the short end of a 30-6 score.

Meanwhile Homedale kept its perfect record intact and moved into the undisputed Western Idaho Conference lead with 27-0 shutout at McCall. Coach Daryl Kellum;s club is now 7-0 on the year and many Homedale supporters are beginning to talk playoff's.

But Homedale still has a big hurdle to cross. A large crowd of Trojan supporters are expected to make the trip to Rimrock for Friday's game. If the Tros win it means the Division I title and a berth in the playoffs against the Division II winner.

Homedale was never really threatened at McCall as the Trojans held the Vandals to less than 150 yards total offense. Meanwhile, the visitors were piling up 341 yards to total offense and recovering five Vandal fumbles.

During the discussion it was pointed out that the Homedale school district has only about \$69,000 of bonding eligibility and that it is likely that this money will be needed within a short time to erect new classrooms due to the fact that the present buildings are overcrowded and an increase in enrollment is expected in the next few years.

138 years ago

October 18, 1866

HORSE STEALING, &c. On last Sunday night a Mr. Hays has two horses stolen from his rendezvous, south of Flint a few miles. The nature of the theft partakes of 'Mellean man.

Speaking of horse stealing, the Flints were subjected to an amusing scare one night last week. A party of Silverites – B—m, B—g, P—t, and others were hunting, fishing, etc., in that neighborhood, and had to camp for the night. An old prospector, en route to Oro, discovered them about sundown, believed they were suspicious characters, and so reported when he got home. The residents of that promising district, were under arms in a short space of time, pickets were stationed at proper intervals, and every precaution taken to prevent surprise, &c. Next morning the "situation" was correctly solved, and the informant cross examined. "Did those men look like horse thieves!" asked one. "Well," said the man, with much earnestness, "by G—, sir any other country but his, I'd say they were horse thieves!" The nimrods in question should remember, when "in any other country but this."

BRUNEAU. J. H. Baker, rancher of Catharine Creek, brings the information that all the soldiers have left the Bruneau; also, that the Indians have abandoned it and are coming to Catharine Creek. The Indians manifest quiet, peaceable and industrious disposition. Will work cheaply and contentedly. If they can be provided with the means of living through the winter, and not be obliged to forage for it, Mr. Baker believes they will be of valuable service to the ranchers next year, and will earn their own living henceforward. The Indian Agent is expected to be there on the 22d to make some arrangements for their wants the coming winter.

GOOD. We have it on a very good authority that the two horse team, laden with Owyhee currency, was seen going towards Boise City, the latter part of last week. "Anywhere, anywhere, out of the world," and this part in particular, suits us. There was supposed to be about forty bushels on the wagon, and estimated to be worth about \$5 per bushel. This was a choice lot, fat above the average value of that in circulation. But, we still hear it stated "that it makes no difference so long as it goes for the usual price." We noticed a man rushing round frantically buying up gunny sacks, and upon inquiry learned that he was bout receiving pay for a few sacks of potatoes, and must have more sacks to hold the currency received, remarking that "as long as it goes I'm bound to take it if I can get sacks to hold it or a place of storage."

STREETS. There is need of a general street cleaning before the advent of winter. So much building has filled the street with all sorts of rubbish, which should be removed. There is one or two months time to do this, yet, it will cost no more to do it now. J. F. Dye & Co. have done a good job in front of their buildings, and we trust the others may become contagious.

THE FIGHTISTS in these parts find it an up hill business when Deputy Sheriff Springer is around. Some ten days ago he knocked down some three or four and ironed one and sent him to jail. After court, he will have more time to watch how "the boys" deport themselves, and treat them accordingly.

WEATHER. We've been having it warm and pleasant until yesterday, when a quiet little rain began to fall and continued up to the time of our going to press.

JUMPING lots in a noticeable feature in Silver City business. Several cases have occurred in the past ten days. We anticipate a few funerals from this occupation. It's a desperate game, and right or wrong the original claimant frequently gets animated with a steak of charity and donates the jumper the contents of a shotgun or revolver, or recklessly breaks a pick or shovel handles over the intruder's head. We in nowise envy a jumper his fun or profit.

EDWARDS & CREED, at Oro, have postponed the erection of the four story brown stone on account of a scarcity of lime, and a few other Oro necessities, perhaps. But the boys are up to the time, have built a fire proof cellar, and intend to get in a big stock of goods for winter and early spring. They belong to the human family, and should be blessed with trade.

HAY. A Jordan Valley rancher informs us that from twelve to fifteen hundred tons of hay have been cut and baled in the Valley this summer. It is now selling at \$65 per ton delivered in Ruby to Silver. It is generally well cured and in all respects good provender.

FRED BRUNZELL'S fire proof cellar is nearly completed and we think it the best in town. The floor is made of cobble stone, put in place with much care. It is a good model for others to imitate.

BRANCH HOUSE. Herman & Co. have recently rented the store room and cellar adjoining J. F. Dye & Co., and will open up a very large stock of good therein during the coming week.

BLAKE & CO.'S receipts for crude bullion for assay during the past week amounts to 15,543.53 ounces.

On the edge of common sense

Meat eating comes naturally

Now that the Atkins all-meat, all-fat diet has been acknowledged by most as effective for weight loss, their newest book is promoting its value in controlling diabetes. All this is great news for cattlemen, rib joints and the Egg Board, but the bagel and vegan crowd continue to be skeptical, mostly based on the idea that something that tastes so good must be bad for you.

Most anthropologists agree that prehistoric humans' rapid advancement was affected by their ability to hunt, digest rich protein (meat), and think. It freed them from the daily grazing grind of herbivores like mastodons, koalas and gorillas who, to this day remain incapable of inventing the wheel. Humans developed, achieved dominance and remain at the top of the meat-eating predator food chain. But somewhere along the way we started increasing the amount of fruits and berries, corn and cabbage, potatoes and tofu in our diet.

Instead of chasing buffalo across the prairie, we planted Anasazi beans. We learned to make tortillas. Eventually we invented a food pyramid that said eat lots of bread and rice and croissants and biscuits and less and less buffalo and chicken and goat.

I acknowledge that many modern cave dwellers have lost these skills, but the hunting instinct is still there. It can now be applied to the search for lo-carb meals; finding the right recipe for guacamole, the right salsa for tortillaless tacos, and the nerve to eat raw liver.

Those who practice the Atkins diet can tell you that the chase is as exciting and exhausting as the consumption. And, because you have to work at it, it is more satisfying. Not to mention the added benefit of losing weight!

My point is, that if we look at our hunting ancestors, it should come as no surprise that increasing meat in our diet would make us healthier.

But then, like now, I suspect that the first man who walked upright was probably ridiculed by his grass-eating neighbors.

Tom is a friend I met on the internet - a pediatrician who lives in Canada, right across the border from the upper tip of Michigan. Tom and I correspond almost daily via email. Over the past year we have exchanged a lot of photos and traded several pieces of camera equipment.

Recently, Tom one-upped me by sending a beautiful German Contax camera, made in 1938. The Contax was the Cadillac of cameras in its day and still can hold its own with modern cameras in the hands of a knowledgeable photographer. I guess Tom believed I filled the bill because of my long photographic history.

Tom has been after me to send him some photos of our local scenery made with the Contax. So last weekend I found a roll of color film, grabbed the camera and headed for the Snake River. Tom has a special interest in the Snake. He saw the stream during a visit to Jackson Hole earlier this year and finds it hard to believe it is the same Snake River that flows through our part of Idaho.

I spent considerable time at the riverfront park snapping photos looking upstream, and across the river with Lizard Butt in the background. The light was just right for some really nice shots and there were just enough fluffy white clouds in the deep blue sky to give it some character.

On the way home, I stopped along the shore of Lake Lowell and shot a few photos of that body of water. The old camera operated as smooth as your proverbial silk. It was a real pleasure to use - a true example of pre-war German craftsmanship. Later that evening I shot some photos of geese flying low over our house, on their way from the lake to nearby fields to feed. The sun was about to set, giving the feathers of the geese a golden hue. Great stuff!

I already had planned to take Monday off from work to take care of some chores. One item on my things to do list was to get my film processed so I could email some photos to Tom.

I picked up the camera, pushed the release button on the bottom of the housing and started turning the rewind knob to pull the exposed film back into the light tight film cassette. Usually, one can feel tension on the knob as it pulls the film. But no matter how many times I turned the rewind knob, it moved freely with no drag.

Fearing the film end had somehow become detached from its cassette, I got out my light tight changing bag

and put the camera inside. Then I stuck my arms in the light-tight sleeves of the bag and opened the camera, planning to put the exposed film in another light proof container so it could be transported to the processing lab. Unfortunately, I couldn't do that because there wasn't any film or cassette in the camera.

I walked back to the room where I store the camera. The first thing I saw was a brand new, unexposed roll of color film that was supposed to have been in the camera, sitting on the desk where I had left it a day earlier.

Most modern cameras are designed so they won't work unless there is film inside. A 1938 classic German Contax operates smoothly with or without film.

UN or US to Decide Forest Management?

The U.S. Forest Service is currently accepting public comments to determine how to change the Clinton-era Roadless Area Conservation Rule to allow timber harvesting in our nation’s forests. But, if the United Nations Conference on Trade and Development (UNCTD) successfully pushes through a newer, bolder version of the International Tropical Timber Agreement (ITTA), the United States may not have much say about timber management within its own boundaries. In 1999, the U.S. signed the UN measure that created the ITTA, which was developed to establish a timber market that is “fair” to all nations and support sustainable use of natural resources, giving more weight to the environment than the needs of humans. Members of the organization are divided into two voting sections; timber producers and timber consumers with the U.S. labeled as the latter. This puts America at a disadvantage because the votes of producer countries, such as Indonesia and Malaysia, carry more weight than consumer nations in determining global timber harvest policies. The UNCTD plans to launch an expanded version of ITTA by 2005, which will give the international community even more power to regulate forest management. The new version ITTA2, will increase “political attention on forest governance,” “interest in monitoring and regulating the international trade,” and “interest in managing natural forests as ecosystems.” If the U.S. doesn’t reject this latest agreement our vast forest resources may be forever lost.

Widow Sues Government

A Great Falls, Montana woman is suing state and federal government agencies charging their mismanagement of grizzly bears resulted in the death of her husband, Timothy Hilston, in 2001. Mary Ann Hilston said in her charge that the U.S. Fish and Wildlife Service and the Montana Department of Fish, Wildlife and Parks failed to warn hunters that grizzlies were becoming a serious threat to elk hunters in the Blackfoot Clearwater Wildlife Management Area. Court documents state: “The defendants knew that bears were becoming accustomed to gunshots and that bears were using the sound of gunshots as a ‘dinner bell.’” Mrs. Hilston said the agents received reports that an aggressive sow grizzly and her two cubs had taken over a hunter’s elk carcass in the area on October 27, 2001, yet failed to warn her husband and others of the danger. Mr. Hilston was killed by the grizzly and her cubs on October 30, three days later. Wildlife managers eventually killed the sow and her cubs, fearing they had picked up too many bad habits from their mother. Mrs. Hilston is seeking a jury trial and unspecified damages for the wrongful death of her husband.

From Farmland to Swamp

A 7,000-acre Illinois farm will soon decay and disappear under the murky waters of a dismal swamp now that The Nature Conservancy has taken control of the 80-year old operation. TNC paid \$18.5 million for the property in 2000 and plans are under way to demolish the outbuildings and homes to be replaced by wetlands, sort of making a sow’s ear out of a silk purse. Nature Conservancy ecologist, Doug Blodgett, thinks it could take three years to destroy 80 years of production agriculture at Emiquon. Blodgett says it is no longer necessary to use marginal ground for crops. In fact, he says, [K]eeping them in use as farms causes a whole range of negative environmental effects.” TNC has been in the swamp restoration business since 1999, when they turned the 1,700 acre Swampy Bottom place into a haven for snakes and frogs. The planners hope their efforts will be duplicated by others seeing more farmland replaced by swamps. Donald Hey, a senior vice president of the Wetlands Initiative, another backwards-looking group, said he believes the farmland to swamp concept can be replicated in river basins from the Cheasapeake [river] to the Sacramento.

\$70 Million for Land Grabs

Interior Secretary Gale Norton has announced the federal government is distributing more than \$70 million of public funds to twenty-eight states and one territory for acquisition of habitat for endangered plants and animals. The money will go a long way in furthering EarthFirst! founder Dave Foreman’s vision of the Wildlands Project of rewilding 50 percent of our nation. The grants are funded through the Cooperative Endangered Species Conservation Fund, the Habitat Conservation Plan Land Acquisition Grants Program, the Habitat Conservation Planning Assistance Grants Program and the Recovery Land Acquisition Grants Program. “These grant programs are some of the many tools we have to help landowners conserve valuable wildlife habitats in the day-to-day management of their lands,” said U. S. Fish and Wildlife Service Director Steve Williams. The grants will allow states and/or non-governmental organizations to keep landowners from using their property without supervision. A quick review of the grants reveal millions of acres of private property will be acquired to provide large tracts of land for wildlife corridors, a key provision of the Wildlands Project. In some cases the Nature Conservancy will buy entire ranches and then sell portions back to the government. The Bush administration has provided an unprecedented amount of money for land acquisition under the cloak of conservation resulting in a rapid escalation of the radical environmentalists’ dream of “the end of industrial civilization,” and a return to “October 1492.”

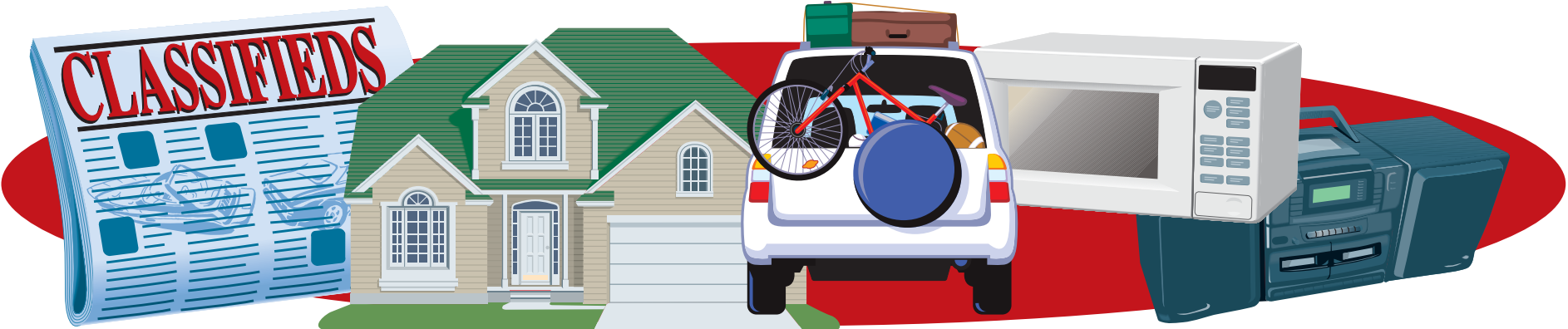

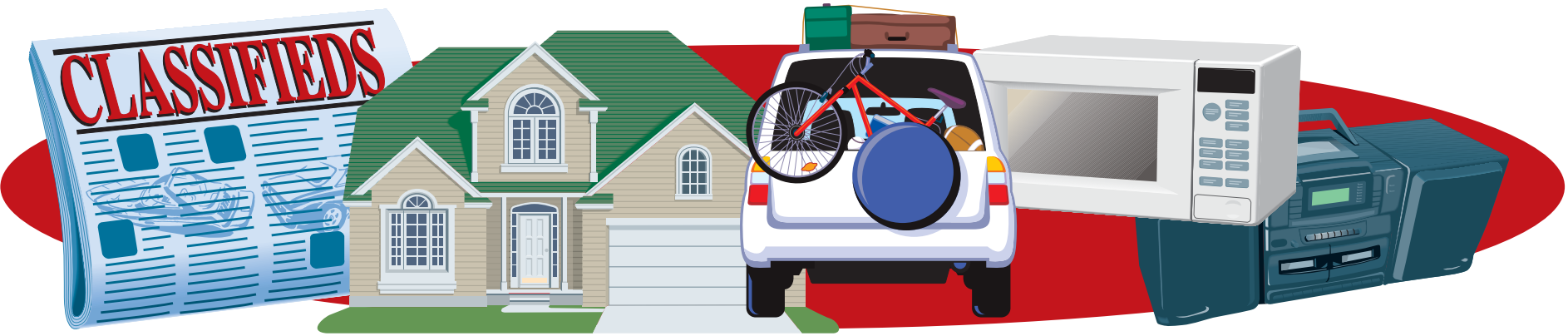


