## Voters oust trustee in recall election

The voters spoke last week and ended a Bruneau/Grand View School District's trustee term with a 92-62 affirmative vote to a recall election filed earlier this year. Russ Turner's term ended last week when nearly 75 percent of the total voters in zone one said no more to Turner's position.

Turner's recall was filed when petitioners claimed he violated the trust of electorates and the children in the school district. The petition said that "trustees must put the children's interest above all others" and "they must listen to the parents and employees of the district. When things are not going well, they must care enough — to page **5** 

#### Elections to be held in Homedale and Grand View

School districts across the state will hold school board trustee elections on May 17 and in Owyhee County, districts in Homedale and Grand View will be among them. Unless an opponent files as a write in candidate in the Marsing School District an election will not be held as only the incumbents, Betty Ackerman in zone 3 and John Ineck, in zone 5, filed for another term.

But in Homedale, incumbent Benita Miller will campaign against Kevin Miyasako who also filed for candidacy in zone 3 and Ric Uria, incumbent will face Samuel Page in zone 4.

In the Bruneau-Grand View School District, the names of those running for school board were not released upon request Monday. Several attempts were made Friday to acquire the names, but calls were not answered. Monday, the Owyhee Avalanche was told that the person who handles the election was not available and would not be until Wednesday. The candidates' names will be published in next week's paper.

## City requests re-negotiation of impact area

The City of Homedale is requesting that the Owyhee County Commissioners renegotiate the area of impact for the city and has given the county 30 days to begin talks. Planning and zoning administrator Sylvia Bahem submitted a letter to the council dated Dec. 28 of last year requesting the council submit a letter to commissioners to reopen talks about the impact area. In February, the council submitted a letter to commissioners requesting they reopen negotiations and last week, the commissioners responded.

A Homedale City ordinance states that the city and the commissioners shall review the area of impact agreement at any time upon either party's request. Mayor Paul Fink could not be reached for comment last week.

Commissioners responded last week by requesting the city advise of three elected officials who will participate in the renegotiation. They said they will select three officers and the commissioners and council will then choose three residents to participate.

The council chose Dave Downum, Cindy Sims and Steve Schultz to head up the city's interests.

"Due to increased population in the City, we feel it is necessary to address the area of impact," Downum said. "It is mostly a formality, but if we need to change boundaries, we need to discuss it now with the county."

## Homedale trustees announce plant facilities levy election

A plant facilities levy election will be held in the Homedale School District next month in conjunction with the school board election. Locations to vote were announced last week.

The election will be held on May 17. The district is asking voters to approve a reserve fund levy in the amount of \$150,000 beginning July 1, 2005 and continuing each year for 10 years.

The question on the ballot will read: "shall the Board of Trustees of Homedale Joint School District #370, Canyon and Owyhee Counties, Idaho be authorized and empowered to levy a School Plant Facilities Reserve Fund Levy in the amount of \$150,000 (onehundred fifty thousand), for the first fiscal year beginning July 1, 2005 and continuing each year in the amount of \$150,000 (one-hundred fifty thousand) for 10 (ten) years for the purpose of allowing the District to acquire, purchase or improve school site or sites; to accumulate funds for and to build a school house or school houses or other building or buildings; to demolish or remove school buildings; to add to, remodel or repair any existing building; to furnish and equip any building or buildings, including all lighting, heating, ventilation and sanitation facilities and appliances necessary to maintain and operated buildings of the District; to purchase school buses; for lease and lease purchase agreements

for any of the above purpose and to repay loans from commercial lending institutions extended to pay for the construction of school plant facilities."

A super majority vote is needed for the election, which is two thirds of the total vote.

## Hearing on Wilke Farms CAFO application continued this week

The Planning and Zoning Commission heard testimony for two days last week on the application for a confined animal feed lot filed by Wilke Farms. The hearing then was continued to Monday afternoon when Tom Wilke was scheduled for rebuttal testimony and questions from the members of the Commission. Results of the hearing were not available at press time.

Commissioners Gene Jayo, chairman, Connie Brandau, Jerry Hoagland, and John Urquidi heard the testimony and Over twenty persons were in attendance during the hearing. Commissioner Landa recused himself and Fred Kelly Grant served as Hearing Officer.

Attorney Chris Meyers from Boise, represented Wilke Farms, and Beaver Dayton and other residents of the subdivision near the proposed site were represented by Lois Hart from Homedale. The hearing began with a question to each Commissioner as to whether any person has spoken to them outside the hearing room about the Wilke operation. Commissioner Jayo said that when someone said something to him about the matter his response was "come to the hearing and find out." Commissioners Brandau and Hoagland stated that when people talked to them about the site, their response was that they really couldn't talk about the matter prior to the hearing. Commissioner Urquidi who is from the east side of the county said that no one had approached him to talk about the site.

Tom Wilke testified for over two hours under questioning from his attorney, cross examination by Hart and questions from the commissioners. His Nutrient Management Plan expert testified on Tuesday and concluded on Wednesday. He offered explanation of how the Nutrient Management Plan places restrictions on the proposed operation through the federal Clean Water Act.

Several landowners who object

to the proposed site sat through Wilke's testimony and that of the expert both Tuesday and Wednesday in order to testify as to their

Local resident Beaver Dayton testified as to his concerns, describing them from the standpoint of his well digging experience and electrical experience. Mary Maher offered her testimony and that of her granddaughter through a letter, which she read into the record. Concern was expressed through that testimony as to the possible mosquito infestation, which could surround the standing water on the proposed site. Colletta Spence testified as to her concerns that her place, which includes a newer home, several head of stock and a large building, which combines several purposes such as a woodworking shop, lies adjacent to and across the road from the site. In her testimony, she stated her concern that they will not be able to sell their place for its real value

sues. Meyers objected as to any testimony or evidence as to the personal interactions between the Wilkes and neighbors in the area. He argued that under the state's Land Use Planning Act and the County Zoning Ordinance such incidents were irrelevant to a zoning issue and should be handled in the proper forum, such as law enforcement. Hart argued that the evidence was relevant under a Resolution issued by the Board of County Commissioners in 1999, which stated that prior operation experience of an applicant is relevant to consideration of whether an application should be granted. Meyers pointed out that there was no mention in either the Ordinance or the controlling Land Use Planning Act, which would allow such evidence to be admitted. He further argued that the Resolution was clearly limited to conduct regarding operation of a prior CAFO. Grant issued a decision, after reviewing the Ordinance, the Land Use Planning Act, the Resolution, and several legal authorities, that the evidence could be admitted, but only if it stemmed

## **US Marshals arrest** Grand View woman

Over 10,000 arrested in nationwide operation

In a nationwide cooperative effort to clear nearly 20,000 felony warrants, the United States Marshals teamed up with federal, state and local law enforcement and performed the biggest fugitive apprehension operation in American history. Of the 10,340 fugitives arrested in the country, one confirmed and two not confirmed additional arrests were made in Owyhee County.

U.S. Marshal Pat McDonald said last week that in Idaho, 51 felony cases were cleared with 44 arrests made. He said he could confirm that Carla Pennington was arrested in Grand View and he was aware of two other arrests made in the Homedale and Marsing areas but he could not confirm them at press time.

Homedale Police Chief Jeff Eidemiller confirmed that a female adult was arrested in Homedale as part of the operation. But he said that the U.S. Marshall's office would have to release her name. McDonald said he did not have that information at this time.

"Falcon was the first national program that has been ran across the United States," McDonald said. "What it did was put 3,000 policemen on the road for one week that did nothing but apprehension. Idaho was part of that. It was a very successful operation. The people we focused"

In Idaho, six cases of assault, 13 burglary and larceny, one financial fraud, one homicide, 12 narcotics, three robbery, seven sexual assault, one failure to register as a sex offender and two weapons charges were cleared.

Operation FALCON, Federal and Local Cops Organized Nationally, was conducted in six days earlier this month. Deputy U.S. Marshals and law enforcement partners arrested over 10,000 fugitives and cleared more than 13,800 felony warrants. Officers from 960 federal, state and local law enforcement agencies took part in the concentrated search, which coincided with Crime Victims Rights Week.

Nationwide, more than 150 who were arrested were wanted for murder, another 550 were sought on rape or sexual assault charges and more than 600 had outstanding arrest warrants for armed robbery. Among those captured were 150 gang members and 100 unregistered sex offenders.

Congress gave the Marshals Service more money and authority to go after fugitives when it refocused the FBI's mission toward stopping terrorism in the wake of the Sept. 11, 2001 attacks.

"We can't do it all the time. We all don't have the resources that we need to be able to go out on an every day basis and do what we've done in the last week, but this certainly shows the potential of that capability," said McDonald.

'Operation FALCON is an excellent example of President Bush's direction and the Justice Department's dedication to deal both with the terrorist threat and traditional violent crime," said Attorney General Gonzales in a press release. "This joint effort shows the commitment of our federal, state, and local partners to make our neighborhoods safer, and it has led to the highest number of arrests ever recorded for a single initiative of its kind. We will use all of our Nation's law enforcement resources to serve the people, to pursue justice, and to make our streets and Nation safer."

"I applaud the achievements of every Deputy Marshal, police officer, detective, trooper, investigator, deputy sheriff, and special agent who hit the street virtually around-the-clock for seven days," said Robert J. Finan II, the Marshals Service's Assistant Director for Investigative Services. "Also of note is that during the course of this initiative, there were no serious incidents or serious injuries to either law enforcement officers or those who were taken into custody."

## Realtor "back in the saddle"

After an automobile accident nearly claimed her life last year, Lori Rasmussen said she is "back in the saddle and ready to go to work". Lori a realtor, who works under the Coldwell Banker name, returned to her desk last month and said she may be confined to a wheel chair, but that is not slowing her down

Last year Lori was involved in a horrific automobile accident. After spending six months in the hospital, seven weeks of which were in intensive care, she spent another three months in a care center. Her final diagnosis was that she would never walk again. But Lori said the diagnosis is just something she deals with and now she feels good, and is ready to get back into life.

Lori collided with a garbage truck on Highway 78 in May. She said she does not remember anything about the accident, but she understands that she ran a stop sign.

"I dropped off my ironing and was heading to work and the rest I don't remember," Lori recalled. "They told me in the hospital that they waited several days before they did my surgery on my neck because they didn't think I was going to make it. They grafted bone from my hip for my C 5 and C 6 vertebrate. They also put in a metal plate." Lori said she also had broken ribs and damage to her spleen.

Although Lori is confined to a wheel chair, she has been able to obtain all the up-to-date necessities to get her where she wants to go, when she wants to get there. She has a portable ramp that she can navigate her electric wheel chair on to enter homes that have stairs. She travels with a companion so she can show the rest of a home where she may not be able to go.

"I have a lot to look forward to," Lori said. "I love this area and although I now live in Boise, I want to come back. I am ready, willing and able to do the job. Your prayers and support have been a great asset in my recovery," Lori says. "I thank all who have stood by me and encouraged me to fight hard and rise above. I have been through quite a lot during my journey down lifes' path and God willing, I have many, many more goals to fulfill. I haven't come this far to give up."

Lori said she has had tremendous support from Coldwell Banker and from her friends in the area.

## County addresses food by-product permit modification

Owyhee County Commissioners addressed a permit modification that is being sought by Food By-Product Management LLC to add whey waste from Meadow Gold Dairies to land applications in the county.

FBM applied for a permit modification in March and comments were due no later than April 14. The commissioners responded that any increase or modification application of wastewater would require a conditional use permit from the county. The commissioners said they were "highly" concerned with increased loads on access roads.

FBM has applied to add 1,444 acres to its application site area by including whey from Meadow Gold Dairies to its current applications. The application season is year-round.

The facility hopes to modify its permit by adding tracking of truck deliveries for daily applications of a mixture of Sorrento wash water and sludge and Meadow Gold whey. Monthly they will deliver a mixture of wastewater from a storage pond to land application.

## **Breshears fishing** derby planned for next month

Local young experienced and in-experienced fisherpersons will have the opportunity to learn new techniques and maybe even catch a fish during the LeRoy Breshears Memorial Kids Fishing Day. The event is planned for May 14 and will again be held at the Marsing

County D.A.R.E. officer and district representative Rich Wills who is coordinating the event, is collecting donations from individuals and businesspeople in the area. He said any donation will be accepted, but donations of \$200 or more will get the donator a spot on the back of a t-shirt kids will be given.

The Owyhee County Sheriff's Department, the Idaho Department of Fish and Game, the local D.A.R.E. program, Owyhee County Sheriff's Posse and several community members organize the event. The event was coordinated after the death of long time hunter education instructor LeRoy Breshears. Breshears passed away in Marsing on April 7, 1999.

"He was a guide and inspiration to beginning hunters in both Marsing and Homedale for nearly 20 years," Owyhee County Sheriff Chief Deputy Dick Freund said. "He was certified by the Idaho Department of Fish and Game as a Hunter Education instructor in May, 1979 and over the years he taught 43 classes and graduated 838 hunter education students in the area."

The Marsing pond was opened to Owyhee County children from kindergarten through sixth grade and stocked with approximately 1,500 catch-able trout. Law enforcement volunteers hold fishing clinics to teach children how to cast, catch and clean fish. Prizes are given for a wide range of accomplishments including the biggest, smallest, first and last fish caught.

The first event recorded approximately 250 children and nearly doubled that amount the second year. Nearly every child attending wins a prize from hats and t-shirts to fishing poles and tackle.

Hot dogs, chips, and pop will be given to sportsman and many Fish and Game officers will be on hand to answer questions and help children learn to fish.

They gathered at Walter's Ferry, at Cleo's Ferry Museum at the historic original 1864 adobe building, one of only a couple of original buildings associated with the ferries that are still in existence. The group then viewed and discussed ten ferry or crossing sites from the Canyon County side of the Snake River. Following a potluck lunch, courtesy of the Marsing Senior Center, the group stopped at many of the same ferry sites on the Owyhee County side. They ended the tour at the Bernard barn, built at the Bernard ferry in the early 1880s, where Edgar Muller's 95th birthday party was being celebrated.

Written application for an absentee ballot may be made to the Clerk of the Board of Trustees on a form made available at the School District Administrative Offices on Monday through Friday, from 8:30 a.m. to 4:00 p.m. Application must be made no later than 12 p.m. on May 17. Electors applying in person may obtain their ballots starting April 19. Electors applying by mail should submit their requests as soon as possible. The absentee ballot must be received by the Clerk no later than 8 p.m. on the day of the election.

to search for the truth." The statement says that Turner has refused to meet with electorates and has chosen to ignore the pleas of his constituents concerning the learning environment of the schools and has chosen to follow the district administration, "blindly."

"I prefer to focus on the positive, so will not address specific charges in the petition other than to state my belief that it is unwarranted,"Turner said in his response to the petition. "I am deeply committed to this community, serving as an active member of the Bruneau American Legion, Bruneau PTO, Bruneau Quick Response Unit and a Bruneau Soil Conservation District Board member as well as nearly five years as a school trustee. I have a daughter who is enrolled in the district and thus a very personal interest in ensuring the district is able to function."

Turner said prior to the election that he did not feel the public would remove him, but 154 voters out of just over 200 turned out to remove the five-year trustee.

Superintendent Dallas Taylor said Wednesday that now the board will accept applications for the position and will have up to 90 days to appoint a replacement. She said Turner's term ended immediately following the results of the election on Tuesday.

Last year, a petition to recall Trustee Chairman Darrel Agenbroad was filed and an election was held in August. The recall failed in a deadlock tie.

Turner did not return calls for comment.

from or resulted from operation of a CAFO. He allowed into evidence any testimony as to safety problems on the road adjacent to the proposed site, or any threat to any neighbor if it was as a result of operation of the CAFO site, or equipment used in operating the CAFO site.

Meyers also contended that the Idaho Water Resource issuance of a permit for operation of the proposed site preempted any speculation as to water levels or water useage, or anecdotal testimony as to well levels being affected. He relied on the Idaho constitutional position of the Water Resources Board, the statutes which set the procedure for challenging the issuance of a permit, and the rules of the Department, which provide for issuance of the permit. He pointed out that when Wilke applied for the permit for operation of the

site, and notice was published in the Avalanche, that provided notice to anyone who thought there would be insufficient water either for the site or for landowners in the vicinity to appear and protest the permit. He argued that it was unconstitutional and unlawful to attack the Water Resource decision that there was adequate water both for the site and for adjacent landowners collaterally in a zoning decision. After reviewing the Idaho Constitution which was amended by the people of Idaho to make the Water Resource Department a constitutional body, the statutes relating to issuance of a permit and the hearing which is made available to contest the permit, Idaho Supreme Court decisions, and the recent LU Ranching case in which the Idaho Supreme Court ruled

that notice of a hearing process provided by statute is sufficient notice to put owners on guard as to the necessity of appearing in the permit process, the Hearing Officer ruled that the Water Resource decision foreclosed speculative and anecdotal evidence as to water levels. He allowed testimony as to potential contamination and quality of water, but not quantity. The ruling once again emphasized the landowners' obligation to protest during the hearing process provided by the Department of Water Resources.

Grant said that following completion of testimony, the commission will take the case under advisement. After counsel files closing briefs, the commission will then render a written decision.

## Snake River cleanup planned for Saturday; volunteers needed

A trash cleanup along one of the more popular stretches of the Snake River is planned for Saturday, April 23, beginning at 9 a.m. Additional volunteers are needed to help with this effort, sponsored by the Idaho Department of Fish and Game.

Food and refreshments will be provided, so volunteers should RSVP to Fish and Game utility craftsman Dennis Hardy at the Fish and Game Nampa office, 465-8465. Hearty volunteers should wear boots and gloves and plan to meet at Fish and Game's Map Rock site, located 6.5 miles west of the intersection of Map Rock Road and State Highway 45 at 9:00 that morning. The project should be completed by early afternoon.

The river cleanup will be conducted from the Walter's Ferry bridge downstream to the Marsing bridge. "A few workers will be assigned to boats for a portion of the cleanup effort," Hardy noted. "But most of the volunteers – and we hope to have a bunch of them – will be working along the banks of the river." Trash will be hauled to a central location for transport to a landfill. Because of a waterfowl nesting closure, federally owned islands on the Snake River will not be part of the trash collection effort

Past cleanup efforts along this same stretch of river have netted more than six tons of trash, including all types of furniture, appliances and even a safe, stolen from an area business.

Area landowners are encouraged to note the cleanup effort date. "We wanted to inform land owners in advance of the activities planned for that day," Hardy noted. "So when they see a flurry of activity along the river, they will know what's going on."



Lauson passed the test with a 65.5 on the written and an eight on his resume. The number one score including the college

"It is tough," Lauson said. "I want to do this as a career. I almost didn't enter in diesel, but I am glad I decided to."

"The last five years we have had competition," Diesel Technology Teacher John Montana said. "Before that we were the only high school diesel shop in Idaho."

Montana took six diesel competitors and four auto competitors. Four students from health occupations also attended. Now Lauson is attempting to raise funds to travel to Missouri for the national competition, which will be held this summer. He said he has fundraisers planned and he is also seeking sponsors to help him go.

Stations include on vehicle workstations, tools, automotive service technology and several other hands on workstations. The students prepare for the competition by fixing customer's vehicles in the shop in Homedale.

Pat Malmberg of Marsing tied Lauson, but ended in second place.

Hannah Johnson and Erika Shanley dominated the 100 m hurdles with times of 18.34 and 19.05. Johnson was also third in the long jump.

Chalsea Hicks won the 1600 meters with a time of 6:44 and placed third in the 400m with 1:11.30. Homedale's 4x200 relay team coasted to a win in 2:07.51, and the sprint medley relay was second. Kelsey Martinat and Mikal Mackenzie were second and third in the high jump.

The seventh grade boys scored 47 points with Jake Tolmie leading the way with three wins in the 1600m 5:39, 400m 1:04.93, and in the 800m with 2:38.61.

Trent Acree won the high jump 4'10", was third in the 100m 13.3, third in the long jump, 13'3" and second in the 200 with 27.89.

Homedale won the 4x200 relay 1:56.68. Alex Mereness was fourth in the shot put 30'10" and fourth in the 100m hurdles 19.45 Aaron Proferes was third in the 100m hurdles 19.34.

The eighth grade boys score 55 points led by Austin Emry's two first place finishes. He won the high jump with a 5'8" jump. The school record is 5'9" set by Walt Sutterfield in 1983 and Tony Hoshaw in 1994. Emry long jumped 18', and placed fourth in the 100m and 200m.

Rodrigo Villarreal won the 100m hurdles 15.76, placed second in 100m 13.15 and third in 200m. Gibson and Fierro were first and second in the 1600m with 5:32 and 5:38. Brandon Valadez tossed the shot put 37'11 ½" and Rowdy Lair was third with a toss of 36'.

I have no doubt Greg will continue to improve each week, but just seeing him out there as a competitor and not a spectator was a great feeling.



Sometimes the best advice one can get is the least appreciated. I'm reminded of this observation when I hear of the honest, some would say cruel, comments the English judge Simon makes to mediocre contestants on American *Idol*. But blunt doesn't necessarily have to be cruel.

I had a nice visit with a fellow New Mexico State alumni who was a student when my father was the Dean of Agriculture. This man, we'll call him Don, was six months into a Master's program with the idea of becoming a college professor. Don told me he received a call from the Dean's secretary. ## Letter to the editor

#### Affected interest

At the hearing on April 12, I attended from 1 p.m. until 7 p.m. I was effectively denied the opportunity to present my testimony regarding Wilke Farms' unauthorized expansion. Approximately 25 other affected neighbors who had put aside their work and driven out to Murphy were also denied, because Wilke counsel monopolized the time. Many of them lost that day and paid in other ways in the hope of participating.

Like myself, most of the neighbors were unable to make the trip to the extended session on Wednesday. The result was that the P and Z Commission heard principally from the offending party and not from the affected neighbors.

Let me make it clear that, as the adjoining neighbor of Wilke Farms, I am already heavily impacted by traffic, noise, flies, dust and loss of tranquility. As summer approaches I can look forward only to heavier impacts plus potential of insect borne diseases, nauseous odors and manure migration from Wilke Farms.

At the head of the list of impacts, however is the looming impacts on my water, both for domestic and landscape irrigation. Twenty-five years of property improvement are about to be destroyed because of the illegal actions of the owners of Wilke Farms, subject of the above hearing.

As I see it, Owyhee County Planning and Zoning can best observe these impacts by making a tour of my farm, the Wilke Farms and the boundary zones. I hereby urgently request you, Mr. Grant, to select a date for such a tour, when the affected public can join you on the ground to personally see the lay of the land and judge the impacts for yourselves. I am forwarding copies of this letter to all parties.

The original library building was constructed in 1920 by the Homedale Development Club. And for nearly two thirds of the period of its existence, it has known only one librarian. But when the library moves on Saturday, the librarian, Hazel Aldrich, won't.

#### 138 years ago

April 20, 1867

GENERAL CARTER went out yesterday to ascertain the latitude of the initial point of the public surveys. Two parties of surveyors, one under the supervision of Mr. P. W. Bell, and the other of Mr. Thompson, were before on the ground. Mr. Bell will begin at once to run the first meridian south, and then a parallel into the Owyhee mining district. Mr. Thompson will run the same meridian north and then a parallel into Boise County. This being done, the meridian will be extended into the extreme northern Counties of the Territory and to the more important localities. Alturas and Oneida Counties will receive attention as soon as it is possible to get to them. The base line, it is thought, will run through or near the Yuba District. Congress has passed an additional appropriation of \$15,000, which will enable the Surveyor General to accomplish more this session than was at first supposed possible. – Statesman, 16th.

WARLIKE. The Cable dispatches indicate war abroad. Prussia and France will have a set-to, unless the latter backs down—at least Bismarck has so informed Napoleon. Russia is liable at any time to give Turkey a crush, and England may be dragged into both difficulties. The states of feeling has caused a depression in stocks and finances.

SUPPLIES. In addition to the supplies advertised for by the offices of the military Posts, the following are called for at headquarters in San Francisco for these places: Camp Smith, 130 tons; Camp Lyon, 140 tons; Camp Winthrop, 140 tons. This indicates that these Posts are not to be abandoned the present year.

THE SENATE has confirmed the Russian-American treaty of purchase. The House of Representatives have a say on it yet, but there is little doubt of final or complete confirmation. Congress may have a quorum in July, but the show for further action before next December, is slim.

POSTAGE STAMPS have finally arrived at the Ruby Office – after being due over six weeks.

SCHOOL. We are informed by parents who were present, that some very fine documentation came off in the District School a week ago yesterday; also, that a prize was carried off by Katie Blackinger. The exercises were generally interesting, and parents note marked advancement of their children.

ARMY SUPPLIES are wanted at Camp Lyon and C. F. Smith. Fine opportunities are offered for large or small contracts. Laboring men can do well by taking contracts for providing a portion of these supplies – and can rest assured of prompt payment upon fulfillment of their contracts.

A SHOOTING MATCH took place at the Shoenbar mill yesterday at three P.M. Stakes, \$25 cash and one basket of champagne. Distance, 100 yards. Shots, off-hand, with muzzle loading rifle, and decision by string measure. The result of the match was unreported at the hour of going to press.

BOISE COUNTY. Placer mining in Boise Basin has generally commenced, and promises well for '67. The many ditches and other facilities inaugurated since water failed last season, warrant the opinion that one thousand more miners would find profitable employment in the Basin.

A few accidents have occurred in mining from caves, &c. A German, called "Charley", lately had his ankle badly crushed, and John Fisher his right leg fractured above the ankle.

An organization to prevent fires in Idaho City is in practical training. A good move.

"STONEWALL JACKSON" came in from Jordan Valley last week, and has since had a lawsuit, plead his own case and made considerable amusement generally. At one juncture of the proceedings he claimed possession, which was nine points, and told his opponent to take the tenth point and – do as he pleased with it. One the wind up, however, Stonewall came to the conclusion that, owing to the lightness of the air or other causes, if Christ was to die once more for sinners it would not be on account of nay love for Silver City.


