Highway District elections open

Positions in the Gem and Homedale Highway District will be up for election and declarations of candidacy for the office of commissioner must be filed by June 24. The election will be held on August 2.

In the Gem Highway District, the district one commissioner's seat will be up for election, which is North of Highway 55. In Homedale, sub-district 2's seat will be open, which is currently being held by Fred Demshar. No one could be reached at Gem Highway District for comment.

Declarations must be filed no later than 5 p.m. on June 24 at the district office in Marsing located at 1016 Main Street and at the district office in Homedale at 102 East Colorado Avenue. Individuals who run as a write-in candidate must file a declaration of intent no later than 5 p.m. on July 8th.

Police target Johnstone Road for speeders and loud music

Homedale Police Chief Jeff Eidemiller told the city council during a meeting last week that a speed saturation had been done on Johnstone Road at the city limits and he found that the majority of the people traveling the roadway were following within the law. Because of the complaints about loud music in vehicles, Eidemiller has instructed his officers to have zero tolerance on loud music.

During an earlier meeting last month, a resident in the area told the council that speeding and loud music was still a problem on Johnstone Road and she wanted to see something done about it. Because of the residential concern, Eidemiller said he would implement a two-phase evaluation process to determine speed and noise conditions.

"For seven days the officers concealed their vehicles and their only purpose was to record the speeds of the drivers for a specific amount of time, and since the complaint alleged that the problems were at all times of the day and late evening, the officer went at different times in three shifts," Eidemiller said in a letter to the council. "The officers were instructed to maintain their positions unless the driver's actions were grossly in violation of the speed limit. The purpose was to allow for a static baseline."

Eidemiller told the council that a total of 362 vehicles were checked for speed and with the exception of a few, even with the officers concealed, the drivers were observant and mindful of the posted speed. He said the majority of the vehicles checked were clocked at traveling between 25 and 35 miles per hour. The average speed determined was

City of Marsing to attempt second water bond levy

Council members of the City of Marsing will try to get voters to pass a second bond levy this year after the first one failed in January. The city has been asking voters to pass a bond so it can install improvements to the city's water system. In February the council asked voters to pass a \$1.25 million bond, which failed by a 76-42 vote. Now city officials are asking voters to pass a \$1.7 million bond.

The election will be held on August 2 and poles will be open from 8 a.m. until 8 p.m. The bond is expected to be used for construction, installation of improvements and betterments to the city's domestic water system. It will include a new well, treatment facilities, booster station, water storage tank and stand by power and distribution improvements together with related improvements and costs.

Thursday, Marsing City Clerk Janice Bicandi said the council has not approved any increases in the water fees that will pertain to the upcoming bond. She said the council did approve an \$18 per home increase in January, but she said if the bond passes an additional increase in fees is not expected.

The city has an existing indebtedness in the amount of \$653,961. The interest rate

anticipated on the proposed bonds is 4.5 percent per annum and the range of anticipated rates is from 4 percent to 10 percent. The total amount to be repaid over the life of the bonds with principal and interest is estimated at \$3,131,400.

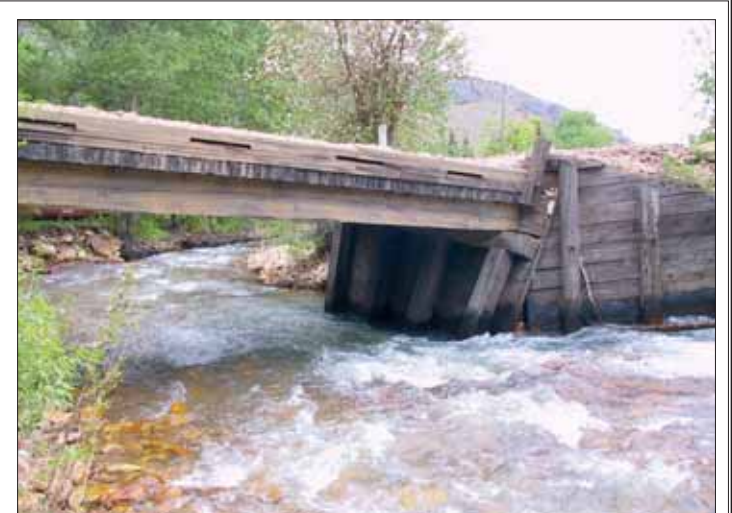
In February, Mayor Don Osterhoudt said that the city would have to "bandaid" deteriorating water lines. He said the whole project was estimated at \$2.5 million, but with grants the original bond could be kept lower. He said not that the first bond failed, an increase would

Tail docking rule omits some from fair

A newly enforced tail-docking rule will omit some 4-H sheep from this year’s fair and some sheep were of concern during last weekend’s first weigh-in by the Owyhee County Extension office.

A memo received from the extension office states that all market lambs are required to have a dock length of .7 inches minimum or longer. Extension Agent Scott Jensen measured each lamb’s tail length during the weigh in Saturday and found several that may not make length. He said during final weigh-in, he would be able to tell if the sheep will make it or not.

“There has been much debate over the acceptable minimum length of a lamb’s tail for a market livestock show,” the memo from the University said. “A recently published scientific study from the Journal of Animal Science concludes that short docked lambs are more prone to rectal prolapse. Local lamb buyers purchasing most of the District II resale fair lambs support having a longer tail on market lambs. Southwest Idaho sheep producers have asked for a consistent rule in order to facilitate docking practices for lambs going to different counties.”

Jensen said a copy of the study is available at the extension office.

have to be asked for.

“We go back to the drawing board,” Osterhoudt said in February. “Now we will have to look at mickey-mousing our stuff on the Canyon County side to get the best possible use of it as we can. I am disappointed because there was a failure. It was a failure for the council to have enough time to communicate the need and the great deal that was presented to the voters. Frankly, as we went through the project, new information was being obtained every day. The council did not have the opportunity to communicate those needs.”

Bicandi said two public meetings have been scheduled to give the public the opportunity to hear the facts about the bond. She said both meetings would be held at the community center with the first scheduled for July 14 at 7 p.m. and the second for July 19 also at 7 p.m.

The bond will need a majority vote to pass. It will mature over a period, which may be less than but not more than 30 years.

at 25.1178 miles per hour.

“Wespentatremendousamount of time down there to come up with about the same results we came up with two years ago,” Eidemiller told the council last week. “Al-

though there are vehicles that do exceed the posted speed, most of them obey the limit. The motoring public is all in all is pretty well behaved down there.”

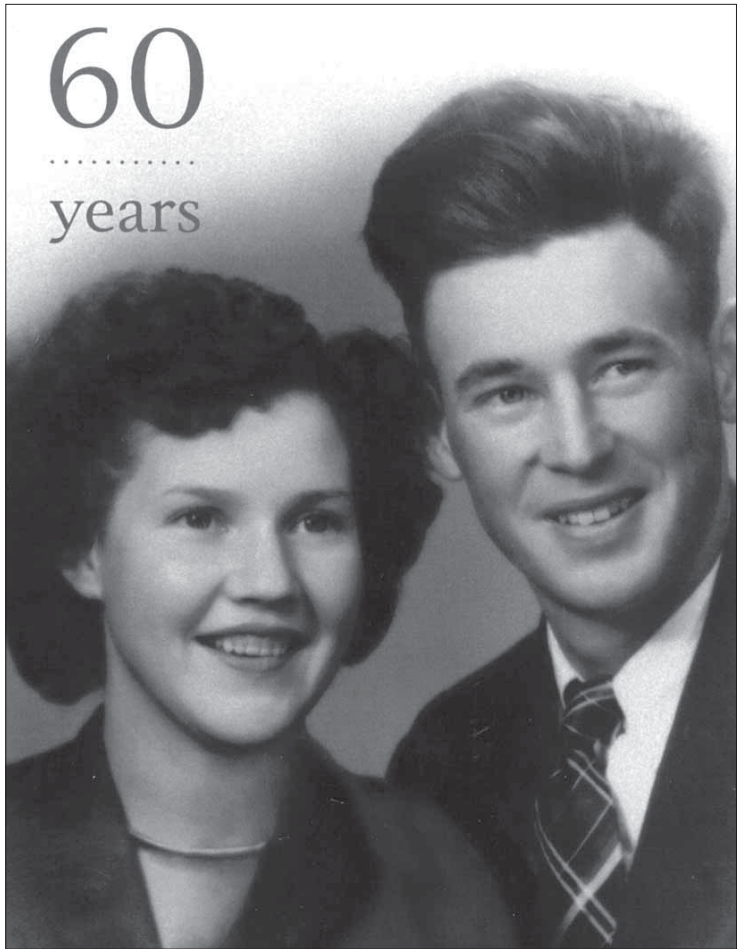
Of the vehicles checked, one was checked at 50 plus miles per hour, five at 40 miles per hour, 31 at 35 miles per hour and 72 at 30 miles per hour. Eidemiller said 109 motorists were traveling at 25 miles per hour, 106 at 20 miles per hour and 38 at 15 miles per hour.

“The biggest issue is going to be during the school year where we have pedestrian travel and whether the motorists like it or not, pedestrians still have right of way and until we have sidewalks down there, you are going to have kids walking down the road,” Eidemiller continued.

“The vast majority are law abiding citizens,” Councilman Steve Schultz commented. “You had one that was over 60 miles per hour and the ones over 40 and 45 miles per hour are going to be the ones who will impress people. Those are the incidents that stick in someone’s mind.”

“It needs to be watched, but I don’t think it is near the problem as some other areas as far as speed,” Eidemiller stated.

As of June 3, Eidemiller said his officers would no longer be issuing warnings for loud music. He said if the officer has probable cause, they would no be issuing tickets for the offence.

Lowell Edwin Rudge "Bud"

Lowell Edwin Rudge "Bud", 92, passed away on June 6, 2005 in Boise, ID. Lowell was born in Riverside Station, ID on April 24, 1913 to Lemuel and Arlie Belle (Bingman) Rudge. He was raised on his family's ranch in the Prairie and Mayfield, ID areas and as a young man moved to Boise. In 1930, he married Kate Berry where they had their 5 children. They later divorced. On March 26th 1955, he married Lilly Gigger and took in her 3 young children as his own. They were married for 45 years until her death in 2001.

Lowell worked for Boise Water Company and then for Chause Swan (that later became Boise Cascade) as a concrete foreman. He was responsible for pouring many of the missile sites located on MHAFB and the surrounding areas. While near Bruneau, he fell in love with the area and bought a

farm in Little Valley. He moved his family there in 1963. While farming and ranching his own place, he also worked as a foreman for Milford Vaught Ranch, which later became known as Rancho Idaho. Lowell moved to Grand View to live with his daughter Jale soon after his wife's death and then later to Boise with his dog companion "Mixie" to live with his son Jeff until his passing.

Lowell was a determined man and insisted on farming until he was 82 years old. He was also a member of the Owyhee Cattleman's Association and attended many Bruneau Rodeos. He was an avid sports fan that never missed a game on TV and an even bigger fan of chocolate. He loved kids and didn't mind at all when his house was full of grandchildren. He was best known for his hard work, his "jack of all trades" knowledge, and for being a wonderful grandpa.

Lowell is preceded in death by his wife Lilly, his sister Grace McClean, brother Robert Rudge, daughters Julie Dohman and Patricia McAdams and son Dee J. McClurg. He is survived by his children George Rudge (Janice) of Milwaukee, OR, Nick Rudge of Oregon, Gary Rudge of Washington, Jeff McClurg of Boise, ID, Jale Rubelt (Jesse) of Grand View, ID and sister-in-law Virginia Rudge of Lake Stevens, WA. Lowell is also survived by several nieces and nephews, and many grandchildren and great-grand children.

Asa L. "Ace" Black

Asa "Ace" Black, age 72 of Bruneau, passed away Thursday, June 9, 2005 at his home in Bruneau, surrounded by his family and the beautiful ranch that he loved.



Ace was born in Bruneau on April 17, 1933 to Albert Lafayette and Bonnie Bernice Goddard Black. He joined an

older brother, Joe and sister, Virginia. Shortly after, younger brothers Bob and Doug were added to complete the family. Asa was an outgoing child, always busy, always teasing others. He grew up in Bruneau, attending Bruneau schools and spending the summers at the family cow camps in the Owyhee Mountains and northern Nevada. He was blessed with a large, loving extended family of aunts, uncles, cousins, and grandparents on the ranch while he was growing up. Ace excelled in sports and enjoyed his school years, where he formed lifelong friendships and graduated from Bruneau High School in 1951.

The Black family members were involved in rodeo from an early age, as Ace's father often

furnished the livestock for rodeos, and the children would trail the animals to local events. It was at the Grand View rodeo where Ace was working as a pick-up man for the rough stock events that he met the sweetheart of his life, Marilyn Ann Nettleton. He literally "roped" her heart--and broke the window of her father's car in doing so. Ace and Marilyn were married on September 20, 1952 at St. Paul's Catholic Church in Nampa. They began their married life in the Bruneau Valley where Ace worked for his parents on their cattle ranch and the couple began to build their family.

From there, the couple moved to Castle Creek in Oreana with their small children, then on to the Joyce Ranch on Sinker Creek near Murphy where Ace was a foreman for Dave Miller for several years. In addition to working on the ranch, Ace continued to work the local rodeos as a pick-up man. Following their dream to have a ranch of their own, in 1962 the Blacks returned to Bruneau with their five young children, Terry, Tony, Patrick, Ann, and Martin. It was at that time that they moved into their two-story house which was built in 1898. Shortly after their move, their five-year-old son Patrick was killed in an auto accident near Bruneau.

The couple continued to build their cattle herd and to ranch in the Bruneau Valley and the Owyhee Mountains and added to their family sons Burke and Bret, and their daughter, Sandy. Even in the busy life of ranching, Ace always made time to take his children with him in his daily work and to support his family in their activities, which included sports, rodeo and 4-H. As the family began to grow up and move away, Ace and Marilyn cut back on their cattle operation, and for the first time in their marriage took time to travel as a couple. They also had more time to spend on community activities.

Ace was proud to be a Charter Member of the Owyhee County Sheriff's posse, formed under Sheriff Jim Tucker to aid law enforcement in the vast areas of Owyhee County. He was involved in countless search and rescue missions, as well as serving as President of the organization during the early years of the posse. As a member of the posse, Black was involved in transporting Claude Dallas back to Idaho to stand trial in the deaths of two Idaho Fish and Game officers.

Ace and Marilyn were active in the local, state, and National Cattlemen's Association at a time when the local ranchers could count on their support to remain on the traditional ranches of the West. He was chairman of the State Brand Committee that revised the brand laws, co-chairman of the State Public Lands Committee appointed to work closely with the State Land Board to change the grazing fees from a set charge to a fluctuating charge similar to the Federal fee. This difficult task took several years to complete. Black was a director on the National Public Lands Committee, served as a National and State Director for the Sagebrush Rebellion, and in later years, Ace was supportive of the cattlemen's group, R-CALF USA.

Locally, Black served as a director on the Bruneau Buckaroo Ditch, a past board member of School District #365, an activity school bus driver to his children's ball games, and a strong supporter of the 4-H, FFA and High

School Rodeo programs. Over the years, Ace and Marilyn also took in several children who were in a family crisis or in need of a temporary home.

The Blacks have been active members of the Catholic community all through their married life, and sponsored many Marriage Encounters over the years at their cabin in the Owyhee Mountains. Asa's faith was strong, and he lived his beliefs openly. Ace belonged to St. Bridgett's Catholic Church in Bruneau, but often attended Mass at Our Lady of Good Counsel in Mountain Home and St. Bernard's in Jordan Valley in his later years.

When the Blacks counted their blessings, they especially treasured their grandchildren and spent many happy vacations, ball games, rodeos, wrestling matches, piano recitals, school plays, and holiday dinners with them. He also held the proud distinction of being the only Grampa at the "Donuts for Daddy" day for first graders. During his battle with cancer, Ace was proud to receive letters and calls from his grandson, Will Black, who is currently serving in Afghanistan as an Army Ranger and his grandson, Patrick Hipwell who is a Seaman Recruit at basic training in Great Lakes, IL. Ace was a wise Grampa, and his grandchildren sought his wisdom, advice, and stories.

Ace and Marilyn enjoyed a long and happy marriage, but suffered many hardships that offered them an opportunity in a "throw-away world" to teach their children and grandchildren the reality that life is hard, but God is good. In 1991, Marilyn was diagnosed with a brain tumor that drastically changed her life and overnight threw Asa into the role of primary caregiver, along with being a full time rancher and truck driver in the partnership of "Ace Black Ranches" he had formed with his two oldest sons, Terry and Tony.

In September of 2002, Asa and Marilyn celebrated their Golden wedding anniversary in Bruneau with their children, grand, and great-grandchildren, family and friends. His tender care of Marilyn through the years was a beautiful testimony to all.

November of 2004 brought more changes for Ace as he was diagnosed with pancreatic cancer. The dismal odds of survival were challenged by Ace as he informed his doctor that "I will make my own odds". With the support of his family and friends, he bravely endured rounds of radiation and chemo in Boise and a risky surgery in Salt Lake City. His strong will to live and sense of humor were a constant source of hope and inspiration to all.

Through the efforts of their children, Ace and Marilyn were able to be together after the surgery for several months until the effects of the treatments began to take their toll on Asa's strength, but not his will to live. After several hospitalizations, Ace asked to go home to Bruneau. With the help and support of Hospice, and the love of family and friends, Asa spent his last two weeks on earth looking out his window at the ranch of his dreams, holding his sweetheart's hand, visiting with his children, grand and great-grandchildren, and reminiscing with family and friends.

Ace lived hard, loved much, never gave up, and was welcomed into the gates of Heaven as a true servant of God. By loving and caring for their mother, he taught

each son to love his wife unconditionally, and his daughters to recognize genuine love and respect to expect from a man. Now, through the struggles of death, he has left an indelible mark on his children to live life with strong faith, and to continue to teach this tradition of love to their own children and grandchildren.

Asa was preceded in death by his grandparents, Joseph R. and Virginia "Jenny" Tate Black; Ed and Mary Brady Goddard; his parents, Albert and Bonnie Black; a brother, Douglas; two sons, Patrick Paul and A. Lonnie; a grandson, Colt J. Black; and several cousins, aunts and uncles. He is survived by his wife of 52 years, Marilyn; children, Terry and Letha Jayo Black, Tony and Charlene Hutton Black, all of Bruneau, Ann and David Rutan of South Mountain, Idaho, Martin Black of Wilder, Elaine Hunt Black of Homedale, Burke and Gerri Ihli Black of Nampa, Bret Black and Kimber Bogue of San Luis Obispo, CA, and Sandy Black of Wilder; grandchildren, Marty Black, Les and Jacque Montrose Black, Trish Black Clements and Matt Hopkins, Loni Black, Eklyn Black, Telby Black, Trina Hipwell, Dennis Rutan, Dana and Billie Carter Rutan, Douglas Rutan, Michelle Gorley, Patrick Hipwell, Breann Hipwell, Carlen Hipwell, Will Black, Wade and Amaia Larzelier Black, Sarah Black; great-grandchildren, Kole and Kortni Clements and Kati Hopkins, Lewis, Riatta and Dally Rutan, and Gus Black.



Three athletes from Homedale have qualified to attend the first ever National Junior High Rodeo Finals in conjunction with the National High School Rodeo Association. Mikal Mackenzie, Brandon McKenzie and Bryan Reay have earned a position on the Idaho Wrangler Junior High Rodeo team.

Mikal qualified to compete in the goat tying event and Bandon and Bryan will compete in the team-roping event. Bryan was also the state champion breakaway roper and will compete in that event as well.

The Wrangler Junior High Finals will be featuring more than 700 contestants from 29 states and one Canadian Province. These competitors will be competing in the world's largest junior high rodeo. In addition to competing for more than \$75,000 in prizes, the three local contestants will also be vying for more than \$50,000 in college scholarships and the chance to be named the Wrangler Junior High Finals Rodeo National Champion.

To earn the title, they must finish in the top 15 after two go-arounds of intense competition before advancing on to the final championship performance. This year, the championship performance will be televised nationally on the RFD TV, as part of the "20Z Rodeo High" telecast series.

Competition is open to boys and girls in the sixth, seventh and eighth grades. Each state or province has held at least one qualifying rodeo and the top contestants in each event will be eligible for the Wrangler National Junior High Finals Rodeo.

Champions will be determined based on their three-head average scores or times.

Events include for the boys, junior bull or steer riding, calf roping or breakaway calf roping, goat tying – with a piggin string, chute dogging, team roping and ribbon roping.

Girls events include, barrel racing, pole bending, goat tying, break-away calf roping, team roping, and ribbon roping.

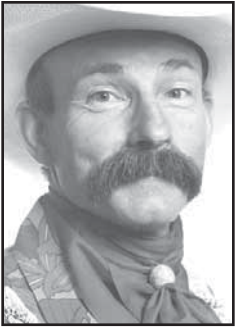

A two-thirds majority was required for the vote to carry. Electors of the school district cast 194 votes favoring the bond issue and there were 100 votes against it.

138 years ago

June 15, 1867

PROSPECTS BRIGHTENING. The belief is becoming settled that Owyhee has seen its darkest business days, and that the stagnation which affects nearly all quartz mining communities, at some period in their history, has partially passed and from this time forward there will be a steady and healthy improvement. The richer the early prospects the more certain a painful season of business depression ensues, resulting mainly from extravagant expectations and a corresponding extravagance and recklessness in the outlay of money and labor. Owyhee exhibits rich ore in more veins than any camp of which we have any knowledge, and this fact has led to early failures of companies, and to a loss of confidence abroad in our best mines. The Oro Fino ledge had acquired an envied reputation in New York and even had admirers in Europe. Its products gave the Camp its first prominence in Idaho and also abroad. Its proprietors, whose reputation as successful miners was no less circumscribed that the richness of the mine, failed largely in debt, and the effect, at least aboard, was similar to a stroke of paralysis to a healthy man. The property has passed into the possession of men who did not want it and whose preference would have been their money and other pursuits, and under their management will undoubtedly regain its former reputation and thus create a most healthy reaction of sentiment in favor of Owyhee, aside from a large amount of continuously healthy business. From all we can learn from Superintendents of mines – including just inferences from their words and actions – we believe that they are more than ever determined to make every dollar expended – whether put up capital or obtained from the mines – tell in favor of the stock holders. Undertaking requiring large sums of money will not be engaged in without reasonable assurance of success. Economy of expenditures will pre-eminently mark every department of prospecting, mining and milling. Past costly experience we think will insure the future against such heavy losses to companies, laborers and credit of the camp in general, and best of all give fine dividends to stockholders. Should present appearances prove real, this mining region will never more be seriously affected by failures that are always incident to all kinds of business.

LEMHI. Mr. Jack Forst – well known in Owyhee – has just returned from the Lemhi Mines via Wood River and Camas Prairie. A few paying claims are known to exist, and a large extent of country is yet unprospected. The mountains will be explored this year. Miners are going in, as well as coming from, every direction. The Lemhi diggings are filled with disappointed men of all occupations – and merchants in particular. Too much of all kinds of merchandise was there and more going that would not sell for near freight upon arrival.

RESOLUTION NO. 05-11
(Authorization of Owyhee County Recreation Task Force and Statement of Mission for the Task Force)

Repeatedly the issue regarding conflicts of use involving motorized and non-motorized recreation, livestock grazing, private property and environmental concerns has been presented to the managing agency for the federal lands in Owyhee County and to

the Owyhee County Board of Commissioners;

Recently, the specific issue regarding conflicts of use at and near the Hemingway Butte OHV Trailhead has been presented to the Board, the Board has been asked to review BLM proposals for fencing projects in the Hemingway Butte area and has referred the issue to the Natural Resources Committee for advisory recommendation;

As the population of the metropolitan Boise area and the Treasure Valley increases, it is foreseeable that the conflicts will at least remain constant and will most likely increase;

The Owyhee Initiative contains a specific recreation and transportation plan of action which will go into effect when the Owyhee Initiative Bill is passed and enacted into law, but until that happens there is no effective process for reviewing specific conflicts of use from a multiple use viewpoint;

The Owyhee County Land Use Management Plan for the Federal Lands provides for protection of private property and private property rights, and for recreation uses for a wide variety of recreation purposes, and often the interests in protecting private property rights and in pursuing access for recreation uses are in conflict;

Therefore, for the above reasons, IT IS HEREBY RESOLVED by the Owyhee County Board of Commissioners that there be created an Owyhee County Recreation Task Force to review specific and general conflicts of use, assist the land management agency in solving the problems related to federal lands, attempt to mediate workable solutions to conflicts of use, and make reports and recommendations to the Board of Commissioners;

IT IS FURTHER RESOLVED that the purpose of this Resolution is to create a process through

which the Board of Commissioners may better assist the BLM in preventing and resolving conflicts between private landowners, recreation users and federal management requirements, and through which the position of conflicting users may be aired, and through which possible mediation of conflict issues may be accomplished;

IT IS FURTHER RESOLVED that the Mission of the Task Force shall be:

(1) to provide a forum for presentation of positions on conflict issues by users involved;

(2) to attempt to work out agreements between such users which will benefit land users, minimize conflicts among the various user groups, and cause the least possible impact on each group of users and on natural resources of the land consistent with applicable laws, the BLM Resource Management Plans, the Owyhee County Land Use Plan for the Federal Lands, and the Owyhee Initiative Agreement, and to report such agreements and findings as to the justification of and impact of such agreements to the Board of Commissioners, the BLM and the users involved;

(3) Where such agreements are not possible, to make recommendations to the Board of Commissioners and to the BLM as to action(s) which need to be taken to resolve the conflict or to mitigate or minimize the adverse impact being caused by the conflict with findings supporting the recommendation(s);

(4) To operate within the parameters of law and the Owyhee County Land Use Plan for the Federal Lands as to protection of private property and private property rights and access for recreation uses;

(5) To advise the Board of County Commissioners, the BLM and the Owyhee County Natural

Resources Committee as to short term and long term resolution of conflicts of land uses; and

(6) To seek consistency between land uses and the Owyhee Initiative Agreement as to protection of the natural resources within the County, protection of private property rights and interests, preservation of the viability of livestock grazing, and open access for recreation uses.

IT IS FURTHER RESOLVED that the Task Force shall place an urgent priority on consideration of the land use conflicts which currently exist at and in the vicinity of the Hemingway Butte OHV Trailhead;

SUMMARY OF ORDINANCE NO. A-146

AN ORDINANCE OF THE CITY OF MARSING, OWYHEE COUNTY, IDAHO, PROVIDING FOR THE CONSTRUCTION AND INSTALLATION OF IMPROVEMENTS TO THE DOMESTIC WATER SYSTEM OF THE CITY OF MARSING; CALLING A SPECIAL ELECTION FOR THE SUBMISSION TO THE QUALIFIED ELECTORS OF THE CITY THE QUESTION OF INCURRING AN INDEBTEDNESS AND ISSUING WATER REVENUE BONDS IN A PRINCIPAL AMOUNT NOT TO EXCEED \$1,700,000 TO PAY A PORTION OF THE COST THEREOF; ESTABLISHING THE DATE, TIME, AND PLACE OF ELECTION; PROVIDING FOR PUBLIC NOTICE OF ELECTION; PROVIDING FOR REGISTRATION OF VOTERS; PROVIDING FOR RELATED MATTERS; AND PROVIDING AN EFFECTIVE DATE

A summary of the principal provisions of Ordinance No. A-146 of the City of Marsing, Owyhee County, Idaho, adopted on June 8, 2005, is as follows:

Section 1: Defines the domestic water system capital improvement project, estimates the total cost, and provides for issuance of water revenue bonds, subject to approval of the qualified electors of the City, in the amount of not to exceed \$1,700,000 to pay a portion of the cost of the Project.

Section 2: Provides for a special water revenue bond election to be held within the City on Tuesday, August 2, 2005, for the purpose of enabling the qualified electors of the City to vote upon the proposition of issuing revenue bonds.

Section 3: Provides that the polls of the special bond election shall open at 8:00 o'clock A.M. on August 2, 2005, and shall remain open until 8:00 o'clock P.M., and provides for the polling place for the special bond election.

Section 4: Provides that the ballot proposition shall be substantially as follows:

SHALL THE CITY OF MARSING BE AUTHORIZED TO INCUR AN INDEBTEDNESS AND TO ISSUE AND SELL ITS WATER REVENUE BONDS IN A PRINCIPAL AMOUNT WHICH MAY BE LESS THAN BUT WHICH SHALL NOT EXCEED \$1,700,000 TO PAY THE COSTS OF IMPROVEMENTS AND BETTERMENTS TO THE CITY'S DOMESTIC WATER SYSTEM, THE BONDS TO MATURE OVER A PERIOD WHICH MAY BE LESS THAN BUT WHICH SHALL NOT EXCEED THIRTY (30) YEARS AND TO BE PAYABLE SOLELY FROM THE REVENUES OF THE DOMESTIC WATER SYSTEM, ALL AS MORE FULLY PROVIDED IN ORDINANCE NO. A-146, ADOPTED ON JUNE 8, 2005?

Section 5: Provides for payment of election expenses.

Section 6: Defines qualified electors as persons eighteen (18) years of age or older who are United States citizens who have resided in the City for at least thirty days prior to the election and who are registered as provided by law.

Section 7: Provides for registration of voters.

Section 8: Provides for preparation of official ballots and sample ballots.

Section 9: Provides for publication of Notice of Special Bond

Election.

Section 10: Provides for canvass of votes.

Section 11: Provides for Debt Disclosure Statement pursuant to Idaho Code § 34-440.

Section 12: Provides for the issuance of water revenue bonds maturing over a period which may be less than but which shall not exceed thirty (30) years, and provides for other matters relating to the water revenue bonds.

Section 13: Authorizes the officers of the City to take appropriate actions to effectuate the provisions of this Ordinance.

Section 14: Ratifies previous actions.

Section 15: Provides for publication of a summary of the Ordinance.

ORDINANCE NO: 05-02

AN AMENDMENT TO SECTION III of OWYHEE COUNTY ORDINANCE 87-01 INCREASING THE MEMBERSHIP OF THE OWYHEE COUNTY HISTORIC PRESERVATION COMMISSION TO SEVEN (7) MEMBERS.

Pursuant to the authority granted under Idaho Code 67-4603, which provides that "The governing body of any county or city is hereby authorized to establish a historic preservation commission...and that the commission shall consist of not less than five (5) and not more than ten (10) members..." Section III (Historic Preservation Commission) of Owyhee County Ordinance 87-01, is hereby amended by striking existing subsections 1 and 2 and replacing them to read as follows:

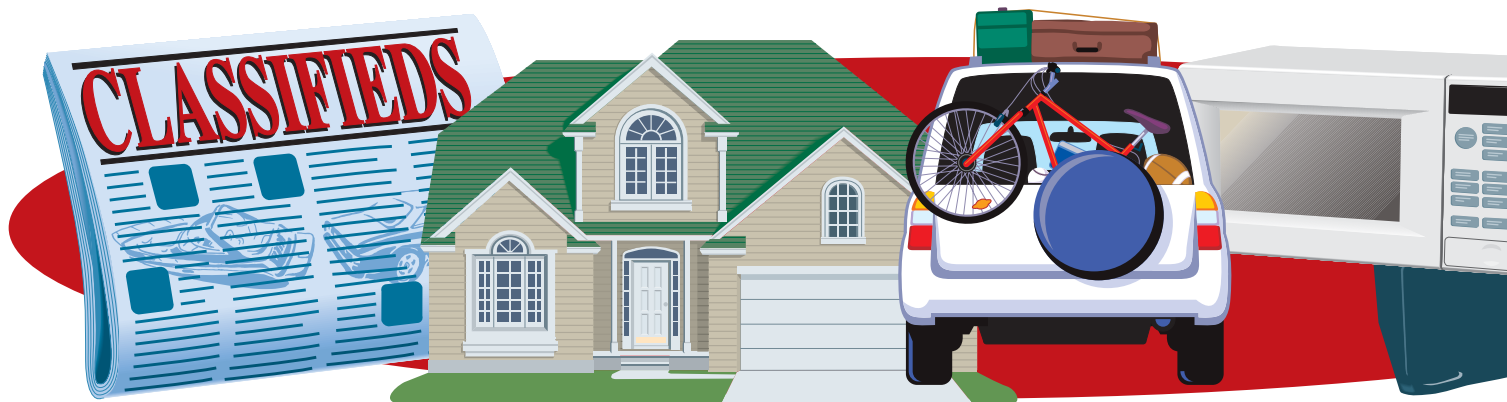

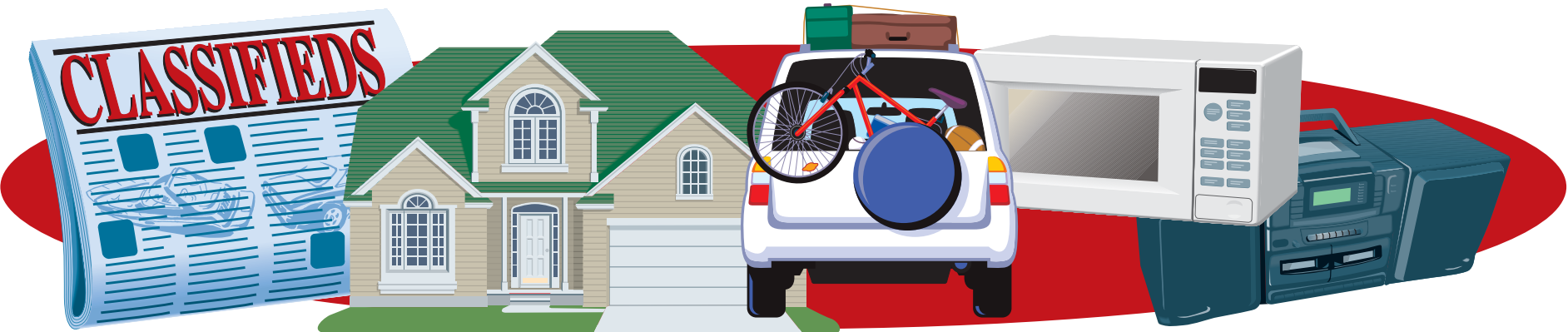
