



Wrestling calves this spring at a branding, there were several young men there to help flank calves. They were all good boys and came to lend a hand. The first hour when they were fresh, it was inspiring to watch those stout young men overpower the calves.

As the morning wore on, they began wearin' down. Moving slower, stepping back, leaning on the fence, breathing heavily and lookin' for a break. That's when the tough ones took the lead. Steady, balanced, using leverage, no wasted motion, sure-handed. That's how we finished the day.

We see examples around us all the time in sports, in couples we know, and in folks we work with.

Our economy

Trade with Asia could expand Idaho ag's reach

Idahoans have a rich history of confronting change head on. We're the ones in control, pulling the levers and dictating our future.

This has always been the story of agriculture in Idaho. At the beginning of the 20^{th} century, the pioneers who settled

some of the rugged sagebrush country of this state knew in their hearts they could turn the desert into the most valuable farmland in the world. They did it with ingenuity, perseverance and homegrown determination.

We're still the creative, hardworking people we always were, but we've adapted to a very different marketplace than what existed 100 years ago.

Our farms and ranches are now global Pat Takasugi businesses with customers throughout the world.

Today's Idaho farmer understands the need to be a player on the world stage. He's savvy about the information-driven world in which we live. He understands that to be competitive, he must engage in a way his forefathers did not. That's why we at the Idaho State Department of Agriculture have so much time and energy invested in international trade. It's why we work closely with the governor and the agriculture community to build trade partnerships overseas.

Agriculture is a venture that is in transition throughout the world. We don't know what farming and ranching will look like in five, 10 or 25 years. Developments in biotechnology may change how food is grown. Scientists are continually searching for ways to improve the quantity, quality and health benefits of our crops. Researchers are turning to Idaho farmers to not only feed the nation but also provide clean, sustainable fuel.

Just 10 years ago, no one could have imagined Idaho would have a \$4.4 billion food industry, a growing economic sector for the state.

But we know this: The world will always demand good, quality agricultural products, and that demand will only grow larger during the next five decades. We can't consume everything we produce — and 95 percent of the world's population is outside the U.S.

During our recent trade mission to Asia, we found that people — from Tokyo to Shanghai to Taipei — want the commodities that we produce in Idaho. We have the best beef, the best wheat, the best potatoes anywhere. In October, we'll hit the road again to Mexico with a strong story to tell about Idaho agriculture.

But it's not enough that we sit back and wait for destiny to intervene and for these markets to come to us. We must go to them. We must invest in marketing and trade and get the word out about what we have to offer, build new relationships and maintain old friendships. Seven years ago, Gov. Dirk Kempthorne had the foresight to recognize the need to pursue relationships with trade partners overseas. That investment is paying off dividends today.

At a recent press conference in the governor's office, state Sen. Dean Cameron made an important observation: There are three main ways to balance a state budget. 1) We can raise revenue. 2) We can cut services. 3) We can look for ways to expand economic opportunity in Idaho. These trade missions to Asia and Mexico represent a positive, smart way to boost the state's economy.

New jobs don't just happen. We have to go out and work for them. Agriculture is one place we can make that happen. Our products can compete in these emerging markets.

Idaho already has a thriving agricultural sector. With the same gusto of the pioneers who settled the western frontier that Idaho once was, we'll make Idaho agriculture even stronger.

Jaycees install one lighted pole

Homedale Jaycess erected one pole and installed lights on it Sunday at the athletic field adjacent to the Homedale fairgrounds, according to President Garland Carson. The pole will furnish lighting for the parking area during the Owyhee county fair.

The lighting fixtures on this pole were donated by George Johnstone, Homedale, as a memorial to his brother Jim, deceased.

John Batt's pole wrecker was used to put up the 90 foot pole, which stands 80 feet in the air and is buried 10 feet in the ground. The pole was wired Tuesday.

Fairgrounds ready for 3-day county fair starting

The tempo of activity and excitement at the Owyhee county fair grounds in northwest Homedale reached its peak this morning (Thursday) with the opening of the three-day county fair.

The banging of hammers on exhibit and concession booths has given way to the excited chatter and laughter of fair crowds and the beat of carnival music. The exhibit halls have blossomed with colorful displays and the stock barns are filled. Rows of colored pennants between the buildings lend a festive air to the proceedings.

"This promises to be the largest and best fair Owyhee county has ever had," declared Harold McJunkin, secretary-manager of the event, who with Ruth Burton, clerk, has been registering livestock and exhibits.

"Entries have come from Weiser to Boise and all the area between," Mr. McJunkin said.

Buildings added.

A new commercial building and lavatories have been added this year. The commercial hall is 30x80 and will accommodate 20 display booths. The lavatory building is of cinder block construction, modern and spacious, and is centrally located.

Besides the new building, the fairgrounds also has two exhibit halls, each 24x32 feet. They contain the community, agricultural, open, educational, 4-H, needle work, flowers and miscellaneous booths. Two 30x120 foot barns accommodate 90 head of stock each.

Besides the six buildings and several lean-tos, the fairgrounds also has a stock scales and facilities for watering livestock.

The queen will be crowned during the parade Saturday by Major General John E. Walsh of the Idaho National Guard. She will lead the parade, followed by her court, all riding in convertibles.

August 17, 1867

With this issue our connection with the Owyhee Avalanche wholly ceases. The change of proprietors is purely a business one — other parties wishing to buy at our own price.

We have spent two full years in the business of publishing a newspaper in Owyhee, and the very nature of the work compelled a careful acquaintance with every mine, and almost every tunnel and shaft in this mining district, and our belief, formed thereby, that is possessed many veins of gold and silver quartz of extraordinary richness if firm and weekly strengthened.

Our chief aim at the outset was to inform the outside world of the mineral wealth of Owyhee, and the files of the leading mining and news journals in California, Oregon and New York will prove that we have, in a reasonable degree, succeeded. Vast improvements in our lines of communication have received valuable aid from us. We have, each week, presented our readers with a careful collection of local items, and a summary of news from the other Idaho journals. In looking back over the management and matter of the Avalanche, we fin but little that we would care to change.

Our successors are men who combine the essential merits of practicalness, industry and intelligence. The public can rest assured that they will represent the interests of this section of Idaho, and everything that pays tribute to it, in a manner advantageous to the common welfare and with credit to themselves. A paper faithfully devoted to local affairs is of incalculable value to the community in which it is published, and the people can expend a portion of their means no more judiciously than by liberally sustaining their local press.

In conclusion, we will say that our patrons have never been annoyed by editorial complains of any kind, nor by duns for cash due or importunities to lend up additional aid; nor will we at the close make an exception to our former course. We have an advertisement in this paper which means what it says and to which we direct attention.

With these remarks and a sincere desire that Owyhee will enrich her citizens and justly acquire the position in the mining work that Virginia and Gold Hill, in Nevada, now do, we respectfully bid our readers an editorial adieu.






