Chadez wins 2A WIC high jump championship

Life just keeps getting better and better for Marsing High School athlete Breeana Chadez. Nine days after signing a national letter of intent with the University of Idaho, the senior won the conference championship in the high jump Wednesday in Nampa.

Marsing's Chadez hopes to refine her natural talent with Vandals

If "The Natural" were ever re-made with track and field replacing baseball as the sport, Breanna Chadez would be perfect for the role.

The Marsing High School senior has excelled as a track and field athlete since an early age. And she has parlayed that ability into a ticket to attend the University of Idaho.

"She's a tremendous athlete with a lot of gifted talent," Huskies track and field coach Don Heller said, "and I hope she successful up there (in Moscow).

"She'll really have to step up her game to go to Division I." The 18-year-old Chadez has

stepped up her game throughout her track career, which began in the fifth grade. She holds three Marsing track records, all set in her sophomore season, and she won the high jump state championship as a freshman in 2003.

At Wednesday's 2A Western

Idaho Conference championship meet in Nampa, she tied for first in the high jump with Kaycee Brunel from girls team champion Nampa Christian. Both girls cleared 5 feet, 4 inches.

But Chadez knows lots of hard work lies ahead with the Vandals.

"I know they're probably try to really make me lift weights," Chadez said. "I'm not too good at that."

The senior is looking forward to

getting more help in refining the raw ability that has put her in the upper echelon of the state's prep high jumpers.

"Once they show me the right way to jump, my natural ability will take over," she said.

That's sort of what got Chadez where she is today.

As a fifth-grader, she entered a Junior Olympics meet in Eugene, Ore., to compete in the 400 meters

Huskies' Covey, Heller collect 2A WIC titles


There were few surprises at the 2A Western Idaho Conference track and field championships, but Marsing High School athletes managed to wedge themselves onto the winner's podium among the bevy of Nampa Christian placers.

"I thought it was an OK day," Marsing coach Don Heller said. "We did have a few highlights with some champions, but overall it was all right."

University of Idaho-bound Breeana Chadez edged out the Trojans' Kaycee Brunel to win the girls high jump at a height of 5 feet, 4 inches. Chris Covey made it a Huskies sweep in the event by winning the boys high jump at

5-10. He also *Holly Heller* finished sec-

ond by three inches in the triple jump with an effort of 39-3¹/₄. Sophomore Holly Heller un-

Marsing's boys and girls had nearly identical fates in the team competition. Both finished fifth, with the boys scoring 66 points and the girls racking up 61. As expected, Nampa Christian ran away with the conference crowns, scoring 274 points in the girls division and 175 in the boys.

Senior MJ Usabel scored 16 points in two events for the Huskies as she placed second in the girls 300-meter hurdles (52.6 seconds) and pole vault (9-0).

Marsing's girls also finished third in two of the three relays

Both the relay records were set when she was a freshman, the same spring she captured the state high jump championship.

Injury-riddled Trojans tackle district play

There's no mystery about where Homedale High School will be seeded for this weekend's start to the 3A District III baseball tournament.

The only thing that concerns Trojans coach Tim Fulwood is whether he'll have enough healthy bodies to compete at Middleton High School.

"My biggest concern right now is to get our kids healthy," Fulwood said last week. "We started (the season) 8-3, and then the injury bug started to spread."

Before Friday's 3A Snake River Valley conference game on the road against league-leading Fruitland, the Trojans were 9-7 overall and 2-6 in league, holding down either the fourth or fifth seed in the tournament.

Unless Homedale slips to sixth in the league behind McCall-Donnelly, the Trojans' first-round opponent should be Payette, which beat the injury-plagued Trojans 12-11 on April 25 on a wild pitch in the bottom of the seventh inning.

And that wildness has a direct link to the injuries.

Fulwood has been riding a patchwork pitching staff through the final stages of the season.

Claudio Garcia has been held out of the rotation because of an elbow ligament problem.

No. 2 pitcher Ross DeWitt has been limited in his duties because of a sore arm.

Ryan Johnson pulled his hamstring in the first game against Weiser on April 21, and he hasn't been able to push off the pitching rubber effectively.

Guillermo Machuca, a lefthander splitting time between the junior varsity and varsity, had been an effective tool for Fulwood. He suffered an ankle injury unrelated to baseball two weekends ago.

Adding to that mess, the team's leading home run hitter and starting catcher, Josh Jolley,

tweaked his knee while trying to make a tag during the Payette game last week.

"We have 10 players, and five of them are injured," Fulwood said.

The situation was so dire last week that the Trojans didn't have nine players to field a team against Melba on April 24 until 1 p.m.

Joey Cline stepped in and scored a run as Homedale beat the Mustangs 11-6 in a nonconference road game.

Brandt Graber went 3-for-5 in that game with two doubles and two runs scored, while DeWitt ripped a two-run homer in the fourth inning.

"I thought we hit the ball better than we had been hitting," Fulwood said of the offense against Melba. "We hit the ball a little better and put some pressure on the defense."

Trevor Krzesnik dodged 10 hits in 5 1/3 innings to get the victory against Melba.

"Trevor Krzesnik did a nice

job on the mound for us, and I think the defense had a nice, solid outing," Fulwood said.

The story was much different in the league loss to Payette a day later.

Krzesnik uncorked the wild pitch that opened the door for the Pirates' winning run in the bottom of the seventh inning. The run snapped an 11-11 tie.

Homedale's thin pitching staff was the primary reason Payette was in a position to win.

"We led 8-0 in the top of the second then we got into some control problems on the mound," Fulwood said. "We had 11 walks in the first couple innings.

"When you give a team that many runners and opportunities, they're bound to take advantage of it."

Johnson started the game and walked 11 in three innings. The Pirates, who had trailed 8-0 after a half-inning, scored six runs in the third to take an 11-8 lead. "Ryan couldn't push off, and he got the ball high," Fulwood said.

David Liddell, who wasn't even in the pitching stable at the beginning of the season, relieved Johnson and allowed one run over the next three innings.

Liddell and Graber singled and scored runs in the fifth inning as Homedale put across three to tie the game 11-11.

Company full of Homedale grads helps alma mater

School's AD hopes to expand athletic program with JV soccer teams, hiring of another football coach

A company operated by a group of Homedale High School graduates is helping their alma mater's athletic program in its quest to thrive.

Earlier this month, Maria Stone of All-Around Sports in Caldwell presented Trojans athletic director Dave Hart with a check for an undisclosed amount after a year-long sports schedule fund-raising effort.

All-Around Sports produced a poster with the schedule for each Homedale sports team for each season — fall, winter and spring. The company sold advertising on the poster, and a percentage of the proceeds went back to the Trojans' athletic budget. And the best part of the deal for Homedale is that All-Around Sports does all the work on selling ads and designing and producing the poster. because they don't have the gate in the spring sports."

Although the current deal between the high school and All-Around Sports was struck with previous Homedale athletic director Randy Potter, Stone foresees a continuation of the relationship with Hart's administration.

Stone also said the percentage that goes into the Homedale coffers will be increased because of the success the Trojans' poster has seen.

All-Around Sports also produces schedule-posters for Albertson College of Idaho as well as high schools in Marsing, Wilder, Notus and Caldwell, Stone said. trustees there has been no increase in pay since 1995.

Hart said adding another assistant coach to the varsity football staff will help the Trojans be more competitive in the 3A Snake River Valley conference. He said the Trojans' five-man staff is the smallest in the league, while Middleton carried nine coaches in its program.

"I also asked for one more middle school coach," Hart said, adding the primary reason is safety because the Homedale Middle School football teams play at separate sites and it a coach had to deal with an injury, no one would be left to manage the team during the game.

The first-year athletic director also said Homedale is in preliminary discussions with the Wilder High School athletic department about a possible co op program for soccer. Hart said this will allow the Trojans to create junior varsity teams and would ensure more playing time for athletes. Combining with Wilder's program would help lessen the cost of expanding to four teams. "It would ensure you'd have 30 (players) at the end of the year, so if a kid gets hurt or is ineligible, you don't have to fold the program," Hart said. Hart told the board in a memo that there would be no increase in transportation costs, but there would be the addition of two stipends for new JV soccer coaches - part of which Wilder would pick up — and a firstyear cost of about \$900 for



"It'll go into the athletic budget," Hart said after receiving the check from Stone, who is a Homedale grad. "We're just trying to survive at this time of year."

Unlike fall sports such as football and volleyball and winter sports including basketball, spring sports don't bring in revenue from ticket sales.

"We sometimes give checks at the end of each season," Stone said.

"But a lot of ADs would rather us bring it at the end of the year The fund-raising program is just part of the job on Hart's plate right now. He's looking for a new coaches for the boys basketball program after the resignations of varsity coach Brad Hill and freshman coach Thomas Thomas.

At a recent Homedale school board meeting, Hart also suggested expansion to the football coaching staff and the boys and girls soccer program as well as increasing the pay for game-day workers such as tickettakers at football and basketball games.

"It's important to have good people," Hart said, who told

IDAHO MINT. It will be seen that Congressional action leading to secure a mint at Boise City is likely to be crowned with success. It is proposed to move the Charlotte (N.C.) mint to Boise. The resolution to effect the removal was introduced by Higby of California. This is the most sensible move made on the subject and the one that likely secure to Idaho a mint. A mint in Charlotte is next to useless, and this facet is well known to Congress, as is the one that Idaho is now second to California, only, in the production of the previous metals. A mint would be a death-blow to dust swindlers, but the masses would hail their rain with unutterably satisfaction. The people of Idaho, so far as they can collectively or individually, should use their influence with members of Congress to secure this valuable adjunct to our Territory. With the varied population of the Territory, some influence can be brought to bear upon M. C.'s from nearly every State. Let every citizen do what he can to secure this feasible proposition of Higby's. If individuals will each consider themselves committee of one to act in this matter, much good may be effected. It may be just within our reach by proper effort, and even should the effort be unnecessary, it would only cost a little time to make it anyhow. "God help them who help themselves," is a pretty true maxim.

IMPORTANT TO MINERS. The following decision relative to stamping certificates of location of mining claims, we fin in the Montana Post. Section 159 of the Act, approved June 30, 1864, points out the method and authorizes the stamping of instruments which were not legally stamped. Parties who value their claims would act safely to give this matter attention.

PROTESTED DRAFTS. In a conversation with business men yesterday, we were informed that one of the most serious drawbacks existing in the way of trade with mining districts of Idaho, was the wholesale issuing of drafts by irresponsible mining companies of South Boise and Owyhee. Customers almost daily appear at the counters of the merchants of this city, from Boise, Ruby, Silver, and Idaho cities and elsewhere with drafts that are really not worth twenty-five cents on the dollar, in offer for merchandise.

SCHOOLS. There is a private school being taught in Silver by Mrs. Watson. The room is not large enough to accommodate many pupils. Amid the hurry and excitement of money making in new places - the education of the rising generation is too much neglected. Parents cannot leave their children so rich and valuable legacies as a good education and habit of industry; nor can communities bequeath to the next generation anything more valuable than educated men and women. Many years of observation and experience have forged the conclusions upon the most thoughtful of mankind. Thorough, practical teachers are of primary consideration; suitable rooms, the best text books, &c., are secondary. It is to be hoped than in the organization of public schools in Owyhee, that these objects will be duly considered. It can go abroad that first class school are among the institution of Owyhee, it will do more to induce thither families and permanent suitors than any one representation we can make. As it required but little - if any - more money to have good than poor schools, it would be, even in the light of dollars and cents, impolite to have them otherwise. At present we only intend to awaken thought on the subject.

- a forty-three feet ledge of which we recently gave some account. The workmen are very positive that it is growing better and that is value has never been overstated. We've seen some rock recently bought in, which shows free fold in abundance. It will take some months to put the two ledges, just mentioned, in a permanently productive condition. However, it will soon be done and they will supply almost any number of stamps.

RAGING. The Jordan is booming with the melted snow. It interferes with creek mining but the banks are being ground sliced down at a rapid rate. Ditches that were dug parallel with and along the mountain line for collecting snow water for washing the high bars, are now full and the water is being used day and night. The hydraulic apparatus in front of the Idaho Hotel is in full blast from one of these mountain-side ditches. We are not informed as to the precise amount of any clean-ups from sluices, but hear of considerable quantities; enough, say, to supply a certain firm in Idaho City with material to make sixteen dollar dust out of twelve dollar stuff to make packers and others unacquainted either with the process or metamorphosed currency when they have it presented to them. Such is business.

CRITICAL. A. N. Gill, Esq., of Silver, received a letter from a brother residing in McConnells town, Penn. The writer speaks of the Avalanche in a style peculiar only to professional theatrical cities. He says, "Our county papers are not half so good as yours. I have an objection to your paper. There is too much hard language in it – swearing. The editor must be an infidel or an abandoned sinner – but he is a sharp fellow. I will send you a paper occasionally and will be pleased to get yours as often as come with. If that criticism don't tickle us we were never tickled. It really inspires us to giggle mushily. You see it is such a good gock on the pious fellows who don't make it half so good appears" in McConnells town, where the Lord is supposed to have been smiling for almost a century. For a firm of old blue stocking Presbyterians to be charged with being infidels or abandoned sinners is nothing to us, but it is an unjust collection of our early instructors. Our contributions to charitable and religious objects would probably build all the churches and pay all the ministers of McConnells town for a decade. If giving to the poor is lending to the Lord, then he's got all our money. We don't run a Pharisaical religion whose devotees appear beautiful outward, but are within full of dead men's bones, hypocrisy, iniquity and of all uncleanness. (See our good old Saint Matthew.) We don't "for pretence make long prayers" of blasphemy, nor believe that asking a cut-and-dried stinted blessing before each meal and slander our neighbors while citing it, is bully piety. We don't allude to our critic, but do say that just such sticklers for nicety of language, are of the class who condemn prostitution and seek ill opportunities to commit adultery; who cry aloud against any spirituous beverage and are ever ready to drink but not "pray in secret," who parrot-like repeat he Golden Rule but never practice it and think their neighbors should; whose eyes are so full of mites that they can see only the reflection in the peepers of others. We're afflicted with a motion that although our piety may not crop out more then forty-five feet on the surface it will pay well when fairly prospected. We've seen and heard men ask a fervent blessing, and with the Amen breath commence slaning everybody round and even profane Him they supplicate; and such men get indignant at the mildest form of such expressions in their newspapers. Or course these kind of Christians are greatly shocked at some careless expression of those whose true piety consists of acts. But we don't' wish to supersede brother Case in lengthy sermons nor in his occupation. For God's sake, friends, don't ask us to quite making such a "good paper" to occupy the pulpit. As the boy said of his Reverend dad, we'd be "hell on a revival" but don't wish a "call" - without a large salary.


The Mexican-Americans across the country are marching in the streets in defense of Mexicans who have crossed the border illegally to work in the land of opportunity. Prevalent in this mass demonstration is the number of teenagers caught up in the excitement.

One of the issues that rears its logical head is how smart is it for Mexican-American school kids, who as a group routinely have the poorest scholastic record and the highest dropout rate, to cut classes? But, that is not what causes my heart to sing. What is flowing from these young people is a recognition and respect for their ancianos, their abuelos, their paisanos, their countrymen.

It is not usually that way. Mexico is very classconscious. The ricos in Mexico, the educated in Mexico, are not the ones helping the pobres who make the long journey.

I grew up in Las Cruces, N.M. My county was 65 percent Spanish-speaking. I have spent my life in agriculture in the company of Spanish speakers. I speak it. I insisted that my daughter take Spanish in high school. I went to the first teacher's meeting that fall in Colorado. I was excited. The teacher was a young woman from San Antonio. She would have called herself a chicana. Someone asked if the class would have field trips. She replied that, "No," they had no money for that sort of thing. There was a large community of farm workers in the area. I raised my hand and suggested we could invite a couple of them to class to talk to the students. She turned on me like a biting dog, "They don't know how to speak proper Spanish!"

This pervasive prejudice within the Hispanic community rubs off on the children. Kids also have the tendency to want to fit in, to assimilate. I see it often. The immigrants don't speak English, their children are bilingual and the third-generation Mexican-Americans don't speak Spanish. It has been their natural inclination to separate and distinguish themselves from the illegals crossing today. They have nothing in common. But seeing them marching in the streets honors the sacrifice and humble beginnings of their grandparents; the men and women I have lived and worked with for years. It is a moment to be cherished. One well supplying water to the City of Marsing, Well #3, has an arsenic concentration of 11 ppb, which exceeds the Maximum Contaminant Level set forth by the EPA. The City of Marsing is required to provide quarterly public notice of this exceedence. You will continue to receive this notice every quarter until such time as the City if notified by IDEQ the notice is no longer required.

Arsenic is a naturally occurring element thought to enter the water source from contact with natural rock formations. Arsenic can cause adverse health effects, including cardiovascular disease, diabetes mellitus, skin changes, nervous system damage, and various forms of cancer.

The City of Marsing is taking action to remove the well as a source of water for the water system. As you may be aware, the City is in the process of upgrading the municipal water system, and a new well to serve the system, and replace Well #3, will be first item completed for water system upgrade project
