Sherry Olson has been a resident of Owyhee County for 13 years and lives on a ranch with her family outside of Murphy.

She has more than 10 years of experience in law enforcement working for the county sheriff and said she is proficient in skills requiring leadership, teamwork, training, customer service, communication, establishing priorities, multi-tasking and 'split-ear.'

"As you know, over the last few years we have heard many stories of laws not being followed, the budget not being published in a timely manner according to law; money spent and no clear answer

for what happened to it," Olson said. "I don't know about you, but I would like to see leaders in our county offices that are willing to take responsibility and accountability for their actions.

"Leaders that will make the citizens of Owyhee County feel like they are valued customers, not an inconvenience. I would like to see employees hired for their experience, not who they know. The 'good ole boy' system is not working very effectively, and it is time for Owyhee County taxpayers to have honest, reliable leaders."

Olson said her goals are to run an open office, excel in customer

service, serve the taxpayers with integrity, honesty and accountability, and use resources to assure the highest of compliance with Idaho Code.

"I also would like to be able to do business over the lunch hour." Olson said.

"The citizens of Owyhee County have to drive too far not have that service afforded them. Isn't that what the county offices are there for: to serve the citizens of Owyhee County with the least amount of inconvenience possible?"

She said if elected she promises to do the job at hand with the utmost of integrity and honesty.

Charlotte Sherburn REPUBLICAN



Charlotte Sherburn moved to Owyhee County with her family in 1989 from Nevada. She has worked for the county for 13 years, including 11 in the clerk's office. She said she was hired by Barbara Jayo as the deputy recorder and deputy welfare

"When Barbara retired, I went to work for the sheriff's office as the driver's license clerk," Sherburn said.

"After two years, I left county employment to help my husband with a hay contracting business. I returned in 2000 as the deputy

auditor and payroll clerk. I have held every position in the clerk's office and understand them well."

Sherburn said being the clerk of the county holds a variety of responsibilities, including clerk to the commissioners, recorder, auditor, elections clerk and clerk of the district court. Another responsibility is supervision of the maintenance of the county courthouse.

"It takes several years to learn and be competent at the jobs required of the position," Sherburn said. "I have an excellent staff, who know their jobs and all work very hard for the good of the county."

Sherburn said she staffs nine employees, and has only increased the staff during her term by one part-time person who works two days a week in the clerk's office and three days a week for the

"I enjoy my job and working with and for the taxpayers of the county," Sherburn said. "The rapid growth our county is seeing is a challenge, and we are seeing an increased workload in each division.

"To change administration and elect a new clerk lacking the knowledge and having no prior work experience in the clerk's office would have a large impact on the citizens of the county, as has happened in the past. I would ask that you re-elect me as your clerk and continue with strong leadership, honesty and the competency I have exhibited the past four years."

Sherburn said she has done her best in the past to save the taxpayers as much money as she possibly can and still provide the services needed.



Chris Collett lives on a fifthgeneration ranch in Oreana with her family. She is passionate when it comes to heritage, saying she feels the county was built on heritage.

"We are a part of it," Collett said. "It is what makes this county unique: the generations of families that live here, work here and die here."

Collett said she was not a rancher before meeting her husband, Brian, but once she began working the land, the county grabbed her heart and held on.

"This area just grabs you," Collett said. "I can't imagine living anywhere else. I am devoted to the area and to the people here."

Collett graduated from Rimrock High School and has an administrative accounting degree from ITT Tech. She said she manages budgets on the ranch and is used to watching dollars very closely.

Collett worked in the county clerk's office for about three years as deputy clerk and as a welfare director. She said she dealt with indigent and charity before she left the office.

"I want to be commissioner because always knew I would run for some kind of office," Collett said. "I have always been drawn to politics."

It is time for a change, Collett said. She said she wants to see communication opened up between the county and the taxpayers.

"I want to change that," Collett said. "I would call them back if a message is left for a commissioner. I don't think that is happening right now.

"I know I won't please everyone, but it frustrates me how much people don't know what is going on in their county. We should have more articles in the papers about what is happening in our county. The No. 1 thing for me is the communication."

Collett said the top issue for her, besides communication, is the handling of the budget. She said she is "disturbed" by how the county currently pays its bills.

"I find it disturbing to see no one knows who is being paid, how they are paid and who approves those payments," Collett said. "There are supposed to be stopgaps, but that is not happening. "

Although Collett is a full-time mom and a rancher, she said she will have plenty of time to devote to the job of commissioner.

Collett also stresses the need for politicians to take responsibility for their decisions.

"Accountability is not happening right now because they don't have an explanation for anything. It always seems to be someone else's fault. If I take on the position, I will take on the responsibility."

Richard Freund has worked for the citizens of Owyhee County as a deputy sheriff for 23 years. He feels he has developed skills that will be helpful in assisting the county grow into the 21st century.

"I have the ability to mediate, negotiate and communicate," Freund said. "I believe these skills are absolutely essential in a representative of the citizens of Owyhee County."

Freund says he plans to retire from the sheriff's office if elected, which will give him the time to devote to doing the job as commissioner right.

"I think there are some things I can do to improve things," he said. "I see some things I would like to change. We need to listen to the things that are going on around us.

"We need to follow our own rules. Our policy manual has been hanging around here for years, and for the last year and half we deal with it. We work together in commissioners is another issue. have been working on changes.

Over the last couple of weeks, the commissioners have worked on changes, and then it gets put off. It has never been finished or updated."

Freund said the policy manual affects every county employee. He warns that someday a problem will and there will be no adequate policy for reference.

"Some of the policy is not even up to state code," Freund said. "With the system the way I perceive it, (the attitude is) 'As long as it doesn't bite us, why mess with it?' Why not have it ready to go if it does happen?

"I would rather be prepared. It is something we have always tried to foster in this department (the sheriff's office): To have the equipment, have a policy and procedures that prepare you and training so if something happens you are prepared to handle it and atmosphere, and that is how we

Freund said he feels the people of Owyhee County should be allowed to be more involved in decisions of the commissioners. He said excluding the citizens is leaving the county behind.

"There is a lot of expertise in this county," Freund said. "I don't see a lot of (the commissioners) going out and asking them what (the citizens) think."

Freund says nine years as a Homedale schools trustee and his time in the sheriff's office has given him experience with budgets. He said he also prepares budgets for his personal home.

"I don't have an agenda or a bone to pick," Freund said. "I would want to go and see where things are at before making any changes. ... Better communication between the people of the county and the this department. It is a teamwork That is an absolute necessity."

Reynolds says he has given his heart to the position and "if God wants me to remain, I will do so."

Reynolds, who is from the Bruneau area, has lived in the county for 34 years. He said although his is not considered a native of the area, Owyhee County is in his heart and in his blood.

"There are so many good things that have happened," Reynolds said. "I want to be here to implement those things and watch them happen."

Reynolds name is among those signed to the Owyhee Initiative that has been in the works for nearly five years. He said when the work is done, the initiative will be a landmark in the United States.

"It will set a precedence," Reynolds said. "The people of Owyhee County should be very proud of it. We just helped it along, but the people of the county are the ones to enact it.

"We have some road issues that need to be taken care of and I want to be here to see those through."

Another big accomplishment Reynolds cites is the closing of the Rimrock Landfill. He said the recently completed project has been on his agenda for some time.

"We finally got it all done," Reynolds said. "A lot of people put their valuable time into this project, and I don't think I can ever thank them enough."

"It has been a very great educational experience to see the people of Owyhee County so dedicated to their way of life. It is so amazing to see how they are so dedicated to each other," Reynolds said. "The county is so diverse. You can spend most of your life here and you still can't see it all."



Nick Ihli was elected four times as county clerk and recorder after being appointed 1956. He is past president of the County Clerk Association and past president of the Idaho Title Association. He is a member of the Historical Society and was treasurer for many years. He was treasurer of the Silver City Taxpayers Association and is a member of the Owyhee County Cattlemen's Association.

Ihli feels his experience of 16 years as county budget officer and clerk of the board of county commissioners gives him the advantage in the position.

He believes that communication and accountability has been a problem in the past with the commissioners. All accounts should be scrutinized before payment is made to avoid duplication, he said.

"The survey of county employee compensation, ordered by the commissioners, by an outside consultant was never adhered to completely and should be reconsidered," Ihli said. "Also the transfer of county public records to the state historical society should be discontinued. These very important records have been found to be unretrievable

and the county museum now has adequate storage for these documents."

Rapid growth in the county, as well as police protection, search and rescue, road maintenance and recreation are all huge problems, Ihli said. He said he will listen to all concerns and answer in a timely manner.

Ihli plans to keep a tight rein on county spending if elected.

"It is just a taxpayer apathy," Ihli said. "It is water down the drain now, but it is something I can make sure does not happen in the future.

"There are several items that have been mishandled, in my opinion. (County officials) have transferred many county records to the state for archival purposes, which are fine, but they failed to institute a way to retrieve those records. Being an old title person, it just infuriates me."

Ihli said voters should vote for him because he has the knowledge, qualifications and the time to put in, and he feels he can do a good job for them.

"I am not afraid of work, and no, it is not a part-time job," Ihli said. "I only live a block from the courthouse. I believe I have a leg up on (other candidates)."







Otter's views

Endangered Species Act

He feels incentives rather than punitive measures engage landowners in helping to conserve species.

Fiscal responsibility — Otter says that while increased spending on homeland security and defense are warranted by the war on terrorism, it's important to practice budget restraint and control government spending. He says he is committed to making taxes

fairer and less burdensome.


Prison overcrowding — While Otter acknowledges the role prisons play in keeping the public safe, he says there are ways to reduce the number of incarcerated and, thus, lessen the need to build more detention centers. One way he suggests controlling the prison population is expanding Idaho's existing drug courts and mental health courts, which require the offender to pay some of the cost. He says improving treatment effectiveness to reduce recidivism is another key.

Public lands — Otter believes federal agencies have a responsibility to be more effective

stewards of the nearly two-thirds of Idaho they manage. He says the government has an obligation to involve those who know and understand the issues best in land management decisions, and people most influenced by federal policies should play a larger role in developing them.

Water rights — Otter says he'll work to maintain the quality of Idaho's water and protect it from out-of-state appropriation or diversion, from letting others determine the priorities for its use, and from attempts to send it downstream without meeting the needs of the state's communities or economy.

Charters said although she does not have formal education in the position she can bring plenty of experience to the job.

"As treasurer, you need to be available to the patrons to answer questions and give them the customer service that they are entitled to," Charters said. "The courthouse is not sitting in the middle of the metropolis of the county. When people come, they usually come from a long way away, and when they come they need to have that service."

Charters said voters should elect her because she has the experience and knowledge of the office through her years of employment.

"I have extensive experience and knowledge of the office and of the county," Charters said. "I

know how the office has treated the people in the past and where the taxpayers stand with elected officials and where the elected officials should stand with the taxpayers. It just is not happening anymore."

Charters said the most important issue to her is customer service, or the lack of it.


