Senior second baseman BreAnn Rodriguez atoned for what could have been a crucial error with sparkling, heads-up defense to stop a Fruitland rally in the fifth inning as the Trojans posted a 9-4 victory in the second-place game of the District III tournament Friday at Sundance Park.

Rodriguez's clutch defense and six hits and four RBIs from senior first baseman Jessica Mooney helped coach Larry Corta's squad to a pair of victories on the final day of the tournament that secured Homedale's first trip to the state tournament since 2003.



The Homedale seventh-grade girls and eighth-grade boys both finished third in their respective championship bids. The HMS eighth-grade girls were fourth.

Adding to the Homedale seventh-grade boys'  $100\frac{1}{2}$  points was a strong performance by Emilio Cuellar, who finished second in the 400 (1:01.89) and was fourth in the 200 (27.45) and the shot put (32-6 $\frac{1}{4}$ ).

Kylie Potter won three events for the HMS seventh-grade girls.

She crossed the line first in the 100 hurdles at 18.32, and also won the 100 sprint (13.7) and the 400 (1:08.84). She was second in the 200 in 29.88.

Seventh-grade teammate Jessica Westergard won the shot put with an effort of 26-8, and grabbed third in the discus at 60-5.

The eighth-grade girls team was paced by victories from Nikole D'Alessio (shot put, 28-6½) and the 4x200 relay team (2:03.13). Katie Holloway was runner-up in the 100 hurdles (17.51) and finished fourth in the high jump at 4-4. Ashlynne Uria was third in the long jump.

The eighth-grade boys received a strong performance from Trent Acree, who was second in the long jump at 17-10<sup>1</sup>/<sub>4</sub> and third in the high jump at 5-0. Jake Tolmie grabbed second in the 800 (2:19.97) and third in the 1,600 (5:16.32).

Jose Gonzalez finished second in the 100 hurdles (16.17) and third in the 400 (59.42).

Notus then knocked off Rimrock for the second berth into the state tournament, which begins Friday in Caldwell. Coach Mike Chandler's Rimrock team seemingly had a full head of steam after the Chandler sisters — Emily and Shelby — drove in two runs each during the regular-season-ending victory over Notus.

The Chandler girls, Shannon Hipwell and Devani Lawson all had two hits apiece against the Pirates.

Hipwell and Shelby Chandler held the Pirates to just four hits and dodged eight walks.

And two of those ninth-graders — Austin Emry and Austin Ferguson — are two of three Trojans who will represent District III in the long jump. Junior Matt Holloway also qualified for the long jump.

Emry, whose season-high 6 feet, 2 inches is the third-best high jump mark among 3A athletes this season, won the district high jump title with an effort of 6-0.

"Tyson Stimmel has been working with them on the high jump," Homedale assistant coach Nick Schamber said.

"That definitely was kind of a sweet surprise to get all three in there."

Sophomore Terence Thomas, the coach's son, will make a return trip to the state meet in the throws. He grabbed the fourth and final District III berth in the shot put, and he finished third in the discus on Thursday with an effort of 135-7.


Thomas Thomas said his son would be seeded fourth in the discus at State.

# **Error-prone Homedale goes down swinging**

The 2006 baseball season had to be one of the most painful examples of "What could have been?" for Homedale High School.

The Trojans finished the year 12-11 after Trent Harrison scored an unearned run in the bottom of the sixth inning of Middleton's 3-2 victory Thursday in the 3A District III tournament on the Vikings' home field.

"It was kind of like a microcosm of the season. We're right there, and if we make one or two more plays, we win the ballgame," Homedale coach Tim Fulwood said.

"Like I told (the Trojans) at the end of the game: You look back at that game plus four or five other games that we lost by one run; we are so close from being a pretty good team to having a really great season."

With junior Ryan Johnson battling through a tender hamstring on the mound, Homedale actually held a 2-1 lead in the third inning against the No. 2 seed Vikings. David Liddell singled with one out in the third inning and scored on Brandt Graber's base hit to push the Trojans out front briefly.

Johnson and reliever Ross DeWitt — the only senior on the Homedale squad this season - held the Vikings to just four hits

"We got a great effort from our pitchers. They pitched outstanding ballgames, both Ryan Johnson and Ross in relief, and I think they put us in the position I thought we needed to be to win the game," Fulwood said.

"We just had a few defensive mistakes in the field that cost us some runs, and that was the ballgame."

Josh Jolley was 2-for-3 with a run scored against Middleton, which joins tournament champion Fruitland as the District III representatives in this week's 3A state tournament.

Homedale started the week with a 14-4 five-inning loss to the Grizzlies on May 8. Fruitland scored eight times in the fifth inning to send the Trojans into the losers bracket.

But the Trojans rallied on May 9 with a shocking 12-11 victory over McCall-Donnelly. Jolley, Homedale's cleanup hitter, dropped down a suicide squeeze

bunt with no outs in the seventh to bring home DeWitt with the winning run.

"Pretty exciting way to end the game," Fulwood said.

"(Jolley) was the No. 4 hitter, and I didn't think they'd be expecting it (the bunt). And they weren't. And Josh is a pretty good bunter."

DeWitt had tied the game 11-11 when his third triple of the afternoon brought in Graber. The senior shortstop was 3-for-5 against the Vandals with four RBIs. Jolley went 3-for-4 with three RBIs and another triple.

"Ross has been playing extremely well for us in the district tournament," Fulwood said. "Ross is a competitor, and he wants to win as bad as anyone else."

DeWitt picked up the decision in relief of junior right-hander Claudio Garcia, who was making a rare start after battling arm trouble all season.

"He says it's fine, but just by his body language, no, I'm not convinced that it's 100 percent yet," Fulwood said of Garcia's arm. "So rather than risk it and the potential of more problems,

Garrett Sweet's run of appearances in the Idaho high school golf state tournament ended at three last week when neither the senior nor any of his Homedale High School teammates managed to qualify out of the 3A District III Tournament.

Payette edged host Weiser by two strokes in the 18-hole tournament played Wednesday at the Rolling Hills Golf Course. The Pirates, Wolverines and thirdplace Fruitland will attend the state tournament. # On the edge of common sense

## In appreciation of Gale Norton



I prefer to call the environmental groups the ANTIs. It is as if they have not noticed America's addiction to skyrocketing energy prices, our increasing dependence on foreign oil, the horrendous forest fires consuming the West, the grinding erosion of rural communities, the elimination of ranchers, lumbermen, miners and the enmity between themselves and the citizens who actually live in the land they are trying to protect.

This is the same ANTI mind-set that prevented beefing up the levees around New Orleans years ago, that stopped development of nuclear power, that still condemns the use of pesticides, antibiotics and genetically modified foods. The same ANTIs who will not be happy until we have returned the West to pristine pre-Aztec days and we are completely dependent on foreign energy, food, timber, phosphate and shoes.

Over the years, I have watched governors like Idaho's Cecil Andrus and Colorado's Roy Romer, who once appreciated agriculture, timber and mining as part of their states' richness, get appointed Secretary of Interior and then turn on us. I watched Gov. Bruce Babbitt of Arizona come from a state that was built on copper, cattle and cotton, get appointed Secretary of Interior and morph into an unfaithful bride. He became to the ranchers what smallpox was to the Indians.

In fairness, Americans have gotten smarter since 9-11. They understand that there is a price to pay to drill



## Wayne Cornell **Not important** ... *but possibly of interest*

When I was a kid, most of our neighbors milked Holstein cows — large animals easily identified by their black and white markings. Holsteins were popular because they produce more milk per cow than most breeds. Another reason Holsteins were the cows of choice was that they are terminally stupid. Holsteins believe their only purpose in life is to eat, stand in a barn and give milk.

When milking time arrived, I could gaze across the fields to neighboring farms and see long files of Holsteins walking — sometimes hurrying — from their pastures to be milked. Nobody had to tell them to come.

The cows belonging to my parents were of the Jersey breed. Jerseys are brown- or fawn-colored and are smaller than Holsteins. They also produce less milk, but it has high butterfat content — something creameries paid extra for in those days. Father also kept Jerseys for sentimental reasons. Some of our cows were descendants of the ones Grandfather Cornell brought to Idaho from Kansas in 1910.

But if you put nostalgia aside, our Jerseys were mainly a pain in the neck. When all the Holsteins in the world were heading for their barns to be milked, our cows were nowhere to be seen. They still were on the far side of the 40 acres. And there they stayed until someone went out and forced them to come home.

Every night, I had to walk up the lane behind our barn, cross the canal and trudge to the pasture where our Jerseys were contentedly grazing. Then I had to physically drive them back to the barn.

It seemed to me that Holsteins were the dogs of the cow world — always trying to please their human benefactors and always ready to eat. Jerseys, on the other hand, were more like cats — barely tolerating their masters and not really giving a rip about their public image. I tried all sorts of tricks to get the Jerseys to come to the barn on their own. Nothing worked. Then one evening, as I was on my way to collect the cows, I picked up a 4-foot length of steel pipe I found in the farmyard. As I walked up the lane I blew in one end of the pipe, the way you blow a trumpet. My efforts produced a sound something like a French horn would probably make if it had a hernia.

In the midst of my musical recital, I looked up. The cows were headed straight for me. Their ears were standing straight up in complete attention. And they were literally running, not walking. I was ecstatic. I finally had found a way to get a Jersey's attention. My hiking days were over!

The next evening at milking time, I picked up my Jersey call and walked to the corral gate. I put the pipe to my lips, blew a long mournful note and waited for the first cow to appear at the top of the hill. I blew it again. There was no response from the pasture.

I marched up the lane and across the canal. The Jerseys were at the regular spot near the fence at the back of our property. I blew my horn. They looked up for a moment then went back to grazing.

A cow named Penny was the nearest to me. I walked over, stopped about 3 feet from her and blew my pipe again. Penny looked at me, lowered her head and knocked me flat on my back. It took several minutes to get my wind back. Then I picked up my pipe horn and informed Penny and the others that if they didn't get moving immediately I would use the instrument for something besides blowing. They seemed to catch my drift.

Jerseys were too smart for their own good. Maybe that's why they have all but disappeared from America's pastures.

### May 12, 1866

INTERESTING. The annual round of the tax assessors and collectors is an interesting period to all. The best way to dispose of these publicans is to be prepared with lawful statements and make them on demand. The assessor and collector are unwelcome guests, yet their mission is necessary, lawful and upon them obligatory. Glancing over our exchanges it is alarming to read how numerous are the frauds upon all kinds of revenue. Papers chronicle seizures, confiscations, indictments and imprisonments almost without number, because of frauds in this particular. Why it is, we won't pretend to explain, but it is true that men who bear irreproachable characters in other respects will commit perjury every time they are called upon for a true list of taxable property. This is a sweeping declaration but as true as gospel. Let all men carefully read the law, review their tax lists as sworn to and then each ask himself, Have I not withheld goods, chattels or money or undervalued them? When making my return. Blackstone says in substance that he who withholds any part of a tax due the public commits the same crime as he who puts his hand in the public purse and steals a like amount. Every violation of the revenue law local or otherwise, it a criminal offence, and if the offender is not punished he's none the less a criminal ad his escape is attributable to his skill in covering up the fraud or the lurches of the officers whose duty it is to enforce the law and punish its violators. Tax-payers should remember their liabilities and calculate that officers and grand juries way to do their whole duty. We make these statements because the various assessors and collectors are on duty and making calls. Those who can't stand the assessments, had better sell out and go where if on earth – no taxes are required.

Mr. Lobenstein has arrived and is ready to attend to business

MAIL TO NEVADA. By recent advices, we learn that a mail route has been established by Congress from Virginia, Nevada, to Boise City, I.T., via Unionville, Star City, Dun Glen and Ruby, and the one from Humboldt City to Boise via Owyhee abolished. Proposals for bids on the new route are advertised by the Post Master General. The bids will be examined June 2d, and the service commence September 1st. Bids for weekly, tri-weekly and daily (except Sunday) service are solicited. We know that responsible parties have made proposals, and if accepted they are prepared and will immediately stock and start the line, without reference to September 1st. We know that active, earnest and able men in Washington are laboring to prevent the contract from being let to men who have only the ability to stock a woolen shirt or a neighbor's blankets. For the past few years we've had routes established from Susanville and from Humboldt City via here to Boise, and contracts let to transport the mails, but a set of irresponsible wretches got the contracts - hence no mails. The P. O. Dept is being waked up from tolerating such puerility and injustice. Every new place is subject to greater or less tribulations; Owyhee has passed her worst.

ACETATED. Leading citizens of Silver and Ruby are favorably entertaining the proposition (made by us last December) of abolishing the names Ruby and Silver and select a new one for both. It is proposed the new one be "Owyhee" and than boundaries be made that will include both towns. We are of the decided opinion that this step - if taken - would be best for the interest of each, for they will of themselves grow together and be one in spite of any opposition. It has been suggested that a meeting be called to take the preliminary steps to perfect the object in view. If this agency is used, the greatest care must be exercised in its management, as a few indiscreet persons would demoralize the project even though nine tenth of the entire community favor it - as we believe they do. A well chose Committee will devise a plan and name correctly - if it can be done. We allude to this matter by request of citizens in both towns, and will add further suggestions in next issue.


