# Huskies run strong at State

Marsing High School's track and field team endured some unusual circumstances to post a memorable showing at the 2A state meet last week.

Senior MJ Usabel tied her school record by clearing 10 feet in the pole vault. But the Northwest Nazarene Universitybound Usabel was unable to defend her state title in the event because Nampa Christian freshman Chelsea Barr ran away with the state crown with a recordshattering vault of 11-6.

"MJ did well," Marsing coach Don Heller said. "She went as high as we thought she would in the pole vault."

Marsing sophomore Elisa Moreno joined the youth movement with a stunning performance in the girls 100 meters. She made the final as an at-large seed and ran a 13.59second championship race to grab a sixth-place finish and a medal.

"Four out of the six (Marsing athletes) medaled, and that was nice," Heller said. "The surprise was Elisa doing so well."

Myers beat Steven Holman of Sugar-Salem, 6-3, 6-0, in the first round. Myers lost to eventual state runner-up Scooter Sabel from The Community School in Ketchum, 6-0, 6-3, in the quarterfinals.

"He had never played (Sabel) before, and it took him a while to figure him out," Weekes said.

Myers fought his way through the consolation bracket, winning three matches to reach the thirdplace match against a familiar face. Trent Timmons of Parma beat Myers, 6-2, 6-3, for third place.

Payette's Esteban Ferrero beat Sabel for the championship, proving that District III is one of the toughest 3A leagues for boys singles with Timmons taking third and Myers grabbing fourth.

"(Myers) played the No. 1, No. 2 and No. 3 in the state during the year, and that's good experience for him," Weekes said.

Myers' road to the third-place match included a 6-0, 6-0 win over B.J. Allen of Clearwater Valley, a 6-3, 6-0 win over Johnny Hullinger of Weiser and a 6-0, 6-0 shellacking of Anthony Velie of Parma. "He was pretty excited," Weekes said. "He got done with his second-to-last match (Velie) and came to me and said, 'I'm going to medal.'"

Levi Jones, Homedale's other representative in the boys singles bracket, started the tournament with a 6-2, 6-2 victory over Brandon Bigford of Troy. Jones was knocked into the consolation bracket when he fell to Velie, 6-4, 6-3, in the second round.

Jones' tournament ended with a 6-2, 6-1 loss to Mike Martin of Clark Fork.

The junior doubles squad of Caleb Johnson and Andrew Bingham kicked off their participation in the boys bracket with an easy 6-1, 6-0 win, but they lost their second-round match. They were eliminated with a loss in their first round of the consolation bracket.

The toughest tournament was endured by the Homedale girls doubles team of Andrea Schwangler and Shanae Galloway. The juniors won their firstround match, but were forced to withdraw prior to their first consolation bracket match.

"They had to forfeit their third match because Shanae got heat exhaustion," Weekes said. "Otherwise, I think they were good enough to get fourth place."

Despite the bad luck and tough brackets, the Trojans' showing this season makes Weekes optimistic about next spring.

"We think that all those kids can do well at State next year," he said.



# District II prep rodeo season winds down

Marsing's Kallie Roeser chases girls all-around championship

With the rest of the high school sports now complete for another year, the cowboys and cowgirls in the District II rodeo competition will have the stage all to themselves Saturday and Sunday for their season finales.

The final rodeos of the 2005-06 season take place this weekend at the Caldwell Night Rodeo arena.

Marsing High School's Kallie Roeser enters the final rodeos of the season in the hunt for the girls all-around championship.

Rodeo club members from Homedale, Marsing and Jordan Valley high schools are among the competitors in District II rodeo.

Homedale junior Bryan Martinat leads the saddle bronc standings. He had won all four competitions heading in the May 13-14 stop at Gem County Fairgrounds in Emmett. Another Homedale cowboy, Kyle Carson, finished second on April 23 and May 7 (both in Homedale) and is in second place in the saddle bronc.

Results from the Emmett stop on the circuit haven't been posted on the District II Web site or otherwise reported.

The top competitors qualify for the state rodeo, which will be held June 19-24 at the Bannock County Fairgrounds in Pocatello.

In the girls all-around before Emmett, Roeser was 14<sup>1</sup>/<sub>2</sub> points behind Melba's Kayla Tiegs. Roeser had closed the gap with big performances May 6-7 at the Owyhee County Fair and Rodeo grounds in Homedale.

Drew Hummel of Kuna held a comfortable 31<sup>1</sup>/<sub>2</sub>-point lead over Jarrod Roberson in the boys all-around after the last Homedale rodeos.

Rye Hyer was third. On the girls side, MikiAnna Williamson won the title, while Roeser finishing fourth. Before Em-

mett, the Hy-

22 and May 7, both in Homedale.

Hummel also led the tie-down roping before Emmett. He had an eight-point lead over Melba's Josh Dygert. Dygert's Melba teammate, Austin Clow, was in fourth place.

Roeser is also battling for the breakaway roping and goat tying championships.

In goat tying, Roeser was locked in a fight first place before Emmett. She and Tiegs both had 35 points heading into the May 13-14 rodeos. Tiegs racked up her points by winning three of the first four competitions of the season. Roeser did it with consistency, winning the April 22 rodeo in Homedale before finishing third in the next two Homedale rodeos.

Roeser was listed in third place in the breakaway roping before Emmett, trailing Tiegs by 11½ points. Homedale's Jennifer Hall was locked in a three-way tie for fifth place.

Hummel's all-around championship hopes have been helped by his partnership with Brittney Edmondson in the team roping division.

After sweeping the Homedale competition, Hummel and Edmondson were four points out of the lead held by Kristan Durcharme and Justin Jarvis heading into the Emmett competition. The Marsing duo of Troy Dines and Kelsey Cook held down third place with 62 points. A team comprised of Homedale's Rye Hyer and Melba's Kyler Dygert won the season's first round of team roping on Sept. 24 in New Plymouth.

Hummel won the cow cutting title this season, edging Homedale's Wade Hyer by 3<sup>1</sup>/<sub>2</sub> points. Another Marsing cowgirl, Kortni Scott, was eight points off Matea Gabiola's barrel racing pace before the Gem County rodeos. Roeser was fourth in the standings.

Roeser also was fifth in pole bending before Emmett. Kacee Donaldson leads that competition.

Other Homedale club members who have appeared in the rodeo standings include Cory Uria, Faith Brasher, Cheyanne Andrade, Hailee Garrett, Mikal Mackenzie

Jordan Valley is represented by Megan Mackenzie and Annie Mackenzie.

# **Crusaders corral Usabel** for smarts, athleticism

MJ Usabel has made it her business to rewrite the Marsing High School track and field record book in the past four years.

Now, the senior is taking her business to Northwest Nazarene University in Nampa, not only because the Crusaders have offered a scholarship but because the private four-year school offers more of what she's looking for.

"They have a very good business program," said the 18-year-old who isn't sure what aspect of business she'll study.

The other factor in Usabel's choosing NNU was as basic as you can expect.

She'll stay close to home, giving her parents, Jody and Joe, the opportunity to attend their daughter's meets.

"All their track meets except one are at home, so we can continue to watch her," Joe said.

"As a father, I feel better that's she's close, but basically the decision was hers."

MJ Usabel, the 2005 Idaho 2A pole vault champion and holder or co-holder of three Marsing track records, made her decision official May 16 by signing a national letter of intent in front of a crowd at the Huskies' gymnasium. The signing, which came with her parents flanking her, was the centerpiece for the awards night for Marsing basketball and track teams. "MJ is the hardest-working female track athlete that I have had," Marsing coach Don Heller said "When she gets to college and gets more individualized help, the sky is the limit." Usabel is the second Marsing track athlete to join an NCAA university's track program in the past month. Breanna Chadez

signed with Division I Idaho on April 24.

And the signings haven't stopped.

Heller told the audience last week that high jumper and triple jumper Chris Covey soon will sign with NNU, too.

Usabel, who also was a varsity standout in volleyball and basketball for Marsing, said she began considering colleges at the start of her senior year. She only made her decision in the past week, and she never expected track to carry her to the threshold of a college education.

But she said the Crusaders seem to be a great fit because the team is running low on talented pole vaulters and hurdlers.

"The coach seemed really interested in my vaulting, and the team needs hurdlers," Usabel said.

NNU got quite a bit of both in the multiple-event state meet qualifier. Crusaders women's track and field coach John Spatz said Thursday that Usabel is a candidate for the heptathlon.

the 100-meter hurdles and the 300 hurdles. In the 300 hurdles, Usabel clocked her best time in three years at the 2A District III championships.

Spatz said one of NNU's goals to help Usabel polish her talent in the pole vault and expand her horizons in the other events.

"We are hoping to be able to help her advance those skills so she can be highly competitive at the college level," Spatz said. "Plus, with her background in the hurdles and some other events, this creates some interesting possibilities for her in college.

"I really feel like even though she will be a freshman next year that with her leadership skills and outgoing personality she will be able to step in right away and contribute to our success as a team."

Heller says Usabel has the ability to get faster in the hurdles as her strength and confidence builds.

## 140 years ago

## May 19, 1866

OFF FOR OWYHEE. Thos. Ewing, formerly one of our heaviest traders and one of the most enterprising citizens of Old Humboldt, has shipped a monster stock of groceries, liquors, clothing, hardware, mining tools, provisions and the like to Silver City – whither he will depart next Monday and be there to check off on arrival of his teams. Tom knows what is wanted in that country and he bought for cash. If the Owyhees have the lust and want something to wear, to eat, to drink, or to work with, he's their man

Mr. Ewing and party arrived here two weeks ago overland - ten days sooner than the above paper via Salt Lake which is our only mail communication in that direction. But 'tis ever thus.

MINERS U.S. LICENSE. This matter has been mentioned to us by miners, some of whom think they are imposed on illegally by the collector. Their authority may be found by referring to the forty-ninth paragraph of Section 79 of the Excise Law approved June 30, 1864, and reads as follows.

Forty-nine. Miners shall pay for each and every license the sum of ten dollars. Every person, firm or company who shall employ others in the business of mining for coal or for gold, silver, copper, lead, iron, zinc, specter, or other minerals, not having taken out a license and manufacturer, and no other, shall be regarded as a miner under this act. Provided, that this shall not apply to any miner whose receipts from his mine shall not exceed annually one thousand dollars.

This seems to be so plain that no one can misunderstand its meaning. We believe that even a strict construction of the law exempts all miners from paying this license who did not employ others in the business of mining &c. Those who do employ others can only be exempted by satisfying the officer that the receipts of their mines do not exceed annually one thousand dollars.

SCANDIA. This is a name of a company and the ledge they own. It is located on Long Gulch a short distance from Silver and discovered last summer by Col. Olson while place mining in the gulch. At the discovery point it is three feet wide, but it was declined best to open it on the mountain side. For this purpose a tunnel was commenced last October and at a distance of sixty-five feet struck the ledge on which a shaft is being sunk 6x7 feet, now down fifteen feet and shows a well defined ledge neatly four feet thick, with solid casings. The quarts looks very well. The native metal is visible in the rock to the naked eye. No mill test has been made though be assay and hand process is prospects very well. We were shown flattering yields of small quantities worked by the very crude process of hand mortars. Assays of over \$500 to the ton have been made. The company are pushing forward the work and expect ere long to have rock worked in the mills. THE TRIAL TRIP. The editor of the Statesman came out on the stage on Wednesday of this week to meet and ride on the steamboat "Shoshone." We failed to receive the paper containing the full report by last mail, so we have to put up with what charley Barnes and "Miller" could remember. The editor says:

Owing to a want of time &c. DuRell and us concluded to abandon the original idea of procuring an Indian willow raft and floating down the Boise and be on hand for the launch &c. so we secured another species of willow work, perfectly water tight with cork buoys and getting aboard Beachey's stage rushed through in time for the supposed (free) launch in waiting at the Owyhee Ferry. Wednesday morning as a morning, was calm and lovely. Not a leaf stirred, not a bird stirred and the further we got away from the Capital it grew smaller by degrees and beautifully less. How curious! But then you can't ell. As we neared the approach of the fast freight wharf we could see a heavy set man standing on the opposite bench, he was found to be Beachey leaning on a cotton umbrella and holding on to a rope that was fastened to a sage brush a little in the rear. Beachey's imagination was highly wrought up by the coming scene and had made himself safe. We immediately secured his pen as port lariat for the occasion. Charley Barnes made the drive just in time to meet the boast.

The "Shoshone" is a floating palace in the way of a river craft. The name "Shoshone" is of serpentine Oregon (pro origin) and is sometime spoken as Sho ' sho ' ne. The S's having the hissing sound in every instance. It requires a forked tongue to pronounce it correctly and easily. But nature has unfortunately deprived us of the proper forkin apparatus. It is hard but to use talkin'. DuRell and us examined the works throughout and submit the following report: Length from stem to stern 212 feet; width from the tip of one wheel house to the other, same, short 200. Depth of hold by holding on to the smoke stack – six feet two inches. As to the amount of water drawn the estimate varies as the vessel heads up or down stream. Revolutions per minute not exactly known, between drinks, exactly none. The boat had some difficulty in crossing as we neared Salmon Falls but DuRell and us got all we wanted without having to cross any bar. The engine works beautifully, though DuRell and us "couldn't see it." In fact we saw no Indians on the whole trip up. Plenty of grass, wood and water, except at the bar. We had a commanding view from the pier deck, with a glass in each hand and two in our eye. Though Captain Myrick commanded the boat. Joe Kersimes was chief engineer. We knew Joe in Pike, he's a brick. He showed up the philosophy of the governor, piston, &c., which interested us very much. At this wring, DuRell and us were completely carried away and laid two. We see no use for Chico now, they may keep a stiff upper lip and all that. One of the principal owners in the Shoshone (just up from below by stage) was so confident of its over whelming success that he put on the Owyhee without sharing in the maiden voyage. We shall give more full and clear particulars in a succeeding number of the Statesman: Salmon (and other) Falls are alone subject enough for one number. So for the present consider that Our bark is on the sea saw, &c.

that includes provisions establishing a board of directors, and other requirements as set forth by state law. None of this has been done. Despite what the mayor claims, there is no city-owned industrial development land in Homedale.

Further, we question the lease overall. The city has taken our tax money, purchased land with it, and then offered it (tax-free, of course, since it is owned by the city) to a private business for 50 years (now he says 25 years) at \$100 a month. According to the county assessor's office, once the land is used for a business instead of agricultural, it would generate \$2,200 in tax revenues annually – nearly double what the city would get under the proposed lease.

But most importantly – we question the city's reasoning for buying land that it doesn't need for city services. Cityowned land not needed for city purposes should be declared surplus and put on the auction block. It would enhance the city's coffers many times over what the proposed lease would bring. There's a 1.9 acre parcel for sale near the same location for \$100,000, and another parcel containing .41 of an acre for \$79,000. It would be speculation in guessing what seven acres would bring.

But one thing is for certain, it would fetch far more than the \$60,000 the lease proposes, (or the \$30,000 for 25 years) and would bring in tax revenues forever. And it would keep government out of the free enterprise system.

## The Indian Crick Gang: Part One

Because my parents ran the weekly newspaper in the small town where I grew up, I usually reported there after school instead of riding the school bus home to the farm. That took me out of daily contact with "farm kids." Because I spent so much time in town, I formed new relationships. That's how I became a member of the Indian Crick Gang.

The group varied in size from three to a half-dozen members, all of us in the 12- to 13-year-old range. During the approximately two years it existed, the gang operated under some very basic guidelines. There wasn't any initiation. There weren't any dues. There weren't any rules except for an unspoken vow not to share any top-secret information with outsiders, male or female. Jerry was the unofficial leader of our group, and the instigator of many of our adventures. Jerry's father was the city maintenance man. As a "town kid" Jerry was more street-wise. He had explored every unoccupied building in the community long before our group formed. He was a walking encyclopedia of useful information. Jerry knew what was stored in the sheds along the Union Pacific siding on the south edge of town. At one time he even had a master key to several railroad padlocks. He also could tell you what was in every cupboard and closet in every shack, shed and barn within a mile of our community. Gary was a year younger than the rest of us. His mother operated the local restaurant and his dad ran the Texaco station across the street from my parents' newspaper. Like me, Gary actually lived out in the country but spent most of his afternoons, evenings and weekends in town. That made him a perfect recruit. The fact that there were tools and space available at his father's garage for us to work on some of our more ambitious projects didn't hurt his standing either.

Butch was a late arrival to the group. His mother and father operated one of the three grocery stores in town. Butch's family moved to the community from Boise during our final year of elementary school. Because he came from the city, we tolerated the fact that he often showed a lot more interest in members of the opposite sex than seemed appropriate for a dedicated gang member.

There were other youths who sometimes participated in gang activities. But most weren't privy to major secrets.

We never considered ourselves members of an organized

We drew much of our inspiration from that small stream that wound along the southern boundary of the community.

In the summer, we swam and fished in the creek or navigated it on inner tubes or homemade "barrel boats." We knew every bend, wiggle, rapid and riffle along a sevenmile stretch of the stream that began at the "Big Eddy," near Gary's house and ended where the water flowed into a manmade canal after exiting a lava rock-lined passage commonly referred to as "The Gorge."

Although our group was a "gang" of sorts, the term had a different meaning in those days. We never tried to intimidate other kids. And although we did do a certain amount of snooping on other people's property, we never vandalized or stole anything. Well, almost never. There was the incident involving three live hand grenades discovered hidden in a dilapidated shed.

But there were extenuating circumstances, and that's another story.


Many Homedale citizens are concerned about the city's recent proposed lease agreement with a local businessperson. The city has offered to lease seven acres to an existing business in our area for \$100 per month for 50 years. When discovering this was illegal, they changed the lease to 25 years. The lease is not signed yet and can still be stopped.

Is the deal ethical? The mayor and a city councilman were in discussions with the business before the land was actually purchased. The mayor and a councilman admitted this. Why was one person chosen to receive this spectacular deal? The ethical thing to do would have been to put this land up for bid instead of give preferential treatment to one individual. Most local businesses are feeling the growth and need to expand.

Is the deal in the best interest of the taxpayers of Homedale? The land is worth \$250,000 commercially. The city would stand to make a profit of over \$200,000 if they sold the land. The owner of a national retail chain has said he would have paid the city \$2,000 per month for 20 years with an option to buy. The \$100 per month to be paid would not even cover the loss of property taxes the city would take on the deal. Without much effort, the city could get a lot better return on their investment for the taxpayers they represent.

One hundred percent of the citizens of Homedale that have spoken to us think this is a rotten deal. The next city council meeting is 6 p.m. on May 25. If you feel the taxpayers of Homedale are being cheated and \$100 a month lease is outrageous, attend the meeting and let your voice be heard. Let's have expansion pay for itself, not the taxpayer.

# **Accuracy in Media** A smelly NSA 'scoop' at USA Today

Harry Jaffe of The Washingtonian has written that USA Today reporter Leslie Cauley's story about how the National Security Agency (NSA) collected "average citizens' phone records from their telecommunications companies, like AT&T and Verizon," was a real "scoop." He says other papers have been scrambling to keep up, and that USA Today has arrived on the national scene with this blockbuster. But it looks like Jaffe — and USA Today — may have gotten the basic facts wrong. The USA Today story, based entirely on anonymous sources, has been seriously challenged.

We should be asking: a scoop of what? Something about this scoop doesn't smell right.

Cauley is quoted by Jaffe as saying that her NSA story "further validates the use of confidential, unnamed sources. They have a real value in our business." Well, not so fast. Verizon has released a statement noting that "One of the most glaring and repeated falsehoods in the media reporting is the assertion that, in the aftermath of the 9/11 attacks, Verizon was approached by NSA and entered into an arrangement to provide the NSA with data from its customers' domestic calls."

There is no doubt as to what the statement is referring to. The Cauley story claimed that the NSA's "domestic" program targeted the calls of "ordinary Americans." She alleged that the NSA was collecting "domestic call records" involving "calls that originate and terminate within U.S. borders." But these assertions are now in question. The Associated Press reports that BellSouth Corp. has made a similar denial of the main essence of the Cauley story.

Haven't we seen this kind of thing before? The controversy over the USA Today story suggests, once again, that the media have rushed into print with something that looks bad, in order to concoct a scandal for the Bush administration and drive down the approval numbers of the president. This is getting to be old hat for the liberal press. During a time of war, our major papers have, time and time again, seized upon an alleged secret activity in order to make it appear as though it's the Bush administration — not the terrorists — that we need to fear. The key to this approach is trying to convince the public at-large that the Bush administration is out to get them.

If the USA Today story had been written to suggest that records of international long distance calls involving al-Qaida operatives were being collected by the NSA in order to identify their U.S. domestic contacts or cells, there would have been no story of any concern to those who want to win the war against terrorism. That may be why it was made to suggest that John Q. Public's innocent phone call to the local pastor or baseball coach was at risk of being monitored.

It appears the basic flaw in the story, as suggested by the entire Verizon statement, is the assumption that phone companies passed along records of local calls to the NSA when the company says such records may not even exist in most cases. International phone calls involving suspected terrorists and their contacts inside the U.S. are a different matter.

We know, because of the fallout from the original James Risen/Eric Lichtblau New York Times story about the NSA program, that the purpose of the effort has been to monitor contacts between al-Qaida operatives here and abroad. Of course, that's not the way the Times portrayed it. Like Cauley of USA Today, the Times suggested that the NSA was monitoring "domestic" calls involving ordinary people. However, in a follow-up story on Dec. 24, Risen and Lichtblau alleged that the NSA was also tracing and analyzing "large volumes of telephone and Internet communications flowing into and out of the United States." They said U.S. telecommunications companies were helping the effort but didn't name them.

USA Today not only named them but alleged that domestic phone records involving millions of Americans were being turned over. This is the sensational aspect of the story that has been challenged by some companies said to be involved.

This is the media template that has been developed: distort and sensationalize an ongoing intelligence operation into something that threatens or scares the daylights out of John Doe. We saw the same approach in the infamous Dana Priest Washington Post story about CIA "secret prisons." If she had written a straightforward story about the U.S. government secretly apprehending and detaining terrorists, the reaction by the public would have been a yawn or a hallelujah. But to claim the government was maintaining "secret prisons" or even Soviet-style gulags, as she implied, took the story to a more sensational and frightening level. It made the Bush administration look worse than the terrorists. The trouble is, nobody has been able to confirm the "secret prisons" exist. It is of no concern to the Post, of course, because Priest has already won her Pulitzer Prize.

USA Today, which was supposed to have a tighter policy on the use of anonymous sources under editor Ken Paulson, may have another scandal on its hands with the Cauley NSA story. Many forget that USA Today ran with the same phony documents on President Bush's National Guard service that got CBS News and Dan Rather into trouble and led to firings. USA Today was anxious to get into print because it knew that CBS was running the story. The paper ran follow-up stories about how it was fooled but never apologized to readers.

In the NSA controversy, USA Today has no phony documents, only anonymous sources and official denials from some companies. Ironically, this is happening under editor Paulson, who took the helm in the wake of the Jack Kelley scandal at the paper. Reporter Kelley was a serial fabricator whose anonymous sources turned out to be nonexistent.

If the USA Today story about the NSA is going to hold up, the paper will have to produce some hard evidence, not more anti-Bush drivel from "sources" whose information now looks questionable if not false.

Looking even more foolish are the politicians who jumped on the story as if it were true and demanded hearings on the matter. Sen. Patrick Leahy (D-Vt.) even brandished a copy of USA Today, as if it were the Gospel. He must have forgotten about the paper's use of the fake Bush National Guard documents.






