## Trojans' Emry just warming up

Sophomore looks strong in followup to second place in 2006 3A state meet

In many regards, it's a shame that the Homedale High School track and field team has just one home meet this season. Fans will have to wait until the April 24 Snake River Valley conference championships to watch the

Trojans christen their new all-weather track surface, complete with distinctive lane markings. But the real crime might be that anyone wanting to see one of the best young high-jumpers in the state will have to hit the road to catch a glimpse

of sophomore Austin Emry. Emry cleared 6 feet, 2 inches at the March 27 Weiser Invitational. He swept all three jumping events with impressive numbers. And, judging from last year's performance — in which he finished second in the state meet with a high jump of 6-0 — Emry probably is just getting started this season. He logged some of the best mea-

surements of his career during a winning performance at Nampa Christian on March 15. Emry won the high jump with a personal-record 6-5, and soared to a 40-11 mark to capture the triple jump. According to Athletic.net, his best triple jump was a second-place showing of 41-7 in May at the Canyon Count Classic.

The sophomore's next action comes Friday in the Lions Invitational in Nyssa, Ore.

But Emry isn't alone on coach Thomas Thomas' boys team. Several Trojans pulled off top-five finishes as Homedale captured second place in the team competition at Weiser.

Emry's 6-2 performance in the high jump led a Homedale sweep of the top three spots. Junior Aus-

tin Ferguson was second at 6-0, and senior Matt Holloway cleared 5-10 for third.

Trojans captured three of the top four spots in the long jump. Emry won with an effort of 20-8, while senior David Liddell continued an impressive rookie season by finishing second with a jump that was 1 inch shorter than his teammate's winning leap. Senior Mark Vance was fourth at 19-9½.

Emry and Vance went 1-2 in

the triple jump. Austin missed his personal best by two inches when he hit the 40-0 mark. Vance soared 39-4¾.

Liddell finished second in the 100 meters (11.19) and third in the 200 (23.66).

Freshman Jake Tolmie ran a 2:13 to nail down fourth in the 800, and he ran the opening 200-meter leg of the sprint medley relay as the Trojans finished fourth in 4:07.5.

Sophomore Tyler Gibson (200), Ferguson (400) and junior Eric Engum (800) also took part in the race.

More youngsters shined for the Homedale girls in Weiser, with triple-jumper Annamaria Salas grabbing the highest Trojans finish. The sophomore was third with a try of 31-5½.

Senior Sarah Black finished fourth in the pole vault (7-0), and freshman Kindra Galloway was sixth in the 100 (13.99).

## Trojans' new coach ready to take next step

### Stragey accepts first varsity head coach job with PRIDE in mind

Kirt Stragey has a strategy when it comes to the Homedale High School girls soccer team.

The Trojans' new coach is determined to pick up where the program's original coach, Lesa Folwell, left off — the drive for a junior varsity team and the creation of a developmental pipeline.

"I plan to build a program that is built on PRIDE as well as spark enough interest in the girls to have a junior varsity team and eventually have some form of involvement from the middle school girls," he said.

PRIDE is a acronym as well as an attitude for Stragey. It stands for Purpose, Respect, Improvement, Discipline, Excellence.

Athletes in the Homedale program have been purposeful in their drive to improve. Last year, Folwell's charges collected the first overall victory and the first Snake River Valley conference win in the program's three-year history.

"I expect within a season to have the girls use their potential and abilities to bring their team to a competitive level," Stragey said.

Stragey embarks on his first varsity head-coaching assignment. He was head coach at Pioneer Middle School in Wenatchee, Wash., for seven years.

His other coaching experience includes two years as a varsity assistant at Wenatchee High School and three years as the Panthers' top junior varsity coach.

Stragey also coached softball and basketball at the middle school level in Washington.

Stragey, who is an optician and general manager for a local America's Best Contacts and Eyeglasses franchise, and his wife moved to Boise five months ago. The coach said that making the

move further west to Homedale isn't out of the question.

"I am very excited to be working with the Homedale High School soccer program and the community involvement," he said. "Together, we should make a positive impact with the girls."

The coach seems to have the right mindset to take over a team that still is getting used to being on the winning side of a score.

"I believe that being a part of a team is a learning experience," Stragey said. "A player must learn to compromise, comfort, celebrate and work through victories and losses together with her teammates."

As far as on the field, Stragey's philosophy is similar to that of his predecessor. The bottom line for Folwell was you can't score if you don't have the ball, and Stragey said he coaches a possession style of play based on a traditional four-forward, four-midfielder and two-fullback set.

The theme of pride is more than an acronym for Stragey. It also defines what an athlete in his stable should project for her school and town.

He comes from a Wenatchee soccer program that consistently received Big Nine scholastic awards. The squad had the best grade-point average in its league at 3.70 the same year that the Panthers led the league in all-conference selections, he said.

"I feel there should be a desire to do her best on the field, but to also bring her best to school, home and the workplace," he said.

"The coach is there to lead the individuals to feel successful, and working together as a team can lead to the most incredible successes."

## 25 years ago

### March 31, 1982

#### Bahem, Davis, Stanford to seek commissioner slots

Both county commissioners whose terms will be up next January plan to seek re-election.

Don Davis and Ernie Bahem each said recently they plan to file as a candidate for re-election.

Davis will be running for a four-year term and Bahem, a two year term.

Davis, a rancher from Bruneau, has been county commissioner of District three from 1965-1968, and again from 1971 to the present. He will run as a Democrat.

Bahem, also a rancher, lives at Flint Creek, east of Jordan Valley, and has served district one for four years. Bahem, a Republican, will be challenged by Jerry Stanford, also a rancher, and also a Republican.

Petitions for county and state offices must be filed between April 1 and April 7.

Jerry Stanford will challenge the incumbent in Owyhee County Commissioners District 1. He will be running on the Republican ticket against incumbent Ernie Bahem in the May primaries.

Stanford, who visited the Chronicle office Monday, said he feels the taxpayers came out short on the paving project in the Pleasant Valley area, and feels he can do a better job of management.

“One thing I will promise,” Stanford said, “is to keep the public informed of what the county is doing.”

Stanford, a rancher on Cow Creek, is married and has five sons, ages 17 to five.

#### HS rodeo at Homedale this Saturday

A District II qualifying High School rodeo will be held at the Homedale Fairgrounds arena this Saturday, April 3, beginning at 12 noon. It will include the girls’ five standard events — pole bending, barrel racing, goat typing, bareback riding, calf roping and a mixed team roping event in which both girls and boys may participate.

The boys’ events will be — saddle bronc, bareback riding, bull riding, steer wrestling, calf roping and the mixed team roping event.

This is the third District II qualifying high school rodeo to be held this year but the first to be sponsored by the Idaho Girls Rodeo Association. The two prior were held in Kuna. All Around buckles will be awarded and those qualifying with enough points from the District rodeos will go on to compete in the State or National finals.

There will be an admission charge of \$1.50 for adults, 50 cents for 12 and under with under 6 admitted free. Concessions will be served.

#### July 4<sup>th</sup> celebration being planned at Homedale

A demolition derby will highlight the July 4<sup>th</sup> celebration at Homedale this year, according to Fred Sarceda, spokesman for the Homedale Lions Club.

Sarceda met with the Homedale Chamber of Commerce last Tuesday, and said the recently reorganized Lions Club plans the auto racing event at the Owyhee County Fairgrounds. The Fair board has approved the event, he said.

Sarceda asked the Chamber and other organizations to help with the Independence Day celebration. “We’re hoping to help the Jaycees purchase fireworks,” he said. Other plans include food booths, refreshments stands and kids and adults games. He suggested the Chamber consider sponsoring “Anything Goes,” as it did a few years back.

“We want this to be a community-wide effort,” he said.

Last year was the first year Homedale Jaycees did not sponsor a fireworks display. The lack of funds in the club was the reason the night-time display was curtailed.

Chamber members voted to help with the effort, and Sarceda was asked to contact Hal Tolmie, the Chamber’s chairman of the Fourth of July events.

In other business the Chamber discussed a city-wide retail promotion, suggesting sidewalk sales, “crazy days,” and other possibilities. No action was taken.

## 140 years ago

### March 30, 1867

HUNGRY and thirsty citizens and wayfarers are requested to read the “Notice” in our advertising columns of the New State Hotel and Poorman Saloon in Ruby City. Mr. Hult is prepared to furnish excellent meals and regular board and most excellent lodgings; and “Pete” of the Poorman Saloon has tiptop liquors and wines and a neat and orderly place to drink them. Conveniences for quiet games of “pitch,” crib, whist, etc.

THE SITUATION. The recent Indian murders and thefts have given rise to much talk as to what ought to be done. In all troublous times, every man will have an opinion on the subject. Gen’l Crook’s understanding and efforts on the matter are probably as nearly correct as those of any man. Detached bands of savages are liable at any time to make cross raids in spite of the best disposition of troops and the utmost vigilance, as long as any red men are left. There is no doubt but the severity of the winter has retarded operations to a much greater extent than could have been anticipated. If a large band could be found and cleaned out in the vicinity of the Malheur retreats, it would most favorably affect the safety of this community, and that object has been tried to be grained with praise worthy vigor.

Troops have not been idle. Movements have been rapid and advantageous. When the news reached Fort Boise road, a detachment of twenty-three men were started with ten days rations, and in less than twenty-four hours had reached the scene of the depredations — a distance of about fifty miles. There is not lack of activity and forcible direction among the troops in this Department. While buck Indians remain at large, atrocities will be committed. It is understood that three more companies will be sent to Idaho for duty. The recent murderous raid is not so much a sign of increased hostilities as those of one year ago when a hundred instead of a dozen perpetrated thefts and murders.

THE COUNTY COMMISSIONERS meet in regular session next Monday. We are informed that bids for feeding, nursing and generally caring for the indigent sick will be considered if offered. The old methods of letting this, that and the other person give them a haphazard care, and present bills lacking uniformity for such service, must of course give the Commissioners much vexatious labor, and in a majority of instances their decision will be unsatisfactory to the claimants. The bid system, if adopted, would at once fix the cost for a certain period; and the system is less liable to abuses than any other where the County Physician has a stated salary, for he would not likely give attendance and medicines to any person not in actual need of them. It would be against his interest to countenance giving public care to any one whose financial or physical ability is sufficient for self-support. The bid system ought to be adopted with all prudent guards against abuse of it.

WE HAVE VERBAL reports that twenty-two head of cattle were stolen from Mr. Ray, on Reynolds Creek, last Monday evening; also, that a cow of his had been killed on Saturday evening not far from his ranch.

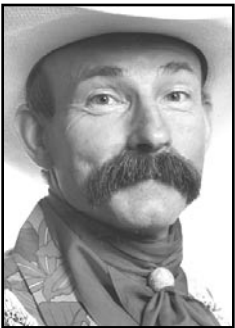

## From Washington FY ’08 budget creates perilous ripples

*All you need in this life is ignorance and confidence; then success is sure.*

— Mark Twain

Last week, Mark Twain’s words rang true in Congress. The confidence with which the majority of the U.S. Senate passed its Fiscal Year 2008 budget resolution corresponds directly with the level of ignorance as to the hard facts of revenue, spending reduction and tax relief that we’ve seen over the past four or five years. Without a wake-up call in conference committee debate, this “success” will result in abject fiscal failure for the federal government and for American families.

As a member of the Senate Budget Committee, I was dismayed to see the destruction of years of hard work that created five consecutive years of economic growth and more than 7 million new jobs, increased federal revenues by nearly \$300 billion over non-partisan estimates by both the Bush administration and Congress, and will result in a projected budget deficit this year equal to 1.6 percent of Gross Domestic Product as compared to 3.6 percent in 2004. The reality of spending increases will inspire significant and severe economic burdens down the road. This budget is not good for Idaho or America.

The FY 2008 Senate Budget Resolution authorizes a massive tax increase to cover \$150 billion in new spending and \$2.2 trillion in new debt over the next five years. Tax increases include no long-term fix for the Alternative Minimum Tax (AMT). The Congressional Budget Office estimates that it soon will be less expensive to repeal the regular income tax than the AMT. In three short years, tax rates on investments (mutual funds, maybe even 529 college savings plans) that middle-class families have made will skyrocket — not good news when tax time approaches,

not to mention an utter disincentive to invest hard-earned money. Come tax season in four years, a family of four earning \$50,000 will experience a 132 percent tax increase — a liability of more than \$3,600. Low-income taxpayers will pay 33 percent more, the child tax credit will be cut in half, married couples will be penalized and 15 million senior citizens will see taxes increase. All of this, incidentally, will coincide with fiscally unmanageable entitlement programs:

The budget resolution contains no mechanism whatsoever to control entitlement (Medicare, Medicaid, Social Security) spending. When we face the reality that in 10 years entitlement spending will consume nearly 70 percent of the federal budget, ignoring it today is nothing short of astonishing.

When you look beyond the next 10 years, the fiscal picture worsens. Government estimates show that we promise our children and grandchildren \$32 trillion in Medicare spending over the next 75 years with no payment mechanism. In his budget request, President Bush proposed a modest \$70 billion reduction in the growth of Medicare. This modest

reduction, which would affect only the wealthiest 5 percent of beneficiaries, actually would remove \$8 trillion of this \$32 trillion unfunded liability. Unfortunately, Senate leadership chose not to include provisions that would even pay off one dollar now of this astronomical future debt. One might call this the “Wimpy approach.” Fans of Popeye know that his friend, Wimpy, goes through life saying, “I will gladly pay you Tuesday for a hamburger today.” Unfortunately, this Congress has chosen to continue eating hamburgers today, while leaving a \$32 trillion (that’s one thousand billion 32 times) tab to be picked up by future generations on future Tuesdays.

I’m reminded of something Laurence J. Peter, author and educator, once observed: “Against logic there is no armor like ignorance.” Congress arms itself with ignorance at our nation’s financial peril.

## Owyhee Initiative

### A new tradition of cooperation dawns in the West

We were on Capitol Hill recently, meeting with members of Congress about the Owyhee Initiative. One of our aims was to explain what this public land management reform effort shows about how things can get done in the West today. We pointed out that westerners have a long tradition of meeting and overcoming challenges. In the old west, arguments were sometimes settled quickly, by the person with the faster draw. Over time, gunfights gave way to lawsuits. The competing sides in disputes over recreation, range management or wilderness stood their ground and fought hard, but flying bullets were replaced by tense words and often thoughtless commentary with neither side willing to give an inch. For all of the heat generated, those decades of confrontation got us nothing but stalemate or deep divisiveness, because for one side to win, the other side had to lose.

In our complex society, we manage to progress only because of the genius of the Founders who designed an American political system that is not about declaring winner-take-all, but about working out reasonable accommodations. We went to Washington, D.C., to explain how our predecessors on the Owyhee County Commission invited ranchers, conservationists, local Tribal representatives, motorized interests, as well as other interested parties, to see if we couldn't find a better way, to resolve the tough resource issues gripping our once nearly empty corner of Idaho.

We once believed we were so rural that we would simply be ignored by the growth that has come to every attractive

city and small town in the West. We were wrong. Others, with a federal judge in their pocket, attempted to dictate how the federal lands in our county were to be used. In short, it looked like we were in for more ugly shootouts-by-lawsuits.

Instead, the county commissioners brought together the various stakeholders. That was in 2001. Now, after thousands of hours of meetings, we have forged an agreement that, while it does not award an out-and-out win to any side, offers important concessions to each.

Recently Sen. Mike Crapo (R-Idaho) put "the plan" before the new Congress in the form of legislation. This is not the end of the story. These diverse groups will continue to meet to fine-tune the plan. Congress and its

expert committees will add their own ideas. Other groups who were not at the table will want to have their say. It will be interesting to see which of these groups will choose to engage in the conversation with Congress, and which just decide file a lawsuit.

In some ways, the best outcome is that we've all holstered our six guns. The parties involved have learned to be a lot more respectful in how we treat each other. Sure, there are folks who still find fault with our plan. There will always be those at the extremes of both the right and the left who can never be satisfied, but the combined efforts of those engaged in the process will lessen their vitriolic impact.

We believe the Owyhee Initiative will be good for Owyhee County. Good for families here now and their kids in the future. Good for our economy, providing certainty and helping to sustain a way of life treasured by our constituents. Good for the land, helping connect and protect wilderness areas and wild rivers. And good for hunters, river-runners, responsible off-road vehicle users and other recreational visitors. Old and new westerners are finding better ways to solve problems. It is all about people who care enough about our land and resources to sit down in good faith, air our differences and look for common ground.

We don't always agree but we can disagree and still be friends because ultimately we all want to get from here, to there, without a gunfight.

### Water summit begins much-needed process

It's no secret to anyone who spends more than five minutes with me that water is one of my favorite topics. Probably more than a few of you have heard me talk about the fact that our space program sends probes halfway to God, and the first thing we look for is water. And few people here on Earth know more about its importance than Idahoans. Our economy and our way of life depend entirely on its management, protection and wise use.

Stakes that high make it natural that so much attention is focusing on the Water Summit I proposed during the campaign. The Idaho Supreme Court's March 5 ruling that the state has authority to manage ground water and surface water as a single resource cleared the way for that summit to occur.

The Idaho Department of Water Resources and my staff have been working hard the past few weeks to put the summit together. I'm happy to announce that it will occur April 17 in Burley, and that a list of principal and

supporting participants in the negotiations is on its way to completion. I will be personally involved and will do my best to ensure the summit is a success.

However, that begs the question of how success should be measured.

It is critically important that the summit not be seen as an end in itself, but rather as an important starting point to a continuing process. The results of the April 17 meeting may not seem dramatic to the public, but the fact that so many diverse interests share a commitment to finding solutions is itself groundbreaking.

Many of the issues involved in managing Idaho's limited and precious water resources have been debated and

litigated for decades. I am more realistic than to believe they can be resolved in a single day. However, I will make it clear to the participants and the public that we cannot go forward with the status quo.

Whatever solutions eventually are reached likely will not please everyone involved. But what I seek is public policies that work. In my view, understanding and accepting that premise will go a long way toward success.

You might say April 17 will be a watershed day in the history of Idaho water policy.

I am very hopeful, but more importantly I am determined, and committed to reaching both near-term and long-range solutions.

As Winston Churchill said in November 1942 after the British defeated the German Afrika Corps in Egypt, "This is not the end. It is not even the beginning of the end. But it is, perhaps, the end of the beginning."

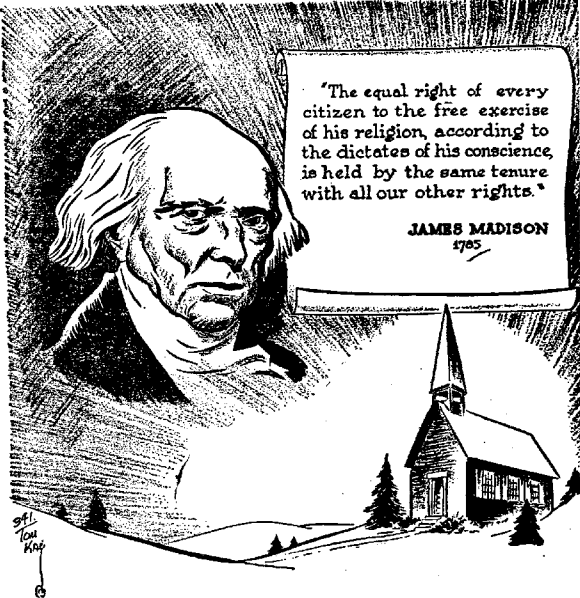

Effective January 26, 2006, the US Environmental Protection Agency reduced the drinking water standard for arsenic from 50 parts per billion (ppb) to 10 ppb. One well supplying water to the City of Marsing, Well #3, has an arsenic concentration of 11 ppb, which exceeds the Maximum Contaminant Level set forth by the EPA. The City of Marsing is required to provide quarterly public notice of this exceedence. You will continue to receive this notice every quarter until such time as the City is notified by IDEQ the notice is no longer required.

Arsenic is a naturally occurring element thought to enter the water source from contact with natural rock formations. Arsenic can cause adverse health effects, including cardiovascular disease, diabetes mellitus, skin changes, nervous system damage, and various forms of cancer.

The City of Marsing is taking action to remove the well as a source of water for the water system. As you may be aware, the City is in the process of upgrading the municipal water system, and a new well to serve the system, and replace Well #3, will be first item completed for water system upgrade project.

Effective January 1, 2006 the US Environmental Protection Agency reduced the drinking water standard for Arsenic from 50 parts per billion (ppb) to 10 ppb. The two Well’s supplying water to the City of Grand View and/or Grand View Water & Sewer Association, Inc. was tested on February 14, 2007 and has an Arsenic concentration of 0.01 ppb, which is at the 10 ppb

Maximum Contaminant Level (MCL) set forth by the EPA. This is considered to be at the exact level of the federal drinking water standard. Although this is not an emergency, you have a right to know what is happening, what you should do and what your water company is doing to continue to keep in compliance. The City of Grand View and/or Grand View Water & Sewer Association, Inc. are still required to provide quarterly public notice of this excess EPA standard Arsenic level. Until such time as Idaho Department of Environmental Quality (IDEQ) notifies the City that this notice is no longer required you will continue to receive this notice quarterly.

What happened? Arsenic is a natural deposit occurring element thought to enter the water source from contact with natural rock formations.

What health effects? Arsenic can cause adverse health effects, including cardiovascular disease, diabetes mellitus, skin changes, nervous system damage, and various forms of cancer.

What is being done? The City of Grand View and/or Grand View Water and Sewer Association, Inc. is taking action with City and/or W/S Engineering Firm – Holladay Engineering Co. with an engineering study. A Draft for a plant removing the arsenic from the City Well’s has been presented to the City of Grand View, Grand View Water

& Sewer Board, and DEQ. DEQ has reviewed this Draft and have sent a response letter. Public Works Supervisor - Robert L. Servis, Holladay Engineering Co., - Andy Gehrke and City Clerk - Helana Race have gathered the requested information and mailed it to DEQ. The next step will be a Public Hearing. Planning Grants have been applied for and two accepted. These monies will be received soon. The City of Grand View and the Grand View Water & Sewer Board agreed to work with USDA-RD Representative David Flesher for loans and grants to pay for this project.

What should I do? It will be each citizen’s choice to use alternative drinking water (e.g., bottled) or drink City of Grand View water. However, if you have specific health concerns, consult your Doctor.

For more information, please contact Grand View City Hall - Monday, Tuesday or Wednesday from 8:00am to 5:00pm, lunch 12:30 to 1:30 – Closed all major holidays or call (208) 834-2700 or you may contact Tiffany Floyd or Steve Stauffer at the Boise DEQ office 373-0550.

Please share this information with all the other people who drink this water, especially those who may not have received this notice directly. The City of Grand View has notified owners of properties to supply copies to their residence. (For example, people in apartments, manufactured home parks, businesses and schools) You can do this by posting this notice in a public place or distributing copies by hand or mail.
