Young wrestlers leave their mark in IF

Homedale youth wrestlers came away with six state championships in a tournament held during the weekend in Idaho Falls.

According to Homedale High School wrestling coach Toby Johnson, four of the titles came in the freestyle discipline, while two others were earned in Greco-Roman.

Andy Montes grabbed a state title in both freestyle and Greco-Roman.

Other freestyle champs included Spencer Fisher, Nash Johnson and Liam Condon. Adam Campos grabbed Homedale's other Greco-Roman state crown.

In all, eight Homedale wrestlers reached freestyle weight class championship matches. Dalton Trevino, Trent Smith, Noah Free love and Dawson Willis came home with silver medals.

Devin Fisher, William Cole and Mariah Jenkins finished third in their respective freestyle weight classes. Adam Campos also reached a third-place match, but had to settle for fourth place because of an injury default.

Chaney Wade and Joel Campos finished sixth in their divisions, while Devin Schoonover and Tano Montes were seventh-place finishers.

On the Greco-Roman side, three other Homedale wrestlers reached title matches with Nash Johnson, Noah Free love and Devin Fisher all pulling down runner-up finishes.

Marsing boys capture Horseshoe Bend meet

Marsing High School track and field athletes collected four victories during the 2A Western Idaho Conference meet last week at Nampa Christian, then the Huskies' boys squad followed that up with a team victory at the Mustang Invitational on Saturday in Horseshoe Bend.

During the April 29 2A WIC meet in Nampa, Natalie Evans, Tyson Heller, Elisa Moreno, and the boys 4x200-meter relay team scored event wins.

Evans, Heller, the 4x200 team, and the 4x100 team notched event wins at the Mustang Invitational in Horseshoe Bend on Saturday.

Marsing's boys team came away with its first meet championship of the season at the Mustang Invitational, and the girls team finished tied for fourth place in the meet, which featured 16 1A schools along with the 2A Huskies. The boys scored 93 points, 15 points ahead of meet runner-up Raft River, while the girls tallied 58 points along with Cascade, trailing Raft River, Lapwai, and Horseshoe Bend.

"We had an awesome day Saturday," Huskies coach Don Heller said. "All the kids did well, and the boys won their first meet."

At the 2A WIC championship,

Sweet shot an 82, leading seven golfers who broke into the 80s.

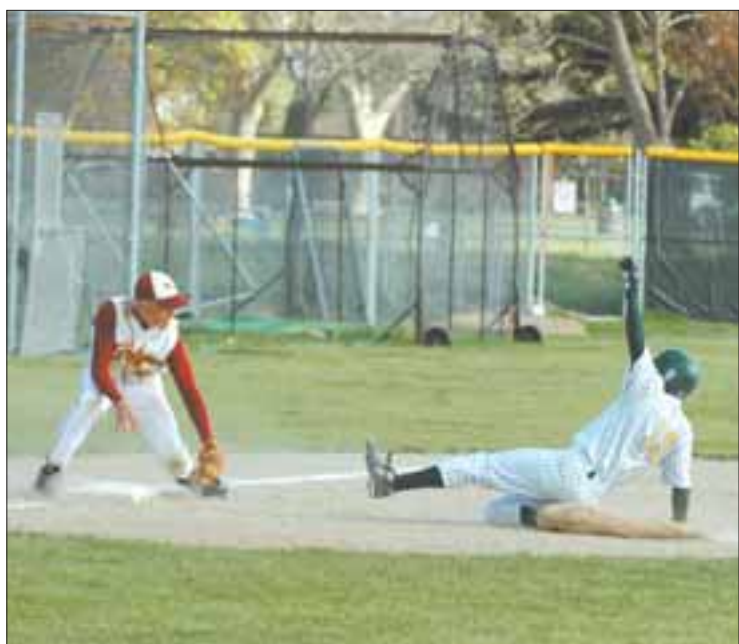
"On a course we only see once a year, there were seven scores in the 80s, and our guys had three of them," Thompson said. "All in all, a good effort."

Red-hot Rimrock rides wave into district baseball tourney

Raiders steam through conference
in search of return ticket to State

Even with a forfeit on its record, the Rimrock High School baseball team looks to be in pretty good shape with the 1A District III Tournament looming.

"The season has been working out very well this year," veteran Raiders coach Bob Murray said. "We are happy to be in the position we are in with one conference game remaining."

That remaining conference game was played in Wilder on Tuesday. Results weren't available at press time.

Having won five of six 1A Western Idaho Conference games heading into the week, Rimrock (7-4 overall through Monday) most likely will pick up the top seed for the district tournament, which begins Thursday in Wilder.

District semifinals will be played at 1:30 p.m. and 4:30 p.m. Thursday, with the winners qualifying for the 1A state tournament in Lewiston. The district championship game is scheduled for 4 p.m. on Monday.

"Hopefully, we are one of

those teams (to reach State)," Murray said after the Raiders pounded Horseshoe Bend, 18-1, on April 28. "If we keep playing the way we do, there should be no problem."

Prior to blasting Horseshoe Bend, Rimrock was forced to forfeit an April 22 conference game to Greenleaf Friends Academy because of a lack of players. Murray characterized the reason for his depleted roster as "some disciplinary actions."

Murray's optimism for the remainder of this season and for 2009 is stoked by what he has

The Antelopes scored the game's first 12 runs and led 12-1 after the second inning.

"Twelve runs were the most we had scored all year, and after losing to Greenleaf (earlier) by a score of 8-7, we knew that they could certainly come back," Adrian coach Kevin Purnell

said.

But Blake Purnell mastered the Grizzlies, allowing only three walks and getting dinged with an unearned run in the second inning.

"It was nice to pick up another win, and we were able to limit our errors," Kevin Purnell said.

Blake Ishida went 3-for-5 and scored three times from the leadoff spot against Greenleaf. It was deuces wild for Jose Arreola and George Ellsworth, who both had two hits, scored two runs and collected two RBI.

Adrian took advantage of eight Greenleaf errors, while the Antelopes committed only two miscues.

Big rally carries Raiders

Powerful bats

The Rimrock High School softball team split a conference doubleheader Thursday in Council.

Three players — Shelby Chandler, Brittany Boman and Jackie Thurman — went 3-for-4 to lead the Raiders to a 12-5 victory over the Lumberjacks in the first game.

Boman paced the offense with a monster game. She knocked in five runs and scored runs in the fourth and fifth innings. She smacked a base-clearing triple in the fifth inning and scored on Thurman's sacrifice fly as the

Raiders rolled out to a 9-2 lead.

Shoni Gennette snapped a 2-2 tie with a two-run single in the third.

Rimrock's offense disappeared in the second game as Council rolled to a 13-3 victory in five innings.

The Raiders trailed 7-0 when coach Mike Chandler's squad broke through with three runs in the fourth inning. The rally was triggered by three consecutive hits before the first out was recorded. Sadie Timmons and Boman both singled before a double by Thurman. Thurman eventually scored the third run for Rimrock.

Council scored 13 times on eight hits and five walks against Shelby Chandler.

H. Bend 13, Rimrock 7
Lee Gray tripled and scored

on Laura Smith's base hit in the second inning as Rimrock started hot in a 1A WIC game played in Horseshoe Bend.

But the Mustangs scored four times in the bottom of the inning and tacked on six more in the fourth to wrest control of the game away from Rimrock.

Shelby Chandler was 3-for-4 with three RBI, but Rimrock rarely cashed in on its chances. The Raiders had 12 hits and drew six walks.

The Raiders led, 2-0, in the top of the second when Gray and Smith scored. Shoni Gennette had the inning's third straight hit to spark her 2-for-4 afternoon.

Rimrock scored four times in the fifth inning, utilizing a two-run double from Chandler and singles by first baseman Brittany Boman and second baseman Jackie Thurman.

Fishing report *From Idaho Fish and Game and Oregon Fish and Wildlife*

C.J. Strike Reservoir

Yellow perch have spawned and fishing for them has slowed. Bass are beginning to become more active with warmer water, crappie fishing can be good but it is off and on. Trout fishing has been good fishing bait off the bottom.

Note — Idaho Power continues construction work on some of its facilities at the reservoir, and work will go on for at least a year in some places. Anglers will find temporary closures in several areas as work proceeds.

Snake River

Channel catfish — Cats are beginning to show up near Loveridge Bridge, but fish are still few and far between.

Smallmouth bass — Some nice bass measuring 14 to 15 inches have been caught below CJ Strike by perch fishermen. For the time being, catch rates for bass seem to be better in the river than in the lake. Use the same lures and techniques as mentioned above.

Sturgeon — These fish have been hit or miss lately. One angler will say the fishing is excellent, the next might ask if there are any sturgeon left in the river. Patient folks should see a bite or two. Most anglers are using pickled herring or whole five to six-inch crappie.

Owyhee Reservoir

Largemouth bass, smallmouth bass, black crappie, catfish and yellow perch — The reservoir was

59 percent full April 20. The boat ramps near the powerhouse, at the resort, and at the day-use area are accessible. All other ramps are out of the water. Angling is slow.

Lower Owyhee River

Brown trout and hatchery rainbow trout — Angling for rainbow trout and brown trout is good. Flow was 243 cubic feet per second (cfs) on April 27.

Upper Owyhee River

Smallmouth bass and channel catfish — Spring runoff continues on the Owyhee River. Discharge at the Rome, Ore., gauge varied from approximately 1,900 to 3,100 cfs from April 23 through April 29. Angling for smallmouth and channel catfish is slow.

Trojans set for last track meet before hosting district finals

Emry clears 6-2 to win Grizzly high jump

The Homedale High School track and field team will tune up for the spotlight by entering the Canyon Classic at Vallivue High School on Friday.

The Trojans play host to the 3A District III Track and Field Championships beginning next Wednesday.

The seeding meeting for that meet is set for Monday.

Last week, Homedale participated in the Grizzly Invitational in Fruitland, with the Trojans finishing sixth in the coed event.

In boys competition, junior Austin Emry grabbed the high jump championship with an effort of 6 feet, 2 inches, while teammate Austin Ferguson cleared 5-10 for third place.

Sophomore Trent Acree captured second in the 200 meters, and was fourth in the 100 dash in 11.39 seconds.

Emry and Acree finished second and third, respectively, in the long

jump.

Zach Tolmie captured fourth in the 300 hurdles in 44.53 seconds, while Tolmie and Aaron Proferes were seventh and eighth, respectively, in the 110 high hurdles.

Daniel Valadez captured runner-up status in the boys shot put and finished fourth in the discus with a throw of 138 feet, 5 inches.

The Trojans finished sixth in the 4x200 relay in 1 minute, 41.24 seconds.

Homedale's medley relay team was clocked in a fifth-place time of 4:13.

On the girls side, Katie Holloway won the 100-meter hurdles in 17.33 seconds, and was sixth in the 300 hurdles in 54.52. Kindra Galloway grabbed fourth in the girls 100 sprint in 13.26 and was fifth in the 200 in 27.94.

Homedale's girls 4x100 relay team finished fourth in 53.96.

In the shot put, sophomore Nickole D'Alessio finished second with an effort of 33 feet, 7 inches. She was third in the discus at 100-5.

Rachel Wheeler nabbed second in the girls high jump, clearing 5 feet, while Annamaria Salas

finished second in both the triple jump (31-1) and the long jump (15-2).

Homedale resident, Kendra Graber, who attends Greenleaf Friends Academy, finished second in both the girls 3,200-meter run and the 1,600 at the Grizzly Invitational.

Two weekends ago, some of Homedale's most promising athletes competed in the YMCA Invitational at Bronco Stadium on April 25.

According to results posted on Athletic.net, junior Austin Emry won the frosh-soph high jump competition by six inches, cresting 6 feet, 6 inches. Emry is the defending 3A state champion in the high jump.

Emry also finished third in the frosh-soph long jump with a 21-1 effort.

On the girls side, junior Annamaria Salas soared 33-1 to finish fifth in the frosh-soph triple jump. She also placed 16th in the frosh-soph long jump final at 14-6½.

Sophomore Nickole D'Alessio was 11th in the frosh-soph shot put at 33-7. She placed 13th in the discus at 83-6.

Evans won the 800-meter run with a time of 2 minutes, 29.65 seconds, and was runner-up in the 1,600 with a time of 5:52.12. Heller scored wins in the shot put and discus, with throws of 47 feet, 6 inches and 144-7 respectively. Moreno was first in the 200, with a time of 28.09, and fourth in the 100 at 13.68. The relay team of Francisco Martinez, Ethan Sauer, Jose Paramo, and Joel Moreno won the 4x200 in 1:36.87, and finished third in the 4x100 at 47.06.

Martinez was also fourth in the 100 (11.84), while Moreno was second in the 400 at 53.03, Chaz Covey was runner-up in the 1,600 at 5:17.84 and the 3,200 at 11:32.48. The sprint medley team of Covey, Sauer, Paramo, and Heller finished second with a time of 4:11.62, while Sauer was second in the triple jump, leaping 36 feet.

For the girls, the 4x200 team of Jessica Freeman, Kelsey Granden, CC Zanardi, and Amanda Staudenmier finished second at 1:57.08, the 4x400 team of Evans, Moreno, Staudenmier, and Zanardi was also second, in 4:37.5, and Holly Heller placed third and fourth in the discus and shot put, respectively, with respective

throws of 89-05 and 28-09½.

At the Mustang Invitational, Evans won both the 800, in 2:30.52, and the 1,600, in 5:54.02. Tyson Heller took the shot put and discus, with throws of 49-3½ and 143-2, while the 4x100 and 4x200 relay teams placed first in 47.03 and 1:36.96.

Martinez was fourth in the 100 and 200 for the Huskies, running the events in 11.93 and 24.18, while Joel Moreno finished third in the 400 at 53.65, and Chaz Covey was second in the 3,200 at 11:10.55. The 4x400 and medley relay teams both finished second, with times of 4:09.21 and 4:10.78, respectively.

Elisa Moreno was third in the 100 for the Marsing girls, with a time of 13.34, while Holly Heller was fourth in the discus (90-9), and the 4x100 and medley relay teams each placed second in 54.15 and 2:08.62, respectively.

Rimrock High School's Ellie Cantrell won the long jump with a leap of 15-10, and placed second in the 100 hurdles at 17.75, and third in the 300 hurdles at 52 seconds, while the Raiders' Brian Simper finished second in the 1,600 at 5:04.28.

Homedale wraps up SRV baseball season

In what turned out to be the final 3A Snake River Valley conference game of the season for Homedale High School, host Payette slammed three home runs en route to a five-inning 16-2 baseball victory April 29.

The Trojans (4-18 overall, 2-6 3A SRV) trailed 10-0 after a first inning that featured five consecutive hits by the Pirates, a three-run homer from Matt Egbert and a two-run shot by Brad Pollock.

Homedale freshman catcher Jonathan Stacey singled and scored on Joey Cline’s fourth-inning double to give Homedale its first run. John Bittick singled later in the inning for the Trojans’ only other hit in the game.

Tyler Ford scored on an error in the fifth inning to wrap up Homedale’s scoring.

Cody Peterson led off the bottom of the fourth inning with a solo home run to cap the Pirates’ scoring. Peterson was 2-for-4 with three runs scored and two RBI. Pollock, who was the winning pitcher, was 3-for-3 with three RBI.

Jason Rangel took the loss for Homedale, surrendering seven runs in one-third of an inning.

The loss to the Pirates completed Homedale’s conference season because a lack of eligible players forced McCall-Donnelly to forfeit the makeup game scheduled for Friday in Homedale, according to Trojans assistant coach Mark Thatcher.

First-year coach Burke Deal’s Homedale squad opened the

On the edge of common sense



Grass- vs. grain-fed beef

I was at the Governor’s Ag Conference in Dover, Del., recently. My column runs in the Delmarva Farmer. Bruce, the senior editor, asked me ... well, here’s how he put it:

“A debate is raging here about which tastes better, grass or grain fed beef. What do you think?”

My first thought was — “Does the continuing use of my column in his paper depend on my answer?”

As I recall, they served chicken at the noon luncheon, so I didn’t get a chance to surreptitiously overhear his comments about beef. To parse the question, he did not say grass fat or grain fat beef. Had that been the case, I could have passed along the observations of meat guru Dr. Gary Smith at Colorado State University, who said, “People crave three things: salt, chocolate and fat.”

I’m not sure how he determined that. Did he lock three diabetics with congestive heart failure in a room? Keep them off feed for 24 hours then lay out platters of salt and pepper, chocolate and vanilla, and fat and tofu to see which disappeared first?

Or did he take a random grouping of Farm House fraternity boys, put them in a locker and waft the scent of fat, chocolate and salt by them to see which made them drool? Maybe use BBQ sauce, woman’s perfume, and new car smell as controls?

But obviously, grain or grass fat is not the issue. What needs to be addressed is grass vs. grain. First, grass is cheaper where it rains. You don’t have to haul it to the cattle. You haul the cattle to the grass, which immediately brings up fencing. Barb wire, hog wire, electric, wooden, plastic, rail or pipe. Inedible fencing material would be the best choice because if it were wood, we’d complicate the problem by having to consider the taste of pine-fenced cattle vs. cedar vs. osage orange, which might flavor the meat.

Regarding grain-fed cattle, the grains include corn vs. all the others. Corn-fed beef is supposed to have a yellow fat. It looks better with some meals than barley- or wheat-fed cattle, which have a white fat.

So, it comes down to comparing, clashing, or complementary-colored side dishes. Sweet potatoes, for instance, and pinto beans go better with white wheat-fed beef; peas and pickled beets enhance yellow corn-fed beef.

In conclusion, the key word in this question is “raging.” I saw no overt signs of raging when I was there. But I do know that the one place I do not want to be is in the middle of anything raging. Be it a fire, a pancake breakfast or a controversy wherein beef is in the taste buds of the beholder.

Sorry, Bruce. I guess I chickened out. Would that be free range or wheat-fed chicken?

The house by the fairgrounds

I wish my “Dream House” would stay out of my dreams.

I’ve had my share of dreams. But I have seldom had the same dream twice. There are a couple of exceptions: In one dream I am forced to return to working full-time for a daily newspaper. But that’s not actually a dream — it’s a nightmare. And after 12 years away from that business, the reoccurrences are rare.

The other dream, however, has returned a number of times during the past one and a half decades.

I’m in the house we left 17 years ago. Just why we have had to move back to the house by the fairgrounds is never clear. But for some reason we have been forced out of the nicest house we’ve ever owned and required to return to our previous abode.

It’s not that I have anything in particular against the house by the fairgrounds. Some of our happiest days were spent there. I remember the girls marching off to explore the banks of Succor Creek to its confluence with the Snake River. Sometimes they caught water skippers in the mud puddles across the street from the house.

I remember playing H-O-R-S-E with Melanie, shooting at the backboard mounted above the garage door. By the time she was a freshman, I couldn’t beat her any more. But I still watched out the living room window as she shot and shot and shot some more.

When we left the house by the fairgrounds 17 years ago, there were only half a dozen residences in the subdivision. Now there are at least three times that number. There are houses where we flushed pheasants and an occasional deer out of the weeds. The last time I checked, the sycamore tree I planted in the back yard had totally taken over that small area.

It was a good house — maybe a little cramped for a family of five, but a lot of folks get by with a lot less space. But after 12 years I needed to get closer to my job. Then everything seemed to come together at once. We found a buyer for our old house and found a perfectly located larger home. So we moved out of the old house and never looked back.

Except for the darn dreams.

At least a couple of times each year, I find myself back in the old house. Sometimes I’m with Sara. Other times, I’m with her and the girls. And each time I am stunned because we have been forced out or voluntarily given up our present house. And the worst part is that I am convinced that this time it isn’t a dream — it’s really happening! Then, after thrashing around for what seems like hours, I realize it’s a dream and wake up.

I thought the dreams would end last fall when we made the final payment on our present home. After all, how can you dream about losing a house when it’s paid for? And that logic worked until last night. I would not be happy if my epitaph read, “He’s not really gone, he’s just living in a house by the Owyhee County Fairgrounds.” It was a nice place with some happy memories, but I’ve never really thought of it as a place to spend eternity.

Young farmers, ranchers see bright future for the industry



A recent American Farm Bureau Federation survey shows young farmers and ranchers are optimistic about the future and a majority believe they are better off now than they were five years ago.

Other findings in the informal survey of 18- to 35-year-old farmers and ranchers show their top concerns about agriculture include land and facility availability, overall profitability, increasing urbanization and loss of farmland, increasing government regulations and availability of health care. This is the 16th annual Young Farmer and Rancher survey conducted by AFBF. It noted that 83 percent of respondents said they are more optimistic about agriculture than they were five years ago. That compares to 79 percent who said they were optimistic last year, 80 percent in 2004, and 61 percent in 2003.

In addition, 92 percent of today’s young farmers and ranchers see themselves remaining in farming for the rest of their lives and 95 percent would like to see their children follow in their footsteps.

Most of those surveyed said they got started in farming through a family partnership, but interestingly, 30 percent said they started in agriculture on their own, without the benefit of family ties.

Two-thirds of survey participants said they believe farm income should come totally from domestic and international markets, while 33 percent said farm income should be supplemented by federal farm program payments. Last year, 63 percent said farm income should come totally from the marketplace and 79 percent agreed in 2006.

For the first time, survey respondents were asked if state and local issues such as property taxes concern them more than federal issues, and 75 percent responded yes.

“The high level of interest in local and state issues by young farmers and ranchers is encouraging,” said AFBF president Bob Stallman. “Their active involvement in Farm Bureau grassroots organizations in every state and 2,800 counties around our nation is critical as we continue working to build strong, prosperous agricultural communities.”

Costs of groceries, energy fueled ... by cost of fuel

This is the third and final in a series of editorials addressing the availability and the rising costs of water, food and energy in Idaho.

You know the feeling. You get in your car and look down at your gas gauge. It’s time to fill up. As you approach your gas station, you begin to feel a slight sense of dread as you get closer to that big sign with those big numbers that seem to always get bigger week after week. And sure enough, when you can finally read them, the price is higher, and you know your wallet is going to empty more than it did the week before.

In my recent travels around Idaho, I visited with commuters who are spending \$100 to fill up their SUVs and farmers who are spending even more to fill their diesel pick-ups. It’s costing truckers upwards of \$600 every time they stop at the gas station. So what are you paying at the pump? No matter what it is, you’re most certainly feeling the fuel pinch.

Rising energy costs are not only pouring out of the nozzle. We are seeing the effects in the grocery line as higher transportation costs drive food prices higher. Americans are feeling the heat in their utility bills, as natural gas prices remain near record highs. Thankfully, we in Idaho and the Northwest are largely spared from

these costs because we have the lowest power prices in the country, being less dependent on natural gas and more reliant on clean, inexpensive hydropower.

I am often confronted by people who want to know why Washington isn’t providing some relief to the American commuter. My mission in Congress for almost three decades has been to reduce our dependence on unstable regions of the world by increasing production of all energy sources here at home.

One of the most promising developments I’ve seen is a growing and evolving renewable fuels industry. Over the past several years, ethanol has moved beyond scientific jargon to become a household word. In 2007, the United States produced 7.8 billion gallons of ethanol, which displaces the need for more oil than the U.S. imported from Iraq and nearly half that from Venezuela in 2007. It also saved Americans billions of dollars.

However, the majority of our domestic production of ethanol is corn-based, posing unique challenges to the livestock industry and raising concerns among the environmental community. As a former cattle rancher, I understand the pressure this booming industry is placing on the demand for corn and corn acres. The cost for feed is higher, and other market and environmental impacts are resulting. For these reasons, I support the movement toward advanced renewable technologies, such as

the development of cellulosic ethanol. Rather than relying on corn kernels for energy, cellulosic ethanol is derived from a variety of “plant fiber” sources, ranging from grain straw to switchgrass, quick-growing trees, and even municipal waste.

Through the establishment of new Department of Energy grant and loan guarantee programs, I am proud to have helped build the groundwork that put Idaho in contention for one of the first successful cellulosic ethanol plants in the United States. The Canada-based Iogen Corp. could break ground on a new plant in Shelley within the next 18 months. The plant would produce 18 to 20 million gallons of cellulosic ethanol from agricultural residues like wheat and barley straw from local producers. I am committed to seeing this plant come to our state, and I led a delegation of Idahoans to Iogen’s cellulosic ethanol demonstration plant in Ottawa, Canada (the largest in the world) on April 7 and saw this groundbreaking technology first-hand. Our country hopes to produce 36 billion gallons of renewable fuels by 2022, and this technology will help us achieve that goal.

Reducing our dependence on foreign energy sources is the only way you and I will stop dreading our trips to the pump.

140 years ago

May 2, 1868

A GREAT MINING ENTERPRISE. Geo. Collier Robbins, Esq., is engaged in organizing a joint stock company for the purpose of running a tunnel through War Eagle Mountain, from Jordan to Sinker Creek, which, if successfully completed, will be the most extensive mining enterprise ever engaged in, inasmuch as the tunnel will be over two miles in length, and cut at a great depth scores of rich ledges already known, besides a large number of others that would doubtless be discovered. A statement in writing commending the enterprise, has been prepared and will be signed by the principal mine-owners, mill and business men in the county to show that the people here possess confidence in the practicability of the project and the immense pecuniary advantage that will result from a prosecution of that great work. Mr. Robbins is now surveying, preparing plans, &c., and in a few weeks will start for New York where it is confident that he can organize a company with sufficient capital to prosecute the proposed work. Already the sum of \$110,000 is subscribed. Mr. Robbins is eminently qualified to conduct the enterprise, he having been identified with the progress and development of the Owyhee mines almost from their discovery to the present time. He is a gentleman who is well acquainted with our people, possesses good judgment, energy and perseverance, and is a good business manager, as was evinced when he was Superintendent of the New York G. & S. M. Co., now the Owyhee Company.

This enterprise offers great inducements to capitalists, as the laws of the Territory allow the owners of such a tunnel to hold all the behind, unlocated and forfeited lodes penetrated for five hundred feet on each side. To owners of mines on War Eagle it presents great advantages in the way of future working, as it will top the mines from three to fifteen hundred feet deep and thus obviate the necessity of expensive hoisting works and effectually draining the mines. We wish Mr. Robbins success and hope to see the work commenced at an early day, believing that it will be of immense benefit to our camp. From what we have seen an idea can be formed of the work, the advantages that will accrue &c. At another time we will speak more at length on the subject, and probably give the entire statement mentioned above.

IMPROVEMENTS. Wm. Dewey is raising his two buildings, situated on corner of Washington and Second Streets. They will be raised about four feet, and when the street opposite them is filled up, their appearance will be materially improved. If two or three other buildings on the lower side of Washington Street were raised out of the mud, and the street filled in, it would considerably enhance their value and make Washington Street the best looking street in town.

Several new buildings, principally dwelling-houses, are in course of construction on the east side of Jordan Creek. The point below the Idaho Stable has also been laid but into lots, a large building is already going up and others will follow as soon as lumber can be procured. Mr. Monohom is building a large stable on Washington Street, in Long Gulch. J. B. Oliver has taken down his house between Herman’s store and the Golden Chariot saloon on Second Street, and will rebuild it on a larger scale for a saloon.

HOLE FILLED UP. To our great relief, that ugly, dangerous, deadfall of a hole in front of the Challenge Saloon, has been filled up. That hole was in some way connected with the projected water works of Silver City, and was dug from the proceeds of sundry balls, pic-nics and other private entertainments last summer but, unfortunately, it was allowed to cave in, and go in rain, making an ugly hole to encounter in the darkness. We are glad that hole is filled up. There are several other eye-sores in that vicinity which a proper system of street grading would relieve to the profit of business men on Washington street.
