Court stymies grazing foes

Winmill upholds BLM's innovative Murphy rehab

A judge who has a reputation for supporting anti-grazing factions ordered livestock to remain on federal allotments in southeastern Owyhee County, a ruling being hailed as a "win-win-win" by a Three Creek rancher and lawmaker.

Idaho District Court Judge B. Lynn Winmill affirmed the federal government's recovery practices in the vast area damaged by the 2007 Murphy Complex Fire when he denied a preliminary injunction motion by Hailey-based Western Watersheds Project that sought a ban on grazing in areas of the Bureau of Land Management's Jarbidge Field Office.

"I view this decision as a win-

Homedale misses federal stimulus request deadline

Money would help infrastructure; library building wish makes it in

Homedale officials say that a communication breakdown led to the city missing the deadline for filing requests for a piece of the massive stimulus package.

The city had submitted applications seeking more than \$1 million to complete the rehabilitation of the sewer system and drill a well at Riverside Park. But a 23-page document released by the State of Idaho on Thursday listed Homedale's requests among more than 50 that had missed the noon Wednesday deadline.

Another request, for \$280,000

for a new building for the Homedale Public Library, was filed on time, according to state records.

Homedale public works supervisor Larry Bauer was puzzled when he learned that the city's request wasn't received in time. He made phone calls to the DFM on Friday after inquiries by The Owyhee Avalanche revealed that the city's projects were on the late list.

Bauer said that a state official told him that there were some communication problems, not

Bridge project brings traffic signals to town

Flaggers, lights to guide cars across narrowed span

Motorists can expect changes to their routine beginning at noon Sunday as the Homedale Snake River Bridge project begins.

According to Idaho Transportation Department spokesman Reed Hollinshead, the project contractor — Concrete Placing Co. Inc., of Boise — will set up traffic controls Sunday afternoon and begin work early Monday.

One lane of travel will be closed using a portable rail traffic barrier. Temporary traffic signals also will be in place

"Flaggers may be used during the project, but we will rely mainly on the traffic signals," Hollinshead said.

There will be one signal on the south side of the bridge, and three signals to the north — one for U.S. Highway 95 traffic, one for Batt Corner Road and one for Homedale Road.

The \$638,815 construction

County's city councils meet today

The city councils for Owyhee County's three municipalities are scheduled to meet tonight.

The Homedale City Council meets at 6 p.m. inside City Hall, 31 W. Wyoming Ave. Councilmen are slated to discuss a resolution supporting Owyhee County's Multi-Hazard Mitigation Plan as well as departmental reports.

At 7 p.m., the council will hold a public hearing to amend the fiscal year 2009 budget to include \$1.5 million in additional funding

for water and sewer projects.

The Marsing City Council will meet in normal session at 7 p.m. at the Marsing City Hall, 425 S. Main St.

The preliminary agenda lists a presentation by city engineer Amy Woodruff on the awarding of contracts on bids received for the upgrade of existing water system facilities and the distribution phase as well. The council will hear from city attorney Stephanie Bonney on additions to the newly

adopted ordinance shifting common city ordinance misdemeanor offenses to infractions.

Woodruff will also report on the work with Owyhee County Planning and Zoning on the Marsing impact area.

An executive session addressing personnel is scheduled after the public meeting.

The Grand View City Council meets at 7 p.m. today at City Hall, 425 Boise Ave. No agenda was provided.

Emergency services summit looks to set dispatch protocol

Owyhee County Sheriff Daryl Crandall held an Emergency Services Summit in Murphy last month, with the objective of developing a county-wide protocol for dispatch personnel.

Representatives of about 20 law enforcement, fire and emergency services agencies attended the Feb. 26 meeting.

A new protocol for use in times of emergency was needed, Crandall said, because of the differing systems of the many emergency responders who use the central county dispatch.

"Dispatch has been struggling with the different protocols used by all the different agencies, and bringing all of them together," Crandall said. "As well as the fact that part of the departments are inclusive of Canyon County and Elmore County, and we were unable to procure maps to those areas."

Money for training was also discussed, according to a press

release provided by Bev White, the sheriff's administrative assistant.

"Over 60 people gathered from the southern end of the county, Owyhee Indian Reservation services to the northern end with Homedale services," White wrote.

"Several groups came to the meeting with matching professional attire. Emergency responders were given time to voice concerns that needed attention. They also had opportunity to listen to dispatch personnel describe the great influx of phone calls that come in with an emergency. Protocol was discussed, and plans were made to solidify the suggestions into guidelines."

Those guidelines, though not yet finalized, will address problems in radio communications, dispatch protocol, mapping and classification of equipment, Crandall explained in an e-mail

to The Owyhee Avalanche. He added that a follow-up meeting will be held in Murphy at 9 a.m. on March 26.

"This (March 26) meeting will address the implementation of all agencies' protocols into one workable protocol to address all concerns of all the different agencies," he said.

White's release said that Shirley Fuchs — the 911 co-coordinator for the Owyhee County Assessor's Office — attended the meeting and offered help in her area of expertise.

She will be getting more detailed GPS coordinates to help all of the emergency services find locations quicker.

As of March 3, Crandall said that Fuchs had already completed this portion of the process, and has the GPS software installed and has begun updating the system information.

County probation heads for Marsing?

Sheriff hires dispatcher after another quits

The new Owyhee County annex building in Marsing may become the new headquarters of the county probation office, according to a conversation during the weekly Board of County Commissioners meeting Monday.

But after chief probation office Doris Jewett expressed concern that moving the entire operation to Marsing would be a burden on her officers because the bulk of probationers live in Homedale, Commissioners Dick Freund and George Hyer agreed an office at the Homedale Magistrate Court three days a week would be a good compromise.

BOCC chair Jerry Hoagland missed the morning session because he was at another meeting in Ontario, Ore., regarding Idaho Power's proposed Boardman-to-Hemingway transmission line.

Jewett told the commissioners that she has already moved into the Marsing office to use it as a supplement to the Homedale headquarters, but that she was unaware that the commissioners wanted to close the main office altogether. The county pays more than \$1,000 per month for a building at the corner of West Idaho Avenue and North 1st Street West.

When Jewett said that her department would need three offices in Marsing to accommodate all three probation officers, District 2 Commissioner Hyer said, "Somebody will have to share."

"It will make it pretty inconvenient for two people to use one office, but we can make it work," Jewett said. "We would need some place to meet in Homedale,

though, because the bulk of our people are in Homedale."

The commissioners directed Prosecuting Attorney Douglas Emery to pursue early termination of the county's lease with Homedale landlord Gypsy Jackson. The move would save the county more than \$10,000 a year.

Dispatcher pay OK'd

The board approved pay for a new dispatcher in the Owyhee County Sheriff's Office. Elaine Bean will earn \$13.34 an hour.

"This puts us up to full staff," Sheriff Daryl Crandall said.

Crandall said another newly hired dispatcher had resigned. "It's probably not something we should get into here, but she left," he told the commissioners.

When Freund asked if job openings had been advertised, Crandall said:

"We went to Job Services long before January and put ads out and we built up a pool of people."

Crandall didn't take office until Jan. 12.

Juniper bid awarded

Commissioners Freund and Hyer approved Environmental Forestry as the contractor with the best bid to undertake a juniper mastication project for the Owyhee Local Working Group for sage-grouse conservation.

The LWG, a subcommittee of the county's Natural Resources Committee, recommended Environmental Forestry after reviewing the handful of bids that were open at the commissioners' March 2 meeting. Working group chair Donna Bennett presented the recommendation Monday.

Emery will review a contract before the hiring of Environmental Forestry is finalized.

Idaho Power seeks public input on B2H

Committees of county residents, state, fed reps, others to determine route

Following comments and resistance from landowners, rounds of public meetings and two grassroots organizations fighting to move the line, Idaho Power has opened the doors to communities to help plot the Boardman-to-Hemingway (B2H) line's controversial route.

Idaho Power spokesperson Echo Chadwick refused to call the process a do-over — as the project itself is still a go, with National Environmental Policy Act and Oregon Energy Facility Site Evaluation Council applications in place — but it is a return to the design phase with the board open for suggestions. This decision removes the problematic Sand Hollow substation from the map, effectively allowing planners, now including residents of areas affected by the line, to determine where, and if, the proposed substation will be located, Chadwick said.

The Monday announcement spoke of the planned "coordination of a community advisory process to site the Boardman-to-Hemingway Transmission Project. The purpose of establishing the process is to engage and further include members of the local communities from Boardman, Ore., to Murphy, Idaho."

"We recognize the need to pause and listen as a result of the public participation and comments received through the federal and state permitting process," said Idaho Power's vice president, Delivery Engineering and Operations Lisa Grow. Grow went on to say that, while the need for the project hasn't changed, the approach to planning has.

"The intention is to conduct a comprehensive and inclusive public process to identify proposed and alternative routes required for this project to proceed," she said in the release.

The planned project community advisory process will involve community members, state and federal government agencies and company representatives. Members will address three elements: "Identification of community is-

suues and concerns, development of a range of possible routes that address community issues and concerns while following all federal, state, and local requirements, and recommendation of proposed and alternative routes with completion expected by the end of 2009."

In other words, residents will be brought on board to help in the siting and impact assessment process of the 500kV B2H transmission line's route. Existing proposed routes will remain on the map, but are now subject to suggestions and alternatives by the advisory committees.

Each regional advisory board will send a single member to a combined board, Chadwick explained.

"We are leveraging a proven collaborative approach with coordinating community advisory teams across our service area to establish this project siting process," said Idaho Power's delivery planning manager David Angell. "Feedback from prior participants indicates a successful experience for all involved, and we look forward to similar results for this project."

People will have a more direct say in where the line — subject to limitations due to resources, cities, wildlife and engineering concerns — goes. Idaho Power expects this process to be more useful than the previous system, it seems.

Chadwick said that details on exactly how advisory boards will be filled is yet to be determined, and comments from Stop Idaho Power — both the Malheur and Owyhee branches — were not available as of deadline. Owyhee County Commissioners had only just heard of the decision, and said they wanted to familiarize themselves with the development before commenting.

Planning boards set meetings

Planning and Zoning boards have full agendas coming up.

The Homedale Planning and Zoning Commission will hold a public hearing on a proposed ordinance governing vending licenses for temporary and transient vendors in the city limits. The hearing is set for 7 p.m. Monday at City Hall, 31 W. Wyoming Ave.

The proposed ordinance sets a fee for and time limit on vending permits and also mandates guidelines for the different types of vendors who do business in town.

The P&Z commission will make a recommendation on the ordinance to the City Council.

Next month, the Owyhee Coun-

ty Planning and Zoning Commission has a scheduled packed with proposed amendments to the county's zoning ordinance.

The public hearing will take place at 10 a.m. on April 1 inside the Owyhee County Courthouse Annex Building, 17069 Basey St., in Murphy.

There are six amendments on the agenda, including one that could move the responsibility of reviewing historic building permit applications for Silver City from the Board of County Commissioners to the P&Z commission.

Other proposals include:

- Amending the section addressing temporary hardship

applications authorizing the P&Z administrator to issue a temporary hardship permit rather than require the matter be heard in a public hearing by the Planning and Zoning commission.

- Allowing the transfer of a conditional use permit from original applicant to another person by an administrative decision. Currently, transfers must go through the public hearing process.

- Language clarifying that the request for a time extension on a permit must be submitted prior to the expiration date.

- A process for a motion to reconsider a decision issued by the P&Z board.

Library, schools apply for federal stimulus funding

The State of Idaho received several Owyhee County-related requests for stimulus funding before Wednesday's deadline.

One project submitted by county commissioners is being re-tooled because it didn't meet specific criteria for the category of funding that would be used, Board of County Commissioners chair Jerry Hoagland said.

The state's Division of Financial Management (DFM) reported Thursday that the following re-

quests were in hand:

- A request for \$280,000 for a new Homedale Public Library facility, which would be built on land adjacent to Homedale City Hall that the City Council donated after a Feb. 26 presentation by library director Margaret Fujishin and library board chair Dawn Whitney.

- The Homedale School District is on the list for \$90,000 aimed at renovations and repairs.

- The Melba School District

also requested nearly \$460,000 for capital improvements at the high school/middle school and elementary school. The district has been struggling in the wake of failed bond elections.

One project missed criteria:

- Hoagland said that the county was hoping for about \$650,000 to fund a magnesium chloride dust control project for county roads. The money was sought through the Idaho Transportation Department, but Hoagland said the price

tag exceeded a \$500,000 cap set for related projects.

Hoagland said a scaled-back plan has been devised in an attempt to take advantage of the stimulus package.

The funding originally was available through the Local Highway Technical Assistance Council, but the program establishing the money pool was discontinued, the District 1 commissioner said.

Several state agencies have applied for funding, including about

\$4.8 million from the Military Division of the Idaho Bureau of Homeland Security to protect from fire 101 communications sites used by state and local agencies, including Squaw Butte, Cinnabar Mountain and South Mountain in Owyhee County.

An executive advisory that includes three former governors is set to make final recommendations to Gov. C.L. "Butch" Otter by Friday.

only involving Homedale's requests, but several other agencies' wish lists. More than 50 projects missed the deadline, according to the state's account.

"It still may be all right," Mayor Harold Wilson said Friday. "Larry's made some calls, and (state officials) said they're getting a lot of calls."

Both Bauer and Wilson took some of the blame for the lateness of the requests.

"We were probably lax and should have been on top of it, and we weren't," the mayor said.

Wilson said he was "involved a little bit" in the formulation of the city's requests, but that Bauer and City Clerk and Treasurer Alice Pegram did most of the work. The mayor said he also assisted library director Margaret Fujishin with the request for funding for a new building, adding that he and Fujishin originally were under the impression that the submission deadline was Thursday.

Bauer said that the City of Homedale didn't have its packet ready for Wilson's signature until 3:30 p.m. on March 3, less than

24 hours before the deadline. Wilson said he was unsure how the library's request was sent to Boise, but in an e-mail to the Avalanche later Friday, Fujishin said she e-mailed the library's project — which has a total price tag of nearly \$450,000 when factoring in more than \$168,000 in state investment pool funding — to Erin McCusker of the Idaho Commission for Libraries at 2 p.m. on March 3.

The city's request for \$653,000 to complete phases 3 and 4 of the sewer project and for \$550,000 to

drill and equip a new well were sent by mail, Bauer said. The money the city sought is above and beyond the bond money that voters approved three years ago, and Wilson said that the federal funds could help pay the bonds back early.

Bauer said one of the first alerts the city had to its possible eligibility for funding under the American Recovery and Reinvestment Act was a Feb. 26 memo from Association of Idaho Cities Executive Director Ken Harward. Also posted to the AIC Web site, that memo was issued nine days after President Obama signed the stimulus legislation into law and Gov. C.L. "Butch" Otter issued

his executive order seeking funding requests.


Two days after the executive order was signed, the State of Idaho issued a press release with information on the funding opportunity as well as the announcement of a stimulus executive committee including former Govs. Phil Batt, John Evans and Cecil Andrus that will make recommendations on which of the \$4.75 billion in requests would be filled by a pool of a little more than \$1 billion in available funding.

The advisors will present recommendations to Otter by Friday.

win-win,” District 23 state Sen. Bert Brackett (R-Rogerson) said. “Western Watersheds is pleased with the decision, the BLM attorney calls it excellent and fair, and I’m very satisfied with the decision.”

“The fact that this was in Winmill’s court makes it even more significant.”

Bureau of Land Management Jarbidge Office manager Rick Vander Voet said cattle could have been kicked off the allotments for as many as 10 years if Winmill had sided with WWP.

In his ruling, Winmill upheld the BLM’s practice to allow grazing in Jarbidge areas not affected by the Murphy fire. WWP argued that livestock foraging on areas not affected by the fire was reducing remaining habitat for threatened species such as sage-grouse, pygmy rabbit and slickspot peppergrass.

“This is an important ruling in that if Watersheds had prevailed, this would be their template for the West,” Brackett said from Boise. “And the fact that they didn’t (prevail), hopefully this will chill (that tactic).”

The BLM has established a reopening criteria for land impacted by the fire that burned 400,000 acres of grazing allotments in the summer of 2007. Vander Voet said that between one and two percent

of the allotments affected by the fire have been reopened.

Vander Voet, who was named in WWP’s lawsuit, said last week that there were four criteria in the emergency stabilization and rehabilitation plan put in place in the aftermath of the fire. All four standards must be met before the land is put back into the grazing rotation. Vander Voet said this was different than the common practice of automatically removing land from grazing for two years after a wild fire.

Vander Voet said that it remains to be seen if the success of the criteria system will trigger a sea-change in the BLM’s philosophy on fire rehabilitation.

“The resumption of grazing is very controversial, and even within science there’s a lot of arguments on both sides by very reputable people,” Vander Voet said.

“If you go to timeframes, you’ll have people arguing for one year and people arguing for 10 years’ rest. And if you go with the criteria, some people would want strict science review.”

Vander Voet said strict science review is fiscally impractical, something that Winmill pointed out in his Feb. 26 ruling.

“It has to be an efficient use of taxpayers’ money,” Vander Voet said. “You can’t have a full-blown

Ph. D., dissertation on grazing (with each rehabilitation plan).”

Vander Voet said that the plan allowed managers to open pastures to grazing before the standard two-year retirement if the natural recovery of the land or the success of seeding projects met criteria.

“We focused the monitoring last year on some of the places on eyeball estimates and what the grazing folks and our folks were seeing on the ground,” he said. “Through that, we got a pretty good idea that they were going to meet the criteria.”

He said more grazing allotments could return to active service this year.

“Part of that decision is not exactly opening up to the same type of grazing that was going on before the fire,” Vander Voet said. “We could change the season of use to a dormant season when the plants aren’t growing and put live-

stock on in lighter numbers.”

While progress has been made through rehabilitation and the efforts of groups such as the Shoshone-Paiute Tribe, which planted sagebrush seedlings last fall, Vander Voet said some allotments may not meet the criteria for another two or three years.

In its March 2008 filing that Winmill ruled upon last month, WWP sought the cessation of grazing on about 57 allotments. In May 2008, the judge excised 20 of those allotments from the case because they already had been covered by a stipulated settlement agreement in September 2005. Another eight allotments were tossed out in the May action because they contained no sage-grouse habitat.

Two more allotments were nullified based on a previous federal court ruling.

Vander Voet said that left 34 allotments affected by the Feb.

26 ruling. Winmill ordered the BLM to pay more attention to the special-status species (sage-grouse, pygmy rabbits and slickspot peppergrass) with habitats on those remaining nearly three dozen allotments — something that Vander Voet said his people already were doing.

Vander Voet said the ruling, hailed by WWP in a press release as the end of “grazing as usual”, actually derailed the possibility that cattle could have been removed from the land for as long as 10 years, until BLM completed a new resource management plan or fully processed permits.

This project will restore and overlay the bridge deck, which consists of two 16-foot travel lanes with a sidewalk on the west side.

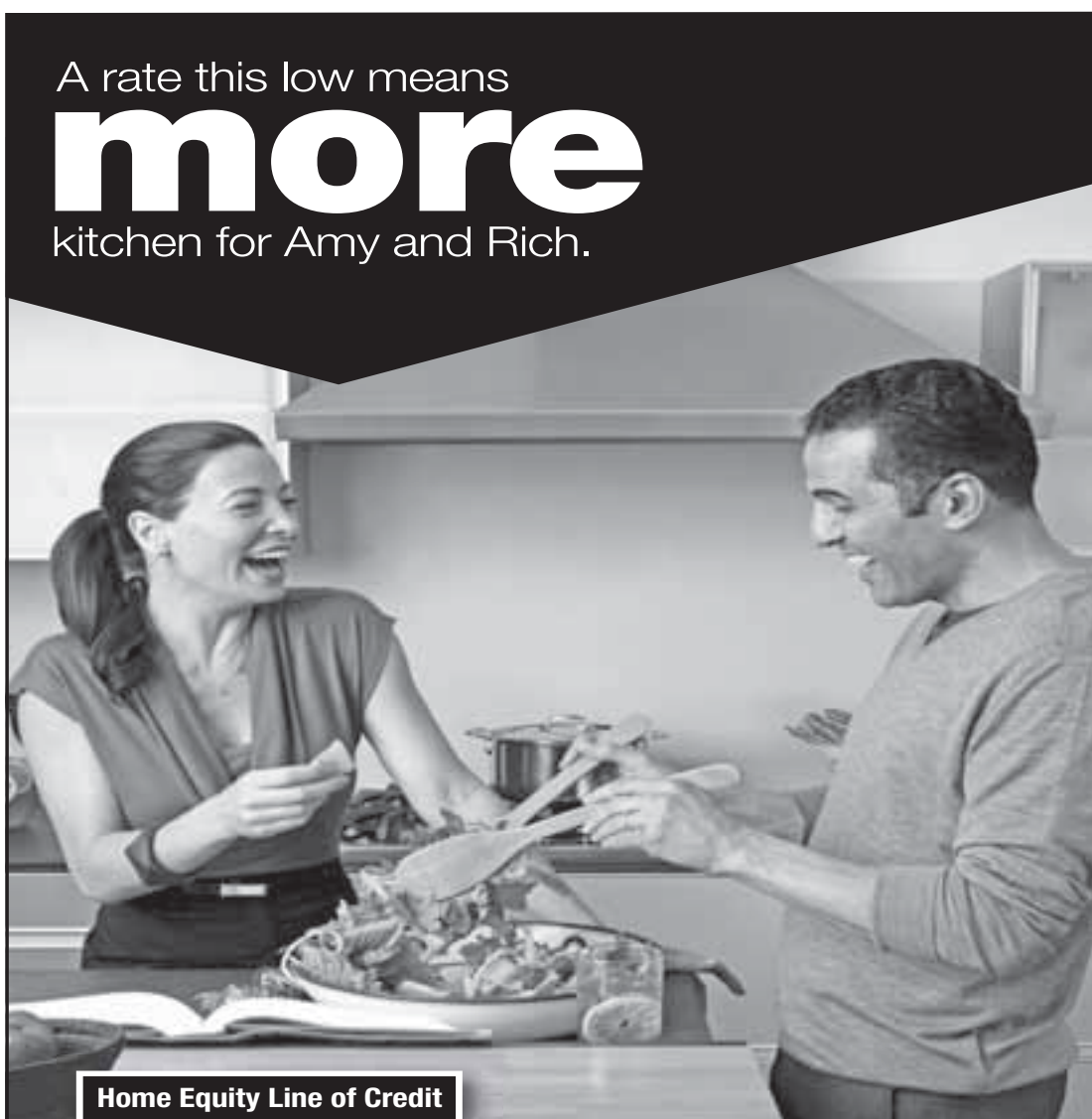

County offers registration of vehicles by mail

A new service for renewing automobile registrations by mail is now being offered through the Owyhee County Assessor's office in Murphy.

Tom Brunzell, Owyhee County Assessor, said that effective with those licenses expiring in March and ending in the number "3" courtesy notices along with instructions for transacting renewals by mail have been sent to registered automobile owners within the county.

Through the new computer system, owners will be reminded and offered the service at the first of each month their licenses are due to expire.

Brunzell affirmed that within 10 days upon his office receiving correct and complete information, as well as remittance of fees, the renewed licenses and stickers will be returned to the applicant by mail.

"The system will better serve all Owyhee County automobile owners," Brunzell said, "but in particular it will accommodate those people who are inconvenienced by long distances to a motor vehicle license clerk, or who had conflicting time schedules."

On the edge of common sense

Abandoned horses saga continues

I had a visit with the president of the Humane Society of the United States (HSUS) recently about the abandoned horse issue. My question to him was: "Since the problem is a direct result of the banning of equine slaughter plants, for which his group led the charge, what are they willing to do to help those of us who have inherited the responsibility for the mess they have made?"

We discussed the woefully inadequate plan to put them in "refuges". We both agreed that euthanasia is not a bad thing, but dumping your unwanted horse along the roadside, in private pastures, or on park land to die of starvation is not humane.

We considered having equine animal shelters, like dog pounds. Maybe one in every state that would accept horses at no charge, hold them for 30 days in hopes they could be adopted, then euthanasia. The facility should include a free pick-up service, a large "feedlot" to hold them, and a rendering plant. He did not readily agree that his group would finance this national program. But they are the richest animal rights group in the world and what better way, I thought, to put their money where their convictions are.

The HSUS has made legitimate criticism of how some horses destined for distant slaughter plants in Canada and Mexico are transported. We livestock people are responsible for the animals in our care from conception until death. We cannot turn a blind eye to double-decked trucks, too long hauls and mistreatment. The Department of Transportation or Agriculture should have laws that guarantee the horses' well being. We should ensure their enforcement.

It's good that we are talking, but this winter the public's awareness of the problem, and their deeper understanding of the cause seems to be lifting the veil of the ignorance which often blinds the naive but well-meaning, be they horse lovers, politicians or journalists. Starving horses are not a pretty sight.

Three states — with more to come — North Dakota, Wyoming and Montana are taking steps to examine the construction of horse slaughter plants to replace the ones the animal-righters have had banned in Texas and Illinois. The day these new plants open up, the abandoned horse problem, with all its unintended abuse, will disappear. There would be a place for them to go.

There are several groups scrabbling around for answers this cold winter to save unwanted horses from the misjudgment of these well-intentioned but irresponsible "animal lovers." I hear from them regularly. I suggest if you are one of these sale barn operators, ranchers, park rangers, farmers or rural residents who have inherited the problem, take photos of the horses, good or bad, that have been dumped in your area. Then when a new state applies for a permit to build a new horse slaughter plant and the animal rights group protest, we will have an entire "Gallery of Abandoned Horses" to show the public the inhumanity of their policy. These photos would be very convincing. Our facts versus their perception. Of course, we could put pictures of abandoned horses on milk cartons with the caption "Brought to you by HSUS, PETA and the 'Frenchmen Should Not Eat Horsemeat Society!'"

Separating fact from fiction

Public records aren't the ones you borrow at the library from the audio-books shelf.

They are records that any member of the public may request from a government or other agency, which are defined by law as being something the public has a right to know. They include things like criminal citations, military records, government certifications, budgets of public entities and so on.

They belong to you, the reader, and to everyone else.

These records, and access to them, are often a point of friction between journalists and government or other public bodies, whether it's the Treasury Department or your local irrigation board. Moreso now, in the age of identity theft and liability, when gun-shy agencies would rather deal with reams of public records requests rather than mistakenly release something that was not a part of the public record.

But does that fear do anyone — outside the insurance industry — any favors?

In most cases, the answer is no.

Owyhee County's new nondisclosure guidelines, currently being put into place under the advice of County Prosecutor Douglas Emery, are not a bad idea. There is no reason to release Social Security numbers, ever, to anyone. Not in a world with thriving identity theft. Likewise, full birthdates are also not something that should be released, unless it is the only route for positive identification of individuals.

But that's where redaction needs to stop.

Digging up dirt is not the reason reporters make public records requests. They make them in order to be accurate, and to answer questions that have been, or should be, asked. Accurate information is the difference between public rumors, supposition, prejudice and assumptions of guilt or innocence, and a valid, factual view of a situation involving the public.

The line between information that should be suppressed and that which shouldn't is narrow. While there are excellent reasons to redact full birthdates to avoid potential identity theft, there are equally good reasons that releasing the age of individuals involved in legal action should happen. Though a newspaper doesn't need to know that John Smith, dogcatcher and three-time pedophile suspect, was born April 1, 1960, it is important that he be identified as John Smith, 49, to ensure other John Smiths aren't mistakenly identified as him. Possible impacts in cases like that are obvious. Town of residence is another identifier that is vital.

Under statute, the names of individuals cited or arrested have to be released, along with the charge made — though the narrative surrounding ongoing cases is optional — and those names involved in incidents handled by both the Homedale Police Department and Owyhee County Sheriff's Office have been largely absent from incident logs provided through the county dispatch center for the past two months. Individuals arrested on warrants have not had the nature of the warrant listed, either.

Chinese, Americans appear to be more alike than not

We returned to the United States from China on Election Day. It was too late to fly on to Idaho that evening from L.A. As soon as we got squared away at our hotel, the six members of our family traveling group went down the street and got some real American hamburgers with fries. The burgers may not have been as healthy as real Chinese food, but they sure tasted good.

It's been four months since we returned from China. It only has been in recent weeks that I've really had a chance to reflect on the trip. Two and a half weeks after we returned, I fell, dislocating my ankle and breaking it in three places. I remember on the day of the accident, waking up after surgery and thinking to myself, "I'm sure glad this didn't happen a month ago because our tickets were nonrefundable."

The year before we went to China we spent two weeks in Europe. When I compare the two adventures, I have to admit I enjoyed the European trip more. I'm sure that's because my ancestors came from Europe and even though I don't speak German, Italian or French, those countries didn't seem as "foreign" as China. And it's not just a language thing. There are more people in China who speak English than there are people in the United States who speak English. That's food for thought.

For me, the most fascinating thing about China was simply being there. I remember when I was six years old, listening to radio reports of the "hordes" of Chinese soldiers attacking American troops in Korea. Even at that age, I remember the stories of how even when the Chinese were mowed down by the hundreds or thousands, they just kept coming — as if they valued human life less than

we do.

When we were in Tiananmen Square in Beijing, a lot of the Chinese tourists were there to see Mao's tomb. And many of the tour groups appeared to be made up of men who were military veterans — men old enough that some of them may have been survivors of the Korean War "hordes." Several of these men approached us and wanted to have their pictures taken with us. They didn't impress me as people who don't value life as much as we do. Maybe their culture has changed in the past 50 years. Or maybe we just misunderstood it.

In recent years, it seems to have become fashionable, especially in Europe, to bad mouth everything American. A lot of Europeans seem to believe we are responsible for most of the ills of the world. They think we should learn to be more like them — more sophisticated — more "worldly."

The Chinese don't bad mouth Americas — at least not where we can hear them. Everywhere we went in China the people seemed happy to meet us — not just because we were spending some money — but because they genuinely liked us — more so than the residents of some European countries. Although China is technically a Communist country, I came away with the feeling that the Chinese identify more closely with Americans than a lot of our so-called European allies.

Both America and China have changed a lot in the short time since our visit. Our economy has taken a nosedive. China's economy is pretty much based on making things for United States consumers. Hundreds of factories in

Today, when I came in at noon, Linda told me that Paul Harvey had died. I'm not embarrassed to say I instantly shed a tear or two and recalled the time I met the man.

The Owyhee Cattlemen's Action Committee organized a fundraiser during the Sagebrush Rebellion, and Paul Harvey was contracted to be keynote speaker.

On the evening of 20 June 1980, I picked up Mr. Harvey at Caldwell's Saratoga Hotel for the event staged at Simplot Stadium. He climbed up to the seat beside me, and we pulled out with Forest Fretwell as outrider. A big piece of paper blew streaming from an alley, spooking his horse and wrapping around my off wheeler's front feet. The leaders weren't bothered much by it, and neither was Mr. Harvey. He said he'd worked horses on the farm and had tense moments with them.

"I would like to hear the stories this stagecoach could tell," then he paused. "... If only it could talk." I told him I'd restored it, and he replied that he restored the car that he and his wife, Angel, had taken on their honeymoon.

When we arrived at the stadium, Dick Bass, Ace Black, Jim Anderson and Paul Nettleton escorted him to the podium.

Not only does squelching that information lead to the spooky possibility of an arrested individual simply disappearing into the legal machinery, it limits public access by making legal requests for information more difficult. It's obviously harder to determine why police cars and an ambulance were parked at the local bank when an incident log is limited to "battery, arrest made" and no name is provided.

Accuracy in information helps, coincidentally, to kill rumors; especially in smaller communities. Unlike an event unfolding in Boise, anything of note that happens in Owyhee County will directly touch a percentage of the population, and will be discussed, and at length, whether facts are available or not. In the example, above, someone might know — or, worse, think they know — who was arrested, but without that information on the incident log, what should be fact turns immediately to guesses and wishful thinking.

If accurate official records are not made available, that lack is rewarded with increasing spirals of gradually more distorted rumor and suppositions of guilt and favoritism

from those who know nothing of the case in question.

Those are not good outcomes.

Ignoring problems, or failing to look for them, does not make problems go away. Improper use of funds, illegal operations, mistaken protocols that lead to legal issues, none of those get better by being ignored; by being "left alone since it's not a big deal" or because "so-and-so is trying their best."

A reporter's job is to tell the truth, to report the legal record, and to do so with all the facts that they can access. While protecting someone from identity theft is a worthy rule, it's equally important not to lose the transparency that is required in government and society in general.

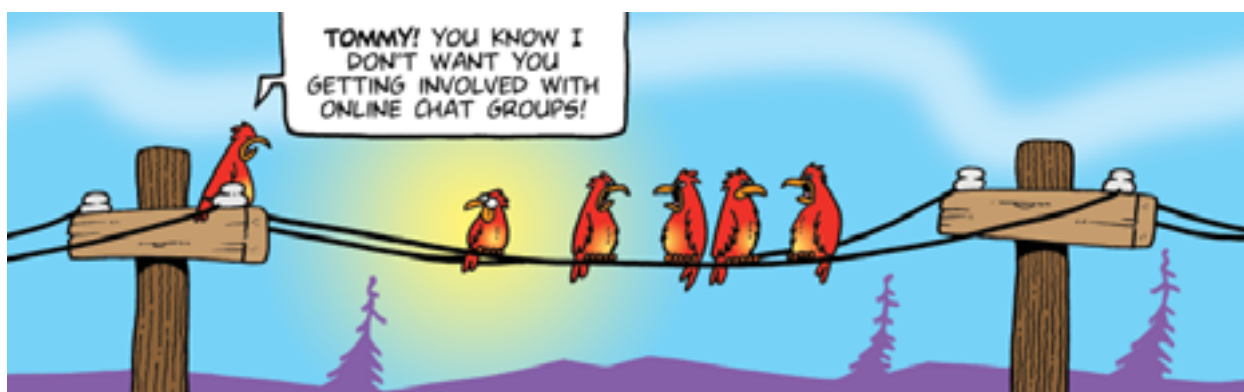
Government employees, local, city and federal, as well as corporate offices, charities, even schools or churches, are not magically immune to corruption, error or mismanagement. Public records are the window that allows every citizen the oversight needed to ensure that is not the case.

Plato asked it first, "Quis custodiet ipsos custodes?" — Who will watch the watchmen?

We all do.

The two Wells supplying water to the Grand View Water & Sewer Association, Inc. was tested on **February 9, 2009** and has an Arsenic concentration of **0.19 ppb** of which is above the 10 ppb Maximum Contaminant Level (MCL) set forth by the EPA. This is considered to be at the violation of the federal drinking water standard. Although this is not an emergency, you have a right to know what is happening, what you should do and what your water association is doing to continue to keep in compliance. The Grand View Water & Sewer Association, Inc. is still required to provide quarterly public notice of this excess EPA standard Arsenic level. Until such time as Idaho Department of Environmental Quality (IDEQ) notifies the Association that this notice is no longer required you will continue to receive this notice quarterly.

What happened? Arsenic is a natural deposit occurring element thought to enter the water source from contact with natural rock formations.

What health effects? Arsenic can cause adverse health effects, including cardiovascular disease, diabetes mellitus, skin changes, nervous system damage, and various forms of cancer.

What is being done? On the second Wednesday of each month there are regular Water & Sewer Board and the City Council meetings at City Hall – 425 Boise Ave. at 7:00 pm. Questions are encouraged concerning your drinking water and other issues.

IDEQ has made a revised loan offer to The Grand View Water and Sewer Association, Inc. for 1.5 m. The Water and Sewer Board at the December 10, 2008 City Council and Water & Sewer regular meeting motioned, seconded and a unanimous voted to accept IDEQ Revised Loan Offer.

Our application for the ICDBG grant in the amount of \$360,000 to the Idaho Department of Commerce has made the short list in the first round. There are two more lists and/or reviews of this application. Some time in March or April 2009 we will receive notice if we will made the second list.

What should I do? It will be each citizen's choice to use alternative drinking water (e.g., bottled) or drink City of Grand View water the choice is the total responsibility of each citizen. However, if you have specific health concerns, consult your Doctor.

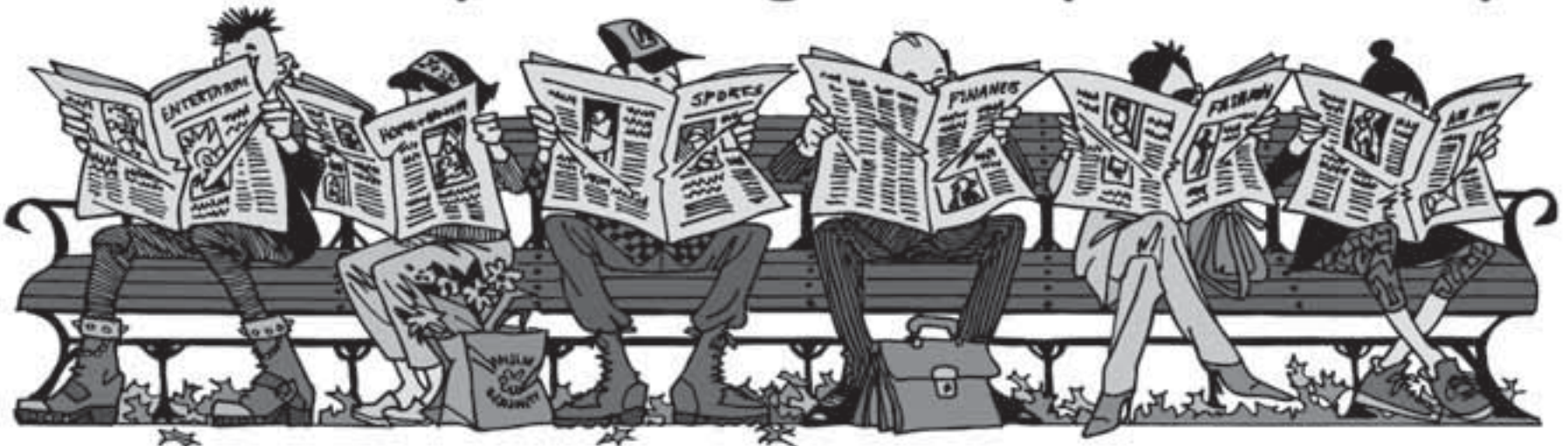

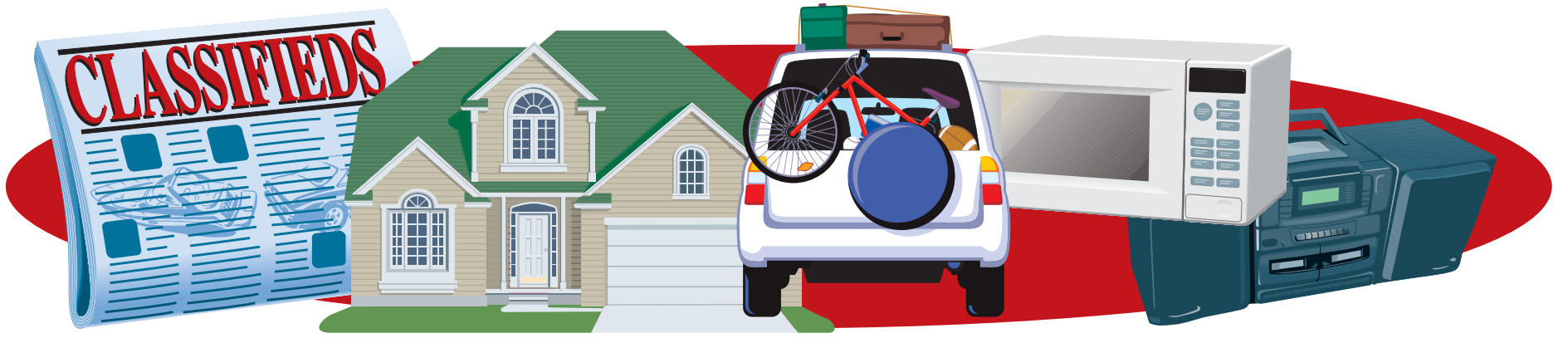
