Missing man found dead

Dale Wilson, 71, was found dead of exposure on Dec. 1 in a cow pasture less than a mile from his Homedale-area home on Hill Road, about 400 yards off North Side Road.

Wilson, reported missing on Nov. 25, was found clad only in socks. Owyhee County Coroner Harvey Grimme said Wilson had died of hypothermia, and that the temperatures and length of time the body had been in place made it impossible to determine an accurate time of death.

Grimme added that Wilson, who had a history of wandering, reportedly did so most often in the evenings.

Four Homedale Middle School are being charged with felony possession of a controlled substance following the Nov. 12 seizure of more than six ounces of freshly picked marijuana in a bread bag at the school.

The students facing charges are accused of having entered the back yard of Richard Stewart, 48, of Homedale and stripped leaves from a pot plant growing behind a

Homedale council set to vote on LID tonight

Establishment next step in downtown revitalization plan

The Homedale City Council will take the next step in the Local Improvement District process tonight.

December's only meeting begins at 6 p.m. at City Hall, 31 W. Wyoming Ave.

After garnering signatures from owners

of 66 percent of the affected property in the proposed revitalization district, the council will vote on whether to establish the LID during the meeting.

The LID is part of a \$779,000 vision city leaders have to bring in new street lighting and rehabilitate sidewalks, curbs and gutters all along Idaho Avenue as well as in a four-block area anchored by the Idaho Avenue-Main Street intersection. The majority of the funding for the downtown revitalization will come from a \$500,000

Idaho Communities Block Grant from the Department of Commerce, but leaders have said the LID will allow improvements on both First Streets, Main Street and Wyoming and Owyhee avenues as well.

Once the LID is established, public hearings will be held to give property owners the opportunity to protest their individual assessments, which can be paid up-front or over a 10-year span.

An agenda for tonight's meeting wasn't released by press time Monday, but the

council also has scheduled a public hearing to address:

- Applications for a special use permit and a variance filed by Gypsy Jackson to add on to her residence.
- An application to vacate the public right-of-way of an alley located off Sixth Street West between Washington and Montana avenues.

Testimony will be taken during the meeting, and materials regarding the applications are available at City Hall.

Gas storage tank removal continues

Anyone passing the intersection of Idaho Avenue and Main Street in Homedale is aware of the work being done at the former Sinclair station located there.

The cranes pounding in 35-foot steel retaining wall sections, backhoes and skidloaders are part of a \$400,000 tank removal project under the aegis of the Brownfields program with oversight from the Environmental Protection Agency.

Workers from G&S Excavation in Nampa spent last week seating a sectional steel wall intended to stabilize neighboring building foundations during the removal process. The plates were vibrated into the ground, causing some annoyance for neighboring businesses. Joyce Wright of Joyce's Creations, which abuts the site, said that merchandise had been sliding around her display tables, and that several pieces had broken when they jiggled off shelves.

The project will pull five 20,000-gallon fuel tanks, each 10 feet in depth and 30 feet long, from the ground, and may involve the removal of any dirt that might have been contaminated by leakage, crews said.

Property owner Tom Gaskins said the work is costing him some, but not nearly the whole \$400,000. As the property was listed as a Brownfields site when he purchased it, he does have to pay a portion of the costs "but it's miniscule compared to the total cost," he said.

Once the tanks are removed the plan is to construct an ozone-injecting unit on the site, Gaskins said. The unit will inject ozone into the ground in an effort to purify any contaminants for a year, he said, and he reported that the machinery to do so was expected to run about \$1,000 a month for power consumption.

Snow falls but not in quantity

Though the Treasure Valley was dusted with a thin blanket of fluffy white on Sunday and Monday, SNOTEL reports show that no major depth of snow has arrived in upland areas in the Owyhees.

Lawmen take kids Christmas shopping

Five Homedale Police officers and 11 people with ties to the Owyhee County Sheriff's Office took more than a dozen underprivileged children shopping Saturday.

The show of kind force was part of the annual excursion to the Nampa Kmart store formerly known as Shop with a Cop. A Kmart representative said copyright issues prevented the use of the term this year.

The children ate breakfast at a Nampa church, where they met up with the law enforcement officers assigned to take them shopping. Each child got a ride in a patrol vehicle — complete with lights and sirens — in the predawn morning to the store.

HPD was represented by Chief Jeff Eidemiller, Cpl. Mike McFetridge and Officers Antana-

cio Montes, Jeff Jensen and Steve Atkins.

OCSO was represented by Sheriff Daryl Crandall and Deputies Russ Turner, Jeff Wasson, Perry Grant, Slade Heeb, Rick Wiley, Kenny Tindall, David Green, Jayne Kingston, Jessica DeGeus and Jim Mackenzie.

Green said the group spent about three hours taking children through the aisles to buy Christmas gifts for themselves and family members.

Four Homedale High School seniors — Neil Doyle, Jose Gonzalez, Dusty Marose and Amelia McIntyre — helped wrap presents.

In all, about 60 children shopped with help from personnel from Idaho Fish and Game, Caldwell Police Department and other agencies.

More property taxes paid in full

Deadline for first-half payments nears

Owyhee County property owners are showing a willingness to pay their tax bills early and — in some cases — in full, according to Treasurer Brenda Richards.

Through Dec. 1, landowners had paid enough of their bills to account for 8.4 percent of the total tax due in the county for 2009, she said. That total is up more than three percent from last year's payments through the same date when 4.9 percent of the total tax had been paid.

"I know there were some concerns from at least our standpoint of how (tax payments) were going to come in because of the economy and the hard times," Board of County Commissioners

chair Jerry Hoagland said. "I just appreciate the people for making an effort to make sure their taxes are covered and placing them in that priority."

"We tried to hold the line as much as we could so it wouldn't be a burden on the taxpayers."

Through Dec. 1, Richards' office has collected \$464,198.33 of a 2009 tax charge of nearly \$5.5 million.

She said bills were paid in full on 78 percent of the 1,568 parcels for which her office has received payments. In 2008, only 59.3 percent of 1,279 parcels were paid in full by the first of December.

The monies received by the treasurer's office are disbursed among the various taxing districts throughout the county — schools, emergency services, libraries and others — as well as to cover the county levy.

"As the tax payments come in

each month, they are calculated and apportioned out accordingly, meaning not only the county, but each district receives their apportionment of the money collected," Richards said.

Property owners have until Dec. 21 to submit at least the first half of their 2009 property tax payment. Richards said the deadline has been extended by one day because the traditional Dec. 20 due date falls on a Sunday this year.

Anyone not paying their bill in full later this month must pay the balance by June 21 (again one day later than the usual deadline because of the Sunday).

Richards speculates that people are paying on time and in full because of the economic times. She says landowners want to hang on to their assets given the unstable financial climate.

✓ **Contract:** Mayor not sold on idea of trading utility costs for PA fees

enforcement contracts, Owyhee County Prosecutor Douglas Emery said Thursday.

Marsing's take on the situation may be a little different.

After "mutually beneficial" negotiations and concessions, the 2010 law enforcement contract with Marsing should be finalized soon, Emery said in an e-mail to The Owyhee Avalanche.

The contract will be discussed at the Marsing City Council meeting at 7 tonight at City Hall.

If Marsing agrees to waive monthly water and sewer charges at the County Annex Building on Reich Street, Emery has agreed to include prosecution of Mars-

ing infractions and misdemeanors under the law enforcement contract, rather than the previously negotiated prosecutorial contract, according to Emery's e-mail.

"No professional fees will be generated from the prosecution or handling of those FY 2010 Marsing cases," Emery wrote.

The annex building utilities — water, sewer and garbage — are a little in excess of \$200 each month, Marsing City Clerk Janice Bicandi said Friday. That would net prosecutorial services for something over \$2,400 yearly.

Marsing Mayor Keith Green is not certain that's what he'd like to see: "There's a couple of different modes of thought," he said. "If there were a lot of cases, then that would make sense."

But there haven't been a lot of cases, Green explained. In the previous five years, Marsing's outlay for prosecution under

Emery's predecessors was about \$175, he said.

"I'm not sure how it would benefit the city to have the (new) contract," Green said. He referenced the currently signed contract with Emery, announced just two weeks ago, that retained his services at \$55 an hour, not to exceed \$1,200 a year.

He's also concerned over changes to the city's enterprise fund. Utilities, and any enterprise fund, are a budgetary unit intended to be self-supporting.

"It's mandated by the government as to how much we have to charge (to service water and sewer costs)," he said. "If we're going to raise the rates in town, and then exclude people from paying the rates ... I won't say it's not going to happen, it's up to council — I only cast a tie-breaking vote — but I don't think it's in the best interest of the city."

"Legally, it can work," he said. "The general fund of Marsing would pay the water, sewer and garbage, but we've paid \$175 dollars in the last five years (for prosecution)."

He said Marsing's most-often violated ordinance, which applies to properties requiring cleanup, was changed from a misdemeanor to an infraction this year, and no longer requires court action, as it's enforced with a fine.

OCSO pact analyzed, too

Green stressed that the law enforcement contract isn't a done deal either.

"There's a lot of unanswered questions, I just need to know how it's going to line out," Green said of the contract negotiation process. "There's a lot of unanswered questions. I want the questions answered."

"I don't want to sound like I'm picking a fight with the county," he said. "But I do think we need to have standalone (budget) items such as the sheriff, water and sewer, and the prosecutor."

"We need protection in town, there's no doubt about that. But as the state says, for felonies and violent misdemeanors, they have to respond," Green said of OCSO personnel.

"On other stuff they don't have

to respond immediately, they can book it. To be quite frank with you, we've been getting booked a lot," he said, with OCSO responding when able to.

"Well, you know that's not a very good \$76,000 a year if they're not in town when we need them," he said. "Sheriff Crandall and former Sheriff Aman both said the same exact thing to us, that we are treated no differently than anybody else in the county. Then they'll turn around and say 'You wouldn't have the officers in town you do, if you didn't have the contract'. Well, you can't have it both ways. Which way is it? Are we getting the same services as anyone else in the county, or are we getting additional services?"

"I wouldn't have moved back to Owyhee County if I hadn't liked Owyhee County," Green said. "And we've got to support our sheriff's department, but they've got to come across with better answers. "When I talk to the officers on a one-on-one basis ... every one of them we have I think is quite capable. They're POST-certified officers that can do the job. It's just a matter of ... how thin can you stretch an officer?"

"Are we at a loss by not having them? I don't know," Green said. "That's up to city council."

shed on property at 214 W. 2nd St. S. The pot then made its way to the middle school, where reports reached the faculty, and then Homedale Police.

Owyhee County Prosecutor Douglas Emery said the four youths would probably be tried in the juvenile judicial system. The maximum first-time punishment for such an offense would likely be in the neighborhood of six months at a juvenile facility, he said.

The Homedale School Board took action on five of the students involved when it met Nov. 30, District superintendent Tim Rosandick confirmed. The board chose to expel all five involved, though

a stay was issued as far as permanent expulsion was concerned.

Per the board’s decision, four of those expelled will attend a class being formed in conjunction with the juvenile probation and parole office, with a possibility, based on performance, of re-entering middle school classes in January. The Homedale school district will pay for the accredited substitute who will teach the four, Rosandick said.

The fifth student has been enrolled at in the Centerpoint junior high program. That student will have an opportunity to return — based on performance — next fall.

An initial search Nov. 25 by Owyhee County deputies, Homedale police and Homedale fire personnel did not locate Wilson. His body was discovered a six days later by a landowner.

After the first day of the search, Homedale Police Chief Jeff Eidemiller had checked on Wilson’s home, located about four miles from Homedale’s city limit, to determine if he had returned.

Representatives of the Posse, Homedale Fire Department and Homedale Police Department all reported that no search had occurred — that they had been informed of — after Wednesday evening.

Wilson had been known to

bicycle or walk as far as Adrian, so searchers on Nov. 25 included Malheur County sheriff’s deputies and an alert was made to Canyon County officials.

Repeated calls to the Owyhee County Sheriff’s Office seeking comment weren’t returned.

Court briefs

B2H: Oregon ag may trump Idaho

While the routing of Idaho Power’s proposed Boardman-to-Hemingway 500-kilovolt line is still under consideration, state law may give Oregon an edge in the eventual placement of the line.

Adam Bless, Oregon Department of Energy facility analyst, said that state law covering the siting of utility corridors on Exclusive Farm Use (EFU) land could give an advantage to Oregon farmers, as long as a reasonable route existed on Idaho ground.

The law requires utilities avoid construction unless one of a few exceptions arise: No other zone of availability, safety, engineering feasibility, overriding state or federal land (such as National Parks) and the need to have the line reach a specified point, he said.

The last exception includes the definition that a line must follow a “reasonably direct route” — but what is reasonable is in part left, in Oregon, to citizen commissions that operate with authority to site corridors under existing legislation, Bless said. In Idaho citizens are in an advisory role through the Idaho Power-created Community Advisory Process (CAP), members of which don’t have authority to site a line, or Idaho legislation backing up their suggestions.

All-Idaho “not feasible”

In contrast, as Malheur County Judge Dan Joyce pointed out after last week’s B2H planning meeting/discussion in Parma, Idaho Power is less than enthused with the bulk of three routes charted largely or completely in Idaho.

Joyce said he was left with the feeling that the routes in question, including one that looped through Washington state and entered Idaho near Lewiston, had been re-

moved from consideration, which he said should not have been done without CAP members’ input.

Idaho Power communications liaison Piper Hyman said that the routes had not been officially excluded, but that Idaho Power delivery planning manager David Angell and project leader Kent McCarthy had verbally confirmed at the meeting that “two weren’t viable for cost and distance reasons. They were cost prohibitive.” They believed parts of a third route might be valid, she said.

She said Angell and McCarthy had expressed opinions that the routes would not work as they failed to dovetail with the existing Treasure Valley Electric Plan.

“Those lines don’t make any sense for the plan,” she said.

Another Idaho Power meeting is set for Dec. 17 in Baker City.

Vessel Fund spending puzzles citizen advisors

Waterways commissioners question boat purchase

Owyhee County Waterways Commission members have some questions on how money — money they are supposed to advise the county on how to spend — is being spent.

Last week, the Board of County Commissioners outlined a retention request for \$46,000 in Vessel Fund monies that otherwise would have had to be returned to the state.

The commissioners have asked to retain funds received from the Idaho Parks and Recreation Department through boat registration fees for a boat ramp and parking facility for the City of Grand View (\$5,000), a vehicle to tow the county’s fleet of patrol boats (\$26,000) and a flat bottom

boat to patrol the Snake River from Grand View to the Oregon line (\$15,000).

But while Marsing resident Bob Aldrich doesn’t have a problem with most of the improvements outlined by the commissioners in last week’s retention document, he and fellow Waterways Commission member Jerry Benson are puzzled about how other monies from the Vessel Fund have been spent this year.

“The biggest confusion is the sheriff bought a new boat for 40-plus thousand dollars and none of the money went through us at all except it came out of our account,” Aldrich said.

The commissioners made a similar retention of funds late in

2008, including an earmark for the purchase of a new boat.

Larry McDaniel of Murphy, who is the Waterways Commission chair, couldn’t be reached for comment for this article. BOCC chair Jerry Hoagland said McDaniel still was chair of the citizens advisory committee for the Vessel Fund despite the fact that McDaniel resigned from his job as county Road District 1 supervisor two months ago.

After a presentation by Owyhee County Sheriff’s Marine Deputy John Nagle on Sept. 8, the BOCC unanimously approved the purchase of a 2008 Kodiak Cobra. According to county records, the cost was \$40,100.

Following the BOCC’s vote, Hoagland said testimony given during the presentation left him with the impression that the Waterways Commission had been

consulted. During the Sept. 8 meeting, Nagle told the board that he had discussed buying the boat and building a storage facility in Marsing with McDaniel. The Waterways Commission never appeared before the BOCC to discuss its take on the proposal.

“We took somebody’s word for granted, and we shouldn’t have,” Hoagland said in the days after the commissioners’ vote, which he characterized as a “procedural error” on the part of the BOCC.

“I think just like any advisory committee or subcommittee, they need to bring their recommendations to the board, and I had assumed that that had been done.”

Aldrich said the Waterways Commission had agreed to give \$10,000 toward the purchase of the boat when Nagle had applied for a state grant for a new boat in January. Nagle told the commissioners in September that

that grant had fallen through.

Last week, Hoagland said future Vessel Fund purchase decisions will be tabled until the Waterways Commission can give its input.

Benson said that the last Waterways Commission meeting he can recall was when Givens resident Bill Jones was still active in the group.

“We’ve had some phone discussions,” Aldrich said. “Generally we go with Larry’s recommendation, too. I haven’t had a problem with that.”

Aldrich added that the Waterways Commission’s diminished advisory role is a new phenomenon.

“It’s only been going on in the new sheriff’s administration,” he said. “Before, everything went through (then-Sheriff Gary Aman). We asked him what he needed.”

Dick Wells of Grand View and Marsing’s Lynn Johnson, owner of Henson’s Dry Dock in Caldwell, were mentioned as possible candidates for the commission now populated by chair Larry McDaniel of Murphy, Givens resident Jerry Benson and Bob Aldrich of Marsing. Aldrich said he has been on the advisory panel for seven years.

“(Members) are supposed to be reappointed every so often and it hasn’t been done for quite some time,” BOCC chair Jerry Hoagland said.

Hoagland said Wells was suggested because, “We really thought we needed someone from the other end of the county.”


Hoagland said the BOCC will begin interviewing those interested in serving on the commission and also will approach the three standing members to gauge whether they want to continue in their roles.

Hoagland said that the knowledge that Aldrich and Benson bring to the commission is vital.

The District 1 commissioner added that anyone wanting information about serving on the advisory panel can call either him or District 2 Commissioner George Hyer or District 3 Commissioner Dick Freund. Inquiries also can be made by calling the county clerk’s office at (208) 495-2421.

Hoagland said that appointments could be made by the end of the year.

144 years ago

December 9, 1865

THE CHURCH is so far advanced as to warrant the announcement of a Sabbath School Festival in it on Christmas eve. The teachers and children decided this matter last Sunday. Subscriptions to carry it through creditably are being liberally made. All it needs now to make it a most interesting occasion for the little ones, is for the ladies to give it their support and presence. Without them, there can be no genuine festival. They furnish home with content and smiles; social gatherings with purity, gayety and attraction. Ladies are peculiarly fitted to contribute to the pleasures of children, and no feast for them can be a success unless directed by women.

COMPLIMENTARY. The citizens of Owyhee have raised nearly \$900, to purchase a large silver brick, which will be presented to his Excellency, Gov. Lyon, the ensuing week. Parties desirous of a peep at the brick can be accommodated at W., F. & Co.’s office. After presentation we’ll note how it was done. E. C. Sterling, Esq., has done the hard work in this matter, and furnished us these points.

GAME. The mountains of Owyhee are alive with game. Deer, mountain sheep, lofty rabbits, grouse and sage hens, are plentiful. Hardly a day passes but a deer is brought into market. Miners who camp out in the hills are at all expert with a gun, are supplied with choice venison and wild mutton. Our old-time friend, Jonathan Wells, says he only needs an hour or two to capture a deer or sheep. Pretty good country in which to live high.

THE DIAMOND FEVER has been raging furiously for the past week. Being owners of only two claims, each 300 feet square, we’ve kept cool, etched its progress, and the excitement seems to have reached the point of culmination. This excitement is one that has diamonds or crystals, which stand every known diamond test, for a foundation. Col. Fogus, Geo. Collier Robins, Messrs. Dewey & Musgrave, have each subjected these crystals to the severest tests known, and they are convinced of the existence of genuine diamonds in the new district – the laws of which are in this paper. The crystals found are small, from the size of a grain of sand to that of a small grain of wheat, but they exist all over a tract of country about forty miles square. Viewed with a glass, they present the shape and true diamond face. The prospecting has been done hastily and very imperfectly. There is a much greater quantity of quartz brought in than diamonds. This arises partly from a want of information on the matter, partly from highly wrought zeal, and to a great extent a disposition to burlesque. So far from this being a real subject of burlesque, it is one that commands the careful attention of our leading and best informed citizens.

DOUBTS have been expressed concerning the existence of quicksilver in the ore found in Quicksilver District. Not being in adept, we were not prepared to deny the expressions. Wednesday P.M. we saw the pure stuff retorted by H. B. Beck. We saw the retort before used, and knew that is was perfectly clean of everything. We saw the rock put in, the retort closed up and our eye was never off it until we saw the quicksilver dropping out of the pipe. The ore tested would not exceed in weight one-half pound, and the quicksilver obtained weighs twenty-nine grains – or equal to two hundred and forty-two ounces to the ton. The ore tested was not an extra specimen, and came from the Discovery claims in Quicksilver District. That immense quantities of cinnabar lie in this district is beyond dispute. That it will be profitable to the parties who work it, and to this region generally is true. Conveniences of wood, water and stone for building furnaces are on the ground and plentiful.

J. A. CHITTENDEM, assayer, has just received a mammoth pair of gold scales, of H. Troemor’s make, Philadelphia. They are capable of weighing 1600 ounces at one draft. This should not discourage the platform scales project. There’s room and profit for both.

On the edge of common sense Veterinary frustrations

In my travels I continue to be amazed by the technologies being used in ranching and feedlot operations. The close monitoring, record keeping and decision-making as a result of implant or ear tag scanning and computer tracking of individual beasts is fine-tuning and improving our productive efficiency.

But it wasn't always that way. Dr. Darrell is a cow veterinarian and theriogenologist, as am I. We were waxing nostalgic about the good ol' days when, despite our valuable medical opinion and sage advice, we didn't always get the message across!

Darrell told of preg-checking a pasture full of dairy heifers in southern Colorado. The farmer, Mario we'll call him, had dumped a few black bulls in with the heifers. About halfway into the bunch Darrell palpated something odd? The heifer he was in had no uterus and no ovaries! To an experienced vet, it's as obvious as reaching into your pocket and suddenly finding no car keys!

"This heifer is open," he told Mario, "She's a freemartin."

Mario looked puzzled. The good doctor explained at length the congenital conditional, defined hermaphrodite, and the prognosis: She would never be capable of conceiving. He even drew diagrams in the dirt, then suggested that the heifer be put into a feedlot and eaten. Mario nodded seriously, then turned her out of the chute. He instructed his helper, "Put her back in with the bulls, her ovaries haven't come down!"

Darrell continued his tales; he was on an 800-head Nevada cow ranch that had never done preg-checking, his grandpa didn't believe in it. But the young rancher wanted to modernize. Darrell painstakingly explained the importance of culling open cows to prevent Trichomoniasis and improve production. They cut the cattle two ways: Open and Bred. Darrell was not surprised by the 50 percent conception rate. While he was rinsing out his bucket, he glanced up to see the young rancher mixing the cows back together! The young rancher acknowledged it was good to know how many calves to expect, but Grandpa always said the place would run 800 cows and who could argue with that?

Once, a company I was working for bought a ranch in northern California. I went down to inventory the cows. With the crew I preg-checked 2,200 head and sorted them into Open, Bred and Old. They had a good set of corrals, so I didn't bother to mark them. It took three days. To finalize the deal, the boss send down a crusty ol' cattle buyer named Harold. He was experienced, the boss told me. I woke up morning four to find Harold had turned the cows all together and was gate cutting them himself in the long alley! I was stunned, mad and bumfoozled! "I sorted these cows, preg-checked and mouthed 'em ... it took us three days!" I stammered.

"Sorry, ya wasted yer time, Sonny," he said, "Anybody can tell if they're old. And I can tell if they're bred by the way the hair lays on their back!"

Eyes on Owyhee Answers are needed



Dale Wilson missed Thanksgiving this year, as he was either dead or dying of hypothermia in a field a little less than a mile from his home on Hill Road west of Homedale.

Wilson was the central figure in what was a search and rescue effort that didn't seem to do much of either. Wilson, 71, possibly off his medication for mood disorders, and with a history of wandering, was reported as missing by a friend and neighbor on Nov. 25, after it was noticed that he hadn't had a fire burning to heat his home.

This just one day after a search involving Sheriff Daryl Crandall, two deputies and three Posse members located two Nampa hunters lost in the Succor Creek area. A successful search announced within 24 hours in a press release.

By 4 p.m. on the 25th Chief Deputy Bill Detweiler and two Owyhee County Sheriff's deputies were on scene at Wilson's home, along with Homedale Police Chief Jeff Eidemiller and the majority of the Homedale Fire Department and Ambulance service. Crandall and Deputy Perry Grant were listed as having been on scene earlier. The report was logged at 1:17 p.m.

Searchers divvied up the roads likely to have been used by Wilson. Wilson was thought to be afoot, as both his truck and bicycle remained at the home.

Firemen, officers and volunteers searched several hours, until nightfall brought a halt.

A press release was issued by the Owyhee County Sheriff's Office on Nov. 27 at 10:14 a.m., giving a description of Wilson and asking for anyone with information to call the sheriff's office.

As far as The Owyhee Avalanche can determine, that was the only action the county took following the initial Wednesday evening search.

Wilson wasn't seen again until his body, clad only in socks, was recovered in a cow pasture on the evening of Dec. 1 after a landowner's report.

What was, or wasn't, done in the interim is a question that begs an answer, and hasn't received one yet. Neither Crandall nor Detweiler were available for comment on what steps the county took to locate the missing man. Calls to OCSO on Nov. 27, 28 and 30 reached only dispatch personnel, who had no information on Wilson or any search. A call in the morning on Dec. 2 to confirm that a body had been found and the nature of the search suffered the same fate. Again, on Dec. 4, a call for information was not returned.

Detweiler had tried to have a tracking dog brought from Canyon County on Nov. 25. Whether the dog ever arrived isn't known. If it did arrive, why it failed to locate the missing man is equally problematic.

Wilson was said to have a habit of breaking into homes or hiding in sheds, and a "shed-to-shed" search was discussed by deputies and searchers on Nov. 25, but whether it ever occurred, and who carried it out, are not known.

His body was discovered less than 100 yards from a small derelict trailer holding an old upholstered chair. Whether the spot was a "holing up" area for Wilson will probably never be known.

The only radio traffic concerning any searches during

We were on our usual Sunday shopping tour. As we left a store, I had an idea.

"Let's stop by Freddy's grocery store," I said to Sara.

"I want to see if they have any olive loaf lunch meat," I said.

Finally, there was olive loaf, my favorite sandwich meat. Olive loaf was much like baloney, but enhanced with green olives and pimentos. In those days, olive loaf came in large square cornered loaves. You could have the guy at the meat counter slice it to any thickness. I liked olive loaf because when I bit into a piece of olive it gave me a burst of accented flavor one didn't get with baloney.

"I checked a while back at the store and couldn't find olive loaf," my mate said. "I don't think anyone makes olive loaf anymore."

"Did you check at Freddy's?"

"No."

"Well it won't hurt to see if they have it," I said. "And you know what?" I added. "If they do have olive loaf, I'm also going to get a loaf of white bread."

In the old days, I always ate my olive loaf on white Wonder Bread. But in recent years Sara has tried to increase the length of my life by buying only whole wheat bread. Although the experts claim white bread is bad for me, I like it much better than whole wheat. Besides, organic, whole wheat bread will mold if you don't eat it quickly. White bread is too loaded with preservatives to ever mold.

At the store, we did some Christmas shopping. Then I headed for the grocery section. I looked around the meat department and was just about to give up on my quest when I spotted an Oscar Meyer display of pre-packaged sandwich meats. And among the choices was OLIVE LOAF!

Interest rate crucial in decision to consolidate student loans

Dear Dave,
I've got my beginner's emergency fund in place, and I'm close to wiping out my consumer loan debt. I still have about \$32,000 in debt from six different government-insured student loans, but they're in deferment at the moment. I was wondering if I should try to consolidate them.

Dear Jason,
Well, you get to consolidate these one time. After that, you're stuck. So, you'll want to make sure that the net interest rate you get through consolidation is lower than your current rate. Also, make sure the interest rate is fixed. You don't want to jump through hoops to make this deal happen, and end up with an interest rate that's equal to or higher than the one you had before!

Student loans are the only things I'll tell people to consolidate. They're a little different



animal than ongoing loans and other kinds of credit. Chances are you're not addicted to going to class, so you probably won't go out and ring up more student loans after you've finished your education and paid off these things.

Just maintain that gazelle intensity, keep working hard to get out of debt, and pay these things off early. Remember, too, that in lots of cases consolidating student loans will move them out of deferral. There's a good chance you'll have to start making payments right away!

the following week heard at the *Avalanche* concerned Eidemiller, who was checking on Wilson's home to determine if he, or anyone, had visited the site. No one had.

Eidemiller confirmed that he checked Wilson's home over the next several days to see if he had returned. He also said he had conducted a vehicular search of the some of the surrounding area. He did not know of any search process under the auspices of the county, which was the

investigating entity in this case, and said he did not see any other searchers when he had been in the area.

Both ranking Homedale Fire personnel and Posse leadership were unable to confirm any further search had been made. Both said they had not received any requests for personnel to search.

Why?

Perhaps there are excellent reasons that the search was limited. Perhaps a massive search occurred, and no one was the wiser, but in any case the public and those who

depend upon OCSO for emergency services have a right to know what was done — or not done — and why.

They had a right to know over a week ago, when it mattered.

We at The Owyhee *Avalanche* invite such an explanation from the sheriff, at his convenience, and up to 500 words in length. We, and others, would be most interested to hear what he has to say.

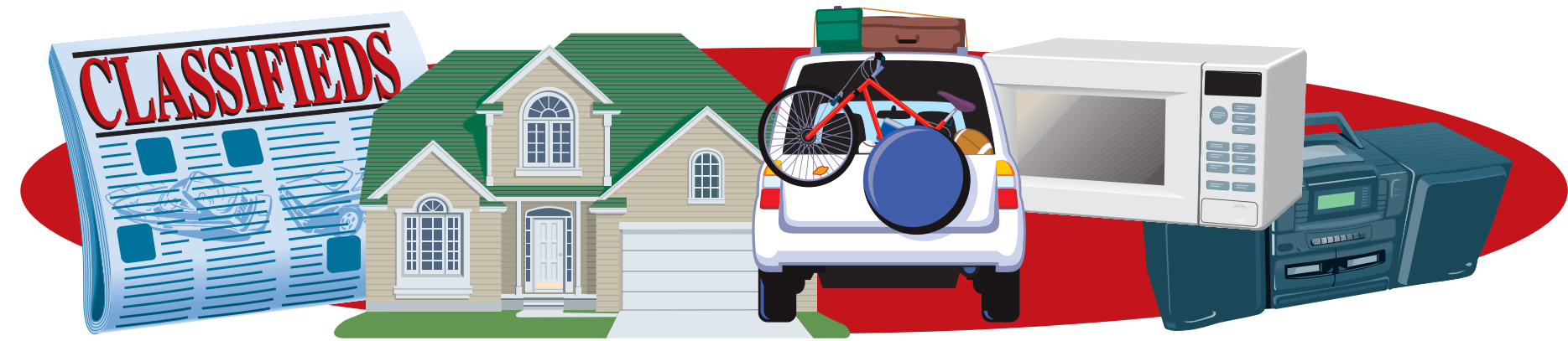
