2009 year-in-review



2009 saw triumphs, tragedies and remembrances, and a county that dealt with them all.

January

Alexandro Juan Dominguez, 26, died Jan. 1 when the Catepillar loader he was piloting tipped over as he was moving feed at a Deruyter Dairy hay lot northwest of Marsing.

The Wilder Holiness Church Food Pantry announced it could no longer service Owyhee County residents.

On Jan. 5 George Hyer was sworn in as District 2 Owyhee County Commissioner. District 1 Commissioner Jerry Hoagland began his second term in office. Douglas Emery became prosecuting attorney. Daryl Crandall became sheriff and Bill Detweiler was named chief deputy.

Arthur Schmierer of Homedale was arrested after allegedly attempting to solicit a minor over the Internet. Anthony Lazaro Quintana, a former Homedale resident whose address is listed as Boise in court records, was charged with lewd conduct with two children under the age of 10 in an Owyhee County case.

American Ecology awarded nearly \$15,000 in grant money to more than a dozen organizations in Owyhee County. Libraries, schools and community centers will get assistance from the company that owns the U.S. Ecology Idaho (USEI) hazardous waste site outside Grand View.

Rotary International member Jerry Conger and fellow volunteers handed out dictionaries to each third-grader at Homedale Elementary School.

During its first meeting of the year on Jan. 14, the Homedale City Council approved the new airport ground lease agreement and passed the proposed vendor license on to the city Planning and Zoning

Commission for discussion and an eventual public hearing.

The Homedale Hawks Pathfinders presented 34 blankets to residents at Owyhee Health and Rehabilitation (OHR) in Homedale on Dec. 27. The holiday gifts were hand-made by the Pathfinders, who began sewing them in October, and finished just in time for the holidays.

Homedale Police Chief Jeff Eidemiller promoted Mike McFetridge to the rank of corporal and moved Atanacio Montes to the position of senior patrol officer while announcing the departure of Cpl. Perry Grant, at the Homedale city council meeting on Jan. 14.

The Senate passed the Omnibus Public Lands Management Act on Jan. 16, sending the bill that contains the Initiative to the House of Representatives.

Hyer balks at lack of protocol in grant approval

Application for energy efficiency money submitted without vote

Citing a breach of protocol, District 2 Commissioner George Hyer abstained from voting on a resolution that could result in money for energy efficiency upgrades to county buildings.

County commissioners Jerry Hoagland (District 1) and Dick Freund (District 3) voted Dec. 22 to let a Boise startup company apply for a grant through the state Office of Energy Resources.

Dec. 18 was the application deadline for the Energy Efficiency and Conservation Block Grant (EECBG), and Hoagland and Freund signed off on the application in time even though the

On Dec. 14, Freund said he would contact Higher Power Energy LLC representative Paul Dietzler to discuss changes the commissioners wanted from the company's original proposal.

Hoagland said he and Freund signed the application on the advice of Prosecuting Attorney Douglas Emery. Hyer said while there was e-mail correspondence between the PA and the commissioners, he was unaware the


Students and faculty utilizing the Rimrock Jr.-Sr. High School library can kick back in style after a donation of furniture.

"The furniture adds a safe and comfortable place to study," Rimrock student Travis Jackson said.


Key Bank also donated cabinets and workstations for use in classrooms throughout the school.

Freund named to BLM RAC for Boise

Commissioner replaces Aman on advisory board

Dick Freund has been named to the Resource Advisory Council for the Bureau of Land Management's Boise District.

The District 3 Owyhee County Commissioner from Murphy announced his appointment at the board's weekly meeting at the courthouse annex. He said he received his letter of appointment for a three-year term Dec. 21 from Interior Secretary Ken Salazar.

Freund replaces former Owyhee County Sheriff Gary Aman on the board. Aman stepped down when his tenure as sheriff ceased. While Freund happens to be from Owyhee County, any elected official from the Boise District's area of coverage was eligible to

apply for the position.

The 15-member panel provides advice and recommendations to the federal agency on resource and land management issues for about 5.4 million acres of public lands in southwestern Idaho.

Field offices in the Boise District include the Owyhee and Jarbidge areas.

Other people with Owyhee County ties on the Boise RAC include ranchers Donna Bennett, Brenda Richards and Ted Hoffman and Shoshone-Paiute Tribes cultural resources director Ted Howard.

Freund said he never has attended RAC

meetings, which are held in Boise, but hopes to give the public a voice in dealings with the BLM.

Freund begins the final year of his four-year term as county commissioner next month.

Atkins reappointed to county board

The planning and zoning commissions for Marsing and Homedale will hold public hearings early next year.

The Marsing P&Z panel is up first, seeking public testimony regarding the city's proposal to annex the Marsing Labor Camp.

The hearing begins at 7 p.m. on Tuesday at Marsing City Hall, 425 Main St

Public comment will be taken during the meeting, and written testimony can be submitted to city hall until 5 p.m. on Tuesday.

The Homedale P&Z board will hold a public hearing on a lot split on the location where the proposed Pruett Lumber yard and store will be built on U.S. Highway 95 next to Pruett Tire Center.

The hearing takes place at 7 p.m. on Jan. 11 at Homedale City Hall, 31 W. Wyoming Ave.

The lot split application and other details can be viewed at city hall during normal business hours.

Earlier this month, the Board of County Commissioners unanimously reappointed Clay Atkins of Bruneau to another three-year term on the Owyhee County Planning and Zoning Commission. Atkins began serving in 2007.

Commissioners appoint 911 advisory panel

Marsing law enforcement contract OK'd

The Board of County Commissioners tied up several loose ends in its final meeting of 2009 last week.

The commissioners finalized a list of emergency communications committee members who will help shape the county's 911 policy.

According to Resolution 09-57, the roster includes Rob Howarth for Marsing Fire and Ambulance (four-year term), Homedale Police Chief Jeff Eidemiller (four years), Murphy-Reynolds-Wilson Fire Chief Wes Anderson (two years), Grand View Ambulance and Fire representative Donna Bennett (two years), Fire Chief Scott Salutregui for Homedale Fire and Ambulance (two years), Bruneau Quick Response Unit and Fire rep Sherry Colyer (two years), Assessor Brett Endicott (four years) and county Civil Defense coordinator Jim Desmond (four years).

While he is the administrator of the 911 system, the sheriff won't be a member of the advisory panel, although he is allowed to make recommendations on his own to the commissioners.

Crandall said during the departmental issues portion of the Dec. 22 meeting that he sent letters informing the candidates of their appointment a day earlier.

The committee appointments end a process that began in the summer when Crandall was instructed to form a committee to study the needs of the county dispatch center's 911 system.

The sheriff later applied for a state grant to finance a new center. District 3 Commissioner Dick Freund told The Owyhee Avalanche last week that he had been told by a state official that the grant had been rejected because it was submitted late.

The grant application was submitted by the deadline, but a signature page with endorsement from the commissioners was sent four days later. Freund said the state panel in charge of awarding grants viewed the application as late because the authorizing signatures didn't arrive with the rest of the packet.

The grant application sought \$98,887.16 in state funds, and \$127,534.09 in county 911 trust fund money would have been added to purchase new 911 equipment.

Law enforcement contract approved

The commissioners unanimously approved a law enforcement contract with the City of Marsing for fiscal year 2010, including provisions for a school resource officer.

During discussion of fulfilling the SRO obligation, Crandall told the commissioners that Deputy Jeff Wasson patrols strictly in Marsing.

Crandall also expressed concern that the call volume in Marsing would increase if the city follows through on its plan to annex the Labor Camp.

He reported that call volume has remained steady in the winter, which is a departure from previous years when calls for assistance dwindled as the temperature dropped. Crandall didn't speculate on why the call volume has remained at levels not usually seen in the winter.

Crandall added that the same phenomenon is happening in Grand View and expressed concern that the constant activity may reflect the possibility of the call load handled by his deputies doubling in the summer.

The sheriff also offered a rough recap of the wrecks triggered by slick conditions during a Dec. 15 snowstorm, including one driver in a rollover accident who was arrested on a charge of felony in possession of a firearm when he emerged from his vehicle with a .22-caliber weapon. The sheriff didn't identify the person arrested during his report.

Rustlers rare in Owyhee County

Though concerns exist for ranchers in Oregon and Nevada, and those who run cattle there, Idaho State Brand Inspector Larry Hayhurst said there were no known instances of organized cattle rustling in Owyhee County, despite a recent widely read Associated Press piece, picked up from The Oregonian, saying otherwise.

"That one article said we were missing 1,200 head of cattle from Murphy to Steens Mountain," Hayhurst said. "That's not true. A lot of ranchers have property into Owyhee County but they're not missing them on the Idaho side, they're missing them on the Oregon and Nevada side."

"There's an issue going on there (in Nevada and Oregon), that's for sure," Hayhurst said. "There is a problem over there. They're missing a lot out of the Alvord Desert and the Steens, Roaring Springs."

Hayhurst said he's attended three meetings in McDermott, Nev. on the situation, and stays in touch with the brand inspectors of other states.

"Those guys in '08 were losing a lot of cattle. I think it'll be better in '09, plus, these ranchers have dipped into their own pocket to bring out reward money ... so those things are all true," Hayhurst said of the Oregon and Nevada thefts. "There's a huge issue over there, but it's not Owyhee County."

That having been said, he pointed out that 200 head missing in Indian Valley last year have never been found, but while Owyhee County may not be free and clear of any cattle loss, it's nothing out of the norm. Being alert, reporting anything out of the ordinary, and just keeping an eye on things is still good advice, he said.

With roundups and head counts underway, Hayhurst expects some numbers for Owyhee County will be available in January or February, which will be the earliest he has a look at what sort of loss will be reported for the year.

"I think the numbers in '09 are going to look better because we have public awareness," Hayhurst

said. "The problem with this (the AP story) is that I have everybody and their dog calling me, but it does make the public aware, so I don't really care if it's inaccurate

As to the areas that are being preyed on by rustlers, Hayhurst said investigations were under

"We will figure it out, sooner or later," he said.

"And when we do, it's not going to be a stranger."

Whoever is taking cattle in the Nevada-Oregon area is familiar with the terrain, feeding schedules and handling stock, he said.

"They know how this game's played."

Fitness class coming to Owyhee extension

The University of Idaho Owyhee County Extension Office is poised to help women with their New Year's resolution of exercising more.

The next Strong Women, Stay Young series of classes will be held in January and February at the extension office, 238 8th Ave. W., in Marsing.

Marsha Lockard leads the classes that are based on a national fitness and nutrition program. The classes are open to women 35 and older in Owyhee County.

According to a press release, health experts recommend strength-training to middle-aged and older women because it improves muscle mass, bone density, balance and weight control. The loss of strength, achy joints, tiredness and weight gain that tend to accompany advancing years have more to do with inactivity than aging.

Participants will learn how to perform eight different strengthtraining exercises, as well as stretching and balance exercises. Each class will conclude with a short nutrition lesson, as well.

Classes will meet Tuesdays and Thursdays from 9:30 a.m. to 10:30 a.m. at the extension office.

Participants develop a plan for their property and share ideas with a team of expert instructors and other participants.

Emery had given his consent.

In abstaining from the Dec. 22 vote, Hyer admonished his colleagues for signing the document, invoking the flap created earlier this year when the sheriff's office was reprimanded for submitting grants without a BOCC vote.

"I'm just trying to follow the guidelines that were set," Hyer said.

Higher Power Energy has been authorized to apply a grant to finance upgrades that include solar-powered water heating for the county jail, courthouse and courthouse annex in Murphy as well as updated windows and doors in the courthouse. Originally, Higher Power had proposed \$34,000 of the grant be used to buy solar-powered street lighting.

According to Higher Power's proposal dated Dec. 1, the grant would total \$100,000. Dietzler filed the company as a limited liability corporation with the Secretary of State's office in July.

If the state awards the grant, Owyhee County would be reimbursed for money it pays Dietzler's firm. There are no matching funds for the grant, Hoagland said. The only non-reimbursable county spending would be a \$4,000 administrative fee.

Hoagland said there is skepticism in the county offices on whether the grant written by Higher Power would pass muster with the grant award panel.

"The prosecutor and us thought there were so many holes in it that the grant staff would take a second look," Hoagland said. "The prosecutor said he'd be surprised if we got it because (the grant application) was poorly developed."

The commissioners selected Higher Power over well-established McKinstry, which had suggested a performance contract approach to beef up efficiency through windows, lighting and heating, ventilation and air conditioning upgrades. The company's representatives also put forth the idea of a future biofuels plant project that would — in theory — take the county complex off

the power grid.

The commissioners were uncomfortable with the performance contract angle because it went beyond the scope of the original grant funding. They also expressed concerns that a county-run power plant would deprive private businesses of opportunity.

Planning and Zoning administrator Mary Huff, who had facilitated contact with the energy companies, had recommended the BOCC select McKinstry.

Despite freezing rain and treacherous roads, more than 80 land-owners and concerned residents attended the first meeting of a grassroots organization that seeks to have Idaho Power relocate its proposed 500-kilovolt (kV) Boardman to Hemingway Transmission (B2H) line route corridor.

The Bruneau Valley Library announced how it used a \$300 U.S. Ecology, Inc. grant. The grant, presented to library director and board members, was spent to buy non-fiction children's books.

February

A crowd of potential bidders put

After more than a year of legal maneuvering, Homedale residents Deborah Hopson and Zachariah Robinson pled guilty to two misdemeanor counts each of animal cruelty on Feb. 6 and were sentenced to two years of probation.

At his Jan. 30 arraignment in Canyon County District Court, Homedale resident Arthur Gene Schmierer entered not guilty pleas to both enticement of children over the Internet and lewd conduct with a child under 16.

Homedale Police Chief Jeff Eidemiller presented Idaho National Guard Capt. Charles Garrison and Spec. Jack Macleod a plaque on Feb. 11 in appreciation of the local unit's cleanup efforts.

Third District Judge Gregory Culet ruled in favor of the City of Homedale in its court battle against Lurre Construction of Caldwell. Local teachers Jennifer Martin and Jim Eisentrager — of Homedale and Marsing Middle Schools, respectively — were presented with \$9,980 checks as winners of Qwest Foundation for Education grants their proposed science class projects.

Homedale businessman Mark Jolley faces a Feb. 27 felony arraignment in Third District Court in Murphy after his preliminary hearing Feb. 23. Jolley entered not guilty pleas to both charges.

The owner of Allied Signs and the Owyhee Ice Cream Co., faced two counts of aggravated assault with the use of a deadly weapon. He was arrested on Dec. 8, 2008.

He was later sentenced to threeto-five years on each conviction, suspended, and was placed on five years of supervised probation and 179 days in jail.

The Idaho Transportation Department announced that rehabilitation and overlay of the U.S. Highway 95 bridge deck in Homedale would begin. The project was slated to cost \$638,815.

The Homedale school district renewed the 2009-10 school year contracts for principals Mike Williams (high school), Luci Asumendi-Mereness (middle school) and Yvonne Ihli (elementary school) during the Feb. 9 meeting.

Fifteen participants ranging in age from 13 to 80 took part in the first Community Emergency Response Team (CERT) training in Marsing in late February.

Homedale High School Language Arts teacher Harley Miller received a \$885.65 Governor's Innovative Grant Award

March

Bruneau's Colyer Herefords was honored with three champion bulls at last month's Fort Worth National Hereford Show in Texas.

The Grand View Water and Sewer Association and City Council both accepted the loan contract from the Idaho Department of Environmental Quality during their joint Dec. 10 meeting. Grand View also pursued, and won, a \$360,000 Idaho Community Block

Grant to help fund its water and sewer project.

Gypsy Jackson, Herb Fritzley, Art Trogdon were all nominated and appointed to four-year terms on the Homedale planning and zoning board, while Jim Packer and Reed Batt were reappointed for six-year terms.

Idaho Power announced the Community Advisory Process to involve residents in the routing of the Boardman-to-Hemingway Transmission Project on March 4, following resistance from Stop Idaho Power, legislators and landowners.

The Owyhee County Board of Commissioners explored moving the county probation office to the new Marsing annex building in early March.

Homedale bridge construction began March 15. ITD crews also began a months-long shoulderwidening project on a seven-mile section of U.S. 95 between milepost 26 and milepost 33.

Jeff Jensen is the newest addition to the Homedale Police Department, hired in late October.

FFA members distributed approximately 1,000 pounds of pork on March 17. Twenty to 35 pounds of meat went to local families, with the rest handed over to local churches and the Homedale food bank.

Homedale officials said that a communication breakdown led to the city missing the deadline for filing requests for a piece of the massive federal stimulus package. 
Richard James "Dick" Kershner

April


Both Marsing and Homedale elementary schools received \$710,000 over five years from the Idaho 21st Century Community Learning Center grant program.

Rylee Loucks, 7, brought home a top-five award from the National Old Time Fiddle Contest in

Weiser. She also finished fourth in the Small Fry Intermediate Novice division at the Nampa Civic Center.

A parade of 55 vintage Ford Model Ts traveled Owyhee County highways from Walter's Ferry Bridge through Homedale on June 29 as part of a centennial observance.

A formerly Melba-based Silver Falcon Mining mill is set to shift its operation to a location near Murphy.

The \$200,000 parcel adjoins Ridge Road (Silver City Road), and the mill was installed and under production by the end of September.

Garrett Bradshaw, 15, of Mountain Home drowned July 6 in the Bruneau River upstream of the Indian Bathtubs. The victim and three companions were swept over a low retaining dam while swimming, and Bradshaw was trapped in the turbulence below, Harvey Grimme, Owyhee County Coroner said.

The Board of County Commissioners approved more than \$3,500 on July 7 to buy a radio for each HPD squad car. This will allow police officers, who have UHF radios, to communicate with Homedale Fire and Ambulance personnel, who talk on the VHF

With the combination of government spending and dwindling revenues threatening fiscal soundness, the Board of County Commissioners declared it must approve all Owyhee County expenditures over \$250.

Facing more property assessment appeals than a year ago, the county Board of Equalization denied a greater number than in 2008. The board heard the last of 64 appeals on July 7 in Murphy.

Southwest District Health spokesperson Laurie Boston told The Owyhee Avalanche on July 13 that a mosquito trapped within the Bruneau townsite last week had tested positive for West Nile

Kurt Shanley was re-elected chairman of the board during the Homedale school trustees' annual meeting.

Zone 2 Trustee Tim Quintana also was sworn in for his next fouryear term at the July 13 meeting. Zone 3 Trustee Kevin Miyasako will continue as vice chairman.

As some observers suspected, Michael Eby was named the Indoor Football League's Defensive Rookie of the Year in mid-July.

The 2002 Homedale High School graduate was tabbed for the postseason award after a first professional season in which he led the Billings Outlaws with 10 interceptions in 14 games. The free safety's pickoff total was tied for second in the IFL.

A 57-year-old man died of a self-inflicted gunshot wound in the afternoon of July 15 on U.S. Highway 95.

Owyhee County chief deputy coroner Aaron Tines identified the man as Arden Ziegenmeyer of Caldwell. Tines said Ziegenmeyer used a handgun to shoot himself in the chest.

In July, Marsing High School celebrated the 70th anniversary of its first graduation. Three of those 1939 graduates survive today: Alpha Muldoon Percifield of Marsing, Dorothy Volkmer Richards of Boise and Spokane's Kimi Matsushita Fukukai.

South Mountain's Doug Rutan, 27, accepted the gavel from Bodie Clapier as the new president of the Owyhee Cattlemen's Association on July 25.

The 75th Owyhee County Fair kicked off on Aug. 3, and the Ro-

Resurfacing of a nine-mile stretch of Idaho highway 78 began in August. Central Paving Co. Inc. of Boise did the work on the \$1.8 million project that resurfaced the highway from its junction with Idaho 45 to Murphy. Work was wrapped up in September.

Marsing announced its proposed fiscal year 2010 budget, which comes in at \$2.5 million, down from \$4.8 million last year. The size of the drop is due to the water project funds shown in last year's budget, rather than cost-cutting.

Jessica Will of Marsing, 19year-old daughter of Amber Will, was crowned queen out of a field of eight contestants as Owyhee County Fair and Rodeo Queen on Aug. 7.

Livestock sale treasurer Debbie Titus said the 81 sheep sold during the auction was the most since county fair auction staff began keeping records in 1991. Sixty-five each were sold in 1992 and 2008.

In all, 182 animals were sold this year, the fourth-highest total on record. Titus said the auction has brought in \$188,818 with add-ons and sales.

2009 saw another Owyhee County Fair record set as Conner Landa's FFA market hog sold over the course of several rounds - for \$17,500. The money will go to the Conner Landa Memorial Scholarship fund that was also boosted at July's Conner Landa/ Daniel Miller Memorial softball tournament in Homedale.

Marsing's new business license ordinance was approved Aug. 12, just weeks after Homedale passed a final version of its own license code. The ordinance was adopted during the monthly Marsing City Council meeting after eight months of discussion.

Five former Owyhee County Sheriff's Office employees seek unspecified damages in a lawsuit filed against Sheriff Daryl Crandall, OCSO and Owyhee County.

No dollar amount was attached to the 24-page document, but it was later revealed the five former employees are seeking general damages, court costs and attorney fees and other forms of relief totaling \$5 million.

The Bruneau-Grand View School District showed off building improvements with an open house and tour Aug. 16.

Financed by a bond valued at nearly \$5 million, capital improvements were carried out at Bruneau and Grand View Elementary schools and Rimrock Jr.-Sr. High School. Patrons passed the bond in August 2007.

A garden of 4,000-plus marijuana plants was destroyed following a multi-agency operation in Owyhee County about eight miles south of the South Mountain Lookout on Aug. 17.

The operation, which resulted from a case developed by the Bureau of Land Management, Owvhee County Sheriff Darvl Crandall said, saw OCSO, BLM, Sheriff's Posse and National Guard members unite to remove and destroy the plants.

Three men were charged, and two arrested, in connection with pot grows in both Oregon and Owyhee County.

Javier Silva-Rangel, Froilan (or Froylan) Rubio-Gomez and Horacio Deavila-Cabrera were charged with conspiracy to manufacture and distribute 1,000 or more marijuana plants, a charge with a minimum 10-year sentence attached.

The strong support was in contrast to Marsing's narrow defeat of its own two-year supplemental levy on Aug. 25. Notus, Parma and Wilder later passed their own

Jack Friedman, 53, of Marsing, was killed in a car-versus-semi collision at the intersection of Buntrock and Thompson roads near Marsing just before 8 p.m. on Sept. 21.

The 11th annual Jordan Valley Rope and Ride raised about \$20,000 during a three-day run at the Jordan Valley Rodeo Arena in September.

This year's event, which as always benefits the Owyhee and Malheur Multiple Use and Legal Defense Funds, featured the usual cow dog trials, roping and stock saddle bronc riding.

An 11-year-old Homedale Middle School sixth-grader and his stepfather were injured when a 2,000 people this year.

Marsing's mayor and city council met Oct. 14 with Owyhee County Sheriff Daryl Crandall, county Prosecutor Douglas Emery and county commissioners to discuss proposed changes to the expired law enforcement contract between Marsing and OCSO. The OCSO counteroffer, with additions by Emery, came in at \$86,385 \$10,000 more than 2009.

Subsequently, the contract was reduced back to the \$76,000 level, but discussion over language continued, and the city and county eventually adopted a bundled version in which the prosecutor's services were received in exchange for the water and sewer bill of the county's Marsing Annex building. The law enforcement contract was also approved, with a clear city demand for an OCSO presence in the schools.

Homedale's Ron Tibbett and Marsing resident Joseph Geary were killed in a single-car rollover Oct. 14 in Oregon.

Oregon State Police reported that the accident occurred near milepost 63 on U.S. Highway 95 south of Jordan Valley.

The individual brought a crossbow in October as an exhibit in his Fish and Game violation case and had not known that carrying a weapon into a courtroom was not the proper protocol, deputy magistrate criminal court clerk Dorla Stoneman said.

District 3 Commissioner Dick Freund said the county is continuing to pursue Homeland Security grant money, available under "hardening targets" programs, to secure the court building.

Ric Uria, Homedale Fire commissioner, handed the keys to the former Homedale 1994 Ford F-350 ambulance to Murphy-Reynolds-Wilson Fire Chief Wes Anderson on Oct. 20. The rig put the Central Owyhee Quick Response Unit three years ahead of schedule, Anderson said, giving the QRU ground response ability, hopefully as soon as December or January.

Fifteen people graduated from the first Owyhee County Citizens Emergency Response Team training. The group received certificates Oct 30 at the Lizard Butte Library in Marsing.

Harvey Grimme, Owyhee County coroner, was honored with the Mills-Adler Award at this year's Idaho Association of Counties' (IAC) annual conference in Coeur d'Alene.

An Owyhee country family got a treat on Halloween when Ron and Nancy Cunningham won the Owyhee Cattlemen's Association Heritage Fund drawing for a Dodge pickup.

November

Three incumbents were among candidates to win seats on their respective city councils in the Nov. 3 municipal elections in Owyhee County.

In Grand View, incumbent Marie Hipwell, former councilman Franklin Hart and newcomer David Buffington were elected.

In Homedale, Tim Downing and Dave Downum each earned another four-year term on the council.

In Marsing, Aron Streibel, a Caldwell city police officer who once served as an Owyhee County Sheriff's deputy, and a write-in candidate for office, received 44 votes. James Ferdinand also landed a seat with 44 votes.

Colyer Herefords of Bruneau was a winner at the American Royal National Hereford Show.

Southwest District Health (SWDH) inoculated approximately 420 Grand View and Bruneau area residents at the organization's H1N1 swine flu shot clinic on Nov. 4. Another 400 people received shots Nov. 5 in Marsing.

Police netted a drug bust Nov. 12, after some Homedale Middle School students arrived at school with a bread bag full of marijuana. An HMS official contacted Homedale police after other students had reported the contra-

Students had climbed a fence and entered the yard of Richard Stewart, 48, of Homedale and stripped leaves from a pot plant growing behind a shed on property at 214 W. 2nd St. S. The plants were screened by other vegetation, police said.

Homedale police arrested Stewart, seizing a large, mature plant and two or three juvenile specimens, HPD Chief Jeff Eidemiller said on Nov. 16.

Four middle school students involved were charged with felony drug possession, and five were expelled from school.

The El-Ada Community Action Partnership in Homedale saw great need in 2009. The organization witnessed a three-fold increase in emergency needs, and twice the usual demand for commodities.

Following Marsing and Rimrock events last month, Homedale had its first H1N1 vaccination clinic on Nov. 18 at the armory building at the Owyhee County Fairgrounds. Laurie Boston of Southwest District Health said that 959 of 1,200 available doses were given out to residents in a five-hour period.

The garden, southwest of Jordan Valley near 15-Mile Creek, was spotted when an MCSO detective was making an overflight of the area, looking specifically for additional illegal activity, Undersheriff Brian Wolfe said on Sept. 1.

September

The Homedale School District, FFA advisor Lori Harrison and Mickey Cowger were named in a lawsuit filed by the parent of a then-freshman injured during a Sept. 21, 2007, Homecoming float accident. Ten unnamed defendants designated as "Does".

The Board of County Commissioners approved a request to spend \$39,600 in Vessel Fund money to buy a new boat to bring waterway coverage back to Marsing.

The approval came after a presentation by county marine deputy John Nagel at the Sept. 8 commissioners meeting. The BOCC also approved the purchase of two portable radios for the marine unit.

Residents saw a bigger bill after Oct. 1 in Marsing for services, as the city boosted water rates by 49.9 percent and sewer by 33.7 percent to balance outlay in the enterprise funds for both.

The new numbers were unanimously adopted by the city council Sept. 9. More than 50 residents attended a Sept. 8 public meeting, addressing the proposed rate hikes for Marsing sewer and water.

A 19-year-old Homedale High School graduate was airlifted to a Seattle hospital Sept. 10 after falling 27 feet from of a fraternity house window at the University of Idaho in Moscow.

Amanda Andaverde, a 2008 HHS graduate, fell out of an open window in the Sigma Alpha Epsilon fraternity house around 1 a.m. She remains under medical care at year's end, having been front-end loader tumbled into a 20-foot-deep ditch off Sage Road near Market on the night of Sept. 22. at approximately 9:30 p.m.

Noah Morris was evacuated by Life Flight with a severely broken leg, emergency workers said. On Sept. 24, the injured boy was flown to Salt Lake City for specialist care, according to friends of the family after spending the 23rd in the Intensive Care Unit at Saint Alphonsus Regional Medical

Doctors at first feared Morris might lose his severely damaged right leg, but muscle grafts appear to have been successful.

Both the Bruneau Quick Response Unit and Grand View Ambulance received state EMS grants totaling nearly \$150,000, which were among 18 that were awarded after 36 different applications were made statewide, according to Bruneau QRU's Mary Tindall.



High School graduate accused of stealing funds from the school's fledgling alumni association, entered a not guilty plea during a Nov. 23 hearing in an Ada County courtroom.

Homedale-area resident Dale Wilson, 71, was reported missing Nov. 25. The Owyhee County Sheriff's Office and Homedale Police, along with firefighters, other emergency personnel and volunteers searched the area between Wilson's home off Hill Road near North Side Road to Homedale proper without success.

His body, clad only in socks, was found one week later.

Fire officials worked to help two families displaced by a Thanksgiving Day fire that destroyed two residences on the west side of Homedale.

Homedale Fire Chief Scott Salutregui said one family was given money from the department's Burnout Fund "on the spot" when the fire broke out Thursday afternoon. The second family received assistance Friday, he said.

December

Faye Pfrimmer, former Marsing mayor and councilperson, faced a Dec. 18 trial on three misdemeanor firearms charges, for what she

described as trying to be the good guy. The proceedings were later continued to February.

Idaho Transportation Department maintenance workers began widening the bridge that takes U.S. Highway 95 over a canal at Taxidermy Lane south of Homedale in early December. A maintenance worker on scene said the project is expected to last until February.

The Board of County Commissioners outlined a retention request for \$46,000 in Vessel Fund monies that otherwise would have had to be returned to the state.

Five Homedale Police officers and 11 people with ties to the Owyhee County Sheriff's Office took more than a dozen underprivileged children shopping Dec. 5.

David Rutan, two-team Owyhee County Fair Board member and current chair, announced his resignation at the Dec. 3 meeting of the fair board.

Homedale City Council members unanimously accepted a petition from affected property owners approving the Local Improvement District during their Dec. 9 meeting. The four councilmen also adopted the resolution establishing

intent to create an LID.

A former Homedale High School student was charged Dec. 9 with plotting to kill Homedale Police Chief Jeff Eidemiller.

John Wayne Richmond, Jr., 24, is charged with solicitation to commit murder, based on evidence the Canyon County Prosecutors's office declined to comment on. Richmond is accused of attempting to trade drugs for a gun that was purported to be for use against Eidemiller to several undercover police officers in Caldwell. The investigation began Dec. 7.

Richmond offered a plea of not guilty at his Dec. 18 arraignment. He is slated for trial on March 30.

The Marsing school board on Dec. 8 accepted the resignation of superintendent Harold Shockley, effective the end of June.

After netting a total of more than 2,600 items, better than doubles last year's record-setting holiday food and clothing drive,

Marsing FFA director Mike Martin and those taking part are organizing a food/toy/clothing bank to distribute the donations.

Homedale school superintendent Tim Rosandick said an electrical contractor will retrofit lighting fixtures in the high school and elementary school during the Christmas break in an effort to reduce power costs.

Winter officially arrived when Pat McCormick of the Owyhee County Road and Bridge department said that the Silver City Road had been closed for the winter to vehicles on Dec. 17.



Caring and Sharing program was success

Bonita Tucker, an administrator at the Homedale Nursing Home has reported that Mayor Paul Fink and Homedale City Council's Caring and Sharing program was a tremendous success. The Caring and Sharing committee had asked the Homedale community to contribute Christmas gifts requested by the Nursing Home residents which had been published in the Owyhee Chronicle before Christmas.

"Many of our elderly folks would otherwise not have received much," Mrs. Tucker said. But the community responded with a genuine warm concern for a Merry Christmas for all by dropping off an overwhelming number of gaily wrapped presents at the Owyhee Chronicle. The gifts were then picked up by the Mayor and members of the committee to be delivered to the Nursing Home.

According to Mrs. Tucker, the annual Christmas party was held on Christmas Eve with the Caring and Sharing packages stacked under the tree "and in all available area" on Christmas morning. "With the avalanche of presents, we could hardly get into the nurses' station," she exclaimed. "But it was so exciting to see the thrill and delight when the patients received their things. It was just beautiful!"

Mrs. Tucker added that she was touched by the generosity that had been extended. "Every patient received at least two or three of the items they had asked for," she said. "I speak for myself, and I know for all the residents here, in expressing our appreciation to everyone who was so thoughtful."

Park resolution may be weeks away

The resolution of a heated debate on the future of the Marsing river park may be several weeks away, according of Mayor Roy Herman. The city may change the park to lessen the amount of "caretaking" they must put into the space.

Marsing was told by the National Park Service, through the Department of the Interior, that they must clean up their parks or the Federal Government would put the land up for public auction. The Marsing City Council, in turn, told the Federal agency that unless the city could maintain the parks, with no intervention or strings attached, the Interior Department could have them. A flood last winter over the river park and vandalism to the structures there have caused some real problems for Marsing, said Herman.

Herman met with a representative very recently with several proposals that the city council had put together at a meeting on Dec. 12. First, the city would like to eliminate the shower on the river park, as well as the RV sewer facilities. All campers staying at the park would be self-contained, or dump into the city sewer for a fee.

Secondly, the boat docks on the river would be re-located at a quieter inlet. This may necessitate government funds, said Herman.

Third, redesign the meeting building on the river. The roof may be saved, but the building would be an open structure to provide shade or a dry space, only.

Lastly, reseed the lawn areas damaged by the flood, provide picnic areas, and barbeque pits. Herman said the Forest Service was lessening their responsibilities at their parks, such as Kirkham Hot Springs, by just providing a fire ring and a public toilet. The only part of the project that would need government monies would be the dock restoration, possibly through the Idaho Waterways Fund.

140 years ago

December 30, 1865

COUNTY SEAT QUESTION. This subject is approaching culmination. It is the one generally discussed in all parts of the county. Parties are at work who will not rest until it has a final settlement. There is now a petition in circulation praying the Legislators to enact a law authorizing a vote on the point of location; also, a remonstrance against the passage of such an Act. The only difference regarding location can be measured in any course from a given point by one-half mile. Inasmuch as the county buildings can occupy but one place, cannot this little matter of distance be harmonized? Why not Ruby and Silver unite in asking the passage of an Act incorporating both places under one name - say Owyhee – then agree upon the most eligible and convenient site for the public buildings? It will not be denied that the prosperity of Silver is that of Ruby, and vice versa. Neither will it be claimed that, should the county seat be definitely settled, with two names to what is really but one community, there would be an end to local wrangling, which could retard somewhat the prosperity of each. Even now, when the elements of society are sparse and unorganized, social bickering is heard. This is all wrong. To us, individually, the location of the county buildings is a matter of indifference – we came to Owyhee, or Owyhee mines – neither to Ruby nor Silver. We suppose others, in effect, did the same. We came here to advocate generally Owyhee interests - not any particular part. We plainly foresaw present events, and this was then the most annoying point to settle in our location, though, as matters shaped, had no influence in the premise. Truly and earnestly, we think the project – long since discussed – of consolidating Ruby and Silver under one name, that that name to be the county seat, is one, the consummation of which, will more certainly satisfy a majority, harmonize only apparently conflicting interests, and insure the general prosperity and average good of all! Two towns so nearly allied in everything but name, should be that. As an instance of its good effect, take Austin and Clifton, Reese River, under the two names they were continually contending; under one, all is harmonious prosperity. Gold Hill and Virginia in Nevada, which bear the same relation to each other as Ruby and Silver would if the space between were a solid mass of business houses, are to this day spending time, money and bad temper over what would not be thought of if both places were under one name, as they are one in location and interest. Those who view Silver and Ruby as having attained their growth, we don't expect will see the applicability of our remarks; but those who comprehend our growth two years hence, and which is sure to follow the general and reasonable expectations, we presume will accept our proposition as the true one for these now divided communities.

SNOW SLIDE. Last Saturday evening a snow slide occurred between this place and Silver, coming from the east side of Florida mountain, passing down by the Silver Bullion tunnel, and checking up near the road. In passing over the flat it struck a shanty occupied by some three or four persons, completely crushing it, covering up the occupants; but one, more fortunate than the others, was enabled to dig his way out from under the snow, which was several feet deep, and made his way though the storm to the Lincoln mill, where he related the facts, and some parties, with shovels, went to the rescue of those still buried in the cabin. With the aid of lantern, they succeeded in getting the location of the cabin, and in digging out the parties covered up, who were found to be not seriously injured, but most uncomfortably situated and without much hope of escaping.

I'd not paid any attention to the road or the scenery. Red said, "Bax, do me a favor."

I said, "Anything." It would give me a way to show my gratitude. He dug a ball of car keys out of his pocket bigger than a hippopotamus cud! "Would you mind holding these while I'm singing? I hate to carry this big wad around."

"Of course," I said obsequiously. We walked off. Well, I didn't want to go to the dance with that big wad of car keys in my pocket either! I peeled off the Cadillac key and threw the wad on the car's floor mat. At midnight I hooked up with another ride who was going to San Antonio. I went into the dance hall and said my goodbyes to Red and went to get my bag out of his car. It was then I realized that Cadillacs had two keys; one for the door and one for the ignition. Eyes on Owyhee Hope for the new year

A new year is a time for rejuvenation, promise, hope and resolve.

With those noble pursuits in mind, here's a list of aspirations for Owyhee County for 2010, and a wish for a happy and prosperous new year for everyone:

• For Owyhee County government officials in Murphy: A hope that lines of communication and organization improve in the coming year.

A recent Board of County Commissioners meeting was little more than table tennis with several agenda items being brought to the floor only to be knocked back onto the agenda for a future meeting because the prosecuting attorney, Douglas Emery, and his deputy, Chuck Saari, voiced concern that they had not had time to review the documents.

There must be a resolution to this situation that gives the impression that the lines of communication between the commissioners, the clerk's office that sets the weekly agenda and the prosecutor's office are frozen like water pipe in the middle of winter.

A packet of information and pertinent materials are supplied to all parties who regularly attend the meetings in Murphy, much like the Homedale City Council receives before its meetings, so communication shouldn't be that difficult.

Of course, the new year's wish for communication within and without the walls of the county complex extends beyond the commissioners and the prosecutor.

Hopefully, Sheriff Daryl Crandall will see fit to be more participatory in informing the citizens he has sworn to protect about law enforcement issues that may affect them.

• For the City of Homedale: A smoother road to progress.

The past year hasn't been a kind one for those who make decisions for the citizens of the county's largest city.

Bickering between councilmen, the mayor and the police chief over well-intended gestures that may have skirted protocol stripped the decision-makers of some of their credibility during a crucial year in which they asked the city's business property owners to pony up hard-earned revenue to help finance downtown improvements.

The end result of the \$500,000 state grant and Local Improvement District may be the first step in improving Homedale's façade, but the image emanating from City Hall will take some time to repair.

There are bright spots, of course, with the continued water and sewer infrastructure improvements, but only a smoother relationship between city council members, the mayor and other employees can convince residents that Homedale is on the right path.

• For the upcoming county elections: Civility and substance.

Two BOCC seats and four other county offices will be contested in May's primary election, including District 2 and District 3 commissioners, clerk, treasurer, assessor and coroner.

Hopefully the candidates will run on the issues and not on petty personality conflicts and back-biting. Owyhee County voters deserve to know the character of their candidates and where those people stand on the issues.

Family marks Idaho centennial

January. It comes right after the big holidays of the previous year so most folks are burned out and watching their pennies. January is also the month when the weather usually is the worst — at least in this part of the country.

January 2010, however, will have special meaning for our family. That's because it marks the 100th anniversary of the arrival of the Cornells in southwest Idaho.

About 1872, my great-grandfather, Salem Cornell, homesteaded in Jewell County, Kan. — a few miles from the Kansas-Nebraska border. My grandfather, Adelbert (Bert) Cornell was born there in 1875. In 1899, Bert married Bessie Mathews. My father, second-oldest of Bessie and Bert's kids, was born near Burr Oak, Kan., in 1902.

At some point, Bert Cornell decided to leave Kansas. When I asked my father years later what prompted the move, he said it was probably because most people there were related and when he got older he would have had to marry a first cousin. I think he was only partly joking. But I have seen photographs of Jewell County, Kan., and if I had lived there, I think I would have wanted to move, too.

Grandpa Bert and two of his neighbors had received some correspondence from some former Burr Oakians who had moved across the Rockies and settled in a valley in the southwest portion of Idaho. Their reports indicated there was better farmland and more opportunity. So Bert and his friends started making plans. In January 1910, they loaded their household goods, farming equipment and livestock into three railroad "Emigrant Cars," and headed west. The men rode with the livestock while the women and children

made the trip in a passenger coach.

Eventually, Grandpa Cornell put the details of the Idaho trip down on paper. I feel it is appropriate, as the centennial approaches, to share that his story. A word of warning, however. Grandfather Cornell had a knack for using five words in an obtuse manner where one word would have done the job much more succinctly. At one time, I believe he held some sort of Idaho Statesman newspaper record when he penned a letter to the editor that contained a sentence 98 words long.

On Moving to Idaho from Kansas, January 1910

By Adelbert Cornell

... A few years ago the writer and two of his neighbors decided on changing their location from their native location near the Kansas-Nebraska state line to the Boise Valley.

After careful investigation we decided to charter a car apiece and load as much of our property as possible. Kansas City to Boise Valley rates on emigrant cars was \$100. This made allowance for each car to be loaded with ten tons of property and a man to accompany each car. All weight in excess of twenty thousand pounds was subject to a 50 cents per hundred added charge. (The cars were weighed at some point enroute and if one had more than his




