## Trojans win state trophy

# Boys knock off Fruitland again for consolation title

Homedale High School capped off a year of boys' basketball milestones with the biggest win of the season Saturday.

Having never beaten Fruitland in conference play before this season, the Trojans pulled off the magic again Saturday to win the consolation championship to close their first appearance in the 3A Real Dairy Shootout state championship.

It's the first state tournament trophy a Homedale boys' basketball team has brought home since a

consolation championship in 1997.

"It's nice to beat them," fourth-year HHS coach Kenny Thomas said after a 49-40 victory over the Grizzlies, "but, you know, it would have felt the same no matter who we played.

"We're super excited to bring home a trophy. It's been a long time since Homedale has done that, especially in basketball."

The Trojans finished the season at 15-11 by collecting two consecutive victories in the state tournament at Meridian High School. All three games were broadcast on radio station KIOV 1450-AM.

# Sage-grouse not listed by feds yet

Stewardship of the greater sagegrouse will remain in the hands of local and state officials even though the federal government placed the bird on the Endangered Species Act candidate list Friday.

Secretary of the Interior Ken Salazar announced placing the sage-grouse on the Endangered Species list in warranted, but will be precluded because other animal species in much more dire circumstances must receive priority.

The bird is on the Endangered Species Act's candidate list, but ESA restrictions won't be imple-

# Homedale meth case

## Richmond trial for solicitation of murder March 30

Lisa Cascino, 41, was sentenced last week to three to seven years in prison following her conviction for possession of methamphetamine. She was arrested in May at a house near the Homedale Elementary School.

Cascino has been put on a 30-day hold to see if she will comply with a court order to provide hair follicles for testing as well as medical records. Cascino was asked to provide the follicle samples previously, but had not done so. Third

District Judge Thomas Ryan has now upped the ante by requesting additional medical records. She has 30 days to comply.

Another individual arrested in the same operation, John Wayne Richmond Jr. of Homedale, is awaiting a March 30 trial following his alleged attempt to solicit the murder of Homedale Police Chief Jeff Eidemiller following the meth bust — a charge equal in weight to first-degree murder — as well as a felony charge of delivery of a controlled substance.

> While some drug convictions are reserved in hopes of getting offenders into the Caldwell drug court, Cascino has already had that option and failed to comply with the drug court's orders, a court source said.

Ryan will have the option on March 23

to either order Cascino to the state penitentiary or to issue her probation.

## Cascino sentenced in Schools boss earns state award

honored with a State Department of Education award last week, he deflected the credit to his administrators and promised the cash that came with the honor would be redirected to help send a Homedale High School student to college.

The Homedale School District superintendent was among a handful of Idaho educators cited for their work in Limited English Proficiency (LEP) programs during a dinner Thursday at the DoubleTree Riverside in Boise.

"These educators and programs serve as great examples of the excellent work I see as I visit schools across Idaho," state Superintendent of Public Instruction Tom Luna said. "Through these awards, we are able to recognize the great work of these educators and communities and share their success stories with others."

Rosandick earned a \$1,000 cash prize as one of the Idaho LEP Educator of the Year Award recipients.

Homedale's federally funded program helps students in the

When Tim Rosandick was LEP category — and all students — through the mandatory implementation of the Sheltered Instruction Observation Protocol (SIOP) instructional method in all classrooms district-wide. Debby Turner has served as the coach to help teachers learn the skills to apply the method, Rosandick said.

"In Homedale, a few years back we had an epiphany: If teachers in the regular classroom had the instructional skills necessary to reach their LEP students, then they were well-equipped to meet the needs of all the kids in their classroom," Rosandick said in his acceptance speech.

Through the SIOP model, Homedale has increased the number of LEP students making Adequate Yearly Progress in reading and math, which is one of the reasons Rosandick earned the award according to a state Department of Education press release. LEP students in Homedale exceed the state average in AYP for the two categories, and that has resulted in a State Board of Education Exceptional Growth Award.

Rosandick thanked the school board for its support of the plan and also acknowledged administrators such as federal programs director Laura Moylan and building principals Luci Asumendi-Mereness, Mike Williams and Yvonne Ihli for their roles in achieving the state honor.

He also singled out district employees Angela Correa and Paula Huddleston.

"For many years, these two ladies have been the lifeblood of Homedale's efforts," he said. "Much of what we have accomplished can be attributed to them."

Rosandick said that part of his plans for the \$1,000 cash award is to give a scholarship to one of several college-bound Homedale students in the LEP program. He said finding a worthy scholar shouldn't be a problem because 30 percent of the seniors in the HHS chapter of the National Honor Society are or were LEP students.

"Now that's something to celebrate," Rosandick said to finish his awards night remarks.

## Inmate charged with drugs in jail

An Owyhee county jail inmate is facing a felony charge of possession of a controlled substance in jail, and a misdemeanor count of possession of paraphernalia.

Daniel Richard Birmingham, Jr., of Melba, who was being held in the Owyhee County jail and who faces a 2009 charge of misdemeanor theft in Homedale, as well as a battery charge in Canyon County, was arrested on Feb. 12 for possession of marijuana and drug paraphernalia while held at the jail.


OCSO Deputy Slade Heeb picked up Birmingham at the Canyon County Jail for transport to Owyhee County. Upon a search by jailer CJ Stappler a pipe-stem was discovered in the prisoner's


A search of his cell turned up a plastic bag containing what later tested to be marijuana was found floating in the cell toilet. Video logs of the cell showed Birmingham dropping an object into the toilet and attempting to flush it, according to the arrest narrative from Heeb.

Birmingham, 21, will be arraigned before Judge Gregory Culet on Friday.

This is his fifth criminal case to be logged in Owyhee County courts. He's also faced two battery charges in Ada County as well as battery and drug charges in Canyon County.

Under Idaho Code any possession of a weapon or controlled substance in jail is a felony.





# Sage official critical of handling of grant

## Firm will help administer energy efficiency project

Sage Community Resources has been appointed to help guide Owyhee County through the administration of its Efficiency Community Block Grant.

Sage's director of business and community development, Pat Engel, reminded the commissioners that her organization is available to help with grant applications because the county is a member.

The appointment vote came during the March 2 Board of County Commissioners meeting in Murphy during which Sage officials criticized the grant application submitted by Higher Power Energy LLC.

Owyhee County recently received a \$69,729 grant after the state Office of Energy Resources approved an application submitted by the Boise-based startup. Thousands of dollars asked for in the grant weren't awarded, however.

"There are some inconsistencies in the application and you didn't get the full award," Engel said.

Engel said she and Sage project coordinator Amy Twilegar spent two to three hours reviewing the application to prepare for their meeting last week with the commissioners.

"I wish (Sage involvement) had been at the beginning of this because we have had to spend some time figuring out the application that you had because it was a cut-and-paste from another application," Engel said of the HPE application.

The commissioners appointed Sage as the coordinator from the grant, which is aimed at replacing the county jail's water heater as well as updating lighting and windows in the courtroom in Murphy.

Sage was approached after

commissioners had misgivings about Higher Power's ability to carry out the work. The chief concern was HPE's lack of a public works license, which is necessary to carry out construction in government buildings.

Sage now will help the county submit paperwork required by the state, including a statement of work. County Clerk Charlotte Sherburn said the window of completion for the project is April 1 to Oct. 15.

Twilegar said Sage will charge about \$2,200 for the coordination services, which is the same amount built into the grant application for such work. The firm will help the county through the bidding process as well as with the quarterly reports on job creation and energy conservation that will be required for two years after the project.

Engel said Sage will serve as the liaison between the county the OER, submitting claims to the state for reimbursement as work is completed.

The county could apply for Idaho Power equipment rebates once the project is finished, too.

Twilegar said that a free energy audit through Idaho Power is available, and District 3 Commissioner Dick Freund said he had had been in contact with Homedale Electric about studying how much cost savings and energy savings the retrofit would achieve.

Twilegar expressed skepticism over the numbers presented in HPE's grant application, but said that the amount awarded should cover equipment and installation

She also pointed out that most of the money requested in the grant application wasn't awarded.

"This grant application was for \$200,000," she said. "The overwhelming majority of it (would have gone) to Higher Power."

## Panel to suggest standalone 911

# State commission report: Owyhee denied 2010 grant

A county committee is expected to recommend a standalone 911 system Tuesday morning before the Board of County Commissioners.

Committee member Jim Desmond told The Owyhee Avalanche that the panel made its final decision during a Thursday meeting in Murphy. He added, however, that only six members were present, and the commissioners of other emergency services agencies — such as Homedale Fire and the Homedale City Council on behalf of the police department — still must ratify the recommendation.

Committee chair Wes Anderson, the Murphy-Reynolds-Wilson Fire chief, will present the recommendation to commissioners at about 11:15 a.m. Tuesday in Courtroom 2 inside the Owyhee County Courthouse in Murphy.

Although the recommendation memo doesn't contain any cost estimates because the final price tag won't be formulated unless and if the BOCC decides to move forward with the recommendation and solicit bids, Desmond said Anderson's testimony will include December estimates by Qwest Communications that put the cost of a standalone system at \$209,843 and the estimate for a

consolidated system with Canyon County at \$146,000.

The standalone price includes full installation and maintenance costs, Desmond said. According to the memo, obtained last week by The Owyhee Avalanche, by going with a standalone system, the county could save about \$15,000 in annual fees associated with a consolidated setup.

The committee's decision is the latest step in a process that had a rocky beginning when Sheriff Daryl Crandall presented a grant application to the BOCC last year in an attempt to finance upgrading the county's 911 system. The commissioners balked at the grant application because county protocol wasn't followed, then the signature page for the grant was submitted after the deadline. Owyhee County was not among the entities that received state grants, according to the Idaho **Emergency Communications** Commission's annual report presented to the Idaho Legislature last month. The county had sought \$98,887.16 in state funds, which was to be combined with \$127,534.09 in county 911 Fund money.

Board of County Commissioners chair Jerry Hoagland said there is some money in the 911 Fund to apply toward the purchase of a system, but more than likely the county would seek a 2011 grant when the application period opens again.

Crandall has favored

a standalone system, but the BOCC also wanted exploration into possible cost savings of a satellite setup with either systems in Canyon County or Elmore County. Under a consolidation, emergency calls would be routed through hardware in the sheriff's offices in either Canyon or Elmore to dispatchers in Murphy.

According to the memo, the committee went with a standalone recommendation, in part, because Qwest Communications representative Susie Hardy told Desmond in a Feb. 18 phone conversation that there probably wouldn't be a difference in equipment costs between the two options.

The committee recommends the Positron Viper 911 system. Last week, commissioners tabled an informational meeting on the system after Positron officials experienced technical difficulties in setting up a Web-based presentation.

The memo said that the life expectancy of the Viper system is about 10 years. The dispatch center computers and software, which also will be part of the upgrade, are expected to last three to five years.

of Boise, was arrested for two counts of aggravated assault and two counts of false imprisonment, as well as a count of battery.

He was initially arrested on Feb. 2, after he allegedly pointed a .45 caliber pistol at Amber Mercado while threatening her. He is additionally accused of pointing

the weapon at Quinton Cornia.

He is also accused of holding Amber at gunpoint in the bedroom of a residence on Sunflower Lane in Homedale.

Ricardo was further charged with battery after allegedly punching and/or kicking Amber in the stomach.

Mercado was charged with

sexual battery of a child 16/17 years of age in March 2009, later amended to battery, for which he was convicted. He received six months of probation and was issued a \$100 fine, which remains unpaid, according to the judiciary repository.

Mercado has had other run-ins with the law in Owyhee County, having previously been found guilty of resisting arrest, seconddegree stalking, violation of a nocontact order and drug, weapon and alcohol charges as a minor. He has had multiple probation violations, both as an adult and as a minor.

Mercado is being held on a \$200,000 bond.



## Sage-grouse: Politicians, ranchers welcome Interior's ESA decision

The re-evaluation of the bird's status was hastened by a court ruling striking down the U.S. Fish and Wildlife's earlier decision not to list the sage-grouse.

"Short of rejecting the proposed listing, which was not a real possibility, this decision is about as good as Southern Idaho of Twin Falls and Owyhee counties could have expected," District 23B Rep. Stephen Hartgen (R-Twin Falls) said. "It will put our private ranchers and other traditional land users in a better position to protect the sage grouse, while preserving traditional land activities.

"This represents a real victory against radical environmental groups who wanted to use the sage-grouse issue to drive ranchers off public lands."

One of those groups, Western Watersheds Project, filed suit in Boise this week alleging that the U.S. Fish and Wildlife Service's ruling violated the ESA and the Administrative Procedure Act. The suit was filed in the courtroom of B. Lynn Winmill, the same U.S. District judge whose ruling triggered the USFWS re-evaluation.

Tom Strickland, the Assistant Secretary of the Interior for Fish and Wildlife and Parks, said the impact of wildfire, invasive species, agricultural operations LWG secretary appointed

Retired biologist Karen Steenhof has been approved as the new secretary of the Owyhee County Local Working Group for sage-grouse conservation.

The Board of County Commissioners approved Steenhof at its March 2 meeting. She will replace Becky Desmond as the person who develops minutes from each LWG meeting.

Owyhee County LWG chair Donna Bennett brought the proposed change before the commissioners. Steenhof will be paid \$100 for each of the quarterly meetings for which she takes notes. The compensation plan already was in place before last week's change in personnel, and the money comes from the county's Interim Use Planning fund.

such as ranching and energy development projects are the main concerns for biologists studying the bird's situation. The results of those studies, he said, qualify the sage-grouse for listing under the Endangered Species Act.

But, he added: "Biologists have determined that the greater sage-grouse, as a whole, remains at a sufficient level with relatively broad habitat range and that extinction is not imminent."

Strickland said sage-grouse's placement on the ESA candidate list frees up more federal resources to help in conservation efforts.

But Idaho's U.S. senators, Republicans Mike Crapo and Jim Risch, said in a statement that more resources wouldn't be used.

"The listing of the sage grouse as a candidate species does not add any additional resources, other than greater federal oversight," the joint statement said. "While we do not believe greater oversight is necessary, the state, conservation groups, permittees and recreationists will continue to find ways to reverse the decline of sage grouse habitat."

The Idaho Cattle Association also chimed in on the issue:

"While there are some activist groups who will continue to seek to use this species as a tool to remove livestock from the range, we remain hopeful that common sense and sound science will prevail," the ICA said in its statement. "In identifying the list of threats to sage-grouse, USFWS recognized that well-managed livestock grazing is not a primary threat to the species and that grazing decisions are best made at the local level.

"Land management decisions made out on the range are much more beneficial to Idaho's wildlife and citizens than those forced out of a courtroom."

Strickland said that with a No. 8 listing, the species is near the bottom third of the federal government's 1-12 priority scale for inclusion on the endangered list.

"We have a window of at least several years before listing would be imminent," he said. "During that window we would hope we could take collaborative efforts (to continue conservation)."

During a media conference call, USFWS acting assistant director Gary Frazer refuted one journalist's claim that there is a high rate of extinction among species on the candidate list.

"We have authorities to do emergency listings that we would exercise if any species was in danger of going extinct while on the list," he said.

Salazar cited conservation efforts by groups throughout western states, including Idaho, as an important reason the bird's

population has stabilized.

The Owyhee County Local Working Group has seeded forage and launched juniper mastication projects to help habitat.

"We're learning from this onthe-ground experience what works most effectively for the sagegrouse and that (experience) will guide future conservation efforts," Strickland said.

Salazar said the bird's population has declined 90 percent in the past century and that its historic habitat range has shrunk 50 percent to 160 million acres and has become fragmented. About 60 percent of that range is on ground administered by the Bureau of Land Management, according to BLM Director Bob Abbey.

Abbey said the BLM will expand the use of new science and mapping technologies to improve land-use planning and develop additional measures to conserve sage-grouse habitat while ensuring that energy production, recreational access and other uses of federal lands continue as appropriate.

"Using sound science and effective on-the-ground coordination with our many partners, we will build on current accomplishments in managing for sustainable sagegrouse populations on our national system of public lands," he said.

## **Hearing:** Testimony to be taken on new city fees during Monday meet

Under the proposal, each city garbage customer will be charged \$2.50 per month for the tote. Westowns customers who now pay \$3 for the option of a cart will get a break of 50 cents on their monthly bills.

The regular-meeting agenda includes Homedale property owner Dennis Davis discussing cleanup of his burned-out home

on West Owyhee Avenue.

Also on the slate is a nonspecific item regarding the library board and the usual department reports from the police, public works, Planning and Zoning, the city attorney and council members and the mayor.

An executive session is scheduled under Idaho Code 67-2345 (1)(f) prior to the public

works report. According to the agenda, the closed meeting will allow the council members to communicate with legal counsel on pending or possible litigation.

Tonight's meeting on garbage totes is the first of two public hearings scheduled before the city council in the next five days.

On Monday at 6 p.m., the council will take up the matter of

new fees during a public hearing. Specific information on the cost of the fees weren't available at press time.

However, the council will receive testimony on the proposed establishment of a fee to cover the administrative costs associated with the abatement of public nuisances. At present, no such fees are charged.

The second fee schedule to be discussed pertains to increasing the amount the building inspector can charge for building permits and plan reviews. City Clerk and Treasurer Alice Pegram said the fees are based on the International Building Code, which the city adopted last year. No specific fee amounts were available.

## **State:** Homedale goes 2-1

Homedale opened the tournament with a 62-51 loss to Priest River on Thursday night, but rallied Friday afternoon with its highest offensive output of the year in an 81-73 triumph over Filer.



## First-year director has HHS music hitting right notes

George Kerrick has a refinery of sorts humming over at Homedale High School.

The first-year music director says he's seen improvement in the raw talent possessed by Trojans' musicians, many of whom were in the program a year ago.

"When I arrived, every group lacked fundamentals and energy," Kerrick said. "The students have done an incredible job of raising the bar for themselves."

As he watches over his students in day-to-day training, the University of Idaho graduate might sound like Yoda, the ancient philosopher and Jedi master from the Star Wars saga.

"In every class I teach, students hear, 'If you can, you must" and "You do not have to be perfect, but you must be better."

The admonishment has paid off. Fronted by Kerrick's energetic conducting style, the HHS Pep Band has tightly played numbers during sporting events, including the first two rounds of the 3A District III Tournament for boys' basketball at Treasure Valley Community College this month.

"The Final Countdown" by '80s hair band Europe seems to be a favorite of Kerrick's. He jumps

around and kicks in time with the music (when there aren't a bunch of fans milling about as there were last week during the Fruitland-Homedale district championship game).

"As students begin to motivate themselves to do what they can and to do it better, they improve dramatically," Kerrick said. "This has been more than evident with the pep band this year.

"I am sure that everyone would agree that this season's pep band has a lot of pep. The thing is, with little exception, this is the same group as last year."

The band itself sounds crisp, seemingly with few missteps or warbled notes.

"The students are motivated, energized, demanding more of themselves as a group and executing their performances better each time," he said. "They sound great and have fun doing it

"I have been very proud of their improvement."

Kerrick said he has received compliments on the musicians' comportment after each performance, including many from parents of the visiting athletes. "If unsolicited compliments from a rival team aren't a strong indicator of the group's improvement, then I don't know what is," he said.

The music program on a whole has seen vast improvement. Kerrick just returned from the Lionel Hampton International Jazz Festival at his alma mater in Moscow where the 10-person HHS Jazz Choir competed in a judged event. Nine of the 10 girls who made the trip to Moscow also competed in the District III Solo/Ensemble Festival in Nampa on Tuesday.

"At this level, making music should be about sharing and investing," he said. "Things like trips to Moscow and district tournaments give the students and opportunity to share what they've been doing and motivates them to invest further in their pursuits in not only music, but anything in which they choose to be involved."

Kerrick is the third HHS music director in as many years. He replaced David Sintay, who served for one year after Karla Kachelmier departed after a twoyear stint.

"She was really great to work with," Lisa Price, Homedale Ambulance administrator and EMT, said. "She always had a smile on her face." Price recalled that no matter how busy Kettle was with her ranch, or school duties, she "was always ready to drop what she was doing to go on a run."

"She was always encouraging to the new EMTs," Price said. "She also was always the peacemaker."

Kettle, who moved to Homedale in 1973, has always had medical leanings of a sort. She holds a bachelor's in biology, and spent five years as a veterinary assistant before becoming certified as an EMT in 1996.

Since 1996 she has worked

with Homedale Ambulance, responding to people in need. She remains with the organization as a driver if needed, but won't be working as an EMT any longer, she said

"We're really glad that she stayed on as driver," Price said. Homedale Ambulance has more than a dozen EMTs and, counting Kettle, four drivers.

The reward for the work, Kettle said, was the "personal satisfaction that you really made a difference somewhere." Though not every call is life and death, "on one in 10 you really make a difference."

The job had its drawbacks, too, with high stress and lifeand-death decisions, Kettle said. Having to stay perfectly sharp in such a field has its own burn-out factor, she explained.

"I was having tiny senior moments," Kettle said. "I didn't feel like I was up to it."

Computerization was also a new and somewhat daunting development, she said. While she praised the instantaneous nature of computer-dependent information aboard ambulances today, and the depth of information provided, the shift in technology was part of her decision to semi-retire.

"The job changed five or six years ago, with computers to do the reports on, and computers onboard the ambulance," Kettle said, pining a bit for the old days of pen-and-paper reports. "It was progressively getting more and more technical.

"(For) the newer minds, it's saving them so much time, but it was very frustrating to me," she said. "It was time to step down for someone young ... and let sharp new minds in there."

Kettle continues in her other job — driving a school bus for the Homedale School District — but hopes that, being semi-retired, she can get back into her hobbies: Oil painting and ceramics. She also enjoys backcountry horse packing, especially around Council and Black Lake.

## Trojans return with first trophy in 13 years

## Reserves rule versus Grizzlies

Versatility and depth were on works the hardest and gets the display Saturday in Homedale High School's final boys' basketball victory of the season.

Reserve post player Trevor Gibson dominated the backboards in the first half, and backup wing Mario Gonzalez shook off pockets of inconsistency to hit key shots as the Trojans collected the consolation trophy in the 3A Real Dairy Shootout state tournament.

Homedale (15-11) wrapped up its first State appearance since 2004 with an impressive 49-40 victory over arch-nemesis Fruitland at Meridian High School on Saturday.

It was the fourth time the Trojans and Grizzlies (17-8) had squared off this season. Fruitland's shots weren't falling Saturday, and Gibson was there to make sure the Grizzlies didn't have many second chances. He had seven defensive rebounds in the first half to solidify the Trojans' chokehold on the game - they never trailed - and finished with 10 of his game-high 11 rebounds on Fruitland's end.

"He worked his tail off. It's the best game he's played all year," Thomas said after the Saturday morning game. "He worked hard (today), and he crashed the boards

"I kind of knew he had that potential in him, and he never quite got rolling. I'm glad he got rolling (today) because we needed it."

The Trojans needed Gonzalez, too. He shook off a few mistakes in the second half to hit some crucial shots and finish with a game-high 13 points. He also had seven rebounds at Homedale held a more than 2-to-1 edge on Fruitland's backboard.

"The one kid that was huge (today) was Mario Gonzalez,"

Thomas said. "He came in and just played really well."

Gonzalez's scoring was important as leading scorers Kenny Esparza (foul trouble) and Walter Almaraz (shooting woes) couldn't get untracked. Staring wing Trey Corta, a sophomore, came through with 10 points, too.

Homedale was 1-for-12 from beyond the three-point line, territory that helped the squad play tough in the first two state tournament games. But the Trojans knocked down 19 of 36 shots from within the arc against Fruitland (52.8 percent).

Conversely, the Grizzlies couldn't find their range from anywhere on the floor. They were 1-for-15 (6.7 percent) from threepoint land, and 14-for-45 (31.1 percent) everywhere else.

"They battle hard always, and they just never got into a rhythm this weekend," Thomas said of the Grizzlies. "And luckily we were there and we kind of continued that and tried to keep them from finding that, and we did a good job."

## Resilient Ryska rallies team vs. Filer

It became apparent fairly early that Friday's Homedale-Filer rematch wasn't going to resemble its predecessor — last year's state tournament play-in game.

Both teams came out swinging a little more than a year after the Wildcats' denied the Trojans a trip to the state tournament.

This time, though, it was Homedale that emerged as the sole survivor after an 81-73 shootout at Meridian High School.

Point guard Ryan Ryska, who has played with a bum knee since the Trojans' state berth-clinching quarter with 12 of his season-high 19 points.

"Huge," HHS coach Kenny Thomas said.

Ryska's hard-nosed style of play came through with 91 seconds left in the game and Homedale leading by just three points, 72-69.

The senior jumped and stole a cross-court pass by Filer's Justin Orban only to get leveled by the Wildcats' Terrell Bailey. The foul sent Ryska to the free-throw line and Bailey to the bench with his fifth foul.

"... That's just him," Thomas win over Weiser last month, car- said of Ryska's toughness. "Just ried Homedale through the fourth like in the district game (against

Weiser), tonight wasn't going to be the last time he was going to play basketball. He made up his mind about that."

The Trojans put up a seasonhigh point total in the win, which was nothing like last year's 56-53 loss to Filer at Glenns Ferry High

'Whenever we score 81 it's going to be a surprise to me because we ain't never done it before," Thomas said. "I could see the potential for a high-scoring game because they shoot the ball well, but I didn't see a high scoring game coming."

But the race was on after Filer

scored nine consecutive points to answer Walter Almaraz's gameopening three-point goal.

Homedale bounced back to grab a 42-33 halftime lead as Almaraz finished the first 16 minutes with 10 points. He and Filer's Bryce Beard carried on a shootout throughout the game.

Almaraz finished with 25 points and was perfect in 11 trips to the foul line. Beard exploded for 24 points after halftime and led all

scorers with 30.

With those two trading baskets — they made nearly a third of the night's 64 field goals — it seemed whoever scored the most in the fourth quarter would live to play for another day.

After scoring just 11 in the third quarter, Homedale racked up 28 points in the final eight minutes to earn a trip into the consolation championship game.

## Pesky Trojans play top-ranked Priest River in first round

## Junior's three-pointers keep Priest River within reach in opener

The public-address announcer screwed up his pregame introduction, but by the end of Thursday's opening-round state tournament game, everyone knew who Walter Almaraz was.

The guizzical look the Homedale High School junior shot at the scoring table before the Trojans' 3A Real Dairy Shootout boys' basketball state tournament game against top-ranked Priest River was only the first of several spoton attempts.

A cold-shooting spurt stretching across the last of first quarter and the start of the second, however, helped the Spartans wriggle off the hook with a 62-51 victory over the Trojans.

"I think my kids know (that) they didn't leave anything out." HHS fourth-year coach Kenny Thomas said. "They left it all on the floor and gave it their all."

Almaraz's three first-half three-point goals helped upstart Homedale (13-11) stay in the contest against the Spartans, who were making their third appearance at State in as many years. The junior hit a running jump shot for a 12-10 Homedale lead midway through the opening quarter, but then the

rim iced over for the Trojans.

"I think late in the first — during that stretch — I think we rushed our shots," Thomas said. "I don't know exactly why that was. We weren't really shooting in rhythm like we were early in the game."

As Homedale missed a dozen shots in a row and endured a 1-for-17 ice age from the field, Priest River took control with a 20-4 run. Senior forward Jake Weimer converted a three-point play to

give the Spartans (20-3) a 30-15 lead four minutes, three seconds before halftime.

But Almaraz had the answer in his sweet, net-searing shot. He hit three treys in the span of two minutes, nine seconds to pull Homedale within seven points, 33-26, at the break.

"He's a shooter. He can create shots and he can put up shots in a hurry, and he got us back in the game," Thomas said. "When he's










Almaraz hit another three-pointer 62 seconds after halftime as Homedale got within six points, 35-29. He finished with five threepointers (two off the state tournament record) and 19 points.

He comprised the only consistent counter to Weimer, who scored 20 points in the first half with a deadly seven-foot turnaround shot in the lane and a keen eye from the foul line.

"He's the best player we've seen all year," Thomas said. "He's just tough."

But with senior Ryan Ryska's harassment at the point leading Homedale's defense in the second half, the Trojans bottled the Spartans' 6-foot-4 senior forward. Weimer achieved only seven points — all from the free-throw line — in the final 16 minutes. He finished with 16 rebounds, six less than the entire Homedale squad.

"I wouldn't necessarily say it was their height but their length," Thomas said in explaining the Spartans' dominance on the glass. "It was their length and athletic ability. Not only were they long but they were athletic.

"When they're that long and athletic it's tough to get the ball."

The banged-up Ryska was Homedale's heartbeat with five

assists, two steals and six points, including his usual gut-check drive to the rim for a quick layup response to a Priest River bucket in the second half. He also drew a five-second call against Spartans point guard Jaden Barrett 2 1/2 minutes into the third quarter.

"He kind of takes pride in that, and he's going to get after it," Thomas said. "He loves defense, and he loves getting his teammates the ball and that's a big part of point guard. And I never have to question his heart."


Barrett got his revenge 30 second later with a long-distance three-pointer that sparked the Spartans' final surge. Max Salesky, along with Weimer and Eric Holbrook part of Priest River's big three that Thomas said the Trojans had to slow, hit a 21-foot three-pointer at the third-quarter buzzer to push the Spartans' lead back to double digits, 46-35. Six of Salesky's 10 points came from beyond the arc, while Holbrook scored nine points.

## Marsing, Homedale both lose out in state competition

Owyhee County's two representatives at the State A-3 and A-4 basketball tournaments in Twin Falls ran up early against the eventual winners of the three-day affair.

Marsing, in their first time at State in A-4 competition, took on Kendrick in their first battle, taking a 78-51 loss. The Huskies then encountered Oakley, the winner over North Gem, to fall 97-65, earning the Marsing squad a seventh place overall in the state. Kendrick took first in A-4.

Marsing coach Ernie Elliott said the Marsing team ran up against a very tough Kendrick, suffering a lapse of concentration by the team in the 2<sup>nd</sup> quarter with only one field goal and two free throws while the team from the north pulled in 21 points. Oakley was also ranked Number 1 in the state and played that way in the second game, he said.

Elliott said James Dugger was a standout in the competition with 16 points in the first game. Also praised for their game were Tom Jones, Randy Lankford, Scott Webb, and Craig Tullis for playing off the bench and adding some points. All players were "good, steady performers," he said.

The Homedale Trojans took on their arch-nemesis Lapwai Wildcats on Thursday, only to succumb to a 65-47 score. The Trojans went into the second half with a 32-26 disadvantage but Lapwai outpaced them for the rest of the show. The Wildcats advanced to the number one position in A-3.

Homedale then faced Sugar-Salem, a one-point loser to Malad. The team from eastern Idaho proved too much for the Homedale group, taking an 89-75 win and placing Homedale also in the seventh place slot.

## Opaline school dedicated at new location at BSU

Two things that education gives children are roots and wings, said Richard Hart, Dean of the Boise State University College of Education. A large group of educators and Owyhee County people met Thursday to remember their roots at the dedication of the Opaline School on the BSU campus.

Attending the ceremonies were John Keiser, BSU president; Jerry Evans, superintendent for Idaho Public Education; Gene Larsen, fifth grade teacher at Marsing; and Sen. Phil Batt from Wilder.

On March 23, 1914, the Lower Enterprise School District No. 30 was formed in the area west of Givens Hot Springs, the petition signed by Jesse Patton, Adam Blackstock, Charles Young, Albert F. Clark, William Rafferty, Mrs. S. Slabaugh, J. P. Moon, and F. M. Myers. The district was later named "Opaline," with the initial spelling being "Opaleen."

The one-room schoolhouse remained open for years until the 1950s, when it was sold to the Opaline Water Board and used as a storage or meeting area. President Keiser, Larsen, and a number of residents felt the building would make an impression on the BSU campus, so the Opaline School was transported last year to its present location near the Special Events Center.

The school remains in the same condition as when it served the hundreds of Marsing area students who attended over the years. The metal and wood desks with the folding tops are there, maps of the world, grammar lesson on the blackboard, and flowers on the teacher's desk. Honored at the ceremony was the first teacher at Opaline, Dorothy Tindall Cahalan; Mildred McClure, and Clara Stoehr, all in attendance.

A generalized statement of purpose was approved by the group and reads as follows: "The purpose of the Owyhee County Historical society is to help investigate and preserve for future generations any kind of historical records, documents, sites, and articles and artifacts pertaining to Owyhee county history, and to help to eventually establish a county museum.

## 144 years ago

#### March 10, 1866

STATE GOVERNMENT. By an Act of the recent Legislature the people are called upon to vote for or against State Government in Idaho in August next; and at the same time elect delegates to a Constitutional Convention. If the people pronounce in favor of Statehood, the Convention is to meet in Boise City in October next. The passage of this bill is probably well enough as a measure to convince a few old hulks of politicians the absurdity with which the real men of Idaho view the proposition. The real question for the people to decide is whether they will ruin themselves by excessive taxation to sustain or boost into high places a score of old ring-boned and pole-eviled politicians, or whether they will consult self-interest by setting the seal of condemnation on the whole tribe. The people have no heart in this move to rob them in a legal way. Those who favor the project are about equally divided between the "Democratic" and "Union" parties. They are of that class who have nothing to lose, no matter which way the question is decided, and everything to gain, if successful. We can name a number of these public pestilences in both parties – and probably will ere long. Men who are struggling for a small fortune (and probably only secure a scanty means of existence,) in these mountains, should not allow themselves to be caught in this trap. Men of capital and property must remember that their taxes will be anywhere from five to ten times greater than now. And for whose benefit? A few old political wrecks. The whole amount of taxes paid into the Territorial Treasury from May 19, 1864, to December 4, 1865, was \$5,585.43, and if all that should have been paid had been, it would only amount to \$16,573.02. Instead of paying this small sum, the people would have to ante fully \$300,000, annually, or be continually borrowing and paying enormous interest. The State tax would be about nineteen times as much as the Territorial. Advocates of State Government will say this is an exaggeration. We say it is not, and will give the figures in due time to show the truth of our proposition. Again, our Territory only contains about sufficient population for a respectable County. Very correct observers say that whites, (blacks), Chinamen and Indians - including the Governor - would aggregate not more than fifteen thousand. There are a thousand Counties in the United States with greater population and far more developed wealth. Look at the condition of Idaho Territory to-day. Politically and financially Boise County has thus far felt herself to be the Territory. In another year, according to residents of that county, it will be principally owned and populated by Chinamen. The future of Alturas is entirely problematical, and in a great measure the same is true of Owyhee. The other counties are mere ciphers in a mineral sense, and are not much to boast of in any way – except Ada, whose motto is: "In onion there is strength." We believe Idaho second to no Territory or State in mineral wealth. But it is undeveloped, and to blight development by the enormous and useless burden of a State Government, is the greatest folly, and it will be our duty to prove this to be true in future numbers of our paper.

SLOSHING around on Wednesday, we made a tramp over War Eagle Mountain, took an outside view of a number of ledges and a thorough inside one of the Oro Fino. Work is being rushed along night and day on a number of ledges and preparations are being made to commence on others. The Oro Fino, Minnesota, Silver Legion, Hays & Ray, Whisky Gulch, Trook & Jennings, and some others are being worked twenty hours each day. The Oro Fino is well known as a first-class ledge, but it may not be as well known that it is growing wider and richer as a greater depth is obtained. At one place for nearly fifty feet in length, the ledge is nine feet in thickness of pure quartz - in much of which gold is plainly visible. The greatest depth at which quartz has been taken is one hundred and eighty feet. Recently, specimens equal in richness to the famous Poorman and Trook & Jennings were found in this mine, and as Col. Fogus remarked, the mine is scarcely prospected yet. It is certainly worth millions of dollars.

Not exactly out of the Beef Quality Assurance manual for handling cattle. Although I'd like to see it included ... fully illustrated!



## When tumbleweeds attack



Most folks wrote off the incident as an act of nature. After all, when the wind blows, tumbleweeds roll. But I had a suspicion that there was more to the story.

My tumbleweed theories began to develop a decade earlier during my daily drive to work. My route took me through an area of undeveloped land next to a landfill that has since become an orchard on top of Homedale Hill. The area provided a haven for a variety of wild animals. Passing through the stretch before sunrise, it wasn't unusual to spot skunks, coyotes or even an occasional deer.

On one particular morning, the wind was whipping smartly as I approached the primitive area. As I rounded a corner, my attention was drawn to a movement off to the right.

Suddenly, a coyote dashed across the road in front of me. That wasn't a terribly unusual event. What was unusual was that this coyote was looking back over his shoulder and was running as if the devil himself was after him.

A moment later the reason for the coyote's flight appeared. A squad of large tumbleweeds dashed into view in my headlights. The weeds were in hot pursuit of the coyote. They bounced and spun crazily as they pulled out all the stops in an attempt to run their prey to ground.

I was so busy watching the little drama unfold that it didn't occur to me that I might be in harm's way, too. Suddenly, two of the tumbleweed flankers gave up the chase of the coyote and turned to attack. One weed threw itself at the driver's door. It bounced off and disappeared into the darkness. The second was more determined. It came at the car head-on, striking right between the headlights.

Back in 1992, a local ditch company had crews work- It hung there for a moment, trying to claw its way up onto the hood. Finally, it lost its grip. Frankly, I had little compassion for my foe as I listened to it being pulverized under the vehicle.

> For the next several years, I didn't give tumbleweeds much thought. But they were simply biding their time.

> One day I walked out of the office to go to lunch. The wind was blowing. As I approached my car I noticed a tumbleweed lurking near the rear of the vehicle. It was obviously trying to act nonchalant, but it didn't fool me for a minute. Two could play that game. As I opened the car door, I pretended I didn't know it was there.

> This particular tumbleweed was obviously a rookie. It badly misjudged the timing of its assault. The car door was only open about six inches when it leaped from its hiding place, dashed forward and attempted to dive into the car ahead of me. The opening was too small. I grabbed it. The weed thrashed around, trying to escape from my chokehold. It squirmed until I stomped it into hundreds of splintered pieces.

> There are just too many coincidences — too many reports of tumbleweed activity. At first they just threw themselves in front of moving cars. But they are learning. Now they are trying to get into vehicles. Next they will be trying to drive. Then we'll be in big trouble.

> We must act before it is too late. Oh sure, there will be some bleeding hearts who will say tumbleweeds are misunderstood or had traumatic childhoods. But don't you believe that for a minute. They are out there somewhere right now, biding their time, waiting for the right moment to strike. Life has changed a great deal since 1992, but tumbleweeds haven't.

## Parks plan right for tough times

Over the past four years, through my work on the state while keeping Idaho's state parks open. Legislature's Joint Finance and Appropriations (JFAC) budgets, including natural resources, I have learned a great deal about our state parks and witnessed what has proven to be an unsustainable growth in state government.

During that time, I have seen state revenue soar to alltime highs and fall back to the levels the state experienced when I first arrived in the Legislature in 2006. Next year, the State's revenues are projected to be \$2.28 billion, down from almost \$3 billion just two years ago, and our national and state recovery is expected to be agonizingly slow.

Given all of that information, those of us with responsibility over state affairs need to be mindful of the requirement to tighten our belts and prioritize what we truly need from state government, making cuts to match revenues.

While the governor has the task of submitting a balanced budget every year it is the Legislature that has the constitutional responsibility of passing a budget that is in balance before we adjourn.

In January, Gov. Otter presented a budget that called for a reduction in the Parks & Recreation budget by \$4.5 million next year. Gov. Otter simultaneously challenged Director Nancy Merrill to develop a business plan that would reduce Parks & Rec's reliance on General Fund appropriations

I am grateful that in response to Gov. Otter's challenge, Director Merrill and her board recently approved a plan that would keep all of our state parks open. Services at all state parks will be somewhat limited and there may be moderate fee increases for those who choose to visit them, but the parks will be open.

I applaud Parks & Recreation Director Nancy Merrill and her leadership within the Parks Board in developing a business plan to move the department to become more self-sustaining.

I would encourage everyone who is concerned about the future of our state parks to buy a season pass for \$35 for one vehicle and \$5 additional for a second vehicle. It is well worth it.

At a time when we must choose between public education or public safety and funding public television or our state parks, Gov. Otter and Director Merrill have struck an appropriate balance that will keep our state parks open for the economic benefit of the state and for the use and enjoyment of everyone.

Recently Marsing voters turned out to pass the COSSA levy, which will provide funds for the facilities expansion. However beneficial the levy will be, there are some questions to be considered.




