## County receives crucial PILT pay

Officials rely on fed money for FY 2011 budget

Every dime of the federal government's Payment in Lieu of Taxes will go into the Owyhee County budget for fiscal year 2011, a county official says.

"Owyhee County is really dependent on that PILT money, especially in leaner times when the revenue sharing from the state isn't there," Board of County Commissioners chair Jerry Hoagland said.

The Department of the Interior said local governments would see their FY 2010 PILT checks by June 29.

Owyhee County is scheduled to get \$1.2 million in compensation for the more than 3.6 million

## Final B2H Owyhee proposal released

Open house slated for July 15 before BLM takes over

The Bureau of Land Management will begin its scoping process for the Boardman-to-Hemingway power line plan in the coming weeks.

Idaho Power submitted its final proposed route June 21 for federal review as part of its preliminary plan of development.

The utility company is proposing a 500-kilovolt electricity

transmission line along a 300-mile route from Boardman, Ore., to the Hemingway Substation in Wilson.

An open house will be held from 4 p.m. to 7 p.m. on Thursday, July 15, at the Phipps-Watson Marsing American Legion Community Center, 126 W. 2nd St. N.

"We really, really want people to come out," Idaho Power spokesperson Stephanie McCurdy said. "This is a great opportunity for people to see the route and give input on the route."

McCurdy said there will be

**New Badiola Arena takes shape east of U.S. 95**

The new Badiola indoor arena spans an area of more than 150 feet across and more than 300 feet in length. At the far end, outside the building, Lurre Construction continues with the groundwork surrounding the building and preparation of the soil for placement on the arena floor.



**Badiola Arena events to start in fall**

The new indoor, climate-controlled Badiola Arena being constructed near the intersection of U.S. Highway 95 and Industrial Road in Homedale will boast more than 45,000 square feet of arena space for various horse events and spectators.

Groundwork for the arena was completed by Lurre Construction, and the steel building is being erected by Arriaga Construction. Lurre recently began screening the soil intended for use inside for the arena floor. Both construction companies are based in Caldwell.

“We hope to draw roping, cutting horse, horse training, and other spectator events since

we will install bucking chutes,” owner Lori Badiola said.

Badiola says a tentative grand opening has been set for Oct. 9-10, but added that the events for that date have yet to be confirmed.

The building will include some additional outbuildings for storage along with a large gravel parking area. Parking will be for event spectators and another area for horse trailer parking that will have electrical hookups for RVs as well.

Inside the arena, there will be heating and air conditioning, a bleacher seating area for spectators and bathroom facilities.

“We wanted a better place to host larger groups, that is

acclimated,” Badiola said.

Badiola Arena’s exterior will have “appealing log entryways, tall pole fencing, trees, and picnic tables,” she added.

The Badiolas currently host team roping twice weekly and barrel racing events two to three times a month at their outdoor arena on Market Road.

“We will keep the arena for a place to practice,” she said.

Badiola hopes the new arena will be a draw that adds to Homedale’s economy.

“It should bring a lot to Homedale — gas, food, etc. — for three-day events,” she said.

**School districts propose fee hikes**

**Marsing poised to institute sports participation fees**

School trustees in Homedale and Marsing will hold public hearings at their next meetings to get comment on proposed fee increases.

The Homedale School District will hold its hearing at 7 p.m. Monday during its regular monthly meeting at the district office boardroom, 116 E. Owyhee Ave.

The Marsing’s proposed fee increases are the subject of a public hearing at 8 p.m. on Tuesday at the district office on 8<sup>th</sup> Avenue West. The hearing also is part of the trustees’ regular monthly meeting.

Homedale has proposed new sports transportation fees of \$10 per athlete per sport for both middle school and high school athletics. Fee hikes have also been proposed for high school activity fees (\$20 to \$22), high school sports fees (\$15 per sport to \$16 per sport), high school lab fees (\$15.90 to \$17), high school drafting fees (\$10.60 to \$11.50) and the high school yearbook (\$34.25 to \$38.50).

According to a legal notice published today by the Homedale district, these fees are being increased to cover rising costs.

Tuesday will mark the second public hearing the Marsing trustees have held on that district’s proposed fee hikes. The increases were amended after last month’s public hearing.

Proposed fees include the advent of pay-to-play charges for middle school and high school athletics.

Athletes at both levels will pay \$45 per sport to participate, or a family will be able to pay \$150 for the year for all sports.

At the hearing, the board will take up a discussion on exactly how the proposed athletics fee schedule will affect families with children competing for both schools, Marsing district business manager Deb Holzhey said.

Other proposed fee increases affect high school students:

- The price of an Associated Student Body/activity card will increase more than 28 percent from \$35 per year to \$45.

- Ag mechanics/fabrication fees are set to rise more than 33 percent from \$15 per semester to \$20 per term.

- Business Professionals of America chapter members will see a more than 13 percent increase in annual dues from \$15 to \$17.

- Students enrolling in Idaho Digital Learning Academy classes can expect a 50 percent increase from \$50 to \$75. Only students who are taking IDLA courses for credit recovery pay these fees. District business manager Deb Holzhey said the district picks up the tab for students who take IDLA courses to supplement their regular class schedules.

The trustees rescheduled the hearing after deciding to make uniform participation fee increases for middle school rather than a separate, more expensive cost for football players.

**July OWC meeting cancelled**

The Owyhee Watershed Council has cancelled its July meeting, and will next meet on Aug. 11.

The OWC meets at 7 p.m. on the second Wednesday of the month between April and October. Generally, the group meets at the University of Idaho Owyhee

County Extension Office, 238 8<sup>th</sup> Ave. W., in Marsing, but sometimes the location varies.

Meetings switch to 4 p.m. from November to March.

# Judge gives man 30 days for DUI

A 47-year-old Homedale man is serving 30 days in jail after being convicted of felony driving under the influence.

Third District Court Judge Thomas J. Ryan sent Philip Homer Poland to jail for a month

and placed him on four years' probation in a June 25 sentencing hearing in Murphy.

Ryan also sentenced Poland to up to five years in state prison, but suspended that portion of the judgment as well as half of a \$1,000 fine and 150 days in jail.

Poland was cited on Feb. 18 by an Idaho State Police trooper.

## Drug charges net probation

A Seattle man has been placed on 12 months' probation for convictions for drug paraphernalia

possession and drug possession.

Magistrate Judge Dan C. Grober sentenced 29-year-old Bryan Thomas Garfinkel on June 21, two weeks after Owyhee County Sheriff's Deputy Karl Kingston arrested him. Charged with misdemeanor possession of paraphernalia and possession of a controlled substance, Garfinkel entered a guilty plea the same day of his arrest, according to county Prosecuting Attorney Douglas D. Emery.

A 90-day jail term was suspended.

# Smoke from fire near Rome drifts into area

Smoky conditions west of Homedale early last week were caused by a small wildfire outside of Jordan Valley.

Mark Wilkening of the Bureau of Land Management Vale District said that 10 BLM engines and equipment and personnel from the Jordan Valley Fire Protection District battled the 380-acre Indian Forks Fire.

The lightning-caused fire was reported to BLM from the Malheur County Sheriff's Office

at 7:15 p.m. on June 29.

Local ranchers also helped out, and the fire was 100 percent contained by Wednesday morning, Wilkening said.

The BLM crew remained on scene to monitor the area late Wednesday morning, he said.

acres of federal lands that are exempt from property tax.

"The entire amount received this year will go into the budget," County Clerk Charlotte Sherburn said.

This is the second consecutive year that the entire PILT amount will go into the county's budget. Previously, a fraction of the PILT money was used for budgetary expenses and the rest was placed in a trust fund dedicated to future expansion of county facilities.

The Emergency Economic Stabilization Act of 2008 authorized a five-year cycle of full PILT funding.

The FY 2010 payment, which came a

few weeks later than last year's check, also marks the second time in the history of the program that the county has been compensated completely for the land. Before last year, the federal government was paying only a fraction of its total obligation.

Owyhee County has received more than \$2.9 million in PILT money in the past two years, and all of it has been put in the budget. The PILT Trust Fund totals a little less than \$1.29 million, Sherburn said. Since 2006, the county has placed only \$961,079 into the building fund while getting a total PILT windfall of more than \$4.5 million.

Owyhee County has the second-largest

swath of federal lands in Idaho, about 900,000 acres fewer than Idaho County's 4.5 million acres. Yet, Owyhee receives just the sixth-highest PILT payment among Idaho's 44 counties. Elmore County will receive the top payment at \$2.3 million despite having only 1.35 million acres of exempt land.

Annual PILT payments are calculated according to the number of acres in a county and that county's population. Payments change as acreage data and Census numbers are updated.

This year, the feds are making payments totaling \$358.4 million.

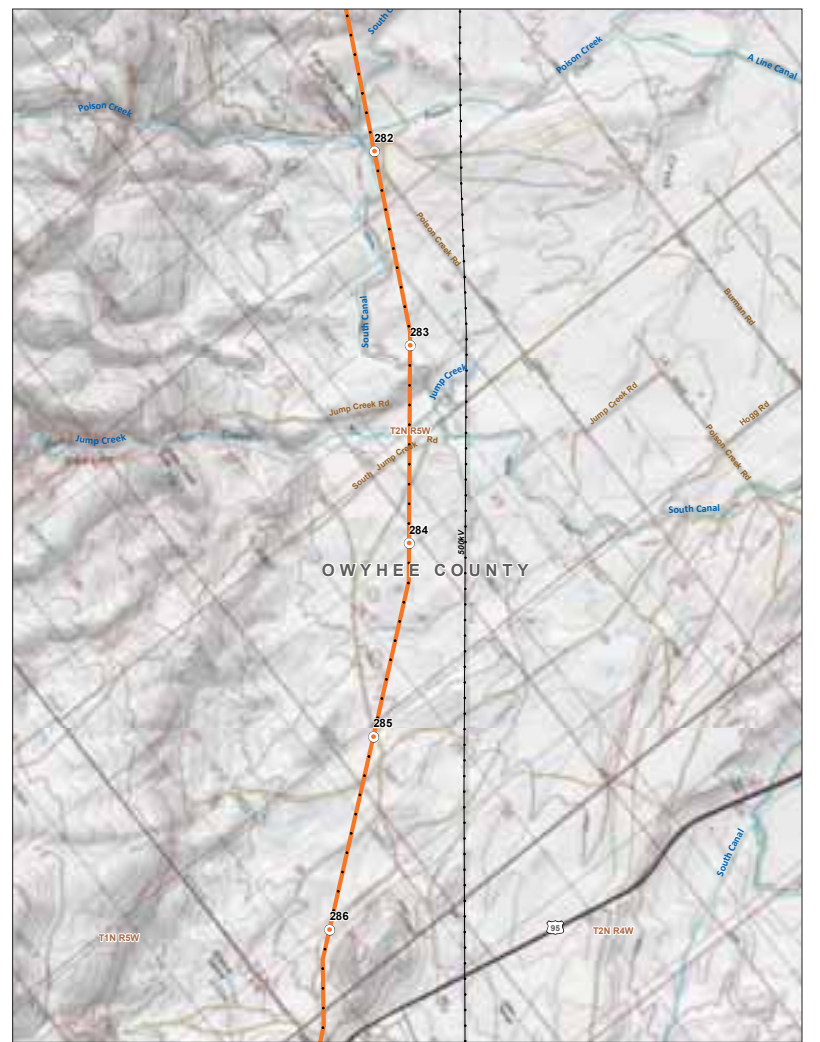

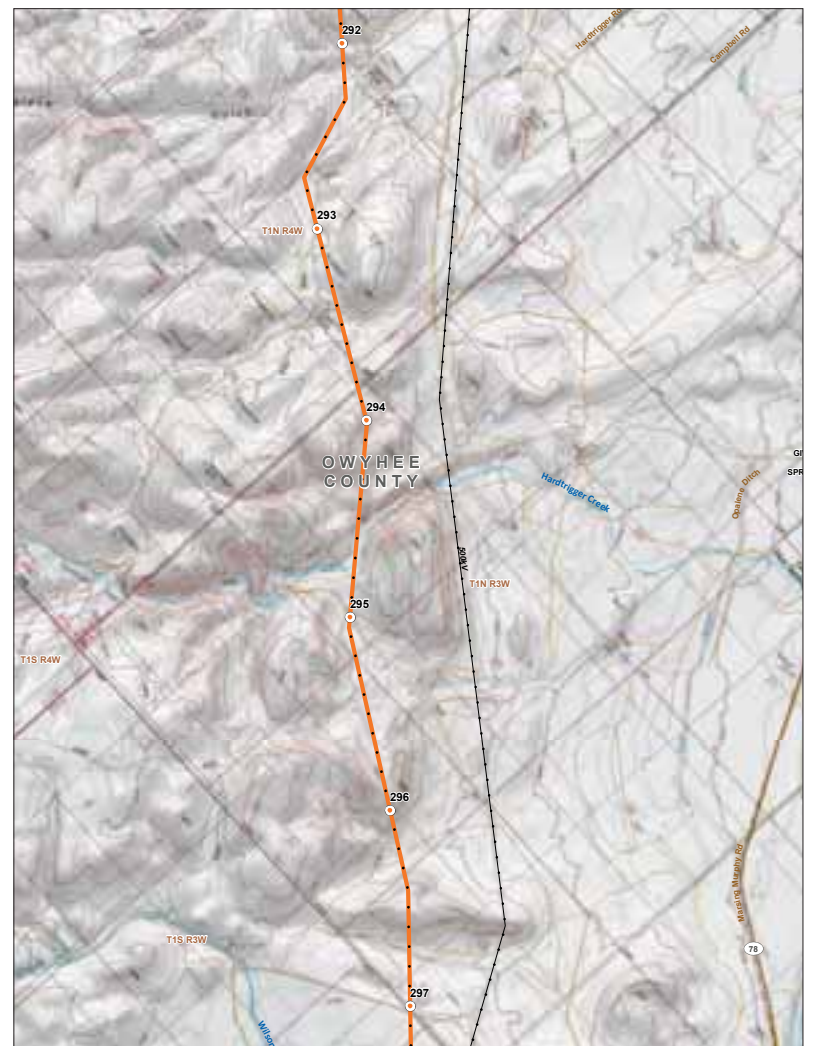

no formal presentation, but key figures from the Community Advisory Process will be on hand to provide answers about the year-long effort that produced the proposal.

A revised application will go to the BLM, and then the federal agency will begin its scoping process. McCurdy said the next opportunity for public comment and suggestions would come during the federal process in August.

The Owyhee County map that will be on display next week is

different even from a map of the proposed route published in April.

The newest map, dated from June, shows the local portion of the route — comprising the final 23 miles of the power line — enters Owyhee from Malheur County at a point west of the existing PacifiCorp 500kV line, which runs on federal land west of Homedale.

McCurdy said the gap between the proposed B2H and the PacifiCorp line is typically between 1,200 and 1,600 feet.

As the line continues on southern route through the county, it is proposed to cross above several roads, including Sands Basin, Poison Creek and Jump Creek.

It will also cross U.S. Highway 95 west of Sommercamp Road and Campbell Road farther south.

Eventually, the two 500kV lines intersect where the PacifiCorp line heads west at a point east of Wilson Creek Road about two miles north of the Hemingway substation.

# Obituary

## Michael ("Mike") Moysard

Michael ("Mike") Moysard, of Peoria, Arizona died Wednesday, June 2, 2010 at Banner Boswell Hospital after a nine-month battle against cancer. He was 75 years old.

Mike was born March 14, 1935 in New York City to Fred and Daisy Moysard and was the eldest of their two children.

In 1952, Mike joined the U.S. Navy; he served in the Korean War and received an Honorable Discharge in 1956; and later he received another Honorable Discharge from the California Army National Guard.

In 1955, he married Janice Nelan. They had five children.

In 1959, he began his career in law enforcement as a police officer with the Menlo Park Police Department in California. In 1964, Mike joined the San Francisco Police Department. During his years with the SFPD, Mike worked with many divisions, including as a member of SWAT, a member of Vice, a handler and trainer for the K-9 Unit, a member of the Bomb Squad and as an instructor at the pistol range. During his career with the SFPD, Mike was awarded five Medals of Valor. When Mike retired from the SFPD in 1980, he moved his family to Caldwell, Idaho. There Mike served as a Sheriff's Deputy in Owyhee County for over five years, and later as Chief of Police



in Homedale, Idaho. In 1992, Mike moved to Midland, Texas, where he worked security at Midland Memorial Hospital for a few years and later as a corrections officer at Cornell Corrections in Big Spring, Texas.

Although he was raised in New York City, Mike always loved the outdoors; he loved hunting, fishing and being one with nature. Mike loved animals. He never met a stranger and getting to know people was what he enjoyed most. Whether it was through tough love or kindness, Mike impacted the lives of all he came in contact with. You could not ask for a better or more loyal friend. Mike's interests were vast: he loved

reading, history, motorcycles, welding, collecting knives, jazz, playing the trumpet, archery and on and on goes his list of passions. He loved hearing a good story or joke almost as much as he enjoyed telling one.

Mike was a role model for living life fully with dignity, enthusiasm and humor. To the end, Mike dedicated his life to public service.

Mike is survived by Jan, his wife of 54 years, their five children (daughter Mary, daughter Lora, son Damon and his wife Kim, daughter Amy, daughter Nikkol and her husband Kyle), their grandchildren (granddaughter Jessica and her husband Bret, granddaughter Krystl, grandson Kaleb, granddaughter Keira and great-granddaughter Timorie), his sister, Suzanne, his cousins and many nieces and nephews.

## Lightning sparks fires

Lightning sparked two wildfires in eastern Owyhee County early last week.

Both fires have been contained, according to the National Interagency Fire Center Web site.

The largest of the two — the Black Butte Fire — burned 16,126 acres on the east side of the Saylor Creek Training Range, which is part of the Mountain Home Air Force Base complex.

Another fire sparked on Idaho Department of Lands acreage west of the training range and burned 9,837 acres. The Saylor Creek Fire began as a 400-acre blaze, but grew to its final size within 19 hours of ignition thanks to 40 to 50 mph winds. It began around 3 p.m. on June 19 in a remote area west of the training range. The BLM put 14 engines and two water tenders on the fire.

Crews had the Black Butte Fire, which burned in the Jarbidge Field Office of the Bureau of Land Management's Twin Falls District, at 90 percent containment by Wednesday morning. Six engines worked the fire, which began at 4:33 p.m. on June 29.

## Big hits highlight 2010 event

Of the 29 participants there were six returning champions. There were five rookies running cars, four women and 12 who have competed in five or more derbies.

The derby is an annual fundraiser for the Homedale Lions to help with ongoing and future projects in the community. Through the nearly 2,400 in attendance for the derby the Lions Club will be able further their efforts in the community.

"It felt good to finish off with a bang there," the son of Tony and Kim Martinat of Marsing said. "It just felt good to go near home and finish off the week and win it."

But the road home for the Homedale High School graduate had a few bumps along the way during his first big week of pro action since finishing the college rodeo season.

The Vale rodeo was the final event of what was supposed to be a three-event day Sunday for Martinat and his traveling partner, Mark Gage of Redmond, Ore.

But once at Vale, the closest rodeo to home for the entire week for Martinat, the outlook improved considerably. He won his second buckle of a week competing in Northwest Pro Rodeo Association-sanctioned events.

"It made up for it because we had to hustle to Grangeville,"

### Landa's State showing earns walk-on at JC

Reece Landa will walk on with the Cardinal golf team at North Idaho College in Coeur d'Alene this fall.

The Homedale High School graduate turned heads with his performance at the 3A state tournament in Post Falls in May.

"Reece was someone we had noticed due to his state tournament performance, then it was an NIC booster that mentioned him to us again saying 'My friend's son would love to come and play for you', so we got in contact with him," NIC golf coach Derek Thompson said.

Landa, who was attracted by the coziness of the NIC campus, is looking forward to the next level.

"The school campus is so nice and not too big," he said. "I loved golf in high school, so why not take the opportunity to move on with it?"

Thompson is impressed with Landa's ability to tackle challenges head-on.

"He is a tough kid that handles adversity, works hard, and we expect him to compete for a spot on the travel team," the coach said.

The Cardinals are the only golf team in the Scenic West Athletic Conference. NIC usually has eight to 10 players on the roster. Thompson likened his team to an independent, allowing the Cardinals to compete against regional four-year golf programs.

"We want to have our players move on to the next level, so it is a huge opportunity for our players to compete with a lot of four-year schools whether NAIA, or NCAA Div. II or III," he said.

Thompson said that exposure to larger programs and their coaches increases the odds of those four-year programs picking up players at the end of their time at NIC.

"They don't have to go out to

recruit, they just schedule with us and see our kids in competition," he said.

The lack of same-level competition, though, has the NIC program flying under the radar

nationally.

"The only perceived downfall of this, is being underrated because of lack of junior college competition," Thompson said.

Despite not being ranked very highly among the National Junior College Athletic Association's Div. I programs in 2010, but still managed to finish 17<sup>th</sup> at the national tournament.

Much like Landa is looking forward to benefits of teeing it up at NIC, Thompson thinks the son of Chris and Virginia Landa can help the Cardinals.

The coach said Landa has "great potential because he will improve so much when focusing on golf up here."

Golf will be a year-round commitment for Landa once he steps on the NIC campus.

"Our schedule with fall golf, winter training and practice, then the spring season keeps them going from September the national tournament in May," Thompson said.

Landa doesn't mind the prospect of more time on the links.

"When I'm doing a lot more golfing, keeping my game open, I'll have the chance to learn all I can, to hopefully compete for a travel spot," he said.

NIC boasts an enrollment of approximately 5,700 students at its 45-acre campus on Lake Coeur d'Alene. The golf team practices at Avondale Golf Course in Hayden Lake, where Thompson doubles as the resident golf professional.

## RV to L.A.? No way, Jose

Our outings in our recently acquired travel trailer might lead readers to believe we are total rookies in the RV field. But that's not exactly true.

Back in the mid-1980s, we rented a 23-foot motorhome and set off with our three darling daughters on the Great American Adventure ... a pilgrimage to Disneyland.

I did have reservations about the trip. Disneyland means Los Angeles, and that means freeways. It was early on a Sunday afternoon when we dropped down off El Cajon Pass. I had planned our time of arrival carefully, figuring if there is ever a quiet time in that area it would be Sunday afternoon. I was half-right. It was a quiet time. But "quiet" isn't really an operative word in Southern California.

There were signs under the palm trees advising motorists that the maximum speed was 55 miles per hour. I really tried to go 55. But after being nearly run over by a semi truck pulling three trailers, I put the speedometer needle on 65 and kept it there for the next seven days.

We were staying in Anaheim and decided to visit Marineland, which is over on the far side of Long Beach. The trip over was fairly uneventful. The morning rush-hour traffic was past. I had the best intentions of getting back to Anaheim before the afternoon rush began. But Marineland was bigger than anticipated. It was 3:30 before we started the return trip.

Things were going smoothly. Suddenly my mate, who was acting as my second pair of eyes on the right side, shouted "slow down!" A split second earlier, the 5,463 cars, trucks and buses on the quarter-mile stretch directly ahead of us had been traveling as a unit at 65 mph. The next second, all 5,463 stopped.

A 23-foot motorhome is fairly heavy. It is even heavier when the 65-gallon water tank is full and the cupboards are loaded with the essentials needed to sustain a family of five for 10 days. It will not stop on a dime. But I discovered that when you have fear as a motivator, you can make a motorhome stop in a shorter distance than you would have ever imagined.

When the dust cleared I looked around. We were in the middle of the world's biggest parking lot. I mentally patted myself on the back for reacting so quickly. In the back of the motorhome, our youngsters were untangling themselves from under the table. They didn't even whimper.

Later, a relative who lives in L.A. explained what happened.

When six lanes of traffic are thundering down an L.A. freeway, bumper-to-bumper, everything is hunky dory as long as no one flinches. Somewhere up around the

## From Washington

### Federal policy continues to stifle small business

The Idaho National Laboratory (INL) was recently recognized by the U.S. Department of Energy as its 2009 Mentor of the Year for its "commitment to mentoring small business." INL was given this honor for its work with small businesses through its Mentor-Protégé Program, which seeks to enhance "the capabilities of small businesses to perform contracts and subcontracts for INL, other DOE Laboratories and federal agencies." There is a very good reason why INL and DOE seek to support and mentor small business. In addition to providing valuable and unique services to DOE Laboratories and other federal agencies, the combined efforts of America's small businesses provide jobs, growth and an incredible boost to our economy — so much so that small business is often referred to as the backbone of the American economy.

Statistics for the latest year available (2006) from the Small Business Administration (SBA) show that Idaho has 38,596 small employers (500 employees or fewer) and 114,338 non-employers (owner-operated businesses). According to the SBA, "[they] make significant contributions to the state's economy, and they bring innovative products and services to the marketplace. They are an important source of employment and opportunity throughout the state ... The number of small employers in Idaho was 38,596 in 2006, accounting for 97.3 percent of the state's employers and 58.6 percent of its private-sector employment." Since the early 1970s, small business has, on the average, created about two of every three net new jobs in the economy. Also since the 1970s, according to the National Federation of Independent Businesses (NFIB), small businesses have produced about half of America's privately generated gross domestic product (GDP). American small business comprises what would be the world's third-largest economy, behind America and Japan. Clearly, small business is a driving

force in the Idaho economy, and the same is true in each state, nationwide.

Unfortunately, given all that small business does for the American economy, America's federal government doesn't seem to be too concerned about returning the favor. While the economy continues to struggle and job growth continues to lag, small business continues to come under assault from all directions by misguided government policies. Small businesses are left to guess at where they are going to be hit next. Uncertainty about future tax policy and the financial burden of increased taxes, fees and compliance costs resulting from the new health care law and upcoming energy regulation and financial reform legislation make it hard, if not impossible, for small businesses to make sound financial decisions. With all of the uncertainty and the increased cost of doing business, they are understandably unwilling to invest, expand and hire, which, in turn, will only add to and extend the problems already facing the economy.

To give our small businesses some certainty and incentive to grow and be competitive in the domestic and international economies, we need to keep their taxes low and not overburden them with expensive new regulations. Rather than continuing the federal government's unsustainable spending spree and its unreasonable plans to pay for it by increasing taxes, we must stop the spree, reduce the spending and keep taxes at a low and reasonable level. We need to get the government out of the way of the small business engine of our economy. Removing the disincentive of high taxes and costly regulation will allow small business to go out and do what they do — create jobs and growth in the economy by providing valuable goods and services to their customers.

When we told my mother-in-law that by doing this we'd be able to pay off our house within 10 years, she told us that would be a stupid move. She couldn't give us a reason why she thought it was stupid, but we couldn't convince her otherwise. How can we explain things to her?

Dear Jason,

OK, she's telling you it's a bad idea, but she has no idea *why* it's a bad idea? It sounds to me like she's the dumb one if she thinks you should behave a certain way, but can't even tell you why. If someone can't tell you why they have an argument against something, then they have no argument in the first place!



A lot of talking heads think it's smart to not pay off your home. They'll tell you things like it's better to borrow money against your house and invest it in the stock market. What they won't tell you is that there's virtually nothing there by the time you adjust for risk and taxes. Why in the world would you take a chance on losing your home over something like that?

Another line they'll throw out is that you don't want to lose your tax deduction. This one's really silly! If you have a \$200,000 loan at five percent interest, you'll pay about \$10,000 a year in interest. Now, let's also say you make \$70,000 a

year, and you're in the 25 percent tax bracket. That \$10,000 tax deduction is saving you \$2,500 in taxes. In essence, you're sending \$10,000 to the mortgage company to keep from sending the government \$2,500. That's pretty stupid! You'd be better off to be debt-free and give \$10,000 to some charity or your church. That way, you'll save on taxes *and* do some good with the money.

By paying off your home, you decrease risk and gain a ton of security!

My husband lost his job a few months ago. He's found another one since then, but we're still trying to rebuild our finances. At the same time, our daughter plays softball on a travel team. It's a great character-building experience, but the costs involved can be pretty high. Do you think

we should cut down on the travel team activities for a while?

Dear Natasha,

You're right. Playing sports can be a great part of the character-building process. But she can learn character lessons playing in a softball league at your local park. She doesn't have to travel all over the place to learn those kinds of things.

If you have kids, there's a pretty good chance you're going to spend some money to help encourage their hobbies and interests. That comes with the territory, and it should be a fun and rewarding experience for everyone. You just have to take a look at your financial situation — and the kid's desires and abilities — and make sure it's a *reasonable* amount of money.

In your situation, playing on a travel team right now is a luxury.

You don't need to be footing the bill for hotel rooms and gas and stuff while you're trying to get back on solid ground financially. Chances are, this child is not going to make a living playing softball. Even if she is that good, she can still sharpen her skills in a hometown league until you guys are back on your feet.

I'm not opposed to kids playing on these kinds of teams per se. But you can't allow the cost and time involved to undermine the needs of your family or blow your budget!

### School consolidation issue surfaces...again

The Homedale School Board will meet with Marsing Superintendent Dr. Richard Johnson at their next trustee session in August about a possible consolidation between the two districts.

Johnson said Tuesday that he had toured the Marsing High School with the Marsing trustees and was given the "go ahead" by the board to confront Homedale with the idea. An attempt to construct a joint high school or transport students from one school to another in a consolidation attempt failed several years ago, when a joint study group determined that the effort would not be successful.

Homedale Superintendent Deward Bell notified the board on Monday night of Marsing's ideas. He said a combination of the two high schools could improve the academic offerings for both groups of students, although passing a levy for a school costing \$4 million to \$5 million might be difficult to impossible in the present economy.

Homedale chairman Kirt Weimer served on the joint committee and had some comments on the venture. He said the group believed the curriculum could be improved by one high school, although they felt that the location of the school of Market Road between the two towns necessitated longer transportation for all the students. Weimer said he felt the majority of people in both towns did not support the idea at the time. Weimer was also concerned that Homedale would need a new elementary school in the next 5-10 years, and construction of a joint high school would kill enthusiasm for what Homedale would require soon.

Trustee Ron Geertson advised turning down the idea that evening, citing possible problems with staff members and the need for an elementary school in Homedale. Member Hal Tolmie said Homedale could work to accept some of the Marsing students and suggested leaving the door open.

### ESI intends to close Bruneau dump

Envirosafe Services Inc. of Idaho has "unofficially" notified the Region 10 Environmental Protection Agency in Seattle that they intend to close the Bruneau waste dump, said Catherine Massimino, permit officer of the EPA.

The EPA office received a letter to that effect this week, and Lee Cleveland, Western division manager for ESII notified EPA officials of the closure last week, reported Bill Hartford of the Idaho Division of the Environment.

Envirosafe must either submit a Part B operating permit for Bruneau by early October or start closure and post-closure proceedings, said Massimino. The company recently submitted a Part B application for the Grand View dumpsite in May. Residents near the Grand View operation expressed opposition to the continued use of the site at a public meeting two weeks ago at Rimrock High School.

While ESII would normally be given 180 days after notification of closure, the process may take longer than that, said Massimino. Following the word from Envirosafe, an application for closure would be submitted, a review begun, and more public hearings set up on the issue.

Envirosafe officials said recently that they would consider closure of the Bruneau operation, rather than spend up to \$3 million for the Part B application process, because of the financial climate of the hazardous waste market. Cost of closure is estimated at \$100,000 to \$300,000.

Owyhee County is concerned about the future of the Bruneau dump after closure, said environmental safety officer Dr. Charles Scott. ESII had stored waste at the radar site at Bruneau with the intention of moving it to Grand View to escape placing extra monitoring wells in the ground; it is the county's intention that the waste stay at Bruneau and be monitored there, said Scott.

Mrs. Mildretta Adams is the author of the new book "Historic Silver City, The Story of the Owyhees," which she placed on sale last weekend at the Dinner Bell, the lunch counter she operates during the summer at Silver City.

Mrs. Adams was born Mildretta Hamilton, July 10, 1907 near the upper end of Lake Lowell when the New York canal was being built. Her father had a contract to build 1/2 mile of ditch with team, plows and scrapers.

Her parents, Ira and Martha Hamilton, originally rode horseback from Meeker Colo., to the Owyhee River near Adrian in 1884, following the south Oregon Trail. Her mother rode sidesaddle.

Mildretta went to schools in Nampa and Caldwell, later attending the 8<sup>th</sup> grade and three years of high school at Homedale.

She was married to Walter Adams January 23, 1926. They bought their home in Homedale in 1931. Their three daughters, Alene (Mrs. Kenneth Downing); Pat (Mrs. Don Davis of Bruneau) and Marilyn (Mrs. Jack Burke) went to school in Homedale and now have families of their own.

Currently she is a charter member of the Owyhee County Historical Society and is a charter member of the American Legion Auxiliary.

When their son-in-law Kenneth Downing bought the John Daley home in Silver City, in 1950 the Adams family began spending most of their vacation time there. Later, in July, 1959, in partnership with Ernie Bahem the Adams bought the old Strode building on 1<sup>st</sup> and Jordan streets, and Mrs. Adams operated a lunch counter, the Dinner Bell, there on the weekends and through the deer hunting season.

## 140 years ago

July 9, 1870

**HALLELUJAH!** The United States Senate have at length heard the ominous voice of the people, and buried the odious income tax. No longer will there be a chance for rich men to establish their poverty, no poor men to acquire a slender reputation for wealth, while honest men everywhere groaned under the weight not only of an oppressive but an odious tax. The House of Representatives should not have continued the tax in force in any shape, but they preferred to yield to the Senate the honor of making it a thing of the past. This result proves the great influence exerted by the press in the legislation of the country. The people were opposed to the tax, and the Press reported their views; when the House failed to respond to the general demand, no stone was left unturned to influence the Senate, and with success.

After the foregoing was in type, a dispatch informs us that the Senate reconsidered the question and voted to continue the tax for two years at 2 1/2 percent.

**THE FOURTH AT WAGONTOWN.** A number of our citizens attended the races at Wagontown last Monday. Everything passed off in the most satisfactory manner. There were four races of a quarter of a mile each, as follows: L.W. Walker's chestnut horse and Jno Catalow's sorrel mare, for \$50 a side, won by the latter. Second, Tim Shay's sorrel horse and Frenchman's roan filly, for \$40 a side, won by Shay's horse. Third, Catalow's sorrel mare and Frenchman's sorrel horse, for \$50 a side, Catalow's mare winner. Fourth, Jordan's black mare and Tom Walls' gray horse, for \$45 a side, Jordan's mare winner.

**THE CORNER STONE** of the Idaho penitentiary, at Boise City, was laid at six o'clock p.m. July 4<sup>th</sup>. A large number of people witnessed the ceremony. We copy from the Chronicle of the 6<sup>th</sup> the list of articles deposited:

We have not visited it, but are informed that the vein is about five feet in width, with a 20-inch streak of decomposed quartz in the middle of it. The prospects obtained by panning out the decomposed stuff show it to be exceedingly rich in gold, and there is much reason to believe that a large portion of gold found in the gulch below came from this ledge. Geo. Gilmore, Sam Slick and Fred Dolbert are the lucky discoverers, and have named it the Amador. Extensions have already been taken up for an indefinite distance, both north and south.

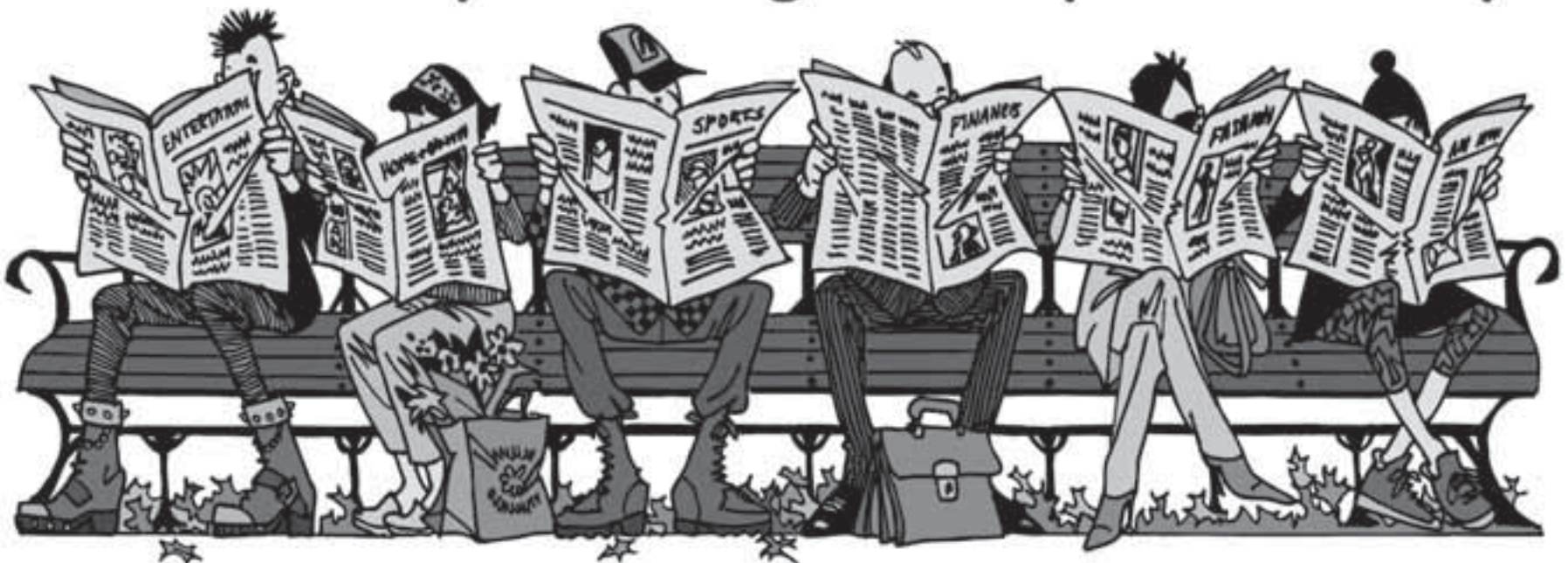

**16-0202-1001, Rules of the Emergency Medical Services (EMS) Physician Commission.** Incorporates by reference the most current edition of the EMS Physician Commission Standards Manual.

**16-0301-1001, Eligibility for Health Care Assistance for Families and Children.** Adds eligibility criteria for and defines a "financially deprived child."

**16-0324-1001, The Medically Indigent Program - Request for Medicaid Eligibility Determination.** (Temp & Prop) New chapter provides the requirements necessary for a hospital or county to submit applications and requests to the Department to determine Medicaid eligibility for an applicant who may be medically indigent.

### 16.05.06 - Criminal History and Background Checks

**16-0506-1001, (Temp & Prop)** Clarifies which Department rules require an individual to have a criminal history and background check; updates the list of disqualifying crimes and unconditional denials that prevent a person from receiving a CHC clearance; provides that individuals listed on the Nurse Aide and Child Protection Central registries will receive unconditional denials; and adds additional crimes to the 5-year disqualifying crimes list.

**16-0506-1002 - (Temp & Prop)** Provides the guidelines for establishing an Idaho Child Protection Central Registry Check and adds a fee to cover the cost of providing requested background checks.

### 16.06.02 - Rules Governing Standards for Child Care Licensing

**16-0602-1001, (Temp & Prop)** Provides requirements and clarification for areas related to daycare licensing that include safety and health standards, licensure requirements, and the suspension, denial, and revocation of licenses.

**16-0602-1002, (Temp & Prop)** Provides requirements for licensing and inspections fees for daycare licensure.

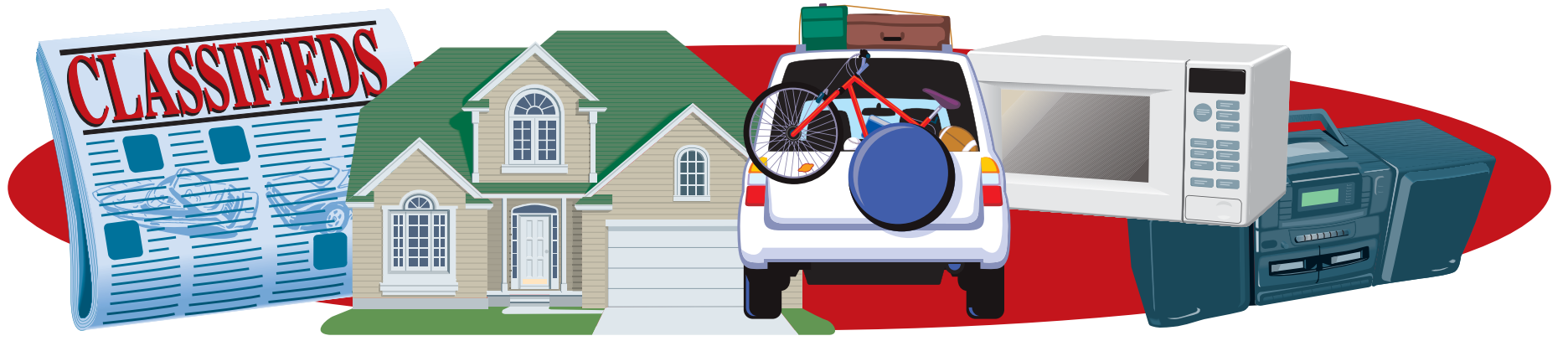
