## Holiday closures noted

**Avalanche classifieds due Friday at 5 p.m.**

Government offices, banks and post offices will be closed Monday for the Fourth of July holiday.

Emergency services throughout Owyhee County, including dispatch, sheriff's office, Homedale police and fire and medical services will still be available.

The Board of County Commissioners will reschedule their weekly meeting from Monday to Tuesday because of the holiday. The BOCC meetings typically start at 9 a.m.

Public libraries and senior centers in the county also will be closed.

The Owyhee Avalanche office also will be closed Monday. Deadlines for the July 6 edition of the Avalanche will remain the same except for classified advertising, which will be due by 5 p.m. Friday.

The South Board of Control, Gem and Ridgeview Irrigation Districts also have moved their boards of directors meetings to Thursday, July 7. The boards usually meet on the first Tuesday of the month.

The Homedale Chamber of Commerce, which typically holds its business luncheon on the first Tuesday of the month, has cancelled the July meeting and will reconvene in August at Owyhee Lanes and Restaurant.

## Derby veteran driving to give crowd a carnage-filled night

**Jake Volk has competed in more than half of the Fourth of July smashfests**

Taking old cars and equipping them with steel plating, modified fuel tanks and roof-mounted radiators may seem bizarre to some, but for those competing in the 30<sup>th</sup> annual Homedale Lions

Club Fourth of July Demolition Derby it's just another day.

As 17-year Homedale derby veteran Jake Volk prepares his car for the annual smashfest, he will draw from years of experience and 14 gently used past rigs to deliver what the crowd wants — "carnage."

"The spectators come to the show for one thing, big hits," Volk said. "They want to see you

## Looking at little things helps Marsing schools

**District retains all contracts during budget crunch**

Despite a budget shift from last year of more than \$1 million, the Marsing School District has managed to set their fiscal year 2012

budget and retain a complete staff without cuts.

District business manager Debbie Holzhey said it has been a wild five months since the passing of the new education laws by the state Legislature. She said without a superintendent in place all administrators have picked up the slack along with the board of

trustees in finding ways to cuts costs while retaining staff and programs.

"We have been working on the numbers for quite a while now," Holzhey said. "Trying to find ways to keep as much as we can was a lot of work. We went through everything, finding all the little expenditures that added

up and finding ways to reduce them."

Holzhey said district wide, officials realized there were many "little things" they looked at to set the upcoming 2011-2012 budget. This school year, after a renegotiation with the district's copy

# Homedale council hears another offer for prosecutor's contract

Emery pushes for pact with city in addition to county obligations

Owyhee County Prosecuting Attorney Douglas D. Emery has thrown his hat into the ring to take up prosecutorial duties for the City of Homedale.

Emery made his pitch at Thursday's Homedale City Council meeting. Emery already handles city prosecutor duties for Marsing for the amount of the Owyhee County Annex building's water bill each month as part of a deal worked out between the city and the Board of County Commissioners.

In his proposal to the council, Emery said the BOCC was fine with him pursuing the contract work. Under the proposed pact, Emery would use city funds to reimburse the county for office supplies and secretarial work associated with Homedale cases.

The council also has a contract on the table for current city prosecutor Russell Metcalf, who has been working under a probationary pact since the middle of December.

"I enjoy this work and it is in my blood," Emery told the council.

cil. "I like Russell Metcalf, but I believe I have more experience."

Emery based much of his contract proposal from the 32 hours-per-month that Metcalf is working for the city. Metcalf has still yet to sign a contract superseding his probation, leaving the door open for Emery to apply.

For his services prosecuting non-conflicting misdemeanors and infractions for the city, Emery is seeking \$1,400 per month. The city would pay Emery each month and then he would send a check to the county covering the costs for his secretary.

The proposal outlines \$100 would be designated to Owyhee County each month to cover office supplies. Another \$200 of the contract would also be paid for a "primary legal P.A. secretary" for the additional secretarial duties each month.

The largest portion of the contract falls for the prosecuting services. Emery proposed an \$1,100-per-month fee for the potential 32 hours spent on city cases. This fee excludes any trial services and additional costs for case litigation.

Emery's proposal lists an alternative partial payment option of: "a portion of the compensation for such Professional Services of City Prosecuting Attorney, could be provided to city prosecutor in form of the fringe benefits of an automobile insurance to prosecutor by Homedale City, with regular service and maintenance

plan and service station (gasoline and oil) card."

For trial services, Emery would charge a flat fee of \$800 per day. Some of the items outlined for this fee include trial preparation, handling and filing pre-trial motions, preparation of and filing legal memoranda, oral argument and witness interviews.

Under the additional costs clause, he lists verifiable "hard costs" which are associated with cases that end up in litigation. Some of these hard costs could include witness fees, exhibit preparation, expert witness fees, witness travel expenses and juror fees.

"If you were to go out and hire a licensed electrician, you would pay more," Emery said. "I do a lot of work from home and don't, per se, get compensated for that."

Emery currently earns more than \$80,000 per year in salary from Owyhee County for his elected position.

On his contract proposal to the city, Emery was willing to "shave" the fee and charge \$1,200 for his services.

Metcalf has earned \$1,200 per month plus expenses since starting in December. The non-probationary contract that has yet to be finalized calls for a \$300-per-month salary increase as well as \$120-per-hour for trials.

The council made no decision as to accept or deny Emery's proposal. Council members are expected to discuss the matter during an executive session at their next meeting, which begins at 6 p.m. on Wednesday, July 13, inside City Hall, 31 W. Wyoming Ave.

Rescheduling May event proves futile

Difficulty trying to reschedule the Jordan Valley Big Loop Rodeo has forced organizers to follow through with cancellation of the 2011 event.

"We have tried to find a date that will work, and there is always something that creates a problem," Jordan Valley Rodeo Association members wrote on the Big Loop website.

"In the best interest of everything, it just seemed best to cancel and concentrate on the 2011 Rope & Ride event."

The 13<sup>th</sup> annual Owyhee Rope

and Ride is scheduled for Sept. 23-25 at the Jordan Valley Rodeo Grounds.

The Big Loop rodeo, originally scheduled for May 20-22, was postponed in the midst of the equine herpesvirus (EHV-1) outbreak. Organizers announced the postponement days before the rodeo was set to begin.

In announcing the cancellation last week, organizers said that any contestant who had paid an entry fee and is entitled to a refund should email [jvrodeo@clearwire.net](mailto:jvrodeo@clearwire.net).

Fresh look, new name for senior center

It's now officially Homedale Senior Center after volunteers kicked off a summer of projects with a new sign and a fresh coat of paint at the building formerly known as the Homedale Senior Citizens Center.

Volunteers give senior center a facelift

Crew burns through nearly 30 gallons to freshen facade; more work planned

Typically on your day off you want to work on your own projects and lists that float around your house. But for a crew of Home Depot employees, their day off Friday was spent putting a fresh coat of paint on the Homedale Senior Center.

The Team Depot crew comprised of 18 employees from the Nampa store mixed and rolled on the new brilliant white exterior.

"We're just tickled about this," senior center coordinator Shirley McAbee said. "I have no idea when the building was last painted, but this really needed to be done. We couldn't have afforded this without the Home Depot volunteers."

From the exterior prep work that took place the day before to the Friday all-hands-on-deck painting, nearly 30 gallons of paint were applied. Throughout the day, crews worked on the inside of the building as well, removing old and outdated toilets, some of which didn't work, and installing new sinks and countertops in the bathrooms.

"This is all volunteer," Home Depot employee and Homedale-area resident Bruce Thomson said. "Community involvement is one of our core values. This is really an excellent way to give back to the community, and this is a great place to do it."

Thomson said he presented the idea to McAbee and she was extremely excited and receptive to the project.

"I asked her if we could do this project. I don't think she really knew what to say," Thomson said. "Communities in the outlying areas don't usually get the attention they need."

Overall, the crew spent around 72 man-hours sprucing up and providing a more welcoming

facility to area seniors.

"Considering the condition of the building, it went well. A little touch up here and there, it will be good to go," Thomson said. "It looks really, really nice. It is the gift of giving. There is no better gift than the gift of self."

The workday supplemented a \$2,000 grant Home Depot awarded to the center for improvements such as new exterior paint, a new sign out front — it's the "Homedale Senior Center" now — and repair and replacement of three of the center's toilets.

"It's just kind of like Christmas," senior center coordinator Shirley McAbee said. "It makes you feel really good to be able to do it."

"And with these other improvements we just got done paying for, I think it just helps clean up this spot here."

The senior center recently wrote a \$4,502.89 check to pay its full share of the Local Improvement District assessment for downtown improvement.

McAbee said the sign change from "Homedale Senior Citizens Center" reflects an effort to invite more community members who may be of senior age, but don't consider themselves "senior citizens".

Home Depot-Nampa assistant manager John Aceves credited Thomson with bringing the project to the store's attention.

"He's kind of my eyes and ears out there," Aceves said. "He comes to me with these projects."

McAbee said Thomson did a lot of the legwork on the paperwork, and Home Depot came up with a huge surprise for the senior center.

The center originally asked for \$800, and Aceves bumped the request to \$1,000 and submitted it

to Sherry Caraway, the community affairs manager for the Western Division of the Home Depot Foundation.

"(The grant) came back at \$1,500, and then she said, 'You know what, let's make it \$2,000,'" Aceves said.

The grant came to the senior center in the form of a gift card, and McAbee and her crew went

shopping.

"We did our own shopping and picked out our own colors," she said. "After we paid for the paint and the other supplies, whatever was left was ours."

McAbee and Joan Thomson plan to repaint the senior center's second-hand store later this year.

Second DUI since '08 means prison time

Man sentenced on assault, obstruction charges, too

A Nampa man convicted of felony driving under the influence in Owyhee County will spend up to seven years in prison as well as other jail time for associated charges.

Third District Court Judge Gregory M. Culet sentenced 37-year-old Allen Wayne Gillespie on June 10.

Gillespie's charge was enhanced to a felony because it was his second DUI in less than three years. He was found guilty in 2008 for a DUI in Owyhee County as well.

Along with the DUI, Gillespie was found guilty on three other charges stemming from the arrest made on March 4 by Homedale Police officer Jeff Jensen and reserve officer Rodney Reyes.

For the DUI, Gillespie was sentenced to three years determinate time and four years indeterminate. He was ordered to pay fines and courts fees totaling \$570.50 for the DUI.

He was also found guilty on misdemeanors of driving without privileges, assault or battery upon certain personnel and resisting and obstructing officers. Gillespie attempted to spit on one of the officers during the arrest, which resulted in the assault charge.

He was sentenced to 180 days in jail and ordered to pay \$152.50 for the driving without privileges charge.

For the assault charge, he will serve 90 days with 22 of those days being credited and fines of \$137.50.

For the obstruction charge, Gillespie will serve 365 days in jail to run concurrent with his DUI sentence and pay \$137.50 in fees.

Half-day closures set for Marsing, Murphy driver’s license bureaus

Offices have limited hours on different days this week

Motorists using the Marsing and Murphy driver’s licenses offices will have to pick the right time to do their business this week. As part of the changeover in design and issuance of new licenses and identification cards happening statewide, both of the Owyhee County branches will be closed half-days once this week. The office at the sheriff’s office in Murphy will be closed from 8 a.m. to 1 p.m. on Wednesday, June 29. Call (208) 495-1154 for more information. The office in the county annex in Marsing will be closed from 8 a.m. to 1 p.m. on Thursday, June 30. Call (208) 896-4210 for more information. Both offices will open after 1 p.m. for the remainder of the day. Schedules are subject to change, according to an Idaho Transportation Department press release. Customers are advised to check with individual

county offices to confirm daily schedules. The new licenses and ID cards will have a new look and feature state-of-the-art security elements. There also will be a new way that the cards are issued. The changes begin this summer. With this new central issuance process, applicants leave the county office with a temporary license valid for 30 days. The new plastic license or ID card is produced at the central production facility and mailed to the customer within about 10 business days. Current Idaho licenses or ID cards remain valid through their expiration date; however, individuals can opt to renew a license or ID card within one year of the expiration date. License and ID card fees remain the same: \$30 for a four-year license and \$55 for an eight-year license (if it’s within a year of expiration); \$15 for duplicate licenses; \$10 or \$20 for ID cards. Individuals with valid licenses or ID cards that are not within the one-year renewal window have the option of surrendering the card and applying for a duplicate card.

hitting hard and putting cars on their sides and tops. People want to see twisted metal and carnage, which is fun to provide."

Volk intends to do everything he can to pick up the slack for other more timid drivers as he makes his entrance in a dark blue, undertaker-themed 1968 Chrysler Town & Country wagon. The wagon, fully equipped when it was produced, boasted two models -- a six-passenger and a nine-passenger weighing in at 4,550 pounds.

"This is the first year I have run a wagon in the derby," Volk said. "I have been working on buying this car for a while now and finally got it. I think with this car, I have as good of a shot as anyone, but we will see at the end of the night."

Saddling the wagon with a Chrysler 383 from one of his past cars, Volk will be gunning for a trophy this year. Even though he hasn't taken home a trophy for first place in his 17 years, he grabbed the showmanship award last year and has picked up hardest hit, twisted metal and most aggressive in numerous years.

"I always try to get the hardest hit or twisted metal award," Volk said. "The crowd really wants

to see the cars get beat up and mangled. That is what I try and do. I do it for a pure adrenaline rush."

With some salvage companies paying up to \$500 for vehicles, most of the two-ton carnage-creating behemoths are being

hauled off and melted down, making it hard to find vehicles year-in and year-out. Volk said one of the hardest things for

drivers in recent years has been the rising scrap metal price.

"It is harder to find good cars anymore. Most people are scrapping the old cars that have been lying around their property," Volk said. "When you do find a car, it isn't unusual to put in 100 hours to get it ready."

In all, Volk said with the help of others he has put in somewhere around 120 hours into this year's car. He said it was hard to put an actual amount to the time, though, because he will do little things here and there to get the car prepped.

"The biggest thing is the sponsors," Volk said. "Without them, none of this would be possible. This goes for all the drivers out there. The sponsors we get change a lot of the time, but they are truly what make it happen getting the cars in the show."

Volk said even though first place carries a near \$1,000 reward, cars could cost in the thousands to prep and get ready for the Fourth of July bash.

"Every little bit helps from the sponsors," Volk said. "Really, though, we are here to put on a show for the fans, and hopefully we do that."

machine provider, the district will now have networked copiers that will phase out the use of printers in each of the classrooms.

Just from the new copiers, Holzhey estimates the savings to be around \$5,700.

"One of the things that has made the budget easier, is our board has always been very fiscally conservative," Holzhey said. "This year, through attrition and retirement we aren't cutting any teachers like other districts."

Holzhey said middle school principal Paul Webster worked with the block-format schedule enough to cover the two teachers who left. The middle school will open up two half-time positions for technology and math. One of

the positions will be filled from within, she said.

Between the three schools, three teachers resigned and one retired. There were also two custodians who have resigned.

"We are still waiting on our consolidated plan to be returned to determine how many educational assistant positions we will have next year," Holzhey said. "We expect to know what is going to happen there mid-to late July."

In April, educational assistants were notified they might not have a job next year because of cuts to the funding from the state level. The notification to the 11 employees was a preemptive measure from the district to give the classroom assistants a jump on

applying for other jobs if need be, Holzhey said.

With the approved FY 2011-12 budget of \$7,837,030, the district is looking at a \$1,368,562 drop from last year's budget.

Even though there won't be any cuts to teaching jobs, Holzhey said each of the teachers would take a one-week furlough. Last year, the teachers were reimbursed in a one-time stipend for the furlough days.

"I'm thankful to be where we are," Holzhey said. "We all know that the funding for next year will be a different story. The staff and the board all recognize that next year will be a harder year to set the budget."

## 140 years ago

July 1, 1871

HARVE JOHNSON MARRIED. That rusty, fusty, cantankerous old Owyhee bachelor, J. H. Johnson, was recently married to Miss Garcia Brant, in Chicago. Being suspiciously fearful of the divorce courts of that notorious city, he left on double-quick time for the West the morning after the twain were made one flesh, and, in company with his fair bride, passed through Boise City last week on his way to Willow Creek, Oregon. It is said that the father of the late Miss Brant is very rich and very old, from which it appears that, after enduring the privations and hardships of a miner’s life for many years, Harve has struck a rich lead and moored himself safely in the haven of prosperity at last.

INFLUENCE OF CLIMATE ON MAN. It is not generally known, but it is nevertheless true, that a pure moderately dry air generally produces great mental sprightliness, especially with full-blooded persons. A cloudy and moist atmosphere, on the other hand, produces mental relaxation, and with many, melancholy. This explains why suicides so often happen when the sky is overcast. Idaho is perfect to help build healthy diet, routine



The U.S. Department of Agriculture (USDA) recently replaced the traditional food pyramid with a new symbol, "MyPlate," to provide simplified visual nutritional guidance. MyPlate also includes recommendations to enjoy food, but to eat less, avoid oversized portions and compare sodium in foods. No matter what picture is used to provide nutritional guidance or even what guidance is best, this change can help spark family discussions about making healthy choices.

Most of us have seen our country's alarmingly high obesity rates, which are a serious health concern. According to the Congressional Research Service (CRS), "about 32 percent of U.S. children and adolescents between the ages of 2 and 9 are overweight, and more than half of those children are considered obese." Children with excessive weight issues lead to children and adults with significant health challenges. CRS indicates that overweight or obese youth have a higher risk of developing high blood pressure, high cholesterol and abnormal glucose tolerance, which are risk factors for developing cardiovascular disease later in life, and other health conditions associated with obesity are asthma, hepatic steatosis, sleep apnea and Type 2 diabetes.

We all know how starting a day when you do not feel well makes everything more difficult, and in the case of overeating, this difficulty can often be prevented. I am not advocating for the federal government to reach into people's refrigerators and cupboards and determine what we should be eating. We can all make those decisions for ourselves, and the federal government already reaches

into too much of our lives. Rather, we can take personal responsibility, and we can lead by example. We owe it to our children to help them understand and build lifestyles that enable them to succeed. This includes making healthy choices and providing families with the freedom to choose the foods that match their interests and needs. For example, the Obama administration's recognition of the nutritional value of potatoes through MyPlate will hopefully translate to better inclusion of potatoes as options in school lunches and the Women, Infants and Children's (WIC) program.

Fortunately, convenient, outdoor recreation, which can provide exercise, rejuvenation and family bonding opportunities, is in abundance in Idaho communities. For example, the Boise River Greenbelt provides 22 miles of a scenic pathway through the city. The Weiser River Trail stretches from Weiser through Midvale, Cambridge and Council, providing 84 miles of trail for public recreation. The Idaho Falls Greenbelt extends five picturesque miles along the Snake River.

Educating youth about the importance of healthy choices can enable fit adulthood, as children carry these lessons throughout their lives. That is one of the reasons I have been an advocate of the Fresh Fruit and Vegetable Program (FFVP) and worked to make this program available in Idaho. The FFVP provides fresh fruit and vegetables as snacks for children in schools and helps educate students about healthy eating choices. This program benefits both students and farmers who grow high-quality produce,

Forget Weinergate: Obama is impeachable over Libya actions

If you want an indication of why Republicans may lose to Obama in 2012, look at the pass they are giving him over his illegal war in Libya. Nothing is more important than committing a nation to war. The military intervention could be the basis of impeachment charges. But Republican leaders in the House — and Republican John McCain in the Senate — don't want to hold Obama accountable.

The war is illegal, and the media — and now the House Republican leaders — have failed to acknowledge the facts.

On the other hand, there was media fascination with "Weinergate," in which then-Rep. Anthony Weiner (D-N.Y.) obviously stonewalled about the origin and distribution of a lewd photo sent to a coed.

In contrast to the Weiner affair, which led to the congressman's resignation, the facts about Obama's violations of the law and the Constitution are clear.

If Weiner was held accountable for an embarrassing sexual matter, why not enforce the law and the Constitution when the president goes to war?

House leaders could bring impeachment charges. Instead, they want to avoid doing their duty.

The Wall Street Journal reports that "House Republican leaders ... abruptly canceled a vote on a resolution forcing U.S. withdrawal from Libya amid signs" that it would pass. House GOP leaders "fend off vote on Libya resolution," the Washington Post proclaims.

"U.S. House leaders pulled a bill calling for the U.S. military to withdraw from Libya after a group of liberals and conservatives said they back the measure," UPI noted.

In the Senate, McCain, who has turned into an advocate for Al-Jazeera, has been an enthusiastic supporter of the war, conducted with the approval of the Arab League and the United Nations but not Congress. Al-Jazeera, committed to the victory of the Muslim Brotherhood in the region, openly backs the "pro-democracy fighters" in Libya, playing down their links to al Qaida and other terrorist groups.

Libyan dictator Muammar Gaddafi, once a prime sponsor of anti-American terrorism, gave up his terrorist aims and nuclear program after the U.S. invaded Iraq and removed Saddam Hussein in 2003. Gaddafi thought he might be the next target. Little did he know that he would be targeted by a liberal U.S. president enforcing a novel U.N. concept known as the "responsibility to protect."

The evidence is overwhelming, even though most of the media will not cover it, that Obama's war in Libya is illegal and unconstitutional. Columnist George Will got most of it right in a recent column, "Is Obama Above the Law?" The war is a violation of the War Powers Act, which says the president can go to war on his own only if there is an imminent threat to the U.S. and there is a 60-day deadline for the withdrawal of forces.

Obama has violated both provisions of the law. There was no direct or immediate threat to the U.S. from Libya, and Obama has ignored the 60-day deadline for approval from the Congress.

George Will notes that McCain has said that no president "has ever recognized the constitutionality of the War Powers Act, and neither do I. So I don't feel bound by any

deadline."

Will commented, "Oh? No law is actually a law if presidents and senators do not 'recognize' it? Now, there is an interesting alternative to judicial review, and an indicator of how executive aggrandizement and legislative dereliction of duty degrade the rule of law."

Rather than hold Obama accountable, the Journal says that "Republican leaders are working to come up with alternatives that are less far-reaching than the Kucinich provision to allow lawmakers to vent their displeasure."

The Kucinich provision, named for Rep. Dennis Kucinich (D-Ohio), itself falls short of the articles of impeachment that are required. Known as House Concurrent Resolution 51 and citing section 5(c) of the War Powers Resolution, it simply requires the president to remove U.S. armed forces from Libya within 15 days of its adoption.

Even with this attempt to give Obama more time to comply, Kucinich says that Obama and House Republican leaders "feel the need to buy even more time to shore up support for the War in Libya." He says they pulled the bill because they realized it would pass.

He goes on, "The House Leadership has communicated to me via email that the vote on Libya will be postponed 'in an effort to compel more information and consultation' from the administration. I have been asked to provide input for the information which the House will seek from the administration."

So the House Republican leaders are content to beg for information from Obama in order to avoid coming to grips with his violations of the law and the Constitution.

Lawyer Bruce Fein drafted an article of impeachment, noted by Politico shortly after the war commenced, which contends, "In all of this, President Barack Obama has acted in a manner contrary to his trust as president and subversive of constitutional government, to the great prejudice of the cause of law and justice and to the manifest injury of the

people of the United States."

Joining liberal Democrat Kucinich in this effort is conservative Rep. Dan Burton (R-Ind.). He read the provisions of the law at a House Foreign Affairs Committee hearing and declared that Obama was in violation of them.

In a March 28 statement, he said, "When President Obama addressed the American people this evening to explain his decision to launch Operation Odyssey Dawn, the American-led war in Libya, I was waiting for him to explain why after three weeks of inaction the situation in Libya suddenly compelled the president to attack Libya with little congressional consultation and zero congressional approval; although he apparently had enough time to consult and get approval from the United Nations and the Arab League.

"I'm still waiting for an answer. The whole northern tier of Africa, as well as the Middle East is blowing up right now and I want to protect peoples' lives, but what makes the Libyan crisis different from Yemen or Syria or Darfur or Cambodia under the Khmer Rouge?"

He noted that back in 2007 then-Senator Obama loudly declared that "The President does not have power under the Constitution to unilaterally authorize a military attack in a situation that does not involve stopping an actual or imminent threat to the nation."

Burton commented, "Libya does not and did not pose such a threat; and nothing the president said tonight convinced me otherwise. Under the circumstances, I wonder what 2007's Senator Obama would say to 2011's President Obama if he had the chance?"

But the matter goes far beyond matters of hypocrisy to issues affecting the law and the Constitution.

Out of deference to Obama and his Republican partners, the media won't dare call it a constitutional crisis.

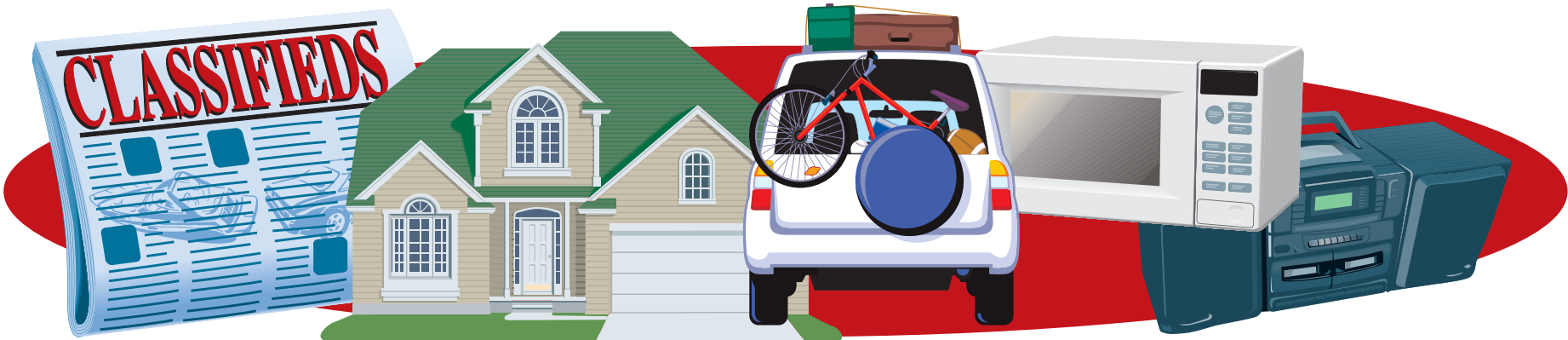
